PART E - SPECIFICATIONS

Revise: E2.3 to read:

Basic First Aid Kits shall be filled in compliance with CSA Z1220-17, First Aid Kits for the Workplace and shall contain the following items as a minimum:

- (a) 25 sterile adhesive bandages, assorted sizes (standard strip, large fingertip, knuckle, large patch);
- (b) 12 sterile gauze pads (7.6 x 7.6 cm, individually wrapped);
- (c) an abdominal pad (12.7 x 22.9 cm, sterile);
- (d) a roll of conforming stretch bandage (5.1 cm x 1.8 m, relaxed length, individually wrapped);
- (e) a roll of conforming stretch bandage (7.6 cm x 1.8 m, relaxed length, individually wrapped);
- (f) 2 sterile compress/pressure dressing with ties (10.2 x 10.2 cm);
- (g) 2 cotton triangular bandages (101.6 x 101.6 x 142.2 cm) with 2 safety pins per bandage:
- (h) a roll of adhesive tape (2.5 cm, 2.3 m total length);
- (i) 25 antiseptic wound cleansing towelettes (individually wrapped);
- (i) 6 topical antibiotic ointments (single use);
- (k) 6 hand/skin cleansing towelettes (individually wrapped) or equivalent;
- (I) a CPR resuscitation barrier device with a one-way valve:
- (m) 4 pairs of disposable examination gloves (medical grade, one-size, powderfree, non-latex);
- (n) a biohazard waste disposal bag (single use);
- (o) a pair of bandage scissors (stainless steel, min. 14 cm) with angled, blunt tip;
- (p) a pair of splinter forceps/tweezers (min. 11.4 cm, fine point, stainless steel);
- (q) an emergency blanket (aluminized, non-stretch polyester, min. 132 x 213 cm)
- (r) a list of contents.

E2.5 Add:

Personal First Aid Kits shall be filled in compliance with CSA Z1220-17, First Aid Kits for the Workplace and shall contain the following items as a minimum:

- (a) 16 sterile adhesive dressings, assorted sizes (standard strip, large fingertip, knuckle, large patch);
- (b) 6 sterile gauze pads (7.6 x 7.6 cm, individually wrapped);
- (c) a roll of conforming stretch bandage (5.1 cm x 1.8 m, relaxed length, individually wrapped);
- (d) 2 sterile compress/pressure dressing with ties (10.2 x 10.2 cm);

- (e) a cotton triangular bandage (101.6 x 101.6 x 142.2 cm) with 2 safety pins;
- (f) a roll of adhesive tape (2.5 cm x 2.3 m);
- (g) 6 antiseptic wound cleansing towelettes (individually wrapped);
- (h) 2 topical antibiotic ointments (single use);
- (i) 4 hand/skin cleansing towelettes (individually wrapped) or equivalent;
- (j) 2 pairs of disposable examination gloves (medical grade, one-size, powder-free, non-latex):
- (k) a biohazard waste disposal bag (single use);
- (I) a pair of splinter forceps/tweezers (min. 11.4 cm, fine point, stainless steel);
- (m) a list of contents.

QUESTIONS AND ANSWERS

Q1: Do we need to bid on all the items within a section?

A1: Yes, Bidders are required bid on all the items within a section in order to be considered for that section. However, you are not required to bid on both sections as per B16.5.1.

Q2: When do we need to submit a request for approval of substitutes in accordance with B6?

A2: Some of the items are brand specific which would require a written request if you are to bid with a different brand. The items that do not have a specific brand in the item description are open for all brands. See B6.3 for timelines.

Q3: Which series of Hyflex gloves are you looking for in items 117-119?

A3: Hyflex 11-801 series.
