## PART D - SUPPLEMENTAL CONDITIONS

Revise: D14.1 to read: The Contractor shall achieve Substantial Performance by August 11, 2023.

Revise: D15.1 to read: The Contractor shall achieve Total Performance by September 1, 2023.

Add: D25. WORK BY OTHERS

- D25.1 Further to C6.25, the Contractor's attention is directed to the fact that other Contractors, the personnel of Utilities and the staff of the City may be working within the project limit, approach roadway, adjacent roadways or right-ofway. The activities of these agencies may coincide with the Contractors execution of work and it will be the Contractor's responsibility to cooperate to the fullest extent with other personnel working in the area, and such cooperation is an obligation of the Contractor under the terms of Contract.
- D25.2 Work by others on or near the Site will include but not necessarily be limited to:
- (a) Mould Remediation at 1377 Clarence Avenue – Century Arena;
- Ice plant controls upgrades at 1377 Clarence Avenue (Century Arena), 709 Keewatin Street (Billy Mosienko (b) Arena) and 901 Kimberly Avenue (Terry Sawchuk Arena).
- Further to D25.1 the Contractor shall cooperate and coordinate all activities with all parties performing required Work by Others. The Contractor must include and accommodate Work by Others identified in D25.2 or additional parties, in their construction schedule and accommodate the necessary area on Site required for the Work by Others to complete the Work.

#### **QUESTIONS AND ANSWERS**

- Q1: Who shall be responsible for the removal and disposal of the existing steel platforms/catwalks at the locations of Century Arena and Terry Sawchuk Arena old scoreboards?
  - A1: The City of Winnipeg will be responsible for this scope of work.
- Who shall be responsible for the removal and disposal of the existing plexiglass cover complete with steel Q2: framing at location of Terry Sawchuk Arena old scoreboard?
