Revise:	B10.1 to read:	Proposals should include: (a) details demonstrating the history and experience of the Proponent and Subconsultants in providing design, management of the project, and contract administration services on two (2) projects of similar complexity, scope, and value for the Proponent and two (2) projects of similar complexity, scope, and value for each Subconsultant.

PART D – SUPPLEMENTAL CONDITIONS

Revise: D11.4(a)(i)(ii) to read: Notwithstanding C1.1(b), the Proponents fees associated with D11.4(a)(i), and the fees to pay for geotechnical drilling, geotechnical sampling, geotechnical instrumentation, geotechnical materials testing, geotechnical monitoring, and geotechnical analysis and reporting as authorized by the Consulting Contract Administrator, will be reimbursed as an Allowable Disbursement under the Geotechnical and Regulatory Permits Allowance outlined in D18.

will be evaluated per Proponent and Subconsultant.

- The Consultant shall ensure that the selected third-party services are provided at competitive market rates.
- Costs shall be substantiated by the provision of suitable documentation.

Revise: D12.2(a)(i) to read: 20 meters of riprap will be used to stabilize and protect the riverbank from erosion and scour. The Underdrain Outfall will be replaced from the new manhole identified in D12.2(a)(ii) to the outfall termination point.

Revise:	D12.6(i) to read:	Notwithstanding C1.1(b), all of the Proponents fees and regulatory permit fees related to D12.6(a) to D12.6(h), as authorized by the Consulting Contract Administrator, will be reimbursed as an Allowable Disbursement under the Geotechnical and Regulatory Permits Allowance outlined in D18.
		(i) Costs shall be substantiated by the provision of suitable documentation.
Revise:	D18.1 to read:	The Geotechnical and Regulatory Permits Allowance in the amount of seventy-five thousand dollars (\$75,000) is to be used for the Proponents fees associated with D11.4(a)(i), and for the fees to pay for geotechnical drilling, geotechnical sampling, geotechnical instrumentation, geotechnical materials testing, geotechnical monitoring, and geotechnical analysis and reporting. This allowance also includes all of the Proponents fees and regulatory permit fees related to D12.6(a) to D12.6(h).
