- Q1: Regarding installing rigid insulation for the upper pump chamber. Is there a required PSI rating for this?
 - A1: Type II insulation is required.
- Q2: Can you provide Assiniboine Winter and Summer Water levels at the existing outfall?
 - A2: Additional information will be provided to the successful proponent.
- Q3: With the proposed work adjacent to the Railway, do you know who owns this railway? Are there any railway restrictions?
 - A3: The railway is owned by CP. No work is to be carried out within the CP Right-of-Way.
- Q4: With the proposed work adjacent to the overhead existing Hydro Poles, what are the restrictions and can the overhead lines be de-energized to facilitate safe work?
 - A4: Contractor to implement required safety measures for working near overhead power lines. Contractor to coordinate required de-energization/hot covers as necessary with MB Hydro.
- Q5: Drawing C0001-001-00 shows existing manholes, down stream of the gate chamber and upstream of the gate chamber. Can you provide any as-builts or information for this?
 - A5: Sewer network drawings can be provided to the successful proponent.
- Q6: Do you have any existing slide gate information? (i.e. Weights, Type, Supplier).

Q7: Do you have any existing flap gate information? (i.e. Weights).

- Q8: Is Builders Risk required for this tender?

 - A9: Form B: Item 21 refers to additional site inspections by the equipment manufacturer representative beyond the required installation and field testing site inspections.
