Add B13.8 as follows:

B13.8 Further to B13.1(e), Bidders providing products that meet the CSA Certification as indicated in the specifications for Background Material will receive full points.

Revise D3.1 to read:

D3.1 Notwithstanding GC.8.01, the Contractor shall perform the Work of this Contract during the period of March 31, 2004 to April 1, 2005.
