PART D - SUPPLEMENTAL CONDITIONS

Revise: D14.1 to read as:

D14.1 The VicWest Tradition "150" metal roof finish 25 year Manufacturer's Warranty shall be provided for this project.

Revise: D14.2 to read as:

D14.2 Air/vapour barrier 5 year manufacturer's warranty shall be provided.

Revise: Drawing S-2 as follows:

Plan A/2 – Roof Plan:

- Note that the existing roof access hatch located at the north end of the new roof area on the west side of the ridge adjacent to the roof top mechanical unit was not shown on the roof plan. The following work related to the access hatch is to be included:
 - Remove and re-install the existing roof access hatch.
 - Supply and install a new custom 1/8" bent plate extension curb as required to suit the new roof envelope installation.
 - Provide new flashings and waterproofing details to suit new roofing installation.
 - Refer to the attached Drawing RS-1.
- 2. Refer to attached Drawing RS-2 for new fascia detail at the east side of the new roof area.

Detail 3/2 – Ridge Detail:

Refer to note: "New Insulated Metal Roof Construction":
Delete reference to "Sprayed On" air/vapour barrier.

Air/vapour barrier shall be elastomeric bituminous sheet, shelf adhesive.
