PART E - SPECIFICATIONS

GENERAL

E1. GENERAL

E1.1 These Specifications shall apply to the Work.

E1.2 The following Drawings are applicable to the Work:

E2. GOODS

E2.1 The Contractor shall supply and deliver internally illuminated pedestrian corridor units in accordance with the requirements hereinafter specified.

E2.2 The internally illuminated pedestrian corridor sign units shall be manufactured in detailed as described in Public Works Department Transportation Division Drawing Number St-145 1 of 3, 2 of 3, and 3 of 3.

E2.3 Each unit shall have the manufacturers (**Name, Date of Manufacture and Tested By**) label placed on the inside of each unit.

E2.4 One (1) sample unit must be shipped for inspection and approval before shipping of any additional units.

E2.5 Any material or components not herein specifically mentioned or included, but may be required and complete, and place the equipment in successful operation, shall be furnished by the Contractor as though specifically mentioned in this Bid Opportunity document. The Contractor shall supply the equipment and all components and all features which are normally considered to be standard on that equipment, unless specifically excluded.

E2.6 Lenses as described in Note 9 on drawing ST-145 pg 2 of 3 will **NOT** be provided with the units.

E2.7 Lamps as described on drawing ST-145 pg 2 of 3 will **NOT** be provided with the units.

E2.8 All heads will be assembled, excluding lenses and, all units must be wired and ready for use.

E2.9 Each assembled unit will be packaged separately, in a manner suitable to protect the unit from damage during shipping.

E2.10 The Contractor shall ensure that the components of the equipment supplied will operate as specified.

E2.11 The Contractor shall meet and adhere to the welding specification CSA Standard W47.2-M1987 as indicated on drawing ST-145 Drawing 2 of 3 listed as Note #17.

E3. DELIVERY

E3.1 Goods shall be delivered on an "as required" basis during the term of the Contract, f.o.b. destination, freight prepaid, to
