## **PART E - SPECIFICATIONS**

### **GENERAL**

#### **E1. GENERAL**

E1.1 These Specifications shall apply to the Work.

E1.2 The following Drawings are applicable to the Work:

1A (Floor Plan)	280 William Avenue (Basement Storage)

#### **E2. GOODS**

E2.1 The Contractor shall supply and install wire mesh partitions and enclosures in accordance with the requirements and floor plan hereinafter specified.

- (a) panels 4' (ft) x 8' (ft) cut to fit the ceiling (about 90" inches);
- (b) wall posts 90" (in);
- (c) T-pots 90" (in);
- (d) swinging doors c/w a set of padlocking hasps
- (e) top rail length 8' (ft)
- (f) material shall be wire mesh from 6 gauge to 10 gauge, the size of mesh can vary from 1 ½" (in) x 3" (in) to 2" (in) x 2" (in).welded for extra strength and rigidity;
- (g) all necessary miscellaneous hardware and floor anchors shall be provided by the Contractor; and
- (h) the finish shall be a power coat with the colour specified at the time of ordering.

#### **E3. DELIVERY AND INSTALLATION**

E3.1 Goods shall be delivered f.o.b. destination, freight prepaid, to 280 William Avenue, Winnipeg, MB.

E3.1.1 Goods shall be delivered within thirty (30) Business Days of the placing of an order, except where otherwise agreed at the time of ordering.

E3.1.2 Goods shall be installed within five (5) Business Days after receipt of material as specified in clause E3.1.1.

E3.2 Goods shall be delivered between 8:30 a.m. and 4:30 p.m. on Business Days.

E3.3 The Contractor shall off-load goods as directed at the delivery location.

E3.4 The Contractor shall confirm delivery with the User at least two (2) Business Days before delivery.

#### **E4. EMPLOYEE BEHAVIOUR AND SUPERVISION**

- E4.1 The Contractor shall provide adequate supervision of its employees and shall ensure that all such employees behave at all times in a manner appropriate to persons in a City facility and shall without limitation ensure that employees:
- (a) behave in a courteous and polite manner to City staff and other persons in the facility;
  - (b) do not smoke within the facility; and
  - (c) obey all posted safety rules.

#### **E5. PERFORMANCE RELIABILITY**

- E5.1 The responsibility for the design of the complete unit, its performance and reliability shall rest upon the Contractor.
- E5.2 The term "*repeat failures*" as used herein is defined to mean that the same component, subassembly, or assembly develops repeated defects, breakdowns and/or malfunctions rendering the unit inoperative, or required repeated shop correction, service and/or replacement during the warranty period applicable for said component, subassembly, or assembly. Minor items or ordinary service adjustments are not included, or considered under the scope of "repeated failures", as well as other factors, such as operational damage due to accidents, misuse or lack of proper maintenance, service and lubrication attention by not following the manufacturer's preventative maintenance schedules.
- E5.3 Where the unit develops "repeated failures" in service, the Contractor shall make any necessary engineering changes, repairs, alterations or modifications in order to guarantee reliability of performance.
