GENERAL

E1. GOODS

- E1.1 The Contractor shall supply chairs in accordance with the requirements hereinafter specified.
- E1.2 Item No. 1 Hon Alaris Chairs #4221 DIM (or approved equal)
- E1.2.1 Goods shall be:
 - (a) 26 5/8 D x 25 ³/₄" W x 41 ¹/₄"H;
 - (b) pneumatic;
 - (c) swivel;
 - (d) passive hip pivot motion;
 - (e) tilt lock;
 - (f) fixed arms c/w urethane cap arm-pads;
 - (g) culp contract fabrics upholstery, BK classic #85 Blue
- E1.3 Item No. 2 Allseating Therapod Chairs #TP-B-HB-DT-AT (or approved equal)

E1.3.1 Dimensions shall be:

- (a) inside seat: 21"W x 19"D;
- (b) overall seat dimensions 25"W x 21"D;
- (c) seat height 17" 22";
- (d) min/max height 46" 55.5";
- (e) back height; 28.5 33.5;

E1.3.2 Construction shall be:

- (a) seat Plan of ³/₄" Laminated Plywood pressed together;
- (b) seat Foam of 2.4 lb with an outer lining to give shape;
- (c) back of polyproplylene molded inner shell c/w a steel rib support structure which allows firm support and dynamic flexibility;
- (d) back foam 1.5" density polyurethane.
- E1.3.3 Back features shall be:
 - (a) height adjustable c/w four adjustable straps for ultimate back adjustability;
 - (b) each strap is individually adjustable for upper back thoracic support, mid back, lumbar, and sacrum;
- E1.3.4 Arms shall be:
 - (a) height adjustable with dial c/w polyurethane arm-caps. 5 caster base.
- E1.3.5 Mechanism;
- E1.3.6 "separate" paddles/controls for forward knee-tilt; any position tilt-lock, gas-lift, back-angle adjustment, height-adjustable back, tension-control.
