## **PART E - SPECIFICATIONS**

# **GENERAL**

### E1. GENERAL

E1.1 These Specifications shall apply to the Work.

### E2. GOODS

- E2.1 The Contractor shall supply and deliver Dog Food in accordance with the requirements hereinafter specified.
- E2.2 God Food conforming to the requirements of the Nutrition Assurance Program of PFAC and bearing the NAP statement and logo on external packaging and/or the nutritional requirements for pet foods as determined by AAFCO, is preferred.
- E2.3 Labelling on external packaging of Dog Food shall list the contents by ingredients and nutritional values in accordance with Government of Canada, Labelling guidelines.
- E2.4 Item No. 1 shall be Dog Food, Dry (adult) as follows:
  - (a) Main ingredient shall be meat or meal based protein;
  - (b) Crude protein (Min) 26%;
  - (c) Crude fat (Min) 14%;
  - (d) Crude fibre (Max) 3%;
  - (e) Moisture (Max) 12%;
  - (f) 80 90% digestible;
  - (g) No soy;
  - (h) No ethoxyquin;
  - (i) In approximately 18 22.6 kg. Bags.
- E2.5 Item No. 2 shall be Dry Dog Food (puppy) as follows:
  - (a) Main ingredient shall be a tri-protein meat base or meal base;
  - (b) Crude Protein (Min) 28%;
  - (c) Crude Fat (Min) 16%;
  - (d) Crude Fibre (Max) 3%;
  - (e) Moisture (Max) 12%;
  - (f) 85 90% digestible;
  - (g) No soy;
  - (h) No ethoxyquin;
  - (i) In approximately 18 22.6 kg. bags.
- E2.6 Item No. 3 shall be Lamb and Rice, Dry Food as follows:
  - (a) Main ingredient shall be lamb and rice;
  - (b) Crude protein (Min) 22%;
  - (c) Crude fat (Min) 14%;

- (d) Crude Fibre (Max) 3%;
- (e) Moisture (Max) 12%;
- (f) No soy;
- (g) No ethoxyquin;
- (h) In approximately 18 22.6 kg. bags.
- E2.7 Item No. 4 shall be Dog Biscuits as follows:
  - (a) 18 23% protein;
  - (b) 5 8% fat;
  - (c) 3-5% crude fibre;
  - (d) 10 12% moisture content;
  - (e) To be available in multiple sizes;
  - (f) In approximately 10 kg. package.

# E3. DELIVERY

- E3.1 Goods shall be delivered on an "as required" basis during the term of the Contract, f.o.b. destination, freight prepaid, to the City of Winnipeg, Community Services Department, Animal Services Agency, 1057 Logan Avenue, Winnipeg R3E 3N8.
- E3.1.1 Goods shall be delivered within one (1) Business Day of the placing of an order, except where otherwise agreed at the time of ordering.
- E3.2 Goods shall be delivered between 8:30 a.m. and 4:30 p.m. on Business Days.
- E3.3 The Contractor shall off-load goods as directed at the delivery location.
