Failure to acknowledge receipt of this Addendum in Paragraph 10 of Form A: Bid may render your Bid Submission non-responsive.

### PART B – BIDDING PROCEDURES

Revise: B14.4 to read:

- B14.4 Further to B14.1(c), the Total Bid Price shall be the sum of the quantities multiplied by the unit prices for each item shown on Form B: Prices adjusted, if necessary, as follows:
  - a) if the lowest evaluated responsive Bid submitted by a responsible and qualified Bidder is within the budgetary provision for the Work, no adjustment will be made to the Total Bid Price; or
  - b) if the lowest evaluated responsive Bid submitted by a responsible and qualified Bidder exceeds the budgetary provision for the Work, the Total Bid prices of all responsive Bids submitted by responsible and qualified Bidders will be adjusted by progressively deducting the sum of the quantities multiplied by the unit prices shown on Form B: Prices for the following items in the order listed until a Total Bid Price within the budgetary provision is achieved.
    - a. item No. 26: Entry Gate feature/supply/install/complete with all structural piles (deduct two (2))
    - b. item No.17: Benches: Supply only Type "A" Petoskey (deduct one (1))
    - c. item No.19: Benches: Supply only Type "B" (deduct two (2))
    - d. item No.28: Dry Laid Limestone Planter 9 (deduct thirty six (36))

B14.4.1 If there is any discrepancy between the Total Bid Price written in figures, the Total Bid Price written in words and the sum of the quantities multiplied by the unit prices for each item, the sum of the quantities multiplied by the unit prices for each item shall take precedence.
