### **PART A – BID SUBMISSION**

Replace: 146-2006 Bid Submission with 146-2006 Addendum 2 - Bid Submission. The following is a summary of changes incorporated in the replacement Bid Submission:

Form B(R1): revised.

### **PART B – BIDDING PROCEDURES**

Revise: B2.1 to read: The Submission Deadline is 4:00 p.m. Winnipeg time, June 12, 2007.

Revise: B10.1 to read: The Bidder should state a price in Canadian funds for each item of the Work identified on Form B: Prices.

Delete: B10.2

Revise: B10.3 to read: The Bidder may state a separate price in Canadian funds for the following item of Work on Form B: Prices:

- (a) Separate Price - Item No. 1 shall be the amount to be deducted from Item No. 2 if framed black secondary welded wire mesh fence is substituted for framed black fence with modular sections of black vinyl-coated chainlink fence material in accordance with E2.2 of the Specifications;

Add: B10.4 The quantities listed on Form B: Prices are to be considered approximate only. The City will use said quantities for the purpose of comparing Proposals.

Add: B10.5 The quantities for which payment will be made to the Contractor are to be determined by the Work actually performed and completed by the Contractor, to be measured as specified in the applicable Specifications.

Revise B17.4 to read: Further to B17.1(c), the Evaluated Bid Price shall be the Unit Price multiplied by the Approximate Quantity shown on Form B: Prices. Item No. 2 may be adjusted, if necessary, as follows:

- (a) if the lowest evaluated responsive Bid submitted by a responsible and qualified Bidder is within the budgetary provision for the Work, no adjustment will be made to the Unit Price bid; or
- (b) if the lowest evaluated responsive Bid submitted by a responsible and qualified Bidder exceeds the budgetary provision for the Work, the unit prices, for Item 2., of all responsive Bids submitted by

responsible and qualified Bidders will be adjusted by deducting the separate price listed in B10.3 until a Total Bid Price within the budgetary provision is achieved, i.e., Amount for Item No. 2 = Unit Price No.2 – Alternate Prices No.1.

- Add B17.5 This Contract may be awarded as a whole or separately by item as identified on Form B: Prices.
- Add B17.5.1 Notwithstanding B10.1, the Bidder may, but is not required to, bid on both items, or on the separate price to be deducted.
- Add B17.5.2 Notwithstanding B18.3, the City shall not be obligated to award any item to the responsible Bidder submitting the lowest evaluated responsive Bid for that item and shall have the right to choose the alternative which is in its best interests. If the Bidder has not bid on both items, he shall have no claim against the City if his partial Bid is rejected in favour of an award of the Contract on the basis of an alternative or item upon which he has not bid.

## **PART D – SUPPLEMENTAL CONDITIONS**

- Revise D2.2 to read:
- a) Supply and install ornamental decorative steel fence approximately 950 lineal feet in length, with an overall height of 8 feet, in 8 foot modular sections.
  - b) Supply and install framed black secondary fence
    - (i) Ideal: Welded wire mesh fence approximately 1450 lineal feet in length, with an overall height of 8 feet, in 8 foot modular sections, or
    - (ii) Alternate 1: Black chainlink fence approximately 1450 lineal feet in length, with an overall height of 8 feet, in 8 foot modular sections.

## **PART E – SPECIFICATIONS**

- Revise: E2.2 to read: The Contractor shall manufacture and install:
- a) Ornamental decorative steel fence approximately 950 lineal feet in length, with an overall height of 8 feet, in 8 foot modular sections.
  - b) Steel framed black secondary fence with welded wire mesh fence approximately 1450 lineal feet in length, with an overall height of 8 feet, in 8 foot modular sections
    - i) Alternate 1: Steel framed black secondary fence with black chainlink fence approximately 1450 lineal feet in length, with an overall height of 8 feet, in 8 foot modular sections
