#### **PART B - BIDDING PROCEDURES**

#### **B1.** PROJECT TITLE

# SUPPLY AND INSTALLATION OF CUSTOM MADE STEEL FENCING FOR ASSINIBOINE PARK

#### **B2. SUBMISSION DEADLINE**

- B2.1 The Submission Deadline is 4:00 p.m. Winnipeg time, June 1, 2007.
- B2.2 Proposal Submissions determined by the Manager of Materials to have been received later than the Submission Deadline will not be accepted and will be returned upon request.
- B2.3 The Contract Administrator or the Manager of Materials may extend the Submission Deadline by issuing an addendum at any time prior to the time and date specified in B2.1.

#### **B3.** SITE INVESTIGATION

- B3.1 Further to GC.2.01, the Bidder may view the Site without making an appointment
- B3.2 The Bidder is advised that an intended layout of the fence has been marked on site. The Bidder should view the site to identify the terrain, tree cover, staging opportunities, access and tree protection requirements.

#### **B4. ENQUIRIES**

- B4.1 All enquiries shall be directed to the Contract Administrator identified in D3.1.
- B4.2 If the Bidder finds errors, discrepancies or omissions in the Request for Proposal, or is unsure of the meaning or intent of any provision therein, the Bidder shall notify the Contract Administrator of the error, discrepancy or omission, or request a clarification as to the meaning or intent of the provision at least five (5) Business Days prior to the Submission Deadline.
- B4.3 Responses to enquiries which, in the sole judgment of the Contract Administrator, require a correction to or a clarification of the Request for Proposal will be provided by the Contract Administrator to all Bidders by issuing an addendum.
- B4.4 Responses to enquiries which, in the sole judgment of the Contract Administrator, do not require a correction to or a clarification of the Request for Proposal will be provided by the Contract Administrator only to the Bidder who made the enquiry.
- B4.5 The Bidder shall not be entitled to rely on any response or interpretation received pursuant to B3 unless that response or interpretation is provided by the Contract Administrator in writing.

#### **B5.** CONFIDENTIALITY

- B5.1 Information provided to a Bidder by the City or acquired by a Bidder by way of further enquiries or through investigation is confidential. Such information shall not be used or disclosed in any way without the prior written authorization of the Contract Administrator.
- B5.2 The Bidder shall not make any statement of fact or opinion regarding any aspect of the Request for Proposals to the media or any member of the public without the prior written authorization of the Contract Administrator.

#### B6. ADDENDA

- B6.1 The Contract Administrator may, at any time prior to the Submission deadline, issue addenda correcting errors, discrepancies or omissions in the Request for Proposal, or clarifying the meaning or intent of any provision therein.
- B6.2 The Contract Administrator will issue each addendum at least two (2) Business Days prior to the Submission Deadline, or provide at least two (2) Business Days by extending the Submission Deadline.
- B6.2.1 Addenda will be available on the Bid Opportunities page at The City of Winnipeg, Corporate Finance, Materials Management Branch internet site at http://www.winnipeg.ca/matmgt.
- B6.2.2 The Bidder is responsible for ensuring that he has received all addenda and is advised to check the Materials Management Branch internet site for addenda shortly before submitting his Proposal.
- B6.3 The Bidder shall acknowledge receipt of each addendum in Paragraph 8 of Form A: Proposal. Failure to acknowledge receipt of an addendum may render a Proposal non-responsive.

#### **B7.** SUBSTITUTES

- B7.1 The Work is based on the materials, equipment, methods and products specified in the Request for Proposal.
- B7.2 Substitutions shall not be allowed unless application has been made to and prior approval has been granted by the Contract Administrator in writing.
- B7.3 Requests for approval of a substitute will not be considered unless received in writing by the Contract Administrator at least seven (7) Business Days prior to the Submission Deadline.
- B7.4 The Bidder shall ensure that any and all requests for approval of a substitute:
  - (a) provide sufficient information and details to enable the Contract Administrator to determine the acceptability of the material, equipment, method or product as either an approved equal or alternative;
  - (b) identify any and all changes required in the applicable Work, and all changes to any other Work, which would become necessary to accommodate the substitute;
  - (c) identify any anticipated cost or time savings that may be associated with the substitute:
  - (d) certify that, in the case of a request for approval as an approved equal, the substitute will fully perform the functions called for by the general design, be of equal or superior substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the Contract;
  - (e) certify that, in the case of a request for approval as an approved alternative, the substitute will adequately perform the functions called for by the general design, be similar in substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the Contract.
- B7.5 The Contract Administrator, after assessing the request for approval of a substitute, may in his sole discretion grant approval for the use of a substitute as an "approved equal" or as an "approved alternative", or may refuse to grant approval of the substitute.

- B7.6 The Contract Administrator will provide a response in writing, at least two (2) Business Days prior to the Submission Deadline, only to the Bidder who requested approval of the substitute.
- B7.6.1 The Bidder requesting and obtaining the approval of a substitute shall be entirely responsible for disseminating information regarding the approval to any person or persons he wishes to inform.
- B7.7 If the Contract Administrator approves a substitute as an "approved equal", any Bidder may use the approved equal in place of the specified item.
- B7.8 If the Contract Administrator approves a substitute as an "approved alternative", any Bidder bidding that approved alternative shall base his Total Bid Price upon the specified item but may also indicate an alternative price based upon the approved alternative. Such alternatives will be evaluated in accordance with B15.
- B7.9 No later claim by the Contractor for an addition to the price(s) because of any other changes in the Work necessitated by the use of an approved equal or an approved alternative will be considered.

#### **B8. PROPOSAL SUBMISSION**

- B8.1 The Proposal Submission consists of the following components:
  - (a) Form A: Proposal;
  - (b) Form B: Prices;
- B8.2 All components of the Proposal Submission shall be fully completed or provided, and submitted by the Bidder no later than the Submission Deadline, with all required entries made clearly and completely in ink, to constitute a responsive Proposal.
- B8.3 The Proposal Submission shall be submitted enclosed and sealed in an envelope clearly marked with the RFP number and the Bidder's name and address.
- B8.3.1 Samples or other components of the Proposal Submission which cannot reasonably be enclosed in the envelope may be packaged separately, but shall be clearly marked with the RFP number, the Bidder's name and address, and an indication that the contents are part of the Bidder's Proposal Submission.
- B8.4 Proposal Submissions submitted by facsimile transmission (fax) or internet electronic mail (e-mail) will not be accepted.
- B8.5 Proposal Submissions shall be submitted to:

#### B9. PROPOSAL

- B9.1 The Bidder shall complete Form A: Proposal, making all required entries.
- B9.2 Paragraph 2 of Form A: Proposal shall be completed in accordance with the following requirements:
  - (a) if the Bidder is a sole proprietor carrying on business in his own name, his name shall be inserted;

- (b) if the Bidder is a partnership, the full name of the partnership shall be inserted;
- (c) if the Bidder is a corporation, the full name of the corporation shall be inserted;
- (d) if the Bidder is carrying on business under a name other than his own, the business name and the name of every partner or corporation who is the owner of such business name shall be inserted.
- B9.2.1 If a Proposal is submitted jointly by two or more persons, each and all such persons shall identify themselves in accordance with B9.2.
- B9.3 In Paragraph 3 of Form A: Proposal, the Bidder shall identify a contact person who is authorized to represent the Bidder for purposes of the Proposal.
- B9.4 Paragraph 0 of Form A: Proposal shall be signed in accordance with the following requirements:
  - (a) if the Bidder is a sole proprietor carrying on business in his own name, it shall be signed by the Bidder:
  - (b) if the Bidder is a partnership, it shall be signed by the partner or partners who have authority to sign for the partnership;
  - (c) if the Bidder is a corporation, it shall be signed by its duly authorized officer or officers and the corporate seal, if the corporation has one, should be affixed;
  - (d) if the Bidder is carrying on business under a name other than his own, it shall be signed by the registered owner of the business name, or by the registered owner's authorized officials if the owner is a partnership or a corporation.
- B9.4.1 The name and official capacity of all individuals signing Form A: Proposal shall be printed below such signatures.
- B9.4.2 All signatures shall be original and shall be witnessed except where a corporate seal has been affixed.
- B9.5 If a Proposal is submitted jointly by two or more persons, the word "Bidder" shall mean each and all such persons, and the undertakings, covenants and obligations of such joint Bidders in the Proposal Submission and the Contract, when awarded, shall be both joint and several.

#### B10. PRICES

- B10.1 The Bidder shall state the lump sum price in Canadian funds for the Work on Form B: Prices.
- B10.2 The Bidder shall state a separate price in Canadian funds for each of the following items of Work on Form B: Prices:
  - (a) Separate Price Item No. 1 shall be the amount to be deducted from the lump sum price if any 8 foot section of ornamental steel fencing is reduced;
  - (b) Separate Price Item No. 2 shall be the amount to be deducted from the lump sum price if any 8 foot section of the secondary fencing is deleted.
  - (c) Separate Price Item No. 3 shall be the amount to be deducted from the lump sum price if one (1) vehicular gate is deleted.
  - (d) Separate Price Item No. 4 shall be the amount to be deducted from the lump sum price if one man gate is deleted.
  - (e) Separate Price Item No. 5 shall be the amount to be deducted from the lump sum price if one (1) decorative double pedestrian gate is deleted.
- B10.3 The Bidder shall state a separate price in Canadian funds for each of the following Alternate items of Work on Form B: Prices:

- (a) Separate Price Item No. 1 shall be the amount to be deducted from the lump sum price if the secondary fencing is changed to steel framed, 1 ½ X 1 ½ inch vinyl coated black chain link fence in accordance with E3.2(d) of the Specifications;
- B10.3.1 Prices on Form B: Prices shall include:
  - (a) duty;
  - (b) freight and cartage;
  - (c) Provincial and Federal taxes [except the Goods and Services Tax (GST) and Manitoba Retail Sales Tax (MRST, also known as PST), which shall be extra where applicable] and all charges governmental or otherwise paid;
  - (d) profit and all compensation which shall be due to the Contractor for the Work and all risks and contingencies connected therewith.

#### **B11. QUALIFICATION**

#### B11.1 The Bidder shall:

- (a) undertake to be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba, or if the Bidder does not carry on business in Manitoba, in the jurisdiction where the Bidder does carry on business:
- (b) be responsible and not be suspended, debarred or in default of any obligation to the City;
- (c) be financially capable of carrying out the terms of the Contract;
- (d) have all the necessary experience, capital, organization, and equipment to perform the Work in strict accordance with the terms and provisions of the Contract:
- (e) have successfully carried out Work, similar in nature, scope and value to the Work;
- (f) employ only SubContractor s who:
  - (i) are responsible and not suspended, debarred or in default of any obligation to the City (a list of suspended or debarred individuals and companies is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Branch internet site at http://www.winnipeg.ca/matmgt); and
  - (ii) have successfully carried out Work similar in nature, scope and value to the portion of the Work proposed to be subcontracted to them, and are fully capable of performing the Work required to be done in accordance with the terms of the Contract;
- (g) have a written Workplace safety and health program in accordance with The Workplace Safety and Health Act (Manitoba);
- B11.2 The Bidder shall be prepared to submit, within three (3) Business Days of a request by the Contract Administrator, proof satisfactory to the Contract Administrator of the qualifications of the Bidder and of any proposed SubContractor.
- B11.3 The Bidder shall provide, on the request of the Contract Administrator, full access to any of the Bidder's equipment and facilities to confirm, to the Contract Administrator's satisfaction, that the Bidder's equipment and facilities are adequate to perform the Work.

#### B12. OPENING OF PROPOSALS AND RELEASE OF INFORMATION

B12.1 Proposal Submissions will not be opened publicly.

- B12.2 After award of Contract, the name(s) of the successful Bidder(s) and the Contract Amount(s) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Branch internet site at http://www.winnipeg.ca/matmgt.
- B12.3 To the extent permitted, the City shall treat all Proposal Submissions as confidential, however the Bidder is advised that any information contained in any Proposal Submission may be released if required by City policy or procedures, by The Freedom of Information and Protection of Privacy Act (Manitoba), by other authorities having jurisdiction, or by law.

#### **B13.** IRREVOCABLE OFFER

- B13.1 The Proposal(s) submitted by the Bidder shall be irrevocable for the time period specified in Paragraph 9 of Form A: Proposal.
- B13.2 The acceptance by the City of any Proposal shall not release the Proposals of the other responsive Bidders and these Bidders shall be bound by their offers on such Work for the time period specified in Paragraph 9 of Form A: Proposal.

#### **B14. WITHDRAWAL OF OFFERS**

- B14.1 A Bidder may withdraw his Proposal without penalty by giving written notice to the Manager of Materials at any time prior to the Submission Deadline.
- B14.1.1 Notwithstanding GC.7.05(2), the time and date of receipt of any notice withdrawing a Proposal shall be the time and date of receipt as determined by the Manager of Materials.
- B14.1.2 The City will assume that any one of the contact persons named in Paragraph 3 of Form A: Proposal or the Bidder's authorized representatives named in Paragraph 0 of Form A: Proposal, and only such person, has authority to give notice of withdrawal.
- B14.1.3 If a Bidder gives notice of withdrawal prior to the Submission Deadline, the Manager of Materials shall:
  - (a) retain the Proposal Submission until after the Submission Deadline has elapsed;
  - (b) open the Proposal Submission to identify the contact person named in Paragraph 3 of Form A: Proposal and the Bidder's authorized representatives named in Paragraph 0 of Form A: Proposal; and
  - (c) if the notice has been given by any one of the persons specified in B14.1.3(b), declare the Proposal withdrawn.
- B14.2 A Bidder who withdraws his Proposal after the Submission Deadline but before his offer has been released or has lapsed as provided for in B13.2 shall be liable for such damages as are imposed upon the Bidder by law and subject to such sanctions as the Chief Administrative Officer considers appropriate in the circumstances. The City, in such event, shall be entitled to all rights and remedies available to it at law, including the right to retain the Bidder's bid security.

#### **B15. INTERVIEWS**

B15.1 The Contract Administrator may, in his sole discretion, interview Bidders during the evaluation process.

#### **B16. NEGOTIATIONS**

B16.1 The City reserves the right to negotiate details of the Contract with Bidders.

- B16.2 Negotiations, if any, are intended to address administrative and technical details of the Contract. The Bidder is advised to present his best offer, not a starting position for negotiations, in his Proposal Submission; the City will not necessarily pursue negotiations with any Bidder.
- B16.3 If, in the course of negotiations pursuant to B16.2 or otherwise, the Bidder amends or modifies a Proposal after the Submission Deadline, the City may consider any amended Proposal as an alternative to the Proposal as originally submitted without releasing the Bidder from the Proposal as originally submitted.

#### **B17. EVALUATION OF PROPOSALS**

- B17.1 Award of the Contract shall be based on the following evaluation criteria:
  - (a) compliance by the Bidder with the requirements of the Request for Proposal:
    - (i) mandatory requirements (pass/fail);
    - (ii) desirable features (25%);
  - (b) qualifications of the Bidder and the SubContractor s, if any, pursuant to B11:
    - (i) mandatory qualifications (pass/fail);
    - (ii) desirable qualifications (25%);
  - (c) Evaluated Bid Price (50%);
  - (d) economic analysis of any approved alternative pursuant to B7.
- B17.2 Further to B17.1(a), the Award Authority may reject a Proposal as being non-responsive if the Proposal Submission is incomplete, obscure or conditional, or contains additions, deletions, alterations or other irregularities. The Award Authority may reject all or any part of any Proposal, or waive technical requirements if the interests of the City so require.
- B17.2.1 Further to B17.1(b), the Award Authority shall reject any Proposal submitted by a Bidder who does not demonstrate, in his Proposal Submission, in other information required to be submitted, during interviews or in the course of reference checks, that he is responsible and qualified.
- B17.4 Further to B17.1(c), the Total Bid Price shall be the lump sum price shown on Form B: Prices adjusted, if necessary, by deducting the separate prices.
- B17.4.1 If there is any discrepancy between the lump sum price written in figures and the lump sum price written in words, the price written in words shall take precedence.

#### **B18.** AWARD OF CONTRACT

- B18.1 The City will give notice of the award of the Contract or will give notice that no award will be made.
- B18.2 The City will have no obligation to award a Contract to a Bidder, even though one or all of the Bidders are determined to be responsible and qualified, and the Proposals are determined to be responsive.
- B18.2.1 Without limiting the generality of B18.2, the City will have no obligation to award a Contract where:
  - (a) the prices exceed the available City funds for the Work;
  - (b) the prices are materially in excess of the prices received for similar Work in the past;
  - (c) the prices are materially in excess of the City's cost to perform the Work, or a significant portion thereof, with its own forces;
  - (d) only one Proposal is received; or

(e) in the judgment of the Award Authority, the interests of the City would best be served by not awarding a Contract.

- B18.3 Where an award of Contract is made by the City, the award shall be made to the responsible and qualified Bidder submitting the most advantageous offer.
- B18.3.1 Following the award of contract, a Bidder will be provided with information related to the evaluation of his Proposal upon written request to the Contract Administrator.


#### **GENERAL**

#### D1. GENERAL CONDITIONS

- D1.1 In addition to the *General Conditions for the Supply and Delivery of Goods*, these Supplemental Conditions are applicable to the Work of the Contract.
- D1.2 The General Conditions are amended by striking out "The City of Winnipeg Act" wherever it appears in the General Conditions and substituting "The City of Winnipeg Charter".
- D1.3 The General Conditions are amended by striking out "Board of Commissioners" or "Commissioner" wherever it appears in the General Conditions and substituting the "Chief Administrative Officer".
- D1.4 The General Conditions are amended by striking out "Tender Package" wherever it appears in the General Conditions and substituting "Request for Proposal".
- D1.5 The General Conditions are amended by striking out "Tender Submission" wherever it appears in the General Conditions and substituting "Proposal Submission".
- D1.6 The General Conditions are amended by striking out "Bidding Instructions" wherever it appears in the General Conditions and substituting "Bidding Procedures".

#### D2. SCOPE OF WORK

- D2.1 The Work to be done under the Contract shall consist of the manufacturing, supply and installation of a custom designed steel fence.
- D2.2 The major components of the Work are as follows:
  - (a) Removal of existing fencing and scrub that has grown into the fence.
  - (b) Supply and install ornamental decorative steel fence approximately 1100 lineal feet in length, with an overall height of 8 feet, in 8 foot modular sections.
  - (c) Supply and install framed black secondary fence
    - (i) Ideal: Welded wire mesh fence approximately 1700 lineal feet in length, with an overall height of 8 feet, in 8 foot modular sections, or
    - (ii) Alternate 1: Black chainlink fence approximately 1700 lineal feet in length, with an overall height of 8 feet, in 8 foot modular sections
  - (d) Two (2) sliding vehicular gates in welded wire mesh material
  - (e) One (1) man gate in welded wire mesh material
  - (f) Two (2) ornamental decorative double pedestrian steel gates at the main entranceways to the gardens, located at the English Gardens and Leo Mol Sculpture Gardens
  - (g) One (1) ornamental decorative 6 foot section and 0ne (1) ornamental decorative 8 foot section of fence hinged to allow vehicular access.

The dark/red line shows the proposed location of the Ornamental steel fence. The blue line is where the secondary fencing is to be installed.

#### D5. CONFIDENTIALITY AND OWNERSHIP OF INFORMATION

- D5.1 Information provided to the Contractor by the City or acquired by the Contractor during the course of the Work is confidential. Such information shall not be used or disclosed in any way without the prior written authorization of the Contract Administrator.
- D5.2 The Contract, all deliverables produced or developed, and information provided to or acquired by the Contractor are the property of the City. The Contractor shall not disclose or appropriate to its own use, or to the use of any third party, all or any part thereof without the prior written consent of the Contract Administrator.
- D5.3 The Contractor shall not make any statement of fact or opinion regarding any aspect of the Contract to the media or any member of the public without the prior written authorization of the Contract Administrator.

#### **SUBMISSIONS**

#### D6. AUTHORITY TO CARRY ON BUSINESS

D6.1 The Contractor shall be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba, or if the Contractor does not carry on business in Manitoba, in the jurisdiction where the Contractor does carry on business, throughout the term of the Contract, and shall provide the Contract Administrator with evidence thereof upon request.

#### D7. WORKERS COMPENSATION

D7.1 The Contractor shall be registered with the Workers Compensation Board of Manitoba, shall provide and maintain Workers Compensation coverage throughout the term of the Contract, and shall provide the Contract Administrator with evidence thereof upon request.

#### D8. INSURANCE

- D8.1 The Contractor shall provide and maintain the following insurance coverage:
  - (a) commercial general liability insurance, in the amount of at least two million dollars (\$2,000,000.00) all inclusive, with The City of Winnipeg being added as an additional insured, with a cross-liability clause, such liability policy to also contain a contractual liability, an unlicensed motor vehicle liability and a products and completed operations endorsement to remain in place at all times during the performance of the Work and throughout the warranty period;
  - (b) automobile liability insurance for owned and non-owned automobiles used for or in connection with the Work in the amount of at least two million dollars (\$2,000,000.00) at all times during the performance of the Work and until the date of Total Performance.
- D8.2 Deductibles shall be borne by the Contractor .
- D8.3 The Contractor shall provide the Contract Administrator with a certificate of insurance of each policy at least two (2) Business Days prior to the commencement of any Work on the Site but in no event later than the date specified in GC.3.01 for the return of the executed Contract.
- D8.4 The Contractor shall not cancel, materially alter, or cause each policy to lapse without providing at least fifteen (15) Calendar Days prior written notice to the Contract Administrator.

#### D9. MATERIAL SAFETY DATA SHEETS

- D9.1 The Contractor shall provide the Contract Administrator with one (1) copy of Material Safety Data Sheets (MSDS's) for each product to be supplied under the Contract at least two (2) Business Days prior to the commencement of Work but in no event later than the date specified in GC.3.01 for the return of the executed Contract.
- D9.2 Throughout the term of the Contract, the Contractor shall provide the Contract Administrator with revisions or updates of the MSDS's as soon as may be reasonably possible.

#### D10. PERFORMANCE SECURITY

D10.1 The Contractor shall provide and maintain performance security until the expiration of the warranty period in the form of:

- (a) a performance bond of a company registered to conduct the business of a surety in Manitoba, in the form attached to these Supplemental Conditions (Form H1: Performance Bond), in the amount of fifty percent (50%) of the Contract Price; or
- (b) an irrevocable standby letter of credit issued by a bank or other financial institution registered to conduct business in Manitoba and drawn on a branch located in Winnipeg, in the form attached to these Supplemental Conditions (Form H2: Irrevocable Standby Letter of Credit), in the amount of fifty percent (50%) of the Contract Price; or
- (c) a certified cheque or draft payable to "The City of Winnipeg", drawn on a bank or other financial institution registered to conduct business in Manitoba, in the amount of fifty percent (50%) of the Contract Price.
- D10.1.1 Where the performance security is in the form of a certified cheque or draft, it will be deposited by the City. The City will not pay any interest on certified cheques or drafts furnished as performance security.
- D10.2 The Contractor shall provide the City Solicitor with the required performance security within seven (7) Calendar Days of notification of the award of the Contract by way of letter of intent and prior to the commencement of any Work on the Site but in no event later than the date specified in GC.3.01 for the return of the executed Contract.

#### D11. SUBCONTRACTOR LIST

D11.1 The Contractor shall provide the Contract Administrator with a complete list of the SubContractor s whom the Contractor proposes to engage (Form J: SubContractor List) at least two (2) Business Days prior to the commencement of any Work on the Site but in no event later than the date specified in GC.3.01 for the return of the executed Contract.

#### D12. DETAILED WORK SCHEDULE

- D12.1 The Contractor shall provide the Contract Administrator with a detailed Work schedule (Form L: Detailed Work Schedule) at least two (2) Business Days prior to the commencement of any Work on the Site but in no event later than the date specified in GC.3.01 for the return of the executed Contract.
- D12.2 Upon award of the Contract, the Contractor shall be bound to this Work Schedule.

#### **SCHEDULE OF WORK**

#### D13. COMMENCEMENT

- D13.1 The Contractor shall not commence any Work until he is in receipt of a letter of intent from the Award Authority authorizing the commencement of the Work.
- D13.2 The Contractor shall not commence any Work on the Site until:
  - (a) the Contract Administrator has confirmed receipt and approval of:
    - evidence that the Contractor is in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba;
    - (ii) evidence of the Workers compensation coverage specified in D7;
    - (iii) evidence of the insurance specified in D8;
    - (iv) the Material Safety Data Sheets specified in D9;
    - (v) the performance security specified in D10;

- (vi) the Sub-Contractor s List specified in D11;
- (vii) the Detailed Work Schedule specified in D12;
- (b) the Contractor has attended a meeting with the Contract Administrator, or the Contract Administrator has waived the requirement for a meeting.
- D13.3 The Contractor shall commence the Work on the Site within seven (7) Calendar Days of receipt of the letter of intent.

#### D14. SUBSTANTIAL PERFORMANCE

- D14.1 The Contractor shall achieve Substantial Performance within 60 consecutive Calendar Days of the commencement of the Work as specified in D13.
- D14.2 When the Contractor considers the Work to be substantially performed, the Contractor shall arrange, attend and assist in the inspection of the Work with the Contract Administrator for purposes of verifying Substantial Performance. Any defects or deficiencies in the Work noted during that inspection shall be remedied by the Contractor at the earliest possible instance and the Contract Administrator notified so that the Work can be reinspected.
- D14.3 The date on which the Work has been certified by the Contract Administrator as being substantially performed to the requirements of the Contract through the issue of a certificate of Substantial Performance is the date on which Substantial Performance has been achieved.

#### D15. TOTAL PERFORMANCE

- D15.1 The Contractor shall achieve Total Performance within 75 consecutive Working Days of the commencement of the Work as specified in D13.
- D15.2 When the Contractor or the Contract Administrator considers the Work to be totally performed, the Contractor shall arrange, attend and assist in the inspection of the Work with the Contract Administrator for purposes of verifying Total Performance. Any defects or deficiencies in the Work noted during that inspection shall be remedied by the Contractor at the earliest possible instance and the Contract Administrator notified so that the Work can be reinspected.
- D15.3 The date on which the Work has been certified by the Contract Administrator as being totally performed to the requirements of the Contract through the issue of a certificate of Total Performance is the date on which Total Performance has been achieved.

#### D16. LIQUIDATED DAMAGES

- D16.1 If the Contractor fails to achieve Substantial Performance in accordance with the Contract by the day fixed herein for Substantial Performance, the Contractor shall pay the City Five Hundred dollars (\$500.00) per Calendar Day for each and every Calendar Day following the day fixed herein for Substantial Performance during which such failure continues.
- D16.2 The amount specified for liquidated damages in D16.1 is based on a genuine pre-estimate of the City's losses in the event that the Contractor does not achieve Substantial Performance by the day fixed herein for same.
- D16.3 The City may reduce any payment to the Contractor by the amount of any liquidated damages assessed.

#### D17. WARRANTY

- D17.1 Further to GC.10.01, if a defect or deficiency prevents the full and normal use or operation of the Work or any portion thereof, for purposes of calculating the warranty period, time shall be deemed to cease to elapse for the defective or deficient portion, and for any portion of the Work whose use or operation is prevented by such defect or deficiency, as of the date on which the defect or deficiency is observed or the use or operation is prevented and shall begin to run again when the defect or deficiency has been corrected or the Work may be used or operated to the satisfaction of the Contract Administrator.
- D17.2 If a defect or deficiency prevents the full and normal use or operation of the Work or any portion thereof, for purposes of calculating the warranty period, time shall be deemed to cease to elapse for the defective or deficient portion, and for any portion of the Work whose use or operation is prevented by such defect or deficiency, as of the date on which the defect or deficiency is observed or the use or operation is prevented and shall begin to run again when the defect or deficiency has been corrected or the Work may be used or operated to the satisfaction of the Contract Administrator.
- D17.3 Notwithstanding GC.10.01, GC.10.02 and D17.1, if any law of Manitoba or of the jurisdiction in which the Work was manufactured requires, or if the manufacturer provides, a longer warranty period or a warranty which is more extensive in its nature, then the provisions of such law or manufacturer's warranty shall apply.

### **PART E - SPECIFICATIONS**

#### **GENERAL**

#### E1. GENERAL

- E1.1 This specification shall cover the removal of existing fencing, and the manufacture, supply and installation of ornamental steel fencing, as detailed on associated drawings.
- E1.2 These Specifications shall apply to the Work.
- E1.3 The Contractor shall provide mechanical drawings of the proposed connections and metal components
- E1.4 The Contractor shall coordinate on site operations and installation with City of Winnipeg staff including
  - (a) Park Foreman
  - (b) Outdoor Garden Supervisor
  - (c) Landscape Architect
  - (d) And, others as required and identified by the Contract Administrator at the project start-up meeting.

#### E2. GOODS

- E2.1 The Contractor shall supply and install ornamental steel fencing and gates in accordance with the requirements hereinafter specified.
- E2.2 The Contractor shall manufacture and install:
  - (a) Ornamental decorative steel fence approximately 1450 lineal feet in length, with an overall height of 8 feet, in 8 foot modular sections.
  - (b) Steel framed black secondary fence with welded wire mesh fence approximately 1250 lineal feet in length, with an overall height of 8 feet, in 8 foot modular sections
    - Alternate 1: Steel framed black secondary fence with black chainlink fence approximately 1250 lineal feet in length, with an overall height of 8 feet, in 8 foot modular sections
  - (c) Two (2) sliding vehicular gates in welded wire mesh material
  - (d) One (1) man gate in welded wire mesh material
  - (e) Two (2) ornamental decorative double pedestrian steel gates at the main entranceways to the gardens, located at the English Gardens and Leo Mol Sculpture Gardens
  - (f) One (1) ornamental decorative 6 foot section and 0ne (1) ornamental decorative 8 foot section of fence hinged to allow vehicular access.
- E2.3 Item No. 1 Ornamental decorative Steel Fencing shall be designed in .
- E2.4 Item No. 2 Secondary wire-welded mesh (or Framed framed black chainlink mesh) fencing shall be as detailed in Drawing A3-HY-4.
- E2.5 Item No. 3 Gates shall be designed by the Contractor and mechanical drawings will be provided to the Contract Administrator within seven (7) days following the award of Contract.
- E2.6 All fence components shall be solid steel finished black.

E2.7 The Contractor shall provide, a sample of both fences within ten (10) Working days of a request by he Contract Administrator; to demonstrate the quality of the materials to be used, the manner in which the fences will be constructed.

E2.8 All Workmanship and all materials finished and supplied under this Specification are subject to close and systematic inspection by the Contract Administrator including all operations from the selection and production of materials through to final acceptance of the Contract. The Contractor shall be wholly responsible for the control of all operations incidental thereto notwithstanding any inspection or approval that may have been previously given. The contract Administrator reserves the right to reject any materials or Work, which are not in accordance with the requirements of this Specification.

#### E3. MATERIALS

E3.1 All materials supplied under this specification shall be of a type approved by the Contract Administrator, and shall be subject to inspection and testing by the Contract Administrator.

#### E3.2 Steel Fencing

- (a) Posts shall be 3 ½" X 3 ½" square steel posts. .
- (b) Ornamental fence panels: Pickets, horizontal bars and rings shall be manufactured of all steel components. Standard fence sections to be designed for installation on posts at eight feet (8') on centre. Materials shall be sized as shown on the Drawings.
- (c) Secondary fence panels: Frame and welded wire mesh shall be manufactured of all steel components. Frames to be designed for standard installation with posts at eight feet (8') on centre of 1 ½" X 1 ½" steel U-channel. Wire mesh shall be welded, consisting of 2"X1" squares. Materials shall be sized as shown on the Drawings.
- (d) Alternate Secondary fence panels: Frames shall be manufactured as detailed on drawings as per E4.2 (c ). Mesh shall be 1 ½" X 1 ½" galvanized chain link fencing black vinyl-coated.

#### E3.3 Powder-coated Finishes

(a) Finishes on all steel components including Posts, steel fence panels, steel frames, and all hardware, gate hinges and locking bars and fasteners shall be Sandblast SSPC-SPID near white, applied with 2 mil zinc powder primer powder top coat, finished with 0-3 mills polyester super durable black finish.

#### E4. CONCRETE PILES

- E4.1 All fence posts are to be set in concrete footings or piles to ensure stability and prevent frost heaving. The current Standard Construction Specifications of the City of Winnipeg, CW 2160-R6-Concrete to be Used in Underground Works, is to be utilized in the installation of the concrete Works for all posts.
- E4.2 The specific concrete requirements shall be:
  - (a) Sulfate resistant, Type 50 Cement
  - (b) 28 day compressive strength of 30Mpa
  - (c) maximum aggregate size of 40mm, nominal
  - (d) slump 90 20mm
  - (e) Maximum water/cement ratio 0.45
- E4.3 Contractor shall notify the Contract Administrator at least 48 hours prior to installation of concrete, so that footings may be inspected in advance of concrete being poured.

E4.4 Fence posts shall have a minimum 300mm (12") diameter concrete footing and shall be centred in the concrete footing to provide a minimum 50mm(2") band of concrete on all sides.

E4.5 Work under this section is considered incidental to the installation of the fencing.

#### E5. SHOP DRAWINGS

- E5.1 The Contractor shall furnish the Contract Administrator with five (5) copies of all steel fabrication Works. Two (2) copies will be returned to the Contractor.
- E5.2 Shop drawings shall indicate the layout and miscellaneous sizes, dimensions, bolt, drilling locations, connections, information relevant to fabrication and erection. Shop welds shall be distinguished on the drawings by AWS welding symbols. All drilling, cutting, and field welding shall be indicated.
- E5.3 Review of shop drawings in no way relieves the Contractor of the final responsibility for correctness of dimensions, sizes, fabrication details, errors made therein or for changes made from the contract administrator's drawings or specifications not covered by the Contractor 's written notification to the contract Administrator. No reprint of the Contract Administrator Working drawing shall be used as the shop drawing.

#### E6. METHODS

- E6.1 Workmanship shall be in accordance with the industry standards, and quality control shall be exercised related to the assembly connection requirements, setting, welding and grinding, trimming, sandblasting, co-ordination of fasteners, alignment and adjusting.
- E6.2 Fabrication of all fence members shall be in accordance with the Drawings. The Contractor shall verify that the dimensions suit the as-built conditions for concrete piles. Once the shop drawings have been approved, the fencing shall be fabricated with all welds ground smooth.
- E6.3 The fencing shall be shop finished. The fence shall be installed straight and plumb as shown n the Drawings.
- E6.4 Any surface damage during the installation shall be touched-up to the approval of the Contract Administrator.

#### E7. ACCESS TO SITE AND DAMAGE TO EXISITING STRUCTURES AND PROPERTY

- E7.1 Access to the Sites as required by the Contractor shall be provided and maintained by the Contractor at his own expense and approved by the Contract Administrator.
- E7.2 All necessary precautions shall be exercised by the Contractor so as not to remove, disturb, or damage any existing trees, shrubs, sod, pavements, streets, roads, boulevards, poles, hydrants, water pipes, gas pipes, electrical wires, cables, conduits, sewers or other existing facilities and equipment at the Site of the Work. For all damage incurred thereto in the performance of the Work, the Contractor shall upon instructions from and to the satisfaction of the City thereof, either replace and repair such damage, whichever may be deemed necessary in the opinion of, and acceptable to, the City thereof and the cost of which shall be borne entirely by the Contractor. The Contractor shall also indemnify and save harmless the City, The Winnipeg School Division and David Wagner Associates Inc. from all claims made directly or indirectly against them in respect to any such damage.
- E7.3 The Contractor 's operations shall be limited to the minimum area necessary for undertaking the Work and he shall be responsible for all damage resulting from his Work on Private property. The Contractor shall take such measures as are necessary to ensure safe and convenient

pedestrian ingress and egress is maintained to private properties while he is Working near them. Any damage caused by the negligence of the Contractor or his Subcontractors to the adjacent Works or properties, shall be promptly repaired by him at his own expense, to the satisfaction of the Contract Administrator.

E7.4 Care shall be taken to protect existing trees and their root systems from damage, compaction, and contamination resulting from construction to the satisfaction of the Contract Administrator. No heavy equipment shall be driven or parked on the area within the drip line of any trees.

#### E8. PROTECTION OF SURVEY INFRASTRUCTURE

E8.1 Refer to CW 1130-R1, Site Requirements, Clause 3.14. The Contractor must ensure all Subcontractor(s) are aware of this clearance procedure and potential restoration costs.

#### E9. PROTECTION OF TREES

- E9.1 The Contractor shall take the following precautionary steps to avoid damage from his construction activities to existing trees, including boulevard trees, within the limits of the construction area or Site access:
  - (a) The Contractor shall not stockpile materials and soil, or park vehicles and equipment on boulevards within 2 metres of trees.
  - (b) The Contract Administrator shall identify the mature tree trucks that shall be strapped with 25x150x2400mm wood planks.
- Ey.2 Excavation shall be performed in a manner that minimizes damage to the existing root systems. Where possible, excavation shall be carried out such that the edge of the excavation shall be a minimum of 2m from the closed edge of the truck. Where the roots must be cut to facilitate excavation, they shall be pruned neatly at the face of the excavation.
- E9.3 All damage to existing trees caused by the Contractor 's construction activities shall be repaired to the requirements and satisfaction of the City of Winnipeg, Public Works, Parks and Open Space Division, Forestry Branch.
- E9.4 Tree protection shall be considered incidental to the Contract Work.

#### E10. BASIS OF PAYMENT

- E10.1 Payment for Work under this section shall be paid for at the Unit Price, measured on a lineal metre basis, for all the Items of Work listed below, which price shall include all costs of material supply, and proper material installation. Corner posts shall be considered incidental to the Work.
