TERMS AND CONDITIONS – SURPLUS GOODS

- BIDDING PROCEDURES

 The Bid must be submitted on the forms provided, with all required entries made clearly
- If the Bidder finds discrepancies or omissions in the Offer of Surplus Goods for Sale or 1.2 any part thereof, or is unsure of the meaning or intent thereof, he shall notify the Buyer. The Buyer will, if he deems it necessary, issue addenda to all Bidders. The Bidder is advised to direct all enquiries or comments to the Buyer at least five (5) business days prior to the Submission Deadline to allow time for the preparation and distribution of necessarv addenda.
- The Bidder is responsible for inspecting the goods, the nature of the Work to be done and all conditions that might affect his Bid or his performance of the Work, and shall assume all risk for conditions existing or arising in the course of the Work which have been or could have been determined through such inspection.
- The Bid must be submitted enclosed and sealed in an envelope clearly marked with the RFQ Number and the Bidder's name and address. Each envelope must contain only the Bid for one Offer of Surplus Goods for Sale.
- The Bid must be submitted to the Materials Management Division at the address specified no later than the Submission Deadline specified. Bids received after the Submission Deadline will not be considered.

- The Buyer will give written notice of the award of the Contract to the successful Bidder, or will give notice that no award will be made.

SCOPE OF WORK

- The Work to be done under this Contract shall consist of the purchase and removal of surplus goods, and the provision of ancillary services in accordance with applicable specifications, drawings and addenda.
- The Contractor shall provide and pay for all materials, labour, equipment, tools, utilities, licenses and fees necessary to complete the Work.

- All goods are sold on an "as is, where is" basis and the City makes no representation or warranty with respect to the fitness, merchantability, suitability or durability of any of the
- 3.2 The Contractor shall remove the goods within seven (7) days of notification by the City
- The Contractor shall inspect the goods at the time of pick up. The City shall not be responsible for any damage, defect or deterioration of the goods purported to have occurred after any prior inspection by the Contractor unless such damage, defect or deterioration is identified at the time of pick up by the Contractor. 3.3

ASSIGNMENTThe Contractor shall not assign the Contract without the prior written approval of the City. 4 1

SUBCONTRACTING

- If the Contractor subcontracts any portion of the Work, he shall:

 a) employ only Subcontractors who have successfully carried out work similar in nature, scope and value to the portion of the Work proposed to be subcontracted to them, or who are fully capable of performing the Work required to be done in accordance with the terms of the Contract;
 - enter into contracts or written agreements with his Subcontractors to require them to perform their work in complete conformance with and subject to the terms and conditions of the Contract; and
 - be as fully responsible to the City for acts and omissions of his Subcontractors and of persons directly or indirectly employed by them as for acts and omissions of persons directly employed by him.

- The Contractor shall save harmless and indemnify the City for twice the contract price plus two million dollars, unless specifically stated otherwise in the contract documents, against all costs, damages or expenses arising from actions, claims, demands and proceedings, by whomsoever brought, made or taken as a result of acts or omissions of the Contractor, his subcontractors, employees or agents in the performance or purported performance of the Work, and more particularly from:

- The Contractor shall pay to the City the value of all legal fees and disbursements required to settle any such claim or to defend the City against any such claim, action, proceeding, claim or demand notwithstanding that the settlement or defence of the said action, proceeding, claim or demand was undertaken on behalf of the City by a salaried employee of the City.
- If the Contractor fails to make any payment required to be made to the City hereunder, the City shall be entitled to deduct the amount of such payment from any payment required to be made by the City to the Contractor under the Contract or take whatever other remedies against the Contractor that the City may have at law.

EVENTS OF DEFAULT

- 7.1 An event of default will be deemed to have occurred if the Contractor:) abandons the Work; or

 - is adjudged bankrupt or files for bankruptcy, becomes insolvent, makes a general is adjudged bankrupt or files for bankruptcy, becomes insolvent, makes a general assignment for the benefit of his creditors, or has a receiver or liquidator appointed in respect of his assets; or in the judgment of the City, is not performing or has not been performing the Work, or any part thereof, in a sound and workmanlike manner and in all respects in strict conformity with the Contract; or in the judgment of the City, is not progressing continuously with the Work or any part thereof, and in such a manner as to ensure the completion of the Work or any part thereof, in accordance with the work schedule; or

 - fails to remedy any defective or deficient; or fails to make prompt payment to his subcontractors, his employees or on account of the purchase or rental of equipment or material; or

 - fails to comply with any laws, by-laws or statutory regulations; or fails to submit any schedules, documents or information required by the Contract; or refuses or neglects to comply with an order given by the City; commits any other breach of the Contract.
- Any provision of the Contract may be waived only by express waiver in writing by the City. 7.2 No express waiver of any provision shall imply the waiver of any other provision

PRICES AND PAYMENT

SPECIFICATIONS

1. GENERAL

1.1 These Specifications shall be applicable to the Work and shall take precedence over the Terms and Conditions.

2. DEFINITIONS

- 2.1 When used in this Request for Quotation:
 - (a) "Business Day" means any Calendar Day, other than a Saturday, Sunday, or a Statutory or Civic Holiday;
 - (b) "Buyer" means the person authorized to represent the City in respect of the Request for Quotation;
 - (c) "Calendar Day" means the period from one midnight to the following midnight;
 - (d) "Contract" means the combined documents consisting of the Request for Quotation package and any documents and drawings referred to and incorporated therein together with any submissions required to be made by the Contractor after award, and all amendments to the foregoing;
 - (e) "Contract Administrator" means the person authorized to represent the City in respect of the Contract and is identified at the time of award of the Contract;
 - (f) "Contractor" means the person undertaking the performance of the Work under the terms of the Contract;
 - (g) "**User**" means a person, department or other administrative unit of the City authorized by the Contract Administrator to order Work under this Contract;
 - (h) "Work" means the carrying out and the doing of all things, whether of a temporary or permanent nature, that are to be done by the Contractor pursuant to the Contract and, without limiting the generality of the foregoing, includes the furnishing of all equipment, facilities, material, labour and services necessary for or incidental to the fulfilment of the requirements of the Contract.

3. SURPLUS GOODS

- 3.1 The surplus goods offered for sale are Railway Equipment and Steel Flat Car Bulkheads as described below:
- 3.2 Item No. 1 Ramp Flat Car shall be one (1) Ramp Flat Car weighing approximately thirty thousand (30,000) pounds. (Picture 2352-R0)

- 3.5 Item No. 4 Track Maintenance Regulator Machine shall be one (1) Track Maintenance Regulator Machine weighing approximately ten thousand (10,000) pounds. (Picture 2377-R0)
- 3.6 Item No. 5 Bulk Heads shall be twelve (12) Bulk Heads each weighing approximately four thousand (4,000) pounds. (Picture 2376-R0. Does not include the car they are sitting on.)
- 3.7 All surplus goods shall be purchased on a per ton basis.

4. PICK UP

4.1 Surplus goods shall be picked up within thirty (30) days of award of the Contract, f.o.b. origin, at 598 Plinguet Street.

- 4.1.1 The Contractor shall promptly report any delay or change to an agreed pick up date to the User.
- 4.2 Surplus goods shall be picked up between 8:00 a.m. and 4:00 p.m. on Business Days.

ADDENDA

- 5.1 The Buyer may, at any time prior to the Submission Deadline, issue addenda correcting errors, discrepancies or omissions in the Request for Quotation, or clarifying the meaning or intent of any provision therein.
- 5.2 The Buyer will issue each addendum to all Bidders by:
 - (a) mail, courier or facsimile transmission (fax) to the usual business address of the Bidder as shown in the records of the Materials Management Division; and/or

- 5.3 The Bidder is responsible for ensuring that he/she has received all addenda and shall acknowledge receipt of each addendum on the Request for Quotation cover page. Failure to acknowledge receipt of an addendum may render a Bid non-responsive.

6. BID SUBMISSION

- 6.2.1 The Bidder is advised that the City cannot take responsibility for the availability of the facsimile machine at any time.
- 6.2.2 Bids submitted by internet electronic mail (e-mail) will not be accepted.

7. PRICES

- 7.1 The Bidder shall state a price in Canadian funds for each item of the Work identified on Form B: Prices.
- Further to 8.1 of the Terms and Conditions, the City will not consider deductions in payment for any charges (e.g., minimum pick up charges, handling charges, container deposits, etc.), except those imposed after the Submission Deadline by a government or regulatory authority having jurisdiction, unless they are identified and quantified in the Bid.
- 7.3 The quantities listed on Form B: Prices are to be considered approximate only. The City will use said quantities for the purpose of comparing Bids.
- 7.4 The quantities for which payment will be made by the Contractor shall be determined by the surplus goods actually supplied to the Contractor.
- 7.5 Collection and removal of the Railway Equipment and Steel Flat Car Bulkheads shall be measured on a weight basis. The weight to be paid for shall be the total weight removed as calculated from scale tickets issued at The City scales at the sites or such other scales as may be approved by The City. Scales must be registered for business use with the Province of Manitoba.
- 7.6 The Contractor shall provide scale tickets for tare weight and loaded weight for each pick-up. Each such ticket shall be for a weighing on the same day as the pick-up.

8. PAYMENTS

- 8.1 Further to 8.4 of the Terms and Conditions, the Contractor shall submit payments to the locations designated by the Contract Administrator prior to the pick-up of surplus goods. In the event that payment does not meet, or exceeds actual cost per ton, adjustments will be made within ten (10) Business Days.
- 8.2 Each payment must be accompanied by a written statement clearly indicating, as a minimum:
 - (a) the City's Transaction number;
 - (b) total amount of payment with GST and PST, where applicable, shown as separate amounts; and
 - (c) where applicable, the Contractor's vendor registration number or a copy of the Contractor's purchase exemption certificate and, where applicable, his/her licence number (see 8.2 and 8.3 of the Terms and Conditions).

9. WORKERS COMPENSATION

9.1 The Contractor shall be registered with the Workers Compensation Board of Manitoba, shall provide and maintain Workers Compensation coverage throughout the term of the Contract, and shall provide the Contract Administrator with evidence thereof upon request.

10. EVALUATION CRITERIA

- 10.1 Award of this Contract will be based on the following evaluation criteria:

11. AWARD OF CONTRACT
