 - a) On the type of equipment being offered, state if VHS videotape <u>or</u> CD Rom training aides are available.
- 16.2.2 State if other training aides are available <u>and</u> state type.

17.0 WARRANTY

- 17.1 Complete details of warranties shall be made available within twenty-four (24) hours of the request of the Contract Administrator.
- 17.2 The Contractor shall warrant **all equipment** and all parts thereof, against any defects of workmanship, construction and materials, and agrees to repair or replace, <u>without cost to the City</u>, any article that has become defective and not proven to have been caused by negligence on the part of the user within **one (1) year** from the date the equipment is put into service by the City of Winnipeg.
 - 17.2.1 Notwithstanding 17.2 above, the Contractor shall warrant **all major components** including, but not limited to, engine, transmission, final drives, all wheel drive system (and all components thereof), pumps and motors, axle assemblies, tandem drives, etc. against any defects of workmanship, construction and materials, and agrees to repair or replace <u>without cost to the City</u>, articles that have become defective and not proven to have been caused by negligence on the part of the user within **one (1) year** from the date the equipment is put into service by the City of Winnipeg.
 - 17.2.2 Notwithstanding 17.2 above, the Contractor shall warrant **all attachments**, and all parts thereof, against any defects of workmanship, construction and materials, and agrees to repair or replace, <u>without cost to the City</u>, any article that has become defective and not proven to have been caused by negligence on the part of the user within **one (1) year** from the date the equipment is put into service by the City of Winnipeg.
- 17.3 <u>The warranty shall not include</u> regular maintenance items or any item deemed as a consumable that is subject to everyday wear and tear, during the regular operation of the unit.

- 17.4 <u>The following shall be covered under manufacture's warranty</u> for six (6) months against defects:
 - a) Batteries.
 - b) Belts.
 - c) Tires.
- 17.5 <u>All incidental warranty</u> related costs (including, but not limited to, Contractor's travel, mileage, deductibles, towing costs etc.) in executing any part of the warranty shall be the sole responsibility of the Contractor.
