PART B - BIDDING PROCEDURES

B1. CONTRACT TITLE

B1.1 SUPPLY AND INSTALL A BIODIESEL FUEL SITE

B2. SUBMISSION DEADLINE

- B2.1 The Submission Deadline is 12:00 noon Winnipeg time, May 9, 2007.
- B2.2 Bids determined by the Manager of Materials to have been received later than the Submission Deadline will not be accepted and will be returned upon request.
- B2.3 The Contract Administrator or the Manager of Materials may extend the Submission Deadline by issuing an addendum at any time prior to the time and date specified in B2.1.

B3. SITE INVESTIGATION

B3.1 Further to C3.1, the Bidder may view the Site without making an appointment.

B4. ENQUIRIES

- B4.1 All enquiries shall be directed to the Contract Administrator identified in D3.1.
- B4.2 If the Bidder finds errors, discrepancies or omissions in the Bid Opportunity, or is unsure of the meaning or intent of any provision therein, the Bidder shall notify the Contract Administrator of the error, discrepancy or omission, or request a clarification as to the meaning or intent of the provision at least five (5) Business Days prior to the Submission Deadline.
- B4.3 Responses to enquiries which, in the sole judgment of the Contract Administrator, require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator to all Bidders by issuing an addendum.
- B4.4 Responses to enquiries which, in the sole judgment of the Contract Administrator, do not require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator only to the Bidder who made the enquiry.
- B4.5 The Bidder shall not be entitled to rely on any response or interpretation received pursuant to B4 unless that response or interpretation is provided by the Contract Administrator in writing.

B5. ADDENDA

- B5.1 The Contract Administrator may, at any time prior to the Submission Deadline, issue addenda correcting errors, discrepancies or omissions in the Bid Opportunity, or clarifying the meaning or intent of any provision therein.
- B5.2 The Contract Administrator will issue each addendum at least two (2) Business Days prior to the Submission Deadline, or provide at least two (2) Business Days by extending the Submission Deadline.
- B5.2.1 Addenda will be available on the Bid Opportunities page at The City of Winnipeg, Corporate Finance, Materials Management Branch internet site at http://www.winnipeg.ca/matmgt.
- B5.2.2 The Bidder is responsible for ensuring that he has received all addenda and is advised to check the Materials Management Branch internet site for addenda regularly and shortly before the Submission Deadline, as may be amended by addendum.
- B5.3 The Bidder shall acknowledge receipt of each addendum in Paragraph 0 of Form A: Bid. Failure to acknowledge receipt of an addendum may render a Bid non-responsive.

B6. SUBSTITUTES

- B6.1 The Work is based on the Plant, Materials and methods specified in the Bid Opportunity.
- B6.2 Substitutions shall not be allowed unless application has been made to and prior approval has been granted by the Contract Administrator in writing.
- B6.3 Requests for approval of a substitute will not be considered unless received in writing by the Contract Administrator at least five (5) Business Days prior to the Submission Deadline.
- B6.4 The Bidder shall ensure that any and all requests for approval of a substitute:
 - (a) provide sufficient information and details to enable the Contract Administrator to determine the acceptability of the Plant, Material or method as either an approved equal or alternative;
 - (b) identify any and all changes required in the applicable Work, and all changes to any other Work, which would become necessary to accommodate the substitute;
 - (c) identify any anticipated cost or time savings that may be associated with the substitute;
 - (d) certify that, in the case of a request for approval as an approved equal, the substitute will fully perform the functions called for by the general design, be of equal or superior substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance;
 - (e) certify that, in the case of a request for approval as an approved alternative, the substitute will adequately perform the functions called for by the general design, be similar in substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance.
- B6.5 The Contract Administrator, after assessing the request for approval of a substitute, may in his sole discretion grant approval for the use of a substitute as an "approved equal" or as an "approved alternative", or may refuse to grant approval of the substitute.
- B6.6 The Contract Administrator will provide a response in writing, at least two (2) Business Days prior to the Submission Deadline, only to the Bidder who requested approval of the substitute.
- B6.6.1 The Bidder requesting and obtaining the approval of a substitute shall be entirely responsible for disseminating information regarding the approval to any person or persons he wishes to inform.
- B6.7 If the Contract Administrator approves a substitute as an "approved equal", any Bidder may use the approved equal in place of the specified item.
- B6.8 If the Contract Administrator approves a substitute as an "approved alternative", any Bidder bidding that approved alternative may base his Total Bid Price upon the specified item but may also indicate an alternative price based upon the approved alternative. Such alternatives will be evaluated in accordance with B15.
- B6.9 No later claim by the Contractor for an addition to the Total Bid Price because of any other changes in the Work necessitated by the use of an approved equal or an approved alternative will be considered.

B7. BID COMPONENTS

- B7.1 The Bid shall consist of the following components:
 - (a) Form A: Bid;
 - (b) Form B: Prices;

- (c) Form G1: Bid Bond and Agreement to Bond, or Form G2: Irrevocable Standby Letter of Credit and Undertaking, or a certified cheque or draft;
- B7.2 Further to B7.1, the Bidder should include the written correspondence from the Contract Administrator approving a substitute in accordance with B6.
- B7.3 All components of the Bid shall be fully completed or provided, and submitted by the Bidder no later than the Submission Deadline, with all required entries made clearly and completely, to constitute a responsive Bid.
- B7.4 The Bid shall be submitted enclosed and sealed in an envelope clearly marked with the Bid Opportunity number and the Bidder's name and address.
- B7.4.1 Samples or other components of the Bid which cannot reasonably be enclosed in the envelope may be packaged separately, but shall be clearly marked with the Bid Opportunity number, the Bidder's name and address, and an indication that the contents are part of the Bidder's Bid.
- B7.5 Bidders are advised not to include any information/literature except as requested in accordance with B7.1.
- B7.6 Bidders are advised that inclusion of terms and conditions inconsistent with the Bid Opportunity document, including the General Conditions, may result in the Bid being determined to be non-responsive.
- B7.7 Bids submitted by facsimile transmission (fax) or internet electronic mail (e-mail) will not be accepted.
- B7.8 Bids shall be submitted to:

B8. BID

- B8.1 The Bidder shall complete Form A: Bid, making all required entries.
- B8.2 Paragraph 2 of Form A: Bid shall be completed in accordance with the following requirements:
 - (a) if the Bidder is a sole proprietor carrying on business in his own name, his name shall be inserted;
 - (b) if the Bidder is a partnership, the full name of the partnership shall be inserted;
 - (c) if the Bidder is a corporation, the full name of the corporation shall be inserted;
 - (d) if the Bidder is carrying on business under a name other than his own, the business name and the name of every partner or corporation who is the owner of such business name shall be inserted.
- B8.2.1 If a Bid is submitted jointly by two or more persons, each and all such persons shall identify themselves in accordance with B8.2.
- B8.3 In Paragraph 3 of Form A: Bid, the Bidder shall identify a contact person who is authorized to represent the Bidder for purposes of the Bid.
- B8.4 Paragraph 0 of Form A: Bid shall be signed in accordance with the following requirements:

- (a) if the Bidder is a sole proprietor carrying on business in his own name, it shall be signed by the Bidder;
- (b) if the Bidder is a partnership, it shall be signed by the partner or partners who have authority to sign for the partnership;
- (c) if the Bidder is a corporation, it shall be signed by its duly authorized officer or officers and the corporate seal, if the corporation has one, should be affixed;
- (d) if the Bidder is carrying on business under a name other than his own, it shall be signed by the registered owner of the business name, or by the registered owner's authorized officials if the owner is a partnership or a corporation.
- B8.4.1 The name and official capacity of all individuals signing Form A: Bid shall be printed below such signatures.
- B8.4.2 All signatures should be witnessed, except where a corporate seal has been affixed.
- B8.5 If a Bid is submitted jointly by two or more persons, the word "Bidder" shall mean each and all such persons, and the undertakings, covenants and obligations of such joint Bidders in the Bid and the Contract, when awarded, shall be both joint and several.

B9. PRICES

B9.1 The Bidder shall state the lump sum price in Canadian funds for the Work on Form B: Prices.

B10. QUALIFICATION

- B10.1 The Bidder shall:
 - (a) undertake to be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba; and
 - (b) be financially capable of carrying out the terms of the Contract; and
 - (c) have all the necessary experience, capital, organization, and equipment to perform the Work in strict accordance with the terms and provisions of the Contract.
- B10.2 The Bidder and any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
 - (a) be responsible and not be suspended, debarred or in default of any obligations to the City (a list of suspended or debarred individuals and companies is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Branch internet site at <u>http://www.winnipeg.ca/matmgt</u>).
- B10.3 The Bidder and/or any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
 - (a) have successfully carried out work similar in nature, scope and value to the Work; and
 - (b) be fully capable of performing the Work required to be in strict accordance with the terms and provisions of the Contract; and
 - (c) have a written workplace safety and health program if required pursuant to The Workplace Safety and Health Act (Manitoba);
- B10.4 Further to B10.3(c), the Bidder shall, within three (3) Business Days of a request by the Contract Administrator, provide proof satisfactory to the Contract Administrator that the Bidder/Subcontractor has a workplace safety and health program meeting the requirements of The Workplace Safety and Health Act (Manitoba), by providing:

- (a) a valid COR certification number under the Certificate of Recognition (COR) Program administered by the Manitoba Construction Safety Association or by the Manitoba Heavy Construction Association's Safety, Health and Environment Program; or
- (b) a report or letter to that effect from an independent reviewer acceptable to the City. (A list of acceptable reviewers and the review template are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Branch internet site at http://www.winnipeg.ca/matmgt.)
- B10.5 The Bidder shall submit, within three (3) Business Days of a request by the Contract Administrator, proof satisfactory to the Contract Administrator of the qualifications of the Bidder and of any proposed Subcontractor.
- B10.6 The Bidder shall provide, on the request of the Contract Administrator, full access to any of the Bidder's equipment and facilities to confirm, to the Contract Administrator's satisfaction, that the Bidder's equipment and facilities are adequate to perform the Work.

B11. BID SECURITY

- B11.1 The Bidder shall provide bid security in the form of:
 - (a) a bid bond, in the amount of at least ten percent (10%) of the Total Bid Price, and agreement to bond of a company registered to conduct the business of a surety in Manitoba, in the form included in the Bid Submission (Form G1: Bid Bond and Agreement to Bond); or
 - (b) an irrevocable standby letter of credit, in the amount of at least ten percent (10%) of the Total Bid Price, and undertaking issued by a bank or other financial institution registered to conduct business in Manitoba and drawn on a branch located in Winnipeg, in the form included in the Bid Submission (Form G2: Irrevocable Standby Letter of Credit and Undertaking); or
 - (c) a certified cheque or draft payable to "The City of Winnipeg", in the amount of at least fifty percent (50%) of the Total Bid Price, drawn on a bank or other financial institution registered to conduct business in Manitoba.
- B11.1.1 If the Bidder submits alternative bids, the bid security shall be in the amount of the specified percentage of the highest Total Bid Price submitted.
- B11.1.2 All signatures on bid securities shall be original, and shall be witnessed or sealed as required.
- B11.2 The bid security of the successful Bidder and the next two lowest evaluated responsive and responsible Bidders will be released by the City when a Contract for the Work has been duly executed by the successful Bidder and the performance security furnished as provided herein. The bid securities of all other Bidders will be released when a Contract is awarded.
- B11.2.1 Where the bid security provided by the successful Bidder is in the form of a certified cheque or draft pursuant to B11.1(c), it will be deposited and retained by the City as the performance security and no further submission is required.
- B11.2.2 The City will not pay any interest on certified cheques or drafts furnished as bid security or subsequently retained as performance security.
- B11.3 The bid securities of all Bidders will be released by the City as soon as practicable following notification by the Contract Administrator to the Bidders that no award of Contract will be made pursuant to the Bid Opportunity.

B12. OPENING OF BIDS AND RELEASE OF INFORMATION

B12.1 Bids will be opened publicly, after the Submission Deadline has elapsed, in the office of the Corporate Finance Department, Materials Management Branch, or in such other office as may be designated by the Manager of Materials.

- B12.1.1 Bidders or their representatives may attend.
- B12.1.2 Bids determined by the Manager of Materials, or his designate, to not include the bid security specified in B11 will not be read out.
- B12.2 Following the submission deadline, the names of the Bidders and their Total Bid Prices (unevaluated, and pending review and verification of conformance with requirements) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Branch internet site at http://www.winnipeg.ca/matmgt.
- B12.3 After award of Contract, the name(s) of the successful Bidder(s) and the Contract Amount(s) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Branch internet site at http://www.winnipeg.ca/matmgt.
- B12.4 The Bidder is advised that any information contained in any Bid may be released if required by City policy or procedures, by The Freedom of Information and Protection of Privacy Act (Manitoba), by other authorities having jurisdiction, or by law.

B13. IRREVOCABLE BID

- B13.1 The Bid(s) submitted by the Bidder shall be irrevocable for the time period specified in Paragraph 0 of Form A: Bid.
- B13.2 The acceptance by the City of any Bid shall not release the Bids of the next two lowest evaluated responsive Bidders and these Bidders shall be bound by their Bids on such Work until a Contract for the Work has been duly executed and the performance security furnished as herein provided, but any Bid shall be deemed to have lapsed unless accepted within the time period specified in Paragraph 0 of Form A: Bid.

B14. WITHDRAWAL OF BIDS

- B14.1 A Bidder may withdraw his Bid without penalty by giving written notice to the Manager of Materials at any time prior to the Submission Deadline.
- B14.1.1 Notwithstanding C23.3, the time and date of receipt of any notice withdrawing a Bid shall be the time and date of receipt as determined by the Manager of Materials.
- B14.1.2 The City will assume that any one of the contact persons named in Paragraph 3 of Form A: Bid or the Bidder's authorized representatives named in Paragraph 0 of Form A: Bid, and only such person, has authority to give notice of withdrawal.
- B14.1.3 If a Bidder gives notice of withdrawal prior to the Submission Deadline, the Manager of Materials will:
 - (a) retain the Bid until after the Submission Deadline has elapsed;
 - (b) open the Bid to identify the contact person named in Paragraph 3 of Form A: Bid and the Bidder's authorized representatives named in Paragraph 0 of Form A: Bid; and
 - (c) if the notice has been given by any one of the persons specified in B14.1.3(b), declare the Bid withdrawn.
- B14.2 A Bidder who withdraws his Bid after the Submission Deadline but before his Bid has been released or has lapsed as provided for in B13.2 shall be liable for such damages as are imposed upon the Bidder by law and subject to such sanctions as the Chief Administrative Officer considers appropriate in the circumstances. The City, in such event, shall be entitled to all rights and remedies available to it at law, including the right to retain the Bidder's bid security.

B15. EVALUATION OF BIDS

- B15.1 Award of the Contract shall be based on the following bid evaluation criteria:
 - (a) compliance by the Bidder with the requirements of the Bid Opportunity (pass/fail);
 - (b) qualifications of the Bidder and the Subcontractors, if any, pursuant to B10 (pass/fail);
 - (c) Total Bid Price;
 - (d) economic analysis of any approved alternative pursuant to B6.
- B15.2 Further to B15.1(a), the Award Authority may reject a Bid as being non-responsive if the Bid is incomplete, obscure or conditional, or contains additions, deletions, alterations or other irregularities. The Award Authority may reject all or any part of any Bid, or waive technical requirements or minor informalities or irregularities, if the interests of the City so require.
- B15.3 Further to B15.1(b), the Award Authority shall reject any Bid submitted by a Bidder who does not demonstrate, in his Bid or in other information required to be submitted, that he is responsible and qualified.
- B15.4 Further to B15.1(c), the Total Bid Price shall be the lump sum price shown on Form B: Prices.

If there is any discrepancy between the lump sum price written in figures and the lump sum price written in words, the price written in words shall take precedence.

B16. AWARD OF CONTRACT

- B16.1 The City will give notice of the award of the Contract or will give notice that no award will be made.
- B16.2 The City will have no obligation to award a Contract to a Bidder, even though one or all of the Bidders are determined to be responsible and qualified, and the Bids are determined to be responsive.
- B16.2.1 Without limiting the generality of B16.2, the City will have no obligation to award a Contract where:
 - (a) the prices exceed the available City funds for the Work;
 - (b) the prices are materially in excess of the prices received for similar work in the past;
 - (c) the prices are materially in excess of the City's cost to perform the Work, or a significant portion thereof, with its own forces;
 - (d) only one Bid is received; or
 - (e) in the judgment of the Award Authority, the interests of the City would best be served by not awarding a Contract.
- B16.3 Subject to B16.2, where an award of Contract is made by the City, the award shall be made to the responsible and qualified Bidder submitting the lowest evaluated responsive Bid.
- B16.3.1 Following the award of contract, a Bidder will be provided with information related to the evaluation of his Bid upon written request to the Contract Administrator.

PART C - GENERAL CONDITIONS

C0. GENERAL CONDITIONS

- C0.1 The *General Conditions for Construction* (Revision 2006 12 15) are applicable to the Work of the Contract.
- C0.1.1 The General Conditions for Construction are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Branch internet site at http://www.winnipeg.ca/matmgt.
- C0.2 A reference in the Bid Opportunity to a section, clause or subclause with the prefix "**C**" designates a section, clause or subclause in the *General Conditions for Construction*.

PART D - SUPPLEMENTAL CONDITIONS

GENERAL

D1. GENERAL CONDITIONS

D1.1 In addition to the *General Conditions for Construction*, these Supplemental Conditions are applicable to the Work of the Contract.

D2. SCOPE OF WORK

- D2.1 The Work to be done under the Contract shall consist of supplying and installing a new biodiesel fuel station with a fully automated fuel management system. The scope of the work includes supplying and installing the following components: fuel pumps, fuel tanks, fuel tank monitoring system, fuel islands, lighting, fully automated fuel system and any other components required to make the site operational. In addition to the supply and install of the components, the fuel site, shall be fully synchronized with all components of the fuel station and must be synchronized with Winnipeg Fleet Management Agency's current I.T. equipment, technology and architecture.
- D2.2 The new Winnipeg Fleet Management Agency fuel site is to be located at 1220 Pacific Avenue and shall be configured according to the proposed site plan attached with this bid opportunity.

D4. CONTRACTOR'S SUPERVISOR

D4.1 At the pre-construction meeting, the Contractor shall identify his designated supervisor and any additional personnel representing the Contractor and their respective roles and responsibilities for the Work.

D5. NOTICES

- D5.1 Except as provided for in C23.2.2, all notices, requests, nominations, proposals, consents, approvals, statements, authorizations, documents or other communications to the Contractor shall be sent to the address or facsimile number identified by the Contractor in Paragraph 2 of Form A: Bid.
- D5.2 All notices, requests, nominations, proposals, consents, approvals, statements, authorizations, documents or other communications to the City, except as expressly otherwise required in D5.3, D5.4 or elsewhere in the Contract, shall be sent to the attention of the Contract Administrator at the address or facsimile number identified in D3.1.

D6. FURNISHING OF DOCUMENTS

D6.1 Upon award of the Contract, the Contractor will be provided with five (5) complete sets of the Bid Opportunity. If the Contractor requires additional sets of the Bid Opportunity, they will be supplied to him at cost.

SUBMISSIONS

D7. AUTHORITY TO CARRY ON BUSINESS

D7.1 The Contractor shall be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba, or if the Contractor does not carry on business in Manitoba, in the jurisdiction where the Contractor does carry on business, throughout the term of the Contract, and shall provide the Contract Administrator with evidence thereof upon request.

D8. SAFE WORK PLAN

- D8.1 The Contractor shall provide the Contract Administrator with a Safe Work Plan at least five (5) Business Days prior to the commencement of any Work on the Site but in no event later than the date specified in C4.1 for the return of the executed Contract.
- D8.2 The Safe Work Plan should be prepared and submitted in the format shown in the City's template which is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Branch internet site at http://www.winnipeg.ca/matmgt.

D9. INSURANCE

- D9.1 The Contractor shall provide and maintain the following insurance coverage:
 - (a) commercial general liability insurance, in the amount of at least two million dollars (\$2,000,000.00) inclusive, with The City of Winnipeg added as an additional insured, with a cross-liability clause, such liability policy to also contain a contractual liability, unlicensed motor vehicle liability, non-owned automobile liability and products and completed operations, to remain in place at all times during the performance of the Work and throughout the warranty period;

- (b) automobile liability insurance for owned automobiles used for or in connection with the Work in the amount of at least two million dollars (\$2,000,000.00) at all times during the performance of the Work and until the date of Total Performance;
- (c) an all risks Installation Floater carrying adequate limits to cover all machinery and equipment utilized during the performance of the Work.
- D9.2 Deductibles shall be borne by the Contractor.
- D9.3 The Contractor shall provide the City Solicitor with a certificate(s) of insurance, in a form satisfactory to the City Solicitor, at least two (2) Business Days prior to the commencement of any Work but in no event later than the date specified in C4.1 for the return of the executed Contract.
- D9.4 The Contractor shall not cancel, materially alter, or cause each policy to lapse without providing at least fifteen (15) Calendar Days prior written notice to the Contract Administrator.

D10. PERFORMANCE SECURITY

- D10.1 The Contractor shall provide and maintain performance security until the expiration of the warranty period in the form of:
 - (a) a performance bond of a company registered to conduct the business of a surety in Manitoba, in the form attached to these Supplemental Conditions (Form H1: Performance Bond), in the amount of fifty percent (50%) of the Contract Price; or
 - (b) an irrevocable standby letter of credit issued by a bank or other financial institution registered to conduct business in Manitoba and drawn on a branch located in Winnipeg, in the form attached to these Supplemental Conditions (Form H2: Irrevocable Standby Letter of Credit), in the amount of fifty percent (50%) of the Contract Price; or
 - (c) a certified cheque or draft payable to "The City of Winnipeg", drawn on a bank or other financial institution registered to conduct business in Manitoba, in the amount of fifty percent (50%) of the Contract Price.
- D10.1.1 Where the performance security is in the form of a certified cheque or draft, it will be deposited by the City. The City will not pay any interest on certified cheques or drafts furnished as performance security.
- D10.2 If the bid security provided in his Bid was not a certified cheque or draft pursuant to B11.1(c), the Contractor shall provide the City Solicitor with the required performance security within seven (7) Calendar Days of notification of the award of the Contract by way of letter of intent and prior to the commencement of any Work on the Site but in no event later than the date specified in C4.1 for the return of the executed Contract.

D11. SUBCONTRACTOR LIST

D11.1 The Contractor shall provide the Contract Administrator with a complete list of the Subcontractors whom the Contractor proposes to engage (Form J: Subcontractor List) at least two (2) Business Days prior to the commencement of any Work on the Site but in no event later than the date specified in the General Conditions for the return of the executed Contract.

SCHEDULE OF WORK

D12. COMMENCEMENT

- D12.1 The Contractor shall not commence any Work until he is in receipt of a letter of intent from the Award Authority authorizing the commencement of the Work.
- D12.2 The Contractor shall not commence any Work on the Site until:
 - (a) the Contract Administrator has confirmed receipt and approval of:

- (1) evidence of authority to carry on business specified in D7;
- (2) evidence of the workers compensation coverage specified in C6.15;
- (3) the Safe Work Plan specified in D8;
- (4) evidence of the insurance specified in D9;
- (5) the performance security specified in D10;
- (6) the Subcontractor list specified in D11; and
- (b) the Contractor has attended a pre-construction meeting with the Contract Administrator, or the Contract Administrator has waived the requirement for a pre-construction meeting.
- D12.3 The Contractor shall commence the Work on the Site within seven (7) Working Days of receipt of the letter of intent.

D13. TOTAL PERFORMANCE

- D13.1 The Contractor shall achieve Total Performance by August 31, 2007.
- D13.2 When the Contractor or the Contract Administrator considers the Work to be totally performed, the Contractor shall arrange, attend and assist in the inspection of the Work with the Contract Administrator for purposes of verifying Total Performance. Any defects or deficiencies in the Work noted during that inspection shall be remedied by the Contractor at the earliest possible instance and the Contract Administrator notified so that the Work can be reinspected.
- D13.3 The date on which the Work has been certified by the Contract Administrator as being totally performed to the requirements of the Contract through the issue of a certificate of Total Performance is the date on which Total Performance has been achieved.

D14. LIQUIDATED DAMAGES

- D14.1 If the Contractor fails to achieve Total Performance in accordance with the Contract by the day fixed herein for Total Performance, the Contractor shall pay the City one hundred dollars (\$100) per Working Day for each and every Working Day following the day fixed herein for Total Performance during which such failure continues.
- D14.2 The amount specified for liquidated damages in D14.1 is based on a genuine pre-estimate of the City's damages in the event that the Contractor does not achieve Total Performance by the day fixed herein for same.
- D14.3 The City may reduce any payment to the Contractor by the amount of any liquidated damages assessed.

CONTROL OF WORK

D15. JOB MEETINGS

- D15.1 Regular monthly job meetings will be held at the Site. These meetings shall be attended by a minimum of one representative of the Contract Administrator, one representative of the City and one representative of the Contractor. Each representative shall be a responsible person capable of expressing the position of the Contract Administrator, the City and the Contractor respectively on any matter discussed at the meeting including the Work schedule and the need to make any revisions to the Work schedule. The progress of the Work will be reviewed at each of these meetings.
- D15.2 The Contract Administrator reserves the right to cancel any job meeting or call additional job meetings whenever he deems it necessary.

D16. PRIME CONTRACTOR – THE WORKPLACE SAFETY AND HEALTH ACT (MANITOBA)

D16.1 Further to C6.24, the Contractor shall be the Prime Contractor and shall serve as, and have the duties of the Prime Contractor in accordance with The Workplace Safety and Health Act (Manitoba).

MEASUREMENT AND PAYMENT

D17. PAYMENT

D17.1 Further to C12, effective January 1, 2007 the City may at its option pay the Contractor by direct deposit to the Contractor's banking institution.

WARRANTY

D18. WARRANTY

D18.1 Notwithstanding C13.2, the warranty period shall begin on the date of Total Performance and shall expire two (2) years thereafter, except where longer warranty periods are specified in the respective Specification sections, unless extended pursuant to C13.2.1 or C13.2.2, in which case it shall expire when provided for thereunder.

E2. WORK SPECIFICATIONS

THE FOLLOWING IS A LIST OF ALL WORK SPECIFICATIONS TO BE COMPLETED:

(a) Supply and Install Fuel Pumps

Supply and install 2 fuel pumps in compliance with all applicable regulations and permit requirements. The pumps shall meet the following criteria:

- (1) Compatible with biodiesel fuel, ultra low sulphur diesel fuel and marked diesel fuel.
- (2) The pumps and components shall be either CSA or ULC approved.
- (3) Complete with lighting box.
- (4) Fuel pumps shall be dispenser type Gasboy Model 9853KXTW1
- (5) Fuel pumps shall be capable of delivering a minimum of sixty (60) and maximum of 80 litres per minute per hose
- (6) Fuel pumps shall be dual pump, twin hose type, single product.
- (7) Fuel pumps shall be weights and measures certified.
- (8) Fuel Pumps shall be automatic temperature compensated.
- (9) Fuel pump housing (cabinet) which includes top, sides and door panels shall be of stainless steel construction
- (10) Fuel pumps shall have mechanical totalizer for totals.
- (11) Fuel pumps shall have built-in, temperature controlled heaters.
- (12) Fuel pumps shall have commercial 1 inch, backlit displays.
- (13) Fuel pumps hoses- shall be a 1 inch x twelve (12) foot long, low temperature Arctic, c/w MxMS fittings.
- (14) Breakaways-1 inch, OPW, reconnectable type, required.
- (15) Whip hose-1 inch x 12 inches, MxM fittings required.
- (16) Nozzles- OPW, 7H nozzles required, c/w hand warmers, splash guards.
- (17) Auto shut off capability available but clips not installed.

- (18) All required framing, mounting hardware, insulators, shall be supplied and installed by the Contractor. Whereas dissimilar metals may come in contact, long life Cathodic Protection shall be provided and installed.
- (19) A leak/pressure test shall be conducted by the Contractor according to the requirements specified by the Manufacturer. A letter or certificate shall be supplied by the Contractor as to the test criteria and the test results.
- (20) All stainless components shall be left in their natural state. All steel components shall be properly cleaned, primed and finished with steel components sandblasted, primed and painted white with two (2) coats of polyurethane enamel, Dupont Imron or Akzo Sikkens.
- (21) High hose hangers shall be supplied and installed.
- (22) Fire Suppression Equipment shall be included.
- (23) The completed Work and all components required to perform the Work shall comply with all the requirements of Manitoba Environment, Fire Code regulations and other regulations pertaining to fuel sites.
- (24) The Work to be performed requires thorough knowledge of and experience with the supply and installation of fuel dispensing systems
- (25) Electrical work shall be performed by qualified, licensed electricians
- (26) The Contractor shall be fully qualified, having the necessary qualified personnel and equipment to carry out the work described herein. The Contractor shall have a minimum of two (2) staff members who are trained and experienced in the installation and operation of fuel dispensing systems

(b) Supply and Install Fuel Tanks

Supply and install fuel tanks in conformance with all applicable regulations and permit requirements whether specifically named or not below. The tanks shall meet the following criteria:

- (1) Compatible with biodiesel fuel, ultra low sulphur diesel fuel and marked diesel fuel.
- (2) Shall be in compliance with all applicable provisions of the CCME Environmental Code of Practice for Aboveground and Underground Storage Tank Systems Containing Petroleum and Allied Petroleum Products, PN 1326, 2003 (CCME Code) and must be eligible for permitting under Manitoba Regulation 188/2001.
- (3) The fuel storage tank capacity shall be a 50,000 litre double-walled tank constructed in conformance with UL S615-98. The fuel storage tank shall be a two compartment tank with compartment sizes of 20,000 and 30,000 litres respectively.
- (4) The fuel storage tank shall be designed with sufficient fittings for vent and supply piping for each compartment, plus a fitting at the centre of each compartment for the installation of tank monitoring equipment.
- (5) The fuel tank shall be capable of burial up to 2.13 metres below grade level. The tank shall be anchored in accordance with the manufacturer's specifications.
- (6) Piping- Underground piping designed to convey product shall be 2" double walled flexible piping constructed in conformance ULC–ORD-C971-2005. Vent piping shall be constructed in conformance with the National Fire Code of Canada (2005).
- (7) Pumping system- Each tank compartment shall be equipped with a 3/4hp submersible turbine pump, with each pump supplying a separate dispenser location.
- (8) Containment Systems- Containment systems shall be provided and installed at the tank and dispensers in conformance with the CCME Code.
- (9) Leak Detection- Leak detection systems shall be provided at the tank and dispenser containment systems and tank interstitial space in conformance with the CCME Code. All leak detection systems on containment sumps and interstitial spaces shall be provided with interlocks to the in-tank monitoring system. A manual leak detector shall be provided for each turbine pump
- (10) Concrete Pad- A 150 mm reinforced concrete slab shall be placed over the storage and the fuelling area. The concrete slab shall be graded to ensure that all run-off is directed to one or more catch basins installed on the site.

(c) Supply and Install Fuel Tank Monitoring System

Each tank compartment shall be equipped with a tank monitoring system designed to provide continuous inventory monitoring, leak detection on sumps and interstitial spaces and periodic leak testing of the storage tank compartment in compliance with unmanned site operation fuel regulations.

The tank monitoring system shall be the Veeder Root TLS 350R system with features as described below:

- (1) The system shall provide continuous monitoring of liquid (product and water) levels and product temperature in the storage tank
- (2) The system shall be capable of providing continuous statistical leak detection with the capability of meeting a monthly leak detection performance standard of 0.76 L/hr with a 95% probability of detection and 5% probability of false alarm.
- (3) The system shall be equipped the required probes to accommodate monitoring of tank and dispenser containment sumps and the interstitial space on the storage tank.
- (4) The tank monitoring system must be capable of interfacing with the fuel management system described below.
- (5) The tank monitoring system shall be provided with visual and audible alarms of all system conditions that may be an indication of leakage or equipment malfunction
- (6) The tank monitoring system shall include a remote display with the ability to display inventory information, delivery data, leak test data, equipment status, and alarm history
- (7) The system shall be capable of generating reports in a screen display or print format.

(d) Supply and Install Fuel Islands

- (1) A 5' wide x 6' length x 1' high metal form concrete pump island shall be installed at each dispenser location.
- (2) 8 inch diameter, Schedule 40, U shaped pipe bollards shall be installed at each end of the pump islands.

(e) Lighting

(1) Two 400W metal halide downlight luminaires mounted on one 25' (7.5m) high pole with a two-sided cross-arm. The cross-arm is to be oriented perpendicular to the line interconnecting the two dispensers. The luminaires are to be Lithonia KAD 400M SR3 or equivalent, complete with 400W MH lamps, and controlled by photocell (on) and time-clock (off).

(f) Back up Generator

A CumminsPower Generation DG-series commercial generator set model DGBC 60 HZ shall be installed in proximity of the building, and power all site requirements for the fuel system, communications system and lighting system. The generator set DGBC 60 HZ has the following add on features:

- (1) Transfer Switch
- (2) Enclosure and tanks

(g) Fully automated fuel management system

The fully automated fuel management system shall be the Coencorp <u>FleetZone</u> Integrated Fleet Management Platform. The Coencorp solution has been selected as the automated

fuel management system for this fuel station as it address several critical, interrelated operational areas by providing:

- Fully automated wireless capture of vehicular data and preventive maintenance scheduling
- Unattended control, tracking and reconciliation of fuel and other fluid consumables
- Yard and building access control
- Employee attendance tracking
- Extensive system customization
- Maintenance and technical support services

The system shall be set up so that a vehicle will fuel up and drive away, and the system will automatically and transparently perform validations while capturing fuel and vehicle data. This fully automated fuel management system shall require no human intervention to capture data. The fuel management system includes the following features::

- (1) Unattended, secure access to fuel 24 hours a day, 7 days a week
- (2) Physically guarantee that fuel is dispensed to authorized vehicles only
- (3) Automatically record and reconcile fuel consumption to inventories including recording all data needed for fuel inventory reconciliation including storage tank levels, product deliveries and pump totalizers.
- (4) One wireless fuel island terminal (PCU).
- (5) Wireless installation that is non disruptive.
- (6) Wireless link to reach a minimum of 2000 feet.
- (7) Ability to cut off the flow of fuel whenever nozzle is removed from vehicle to eliminate fuel spillage.
- (8) Notify of storage tanks leaks.
- (9) Protection and electrical isolation from outdoor equipment
- (10) No special dispenser nozzle, hose or fittings needed
- (11) Plug-and-play Vehicle Data Unit installation, no configuration or calibration
- (12) Connects directly to the engine computer where available.
- (13) Supports speed and ignition sensor on older equipment where the engine computer is not available.
- (14) Supports any identification technology including but not limited to RFID, mag stripe, iButton.
- (15) Supports connectivity with the existing Computrol fuel management system already in place at other Winnipeg Fleet Management Agency fuel sites.
- (16) Ability to capture fuel information through fuel management software to include modules on fueling transactions, fuel inventory, and access control and attendance module.
- (17) The software has a network multi-user operation: all updates are immediately visible to all users, multiple sites managed from a single, central database, ensure that site data is collected automatically over private network, phone line, cellular or the Internet, has a full featured data import/export engine: no programming needed and is extensively customizable.
- (18) The Fueling Transaction module of the fuel management software has the following features
 - Detailed account of fuel dispensed
 - Detailed account of shop fluids dispensed (engine oil, transmission oil, etc.)

- Vehicle performance analysis
- Automatic quarantine of suspicious transactions
- Excessive fuel consumption exception report
- Fuel cost per vehicle, employee, cost center, etc.
- Capture of defect codes at fuel time
- Complete reporting package
- (19) The Fuel Inventory module of the fuel management software has the following features:
 - Detailed account of fuel deliveries
 - Automatic record of storage tank level gauging
 - In Transit Visibility (ITV)
 - Automatic recording of fuel deliveries
 - Automatic recording of pump totalizers for both mechanical and electronic pumps
 - Automatic inventory reconciliation
 - Daily reconciliation of inventories versus dispensed fuel
 - Immediate notification of storage tank leaks by e-mail and pager
 - Complete reporting package
- (20) The access control and attendance module of the fuel management software has the following features:
 - Weekdays and weekend scheduling
 - Exception and holiday scheduling
 - Electronic punch, regular and overtime worked hours
 - Detailed gate access transactions
 - Detailed door access transactions
 - Detailed account of vehicle and personnel entry/exit
 - Complete reporting package
- (21) Wirelessly capture and time stamp complete vehicular information within seconds from entering the field of a data collector. Vehicle information to capture includes the following:
 - Mileage
 - Trip mileage
 - Engine hours
 - Trip engine hours
 - Engine idling time
 - Engine fault codes

- Any custom data
- (22) Vehicles are detected from a minimum of 500 ft from the data collector.

(h) <u>Ensure synchronization with total fuel distribution system, current I.T. equipment,</u> <u>technology and architecture</u>

- (1) All components for the fuel distribution system will be synchronized, including synchronization between fuel pumps, fuel tanks, fuel tank monitoring system and the fully automated fuel management system.
- (2) All components supplied and installed will be synchronized with Winnipeg Fleet Management Agency's Information Technology Environment

(i) Supply and install any other components required to have an operational fuel site

(1) All parts not specifically mentioned but which are required to complete and place the fuel station into successful operation shall be furnished as though specifically mentioned in this proposal.
