  - ANY FIELD WELDING SHALL BE TOUCHED UP WITH 'CLOVA-ZINC 1' PAINT OR EQUIVALENT COATING.
  - TYPICAL WELD: 5V
  - ALL REINFORCING EMBEDS THAT INVOLVE WELDING SHALL BE WELDABLE.
  - ALL COPING AND RAIL'S PAINTED WITH RUST PAINT INSTEAD OF GALVANIZED.
  - REVEAL CONTINUES THROUGH THE FLAT PART OF ANY HUBBA LEDGE THAT IS CONNECTED TO A FLAT LEDGE MEANS THE FLAT LEDGE "SHADOW LINE" (DETAIL 11,12,14) ONLY APPLIES TO FLAT LEDGES THAT ARE FREE STANDING OR ON THEIR OWN NOT HUBBA /FLAT LEDGES COMBOS.
  - REFER TO SPECIFICATIONS OF HUBBA REVEAL, COPING AND RAIL.
