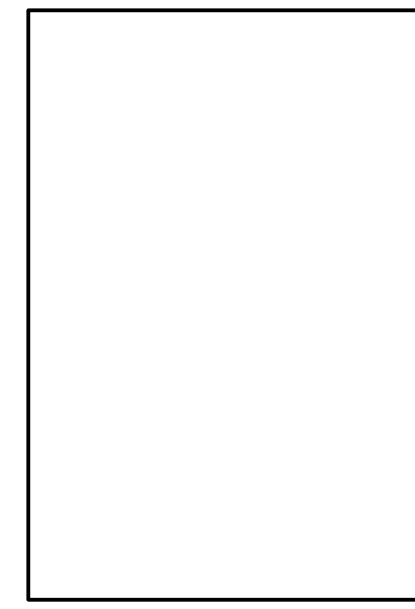
ELECTRICAL 114 - NORTH

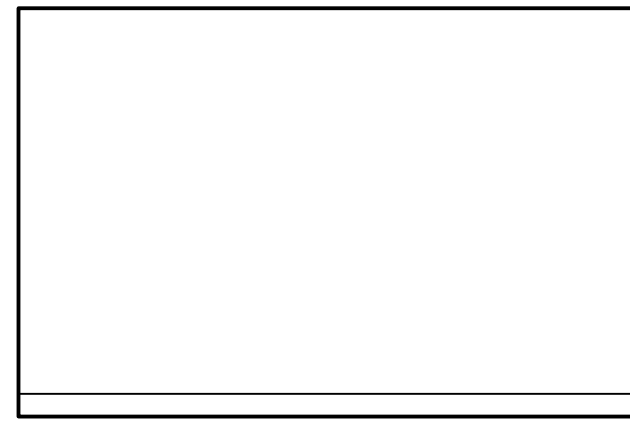
ELECTRICAL 114 - EAST

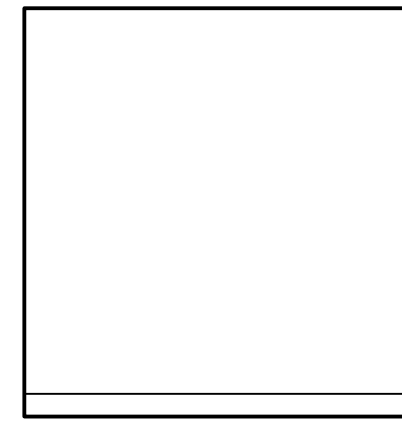
ELECTRICAL 114 - SOUTH

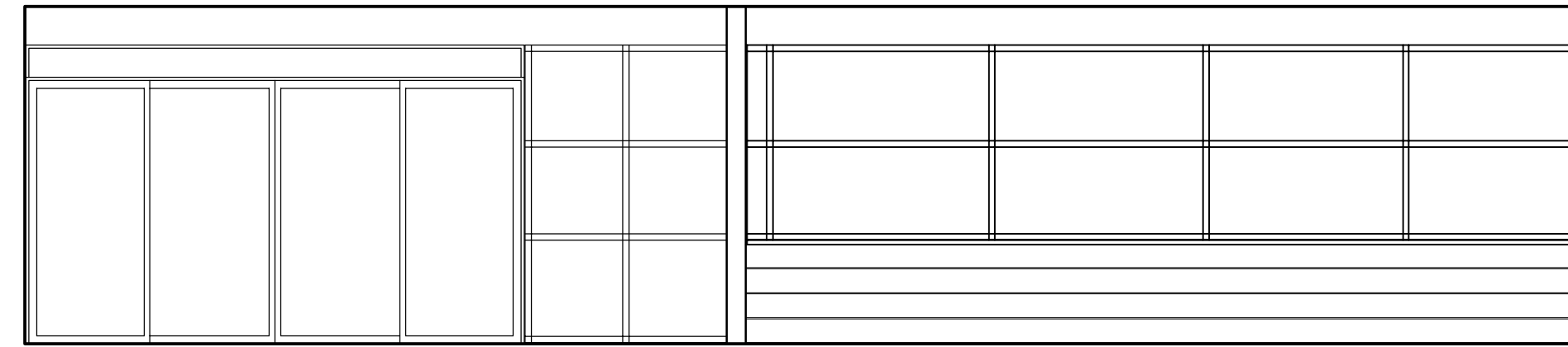

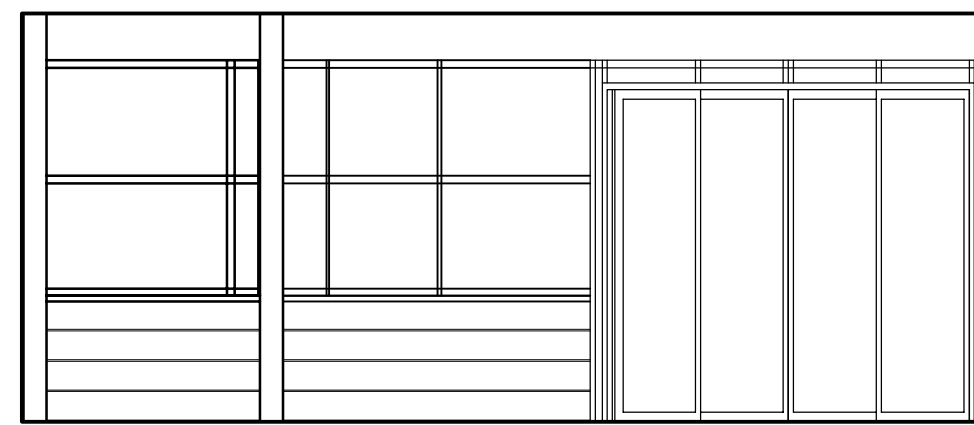

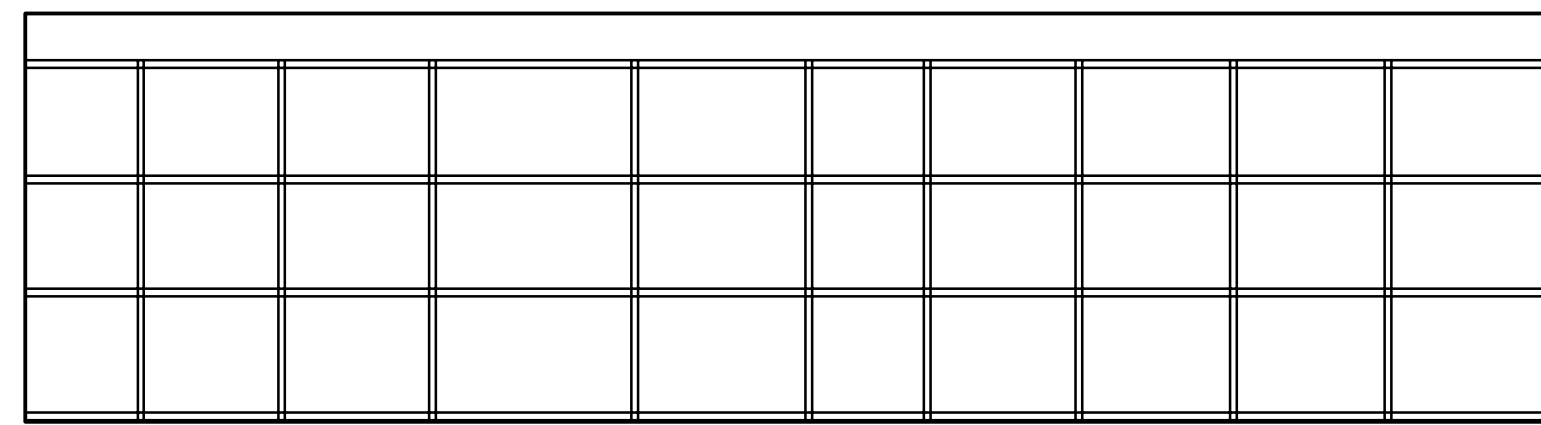
VESTIBULE 101 - NORTH
