Location: St. John's Park, Anderson @ St. Cross **Installation:** Install on existing concrete slab
- 1b. **TRAILHEAD SIGN** - trailhead panel same as at south end. Located at south entrance to park.
Location: Kildonan Park south entrance **Installation:** Install on new concrete slab (in planting bed)
2. **"GREENSPACE & PRAYER"**
Location: Adjacent to the most northerly entrance pathway in St. John's Park, near Mortimer Place. **Installation:** Install on new concrete slab
3. **"FROM SETTLEMENT TO COMMUNITY"**
Location: Polson Pump Station **Installation:** Install on existing concrete slab
4. **"CLASSROOMS & CATTLE"**
Location: Polson Pump Station **Installation:** Install on existing concrete slab
5. **"UKRAINIAN & JEWISH COMMUNITIES"**
Location: Street right-of way, directly in front of Ukrainian Catholic Archeparchy (235 Scotia@ Smithfield) **Installation:** Install on new concrete slab

Location: Volunteer Park adjacent to sidewalk **Installation:** Install on existing concrete slab
7. **"VOLUNTEER PARK & 1997 FLOOD"**-
Location: Volunteer Park, adjacent to sidewalk **Installation:** Install on existing concrete slab
8. **"AGRICULTURE & EARLY YEARS OF SETTLEMENT"**
Location: Jefferson Pump Station **Installation:** Install on existing concrete slab
9. **"THE SCOUNDREL & THE LAWYER"**
Location: New Marymount Plaza **Installation:** Install on existing concrete slab
10. **"MARYMOUND- FINDING THE GOOD"**
Location: New Marymount Plaza **Installation:** Install on existing concrete slab
