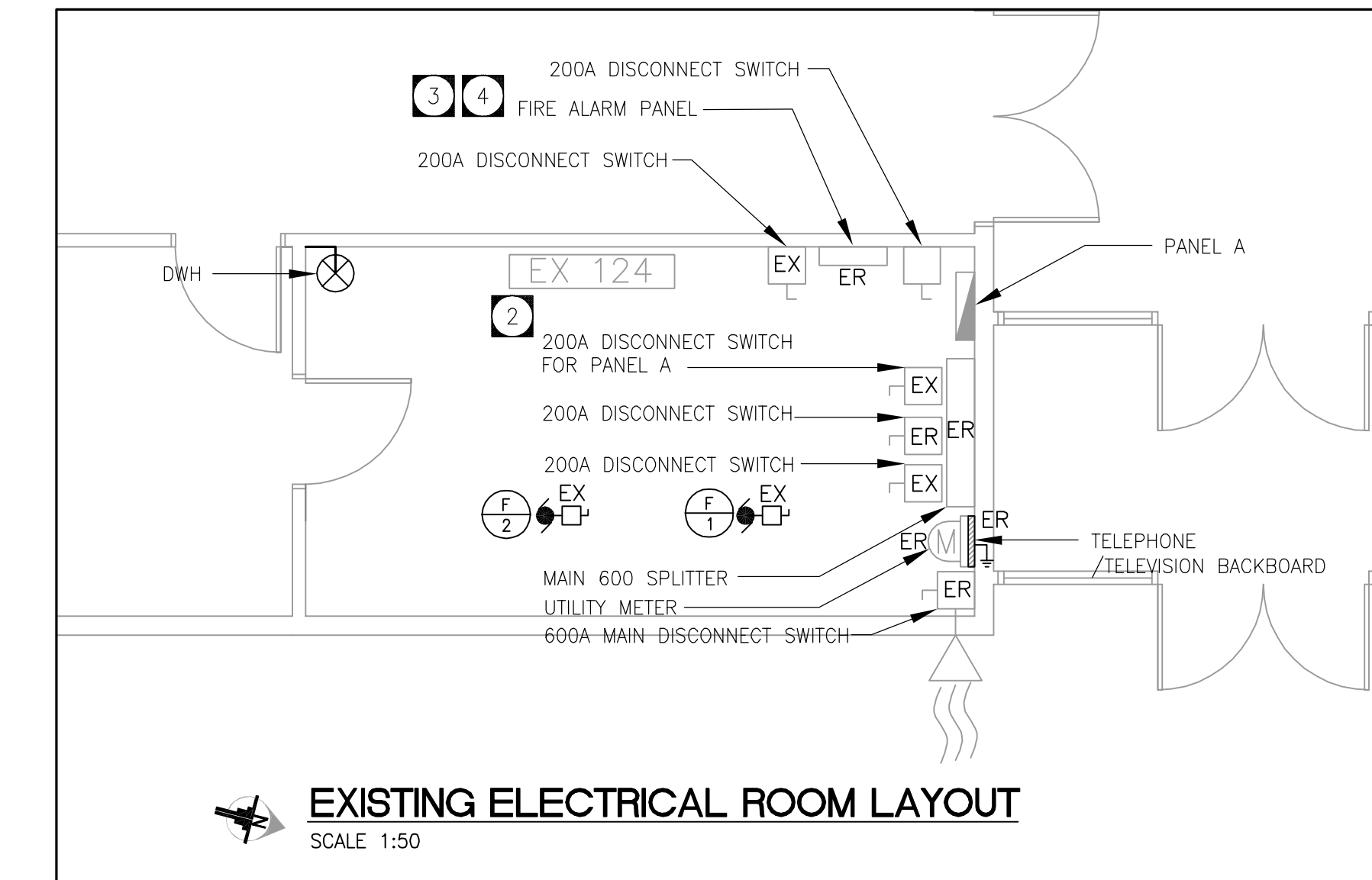


**MAIN FLOOR DEMO PLAN**

- 1 THIS AREA TO BE DEMOLISHED AND RENOVATED. DEVICES SHOWN ARE FOR REFERENCE ONLY AND DO NOT NECESSARILY INDICATE EVERY EXISTING DEVICE AND/OR OUTLET. DISCONNECT AND REMOVE ALL UNUSED DEVICES, OUTLETS, CONDUITS, MECHANICAL EQUIPMENT AND ALL ASSOCIATED WIRING BACK TO RESPECTIVE PANELS UNLESS OTHERWISE NOTED. REFER TO ELECTRICAL DRAWINGS E-2.0 AND E-3.0 FOR NEW/RELOCATED LOCATIONS OF EXISTING OUTLETS/DEVICES. MAKE ALL PROVISIONS TO RELOCATE EQUIPMENT AND DEVICES REQUIRED TO BE RELOCATED.
- NOTE: REFER TO ARCHITECTURAL FOR COMPLETE SCOPE OF RENOVATION AND MECHANICAL DEMOLITION DRAWINGS.
- 2 ALL ELECTRICAL DEVICES ALONG WALL TO REMAIN.
- 3 REPLACE EXISTING FIRE ALARM PANEL WITH NEW SINGLE STAGE ADDRESSIBLE 5 SIGNAL ZONE PANEL C/W BATTERY BACK-UP. ENSURE THAT IT IS OPERATIONAL BEFORE REMOVING THE EXISTING FIRE ALARM PANEL. COORDINATE WITH THE CONTRACT ADMINISTRATOR FOR PHASING.
- 4 REPLACE ALL EXISTING FIRE ALARM CONVENTIONAL DEVICES WITH ADDRESSIBLE TYPE. CONTRACTOR SHALL CONFIRM ONSITE FOR EXACT NUMBER AND LOCATION. (TYP)
- 5 EXISTING LIGHTING TO REMAIN. RELOCATE EXISTING LIGHT SWITCHES AS INDICATED ON DRAWING E-3.0.
- 6 MAKE ALL PROVISIONS AND COORDINATE WITH ELECTRIC UTILITY TO DISCONNECT AND REMOVE THE UTILITY TRANSFORMER AND POLE AS WELL AS ALL ASSOCIATED HARDWARE AND WIRES.
- 7 REMOVE EXISTING SOUTH RINK 'PANEL S' AND RETURN TO NORBERRY-GLENLEE COMMUNITY CENTRE FOR FUTURE USE.
- 8 MAKE ALL PROVISIONS AND COORDINATE WITH THE TELEPHONE/TELEVISION UTILITY TO REROUTE THE TELEPHONE/TELEVISION CABLE TO THE NEW TELEPHONE/TELEVISION BACKBOARD.
