Replace: 182-2009_Bid Submission with 182-2009_Addendum 2-Bid Submission. The following is a summary of changes incorporated in the replacement Bid Submission:

Form B(R1): Add Separate Price - Item No. 1A.

PART B – BIDDING PROCEDURES

- Revise: B2.1 to read: The Submission Deadline is 4:00 p.m. Winnipeg time, May 12, 2009.
- Revise: B9.2 to read: The Bidder shall state a separate price in Canadian funds for each of the following items of Work on Form B: Prices:
 - (a) Separate Price Item No. 1 shall be the amount to be deducted from the lump sum price if unit heater UH-1 specified in Specification Sections 23 06 80.13 and 23 82 39.19 is deleted;
 - (b) Separate Price Item No. 1A shall be the amount to be deducted from the lump sum price if the requirement to turn over and deliver decommissioned return fan F-1 and associated controls to the City as specified in Specification Section 23 05 01 Clause 1.5.2 is deleted, and removal and disposal is in accordance with 23 05 01 Clause 1.5.1;
 - (c) Separate Price Item No. 2 shall be the amount to be deducted from the lump sum price if the return air and supply air airflow measuring station and associated controls specified in Specification Sections 23 09 33 and 23 09 33.13 are deleted;
 - (d) Separate Price Item No. 3 shall be the amount to be deducted from the lump sum price if:
 - silencers SA-1 and SA-2 specified in Specification Sections 23 06 30.29 and 23 33 01 are deleted, and replaced with acoustically lined duct specified in Specification Section 23 07 13; and
 - (ii) the air handling unit AHU-2 fan section external vibration rail specified in Specification Sections 23 05 48 is deleted.
- Revise: B14.4 (b) to read: if the lowest evaluated responsive Bid submitted by a responsible and qualified Bidder exceeds the budgetary provision for the Work, the lump sum prices of all responsive Bids submitted by responsible and qualified Bidders will be adjusted by progressively deducting separate prices in the order listed in B9.2 until a Total Bid Price within the budgetary

provision is achieved, i.e., Total Bid Price = Lump Sum Price - Separate Price No. 1 - Separate Price No. 1A - Separate Price No. 2 - Separate Price No. 3.
