PART B - BIDDING PROCEDURES

B1. CONTRACT TITLE

2009 ALLEY RENEWAL PROGRAM – NORTH AREA – CONTRACT I

B1.1

B2. SUBMISSION DEADLINE

B2.1 The Submission Deadline is 12:00 noon Winnipeg time, May 27, 2009.

B2.2 Bids determined by the Manager of Materials to have been received later than the Submission Deadline will not be accepted and will be returned upon request.

B2.3 The Contract Administrator or the Manager of Materials may extend the Submission Deadline by issuing an addendum at any time prior to the time and date specified in B2.1.

B3. ENQUIRIES

B3.1 All enquiries shall be directed to the Contract Administrator identified in D3.1.

B3.2 If the Bidder finds errors, discrepancies or omissions in the Bid Opportunity, or is unsure of the meaning or intent of any provision therein, the Bidder shall notify the Contract Administrator of the error, discrepancy or omission, or request a clarification as to the meaning or intent of the provision at least five (5) Business Days prior to the Submission Deadline.

B3.3 Responses to enquiries which, in the sole judgment of the Contract Administrator, require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator to all Bidders by issuing an addendum.

B3.4 Responses to enquiries which, in the sole judgment of the Contract Administrator, do not require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator only to the Bidder who made the enquiry.

B3.5 The Bidder shall not be entitled to rely on any response or interpretation received pursuant to B3 unless that response or interpretation is provided by the Contract Administrator in writing.

B4. ADDENDA

B4.1 The Contract Administrator may, at any time prior to the Submission deadline, issue addenda correcting errors, discrepancies or omissions in the Bid Opportunity, or clarifying the meaning or intent of any provision therein.

B4.2 The Contract Administrator will issue each addendum at least two (2) Business Days prior to the Submission Deadline, or provide at least two (2) Business Days by extending the Submission Deadline.

B4.2.1 Addenda will be available on the Bid Opportunities page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <http://www.winnipeg.ca/matmgt/bidopp.asp>

B4.2.2 The Bidder is responsible for ensuring that he has received all addenda and is advised to check the Materials Management Division website for addenda regularly and shortly before the Submission Deadline, as may be amended by addendum.

B4.3 The Bidder shall acknowledge receipt of each addendum in Paragraph 10 of Form A: Bid. Failure to acknowledge receipt of an addendum may render a Bid non-responsive.

B5. SUBSTITUTES

- B5.1 The Work is based on the Plant, Materials and methods specified in the Bid Opportunity.
- B5.2 Substitutions shall not be allowed unless application has been made to and prior approval has been granted by the Contract Administrator in writing.
- B5.3 Requests for approval of a substitute will not be considered unless received in writing by the Contract Administrator at least five (5) Business Days prior to the Submission Deadline.
- B5.4 The Bidder shall ensure that any and all requests for approval of a substitute:
- (a) provide sufficient information and details to enable the Contract Administrator to determine the acceptability of the Plant, Material or method as either an approved equal or alternative;
 - (b) identify any and all changes required in the applicable Work, and all changes to any other Work, which would become necessary to accommodate the substitute;
 - (c) identify any anticipated cost or time savings that may be associated with the substitute;
 - (d) certify that, in the case of a request for approval as an approved equal, the substitute will fully perform the functions called for by the general design, be of equal or superior substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance;
 - (e) certify that, in the case of a request for approval as an approved alternative, the substitute will adequately perform the functions called for by the general design, be similar in substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance.
- B5.5 The Contract Administrator, after assessing the request for approval of a substitute, may in his sole discretion grant approval for the use of a substitute as an “approved equal” or as an “approved alternative”, or may refuse to grant approval of the substitute.
- B5.6 The Contract Administrator will provide a response in writing, at least two (2) Business Days prior to the Submission Deadline, only to the Bidder who requested approval of the substitute.
- B5.6.1 The Bidder requesting and obtaining the approval of a substitute shall be entirely responsible for disseminating information regarding the approval to any person or persons he wishes to inform.
- B5.7 If the Contract Administrator approves a substitute as an “approved equal”, any Bidder may use the approved equal in place of the specified item.
- B5.8 If the Contract Administrator approves a substitute as an “approved alternative”, any Bidder bidding that approved alternative may base his Total Bid Price upon the specified item but may also indicate an alternative price based upon the approved alternative. Such alternatives will be evaluated in accordance with B14.
- B5.9 No later claim by the Contractor for an addition to the Total Bid Price because of any other changes in the Work necessitated by the use of an approved equal or an approved alternative will be considered.
- B5.10 Notwithstanding B5.2 to B5.9, in accordance with B6.6, deviations inconsistent with the Bid Opportunity document shall be evaluated in accordance with B14.1(a).

B6. BID COMPONENTS

B6.1 The Bid shall consist of the following components:

- (a) Form A: Bid;
- (b) Form B: Prices, hard copy;
- (c) Bid Security;
 - (i) Form G1: Bid Bond and Agreement to Bond, or
Form G2: Irrevocable Standby Letter of Credit and Undertaking, or
a certified cheque or draft.

B6.2 Further to B6.1, the Bidder should include the written correspondence from the Contract Administrator approving a substitute in accordance with B5.

B6.3 All components of the Bid shall be fully completed or provided, and submitted by the Bidder no later than the Submission Deadline, with all required entries made clearly and completely, to constitute a responsive Bid.

B6.4 The Bid shall be submitted enclosed and sealed in an envelope clearly marked with the Bid Opportunity number and the Bidder's name and address.

B6.4.1 Samples or other components of the Bid which cannot reasonably be enclosed in the envelope may be packaged separately, but shall be clearly marked with the Bid Opportunity number, the Bidder's name and address, and an indication that the contents are part of the Bidder's Bid.

B6.4.2 A hard copy of Form B: Prices must be submitted with the Bid. If there is any discrepancy between the Adobe PDF version of Form B: Prices and the Microsoft Excel version of Form B: Prices, the PDF version shall take precedence.

B6.5 Bidders are advised not to include any information/literature except as requested in accordance with B6.1.

B6.6 Bidders are advised that inclusion of terms and conditions inconsistent with the Bid Opportunity document, including the General Conditions, will be evaluated in accordance with B14.1(a).

B6.7 Bids submitted by facsimile transmission (fax) or internet electronic mail (e-mail) will not be accepted.

B7. BID

B7.1 The Bidder shall complete Form A: Bid, making all required entries.

B7.2 Paragraph 2 of Form A: Bid shall be completed in accordance with the following requirements:

- (a) if the Bidder is a sole proprietor carrying on business in his own name, his name shall be inserted;
- (b) if the Bidder is a partnership, the full name of the partnership shall be inserted;
- (c) if the Bidder is a corporation, the full name of the corporation shall be inserted;

- (d) if the Bidder is carrying on business under a name other than his own, the business name and the name of every partner or corporation who is the owner of such business name shall be inserted.

B7.2.1 If a Bid is submitted jointly by two or more persons, each and all such persons shall identify themselves in accordance with B7.2.

B7.3 In Paragraph 3 of Form A: Bid, the Bidder shall identify a contact person who is authorized to represent the Bidder for purposes of the Bid.

B7.4 Paragraph 12 of Form A: Bid shall be signed in accordance with the following requirements:

- (a) if the Bidder is a sole proprietor carrying on business in his own name, it shall be signed by the Bidder;
- (b) if the Bidder is a partnership, it shall be signed by the partner or partners who have authority to sign for the partnership;
- (c) if the Bidder is a corporation, it shall be signed by its duly authorized officer or officers and the corporate seal, if the corporation has one, shall be affixed;
- (d) if the Bidder is carrying on business under a name other than his own, it shall be signed by the registered owner of the business name, or by the registered owner's authorized officials if the owner is a partnership or a corporation.

B7.4.1 The name and official capacity of all individuals signing Form A: Bid should be printed below such signatures.

B7.5 If a Bid is submitted jointly by two or more persons, the word "Bidder" shall mean each and all such persons, and the undertakings, covenants and obligations of such joint Bidders in the Bid and the Contract, when awarded, shall be both joint and several.

B8. PRICES

B8.1 The Bidder shall state a price in Canadian funds for each item of the Work identified on Form B: Prices.

B8.1.1 For the convenience of Bidders, and pursuant to B6.4.2 and B14.4.3, an electronic spreadsheet Form B: Prices in Microsoft Excel (.xls) format is available along with the Adobe PDF documents for this Bid Opportunity on the Bid Opportunities page at the Materials Management Division website at <http://www.winnipeg.ca/matmgt>

B8.2 The quantities listed on Form B: Prices are to be considered approximate only. The City will use said quantities for the purpose of comparing Bids.

B8.3 The quantities for which payment will be made to the Contractor are to be determined by the Work actually performed and completed by the Contractor, to be measured as specified in the applicable Specifications.

B8.4 Prices from Non-Resident Bidders are subject to a Non-Resident Withholding Tax pursuant to the Income Tax Act (Canada).

B9. QUALIFICATION

B9.1 The Bidder shall:

- (a) undertake to be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba; and
- (b) be financially capable of carrying out the terms of the Contract; and
- (c) have all the necessary experience, capital, organization, and equipment to perform the Work in strict accordance with the terms and provisions of the Contract.

- B9.2 The Bidder and any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
- (a) be responsible and not be suspended, debarred or in default of any obligations to the City. A list of suspended or debarred individuals and companies is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <http://www.winnipeg.ca/matmgt/debar.stm>
- B9.3 The Bidder and/or any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
- (a) have successfully carried out work similar in nature, scope and value to the Work; and
 - (b) be fully capable of performing the Work required to be in strict accordance with the terms and provisions of the Contract; and
 - (c) have a written workplace safety and health program if required pursuant to The Workplace Safety and Health Act (Manitoba).
- B9.4 Further to B9.3(c), the Bidder shall, within five (5) Business Days of a request by the Contract Administrator, provide proof satisfactory to the Contract Administrator that the Bidder/Subcontractor has a workplace safety and health program meeting the requirements of The Workplace Safety and Health Act (Manitoba), by providing:
- (a) a valid COR certification number under the Certificate of Recognition (COR) Program administered by the Manitoba Construction Safety Association or by the Manitoba Heavy Construction Association's Safety, Health and Environment Program; or
 - (b) a report or letter to that effect from an independent reviewer acceptable to the City. (A list of acceptable reviewers and the review template are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <http://www.winnipeg.ca/matmgt>)
- B9.5 The Bidder shall submit, within three (3) Business Days of a request by the Contract Administrator, proof satisfactory to the Contract Administrator of the qualifications of the Bidder and of any proposed Subcontractor.
- B9.6 The Bidder shall provide, on the request of the Contract Administrator, full access to any of the Bidder's equipment and facilities to confirm, to the Contract Administrator's satisfaction, that the Bidder's equipment and facilities are adequate to perform the Work.

B10. BID SECURITY

- B10.1 The Bidder shall provide bid security in the form of:
- (a) a bid bond, in the amount of at least ten percent (10%) of the Total Bid Price, and agreement to bond of a company registered to conduct the business of a surety in Manitoba, in the form included in the Bid Submission (Form G1: Bid Bond and Agreement to Bond); or
 - (b) an irrevocable standby letter of credit, in the amount of at least ten percent (10%) of the Total Bid Price, and undertaking issued by a bank or other financial institution registered to conduct business in Manitoba and drawn on a branch located in Winnipeg, in the form included in the Bid Submission (Form G2: Irrevocable Standby Letter of Credit and Undertaking); or
 - (c) a certified cheque or draft payable to "The City of Winnipeg", in the amount of at least fifty percent (50%) of the Total Bid Price, drawn on a bank or other financial institution registered to conduct business in Manitoba.
- B10.1.1 If the Bidder submits alternative bids, the bid security shall be in the amount of the specified percentage of the highest Total Bid Price submitted.
- B10.1.2 All signatures on bid securities shall be original.
- B10.1.3 The Bidder shall sign the Bid Bond.

- B10.1.4 The Surety shall sign and affix its corporate seal on the Bid Bond and the Agreement to Bond.
- B10.2 The bid security of the successful Bidder and the next two lowest evaluated responsive and responsible Bidders will be released by the City when a Contract for the Work has been duly executed by the successful Bidder and the performance security furnished as provided herein. The bid securities of all other Bidders will be released when a Contract is awarded.
- B10.2.1 Where the bid security provided by the successful Bidder is in the form of a certified cheque or draft pursuant to B10.1(c), it will be deposited and retained by the City as the performance security and no further submission is required.
- B10.2.2 The City will not pay any interest on certified cheques or drafts furnished as bid security or subsequently retained as performance security.
- B10.3 The bid securities of all Bidders will be released by the City as soon as practicable following notification by the Contract Administrator to the Bidders that no award of Contract will be made pursuant to the Bid Opportunity.

B11. OPENING OF BIDS AND RELEASE OF INFORMATION

- B11.1 Bids will be opened publicly, after the Submission Deadline has elapsed, in the office of the Corporate Finance Department, Materials Management Division, or in such other office as may be designated by the Manager of Materials.
- B11.1.1 Bidders or their representatives may attend.
- B11.1.2 Bids determined by the Manager of Materials, or his designate, to not include the bid security specified in B10 will not be read out.
- B11.2 Following the submission deadline, the names of the Bidders and their Total Bid Prices (unevaluated, and pending review and verification of conformance with requirements) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <http://www.winnipeg.ca/matmgt>
- B11.3 After award of Contract, the name(s) of the successful Bidder(s) and the Contract Amount(s) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <http://www.winnipeg.ca/matmgt>
- B11.4 The Bidder is advised that any information contained in any Bid may be released if required by City policy or procedures, by The Freedom of Information and Protection of Privacy Act (Manitoba), by other authorities having jurisdiction, or by law.

B12. IRREVOCABLE BID

- B12.1 The Bid(s) submitted by the Bidder shall be irrevocable for the time period specified in Paragraph 11 of Form A: Bid.
- B12.2 The acceptance by the City of any Bid shall not release the Bids of the next two lowest evaluated responsive Bidders and these Bidders shall be bound by their Bids on such Work until a Contract for the Work has been duly executed and the performance security furnished as herein provided, but any Bid shall be deemed to have lapsed unless accepted within the time period specified in Paragraph 11 of Form A: Bid.

B13. WITHDRAWAL OF BIDS

- B13.1 A Bidder may withdraw his Bid without penalty by giving written notice to the Manager of Materials at any time prior to the Submission Deadline.

- B13.1.1 Notwithstanding C23.3, the time and date of receipt of any notice withdrawing a Bid shall be the time and date of receipt as determined by the Manager of Materials.
- B13.1.2 The City will assume that any one of the contact persons named in Paragraph 3 of Form A: Bid or the Bidder's authorized representatives named in Paragraph 12 of Form A: Bid, and only such person, has authority to give notice of withdrawal.
- B13.1.3 If a Bidder gives notice of withdrawal prior to the Submission Deadline, the Manager of Materials will:
- (a) retain the Bid until after the Submission Deadline has elapsed;
 - (b) open the Bid to identify the contact person named in Paragraph 3 of Form A: Bid and the Bidder's authorized representatives named in Paragraph 12 of Form A: Bid; and
 - (c) if the notice has been given by any one of the persons specified in B13.1.3(b), declare the Bid withdrawn.
- B13.2 A Bidder who withdraws his Bid after the Submission Deadline but before his Bid has been released or has lapsed as provided for in B12.2 shall be liable for such damages as are imposed upon the Bidder by law and subject to such sanctions as the Chief Administrative Officer considers appropriate in the circumstances. The City, in such event, shall be entitled to all rights and remedies available to it at law, including the right to retain the Bidder's bid security.

B14. EVALUATION OF BIDS

- B14.1 Award of the Contract shall be based on the following bid evaluation criteria:
- (a) compliance by the Bidder with the requirements of the Bid Opportunity, or acceptable deviation therefrom (pass/fail);
 - (b) qualifications of the Bidder and the Subcontractors, if any, pursuant to B9 (pass/fail);
 - (c) Total Bid Price;
 - (d) economic analysis of any approved alternative pursuant to B5.
- B14.2 Further to B14.1(a), the Award Authority may reject a Bid as being non-responsive if the Bid is incomplete, obscure or conditional, or contains additions, deletions, alterations or other irregularities. The Award Authority may reject all or any part of any Bid, or waive technical requirements or minor informalities or irregularities, if the interests of the City so require.
- B14.3 Further to B14.1(b), the Award Authority shall reject any Bid submitted by a Bidder who does not demonstrate, in his Bid or in other information required to be submitted, that he is responsible and qualified.
- B14.4 Further to B14.1(c), the Total Bid Price shall be the sum of the quantities multiplied by the unit prices for each item shown on Form B: Prices.
- B14.4.1 If there is any discrepancy between the Total Bid Price written in figures, the Total Bid Price written in words and the sum of the quantities multiplied by the unit prices for each item, the sum of the quantities multiplied by the unit prices for each item shall take precedence.
- B14.4.2 Further to B14.1(a), in the event that a unit price is not provided on Form B: Prices, the City will determine the unit price by dividing the Amount (extended price) by the approximate quantity, for the purposes of evaluation and payment.
- B14.4.3 The electronic Form B: Prices and the formulas imbedded in that spreadsheet are only provided for the convenience of Bidders. The City makes no representations or warranties as to the correctness of the imbedded formulas. It is the Bidder's responsibility to ensure the extensions of the unit prices and the sum of Total Bid Price performed as a function of the formulas within the electronic Form B: Prices are correct.

B15. AWARD OF CONTRACT

- B15.1 The City will give notice of the award of the Contract or will give notice that no award will be made.
- B15.2 The City will have no obligation to award a Contract to a Bidder, even though one or all of the Bidders are determined to be responsible and qualified, and the Bids are determined to be responsive.
- B15.2.1 Without limiting the generality of B15.2, the City will have no obligation to award a Contract where:
- (a) the prices exceed the available City funds for the Work;
 - (b) the prices are materially in excess of the prices received for similar work in the past;
 - (c) the prices are materially in excess of the City's cost to perform the Work, or a significant portion thereof, with its own forces;
 - (d) only one Bid is received; or
 - (e) in the judgment of the Award Authority, the interests of the City would best be served by not awarding a Contract.
- B15.3 Where an award of Contract is made by the City, the award shall be made to the responsible and qualified Bidder submitting the lowest evaluated responsive Bid, in accordance with B14.
- B15.3.1 Following the award of contract, a Bidder will be provided with information related to the evaluation of his Bid upon written request to the Contract Administrator.

PART C - GENERAL CONDITIONS

C0. GENERAL CONDITIONS

- C0.1 The *General Conditions for Construction* (Revision 2006 12 15) are applicable to the Work of the Contract.
- C0.1.1 The *General Conditions for Construction* are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/gen_cond.stm
- C0.2 A reference in the Bid Opportunity to a section, clause or subclause with the prefix “**C**” designates a section, clause or subclause in the *General Conditions for Construction*.

PART D - SUPPLEMENTAL CONDITIONS

GENERAL

D1. GENERAL CONDITIONS

D1.1 In addition to the General Conditions for Construction, these Supplemental Conditions are applicable to the Work of the Contract.

D2. SCOPE OF WORK

D2.1 The Work to be done under the Contract shall consist of:

- (a) Pavement Reconstruction
 - (i) Fort Street West Alley from North of Graham Avenue to South of Portage Avenue
 - (ii) Kennedy Street / Edmonton Street Alley from Sargent Avenue to Cumberland Avenue
 - (iii) Burnell Street / Arlington Street Alley from St. Matthews Avenue to Ellice Avenue
 - (iv) Sherburn Street / Ingersoll Street Alley from Portage Avenue to St. Matthews Avenue
 - (v) Banning Street / Burnell Street Alley from Wellington Avenue to 190 metres North

D2.2 The major components of the Work are as follows:

- (a) Pavement Reconstruction
 - (i) Removal of existing pavement
 - (ii) Excavation
 - (iii) Installation of catchbasins, sewer services, sewer connections and drainage connection pipes
 - (iv) Installation of subdrains
 - (v) Compaction of existing subgrade
 - (vi) Placement of separation / reinforcement fabric
 - (vii) Placement of geogrid
 - (viii) Placement of sub-base and base course material
 - (ix) Adjustment of existing catchbasins and inlets
 - (x) Construction of 150mm concrete pavement (reinforced)
 - (xi) Installation of lip curb, modified curb and curb ramp
 - (xii) Renewal of existing sidewalk
 - (xiii) Restoration of adjacent surfaces
 - (xiv) Restoration of boulevards

D3. CONTRACT ADMINISTRATOR

D4. CONTRACTOR'S SUPERVISOR

- D4.1 At the pre-construction meeting, the Contractor shall identify his designated supervisor and any additional personnel representing the Contractor and their respective roles and responsibilities for the Work.
- D4.2 At least two (2) business days prior to the commencement of any Work on the site, the Contractor shall provide the Contract Administrator with a phone number where the supervisor identified in D4.1 or an alternate can be contacted twenty-four (24) hours a day to respond to an emergency.

D5. NOTICES

- D6.1 Upon award of the Contract, the Contractor will be provided with five (5) complete sets of the Bid Opportunity. If the Contractor requires additional sets of the Bid Opportunity, they will be supplied to him at cost.

SUBMISSIONS

D7. AUTHORITY TO CARRY ON BUSINESS

- D7.1 The Contractor shall be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba, or if the Contractor does not carry on business in Manitoba, in the jurisdiction where the Contractor does carry on

D9. INSURANCE

- D9.1 The Contractor shall provide and maintain the following insurance coverage:
- (a) commercial general liability insurance, in the amount of at least two million dollars (\$2,000,000.00) inclusive, with The City of Winnipeg added as an additional insured, with a cross-liability clause, such liability policy to also contain contractual liability, unlicensed motor vehicle liability, non-owned automobile liability, broad form property damage cover and products and completed operations, to remain in place at all times during the performance of the Work and throughout the warranty period;
 - (b) automobile liability insurance for owned automobiles used for or in connection with the Work in the amount of at least two million dollars (\$2,000,000.00) at all times during the performance of the Work and until the date of Total Performance;
 - (c) an all risks Installation Floater carrying adequate limits to cover all machinery, equipment, supplies and/or materials intended to enter into and form part of any installation.
- D9.2 Deductibles shall be borne by the Contractor.

D10. PERFORMANCE SECURITY

- D10.1 The Contractor shall provide and maintain performance security until the expiration of the warranty period in the form of:

 - (viii) the detailed work schedule specified in D12; and
- (b) the Contractor has attended a pre-construction meeting with the Contract Administrator, or the Contract Administrator has waived the requirement for a pre-construction meeting.

D13.3 The Contractor shall commence the Work on the Site within seven (7) Working Days of receipt of the letter of intent.

D14. WORKING DAYS

D14.1 Further to C1.1(gg);

D14.1.1 The Contract Administrator will determine daily if a Working Day has elapsed and will record his assessment. On a weekly basis the Contract Administrator will provide the Contractor with a record of the Working Days assessed for the preceding week. The Contractor shall sign each report signifying that he agrees with the Contract Administrator's determination of the Working Days assessed for the report period.

D14.1.2 Work done to restore the Site to a condition suitable for Work, shall not be considered "work" as defined in the definition of a Working Day.

D14.1.3 When the Work includes two or more major types of Work that can be performed under different atmospheric conditions, the Contract Administrator shall consider all major types of Work in determining whether the Contractor was able to work in assessing Working Days.

D15. RESTRICTED WORK HOURS

D15.1 Further to clause 3.10 of CW 1130, the Contractor shall require written permission forty-eight (48) hours in advance from the Contract Administrator for any work to be performed between 2000 hours and 0700 hours, or on Saturdays, Sundays, Statutory Holidays and or Civic Holidays.

D16. WORK BY OTHERS

D16.1 Work by others on or near the Site will include but not necessarily be limited to:

- (a) Manitoba Hydro Gas Division – Lowering and/or rock wrapping of underground gas mains and services, if required;
- (b) Manitoba Hydro - Installing or protecting overhead street lighting cable, repair/relocation of underground services and adjustment of manhole/chambers, if required;
- (c) Manitoba Telecom System – Repair/relocation of underground services and adjustments of manholes/chambers, if required;
- (d) City of Winnipeg Geomatics Branch – Various work on survey monuments, if required; and

D17. SEQUENCE OF WORK

- (a) **Phase 1** – Sta. 1+53 to Sta. 1+85
 - (i) Maintain access to Impark lot between #280 and #292 Fort Street and parking lot between #294 and #308 Fort Street;
 - (ii) Replace catchbasin at Sta. 1+78.9;
 - (iii) Complete all required works up to and including mainline concrete paving; and
 - (iv) Provide temporary granular ramps to existing parking locations during subsequent phasing.
- (b) **Phase 2** – From South Limit of Alley to Sta. 1+53
 - (i) Maintain access to Impark lot between #280 and #292 Fort Street and parking lot between #294 and #308 Fort Street;

- (ii) Complete all required works up to and including mainline concrete paving; and
- (iii) Provide temporary granular ramps to existing parking locations during subsequent phasing.

(c) **Phase 3** – Sta. 1+85 to Fort Street

- (i) Maintain access to Impark lot between #280 and #292 Fort Street and parking lot between #294 and #308 Fort Street;
- (ii) Connect proposed sewer service to existing 300 Concrete Combined Sewer on Fort Street; and
- (iii) Complete all required works up to and including mainline concrete paving.

(d) **Phase 4** – From South Limit of Alley to Fort Street

- (i) Restore adjacent surfaces and approaches; and
- (ii) Curb renewals, concrete boulevard works and sidewalk reconstruction.

D17.2.3 Kennedy Street / Edmonton Street Alley from Sargent Avenue to Cumberland Avenue

(a) **Phase 1** – Sta. 1+73 to Cumberland Avenue

- (i) Maintain access to #454 Edmonton Street parking lot;
- (ii) Complete all required works up to and including mainline concrete paving; and
- (iii) Provide temporary granular ramps to existing parking locations during subsequent phasing.

(b) **Phase 2** – Sargent Avenue to Sta. 1+73

- (i) Complete all required works up to and including mainline concrete paving.

(c) **Phase 3** – Sargent Avenue to Cumberland Avenue

- (i) Restore adjacent surfaces and approaches;
- (ii) Curb renewals, concrete boulevard works and sidewalk reconstruction; and
- (iii) Placing topsoil and finish grading.

D17.2.4 Burnell Street / Arlington Street Alley from St. Matthews Avenue to Ellice Avenue

(a) **Phase 1** – Sta. 2+65 to Sta. 4+17

- (i) Replace catchbasin at Sta. 3+40.41
- (ii) Complete all required works up to and including mainline concrete paving; and
- (iii) Provide temporary granular ramps to existing parking locations during subsequent phasing.

(b) **Phase 2** – Burnell Street to Sta. 2+65

- (i) Install catchbasins, catchpits, drainage connection pipe, sewer service and all underground works;
- (ii) Connect proposed sewer service to existing 2550 Concrete Storm Relief Sewer on Burnell Street;
- (iii) Complete all required works up to and including mainline concrete paving; and
- (iv) Provide temporary granular ramps to existing parking locations during subsequent phasing.

(c) **Phase 3** – Burnell Street to Arlington Street

- (i) Complete all required works up to and including mainline concrete paving.

(d) **Phase 4** – Burnell Street to Arlington Street and Burnell Street to Sta. 4+17

- (i) Restore adjacent surfaces and approaches;
- (ii) Curb renewals, concrete boulevard works and sidewalk reconstruction; and
- (iii) Placing topsoil and finish grading.

D17.2.5 Sherburn Street / Ingersoll Street Alley from Portage Avenue to St. Matthews Avenue

(a) **Phase 1** – Sta. 2+48 to Sta. 4+02

- (i) Complete all required works up to and including mainline concrete paving; and
 - (ii) Provide temporary granular ramps to existing parking locations during subsequent phasing.
- (b) **Phase 2** – Sta. 4+02 to Sta. 5+53
- (i) Replace catchbasin and all underground works;
 - (ii) Complete all required works up to and including mainline concrete paving; and
 - (iii) Provide temporary granular ramps to existing parking locations during subsequent phasing.
- (c) **Phase 3** – Sherburn Street to Sta. 2+48
- (i) Replace catchbasin and all underground works;
 - (ii) Complete all required works up to and including mainline concrete paving; and
 - (iii) Provide temporary granular ramps to existing parking locations during subsequent phasing.
- (d) **Phase 4** – Sta. 5+53 to St. Matthews Avenue
- (i) Remove existing catchbasin;
 - (ii) Install new catchbasin; and
 - (iii) Complete all required works up to and including mainline concrete paving.
- (e) **Phase 5** – Sherburn Street to St. Matthews Avenue
- (i) Restore adjacent surfaces and approaches;
 - (ii) Curb renewals, concrete boulevard works and sidewalk reconstruction; and
 - (iii) Placing topsoil and finish grading.

D17.2.6 Banning Street / Burnell Street Alley from Wellington Avenue to 190m North

- (a) **Phase 1** – Sta. 1+85 to Sta. 2+85
- (i) Complete all required works up to and including mainline concrete paving; and
 - (ii) Provide temporary granular ramps to existing parking locations during subsequent phasing.
- (b) **Phase 2** – Wellington Avenue to Sta. 1+85
- (i) Replace catchbasin; and
 - (ii) Complete all required works up to and including mainline concrete paving.
- (c) **Phase 3** – Wellington Avenue to North Limit of Alley
- (i) Restore adjacent surfaces and approaches;
 - (ii) Curb renewals, concrete boulevard works and sidewalk reconstruction; and
 - (iii) Placing topsoil and finish grading.

D17.2.7 Immediately following the completion of an alley, the Contractor shall clean up the Site and remove all plant, surplus material, waste and debris, other than that left by the City or other Contractors.

D18. SUBSTANTIAL PERFORMANCE

D18.1 The Contractor shall achieve Substantial Performance within sixty (70) consecutive Working Days of the commencement of the Work as specified in D13.

D18.2 When the Contractor considers the Work to be substantially performed, the Contractor shall arrange, attend and assist in the inspection of the Work with the Contract Administrator for purposes of verifying Substantial Performance. Any defects or deficiencies in the Work noted during that inspection shall be remedied by the Contractor at the earliest possible instance and the Contract Administrator notified so that the Work can be re-inspected.

D18.3 The date on which the Work has been certified by the Contract Administrator as being substantially performed to the requirements of the Contract through the issue of a certificate of Substantial Performance is the date on which Substantial Performance has been achieved.

D19. TOTAL PERFORMANCE

D19.1 The Contractor shall achieve Total Performance within sixty five (75) consecutive Working Days of the commencement of the Work as specified in D13.

D19.2 When the Contractor or the Contract Administrator considers the Work to be totally performed, the Contractor shall arrange, attend and assist in the inspection of the Work with the Contract Administrator for purposes of verifying Total Performance. Any defects or deficiencies in the Work noted during that inspection shall be remedied by the Contractor at the earliest possible instance and the Contract Administrator notified so that the Work can be re-inspected.

D19.3 The date on which the Work has been certified by the Contract Administrator as being totally performed to the requirements of the Contract through the issue of a certificate of Total Performance is the date on which Total Performance has been achieved.

D20. LIQUIDATED DAMAGES

D20.1 If the Contractor fails to achieve Substantial Performance in accordance with the Contract by the day fixed herein for Substantial Performance, the Contractor shall pay the City one thousand two hundred dollars (\$1,200.00) per Working Day for each and every Working Day following the day fixed herein for Substantial Performance during which such failure continues.

D20.2 The amount specified for liquidated damages in D20.1 is based on a genuine pre-estimate of the City's damages in the event that the Contractor does not achieve Substantial Performance by the day fixed herein for same.

D20.3 The City may reduce any payment to the Contractor by the amount of any liquidated damages assessed.

D21. SCHEDULED MAINTENANCE

D21.1 The Contractor shall perform the following scheduled maintenance in the manner and within the time periods required by the Specifications:

(a) Sodding as specified in CW 3510-R9.

D21.2 Determination of Substantial Performance and Total Performance shall be exclusive of scheduled maintenance identified herein. All scheduled maintenance shall be completed prior to the expiration of the warranty period. Where the scheduled maintenance cannot be completed during the warranty period, the warranty period shall be extended for such period of time as it takes the Contractor to complete the scheduled maintenance.

CONTROL OF WORK

D22. JOB MEETINGS

D22.1 Regular weekly job meetings will be held at the Site. These meetings shall be attended by a minimum of one representative of the Contract Administrator, one representative of the City and one representative of the Contractor. Each representative shall be a responsible person capable of expressing the position of the Contract Administrator, the City and the Contractor respectively on any matter discussed at the meeting including the Work schedule and the need to make any revisions to the Work schedule. The progress of the Work will be reviewed at each of these meetings.

D22.2 The Contract Administrator reserves the right to cancel any job meeting or call additional job meetings whenever he deems it necessary.

D23. PRIME CONTRACTOR – THE WORKPLACE SAFETY AND HEALTH ACT (MANITOBA)

D23.1 Further to C6.24, the Contractor shall be the Prime Contractor and shall serve as, and have the duties of the Prime Contractor in accordance with The Workplace Safety and Health Act (Manitoba).

WARRANTY

D24. WARRANTY

D24.1 Notwithstanding C13.2, the warranty period shall begin on the date of Total Performance and shall expire two (2) years thereafter unless extended pursuant to C13.2.1 or C13.2.2, in which case it shall expire when provided for thereunder.

E2. GEOTECHNICAL REPORT

E2.1 Further to C3.1, the geotechnical report is provided to aid the Contractor's evaluation of the pavement structure and/or existing soil conditions. The geotechnical report is contained in Appendix 'A'.

E3. PROTECTION OF EXISTING TREES

E3.1 The Contractor shall take the following precautionary steps to prevent damage from construction activities to existing boulevard trees within the limits of the construction area:

- (a) The Contractor shall not stockpile materials and soil or park vehicles and equipment on boulevards within 2 metres of trees.
- (b) Trees identified to be at risk by the Contract Administrator are to be strapped with 25 x 100 x 2400mm wood planks, or suitably protected as approved by the Contract Administrator.
- (c) Excavation shall be performed in a manner that minimizes damage to the existing root systems. Where possible, excavation shall be carried out such that the edge of the excavation shall be a minimum of 1.5 times the diameter (measured in inches), with the outcome read in feet, from the closest edge of the trunk. Where roots must be cut to facilitate excavation, they shall be pruned neatly at the face of excavation.
- (d) Operation of equipment within the dripline of the trees shall be kept to the minimum required to perform the work required. Equipment shall not be parked, repaired, refuelled; construction materials shall not be stored, and earth materials shall not be stockpiled within the driplines of trees. The dripline of a tree shall be considered to be the ground surface directly beneath the tips of its outermost branches. The Contractor shall ensure that the operations do not cause flooding or sediment deposition on areas where trees are located.
- (e) Work on-site shall be carried out in such a manner so as to minimize damage to existing tree branches. Where damage to branches does occur, they shall be neatly pruned.

E3.2 All damage to existing trees caused by the Contractor's activities shall be repaired to the requirements and satisfaction of the Contract Administrator and the City Forester or his designate.

E3.3 No separate measurement or payment will be made for the protection of trees.

E3.4 Except as required in clause E3.1(c) and E3.1(e), Elm trees shall not be pruned at any time between April 1 and July 31.

E4. TRAFFIC CONTROL

E4.1 Further to clauses 3.6 and 3.7 of CW 1130-R1:

- (a) Where directed, the Contractor shall construct and maintain temporary asphalt ramps to alleviate vertical pavement obstructions such as manholes and planing drop-offs to the satisfaction of the Contract Administrator. Payment shall be in accordance with CW 3410-R8.
- (b) In accordance with the Manual of Temporary Traffic Control, the Contractor ("Agency" in the manual) shall make arrangements with the Traffic Services Section of the City of Winnipeg to place all temporary regulatory signs. The Contractor shall bear all costs associated with the placement of temporary traffic control devices by the Traffic Services Section of the City of Winnipeg in connection with the works undertaken by the Contractor.

E5. TRAFFIC MANAGEMENT

E5.1 Further to clause 3.7 of CW 1130-R1:

- E5.1.1 Each alley shall be closed to traffic, according to specified phasing. The Contractor shall sign the alley "Alley Closed" in accordance with the Manual of Temporary Traffic Control.
- E5.1.2 Intersecting street access shall be maintained at all times whenever possible. Temporary closures to intersecting streets will be allowed during sewer service connections to existing sewers located within the right-of-way of intersecting streets.
- E5.1.3 The Contractor shall provide a minimum of 48 hours notification to the affected residence or business and the contract Administrator, prior to disruption of access. The Contractor shall provide temporary access ramps, as practicable, to minimize the disruption of traffic to commercial properties affected by the construction activities according to the Sequence of Work as detailed in D17.
- E5.1.4 For each alley, construction shall be staged such that backfilling with sub-base material immediately follows excavation and underground works. Excavation shall be filled to the design top of sub-base elevations at the end of each working day.

E6. REFUSE AND RECYCLING COLLECTION

E6.1 While access to refuse and/or recycling collection vehicles is restricted, the Contractor shall accommodate refuse and/or recycling collection in accordance with E6.2 to permit the normal collection vehicles to collect the materials.

E6.2 Collection Schedule:

Fort Street West Alley from North of Graham Avenue to South of Portage Avenue

Collection Day(s): **Refuse: Monday and Thursday, Recycling: Monday**

Collection Time: **Varies**

Collection Protocol: **4 Autobins will be moved to the south leg of the alley along the existing guardrail fence adjacent to the Impark parking lot and emptied on scheduled days. Remaining private front-load bins will be moved to a location near the site on a weekly basis coordinated between the Contract Administrator and the private owner.**

Contractor Responsibility: **Move the 4 Autobins to the south leg of the alley along the existing guardrail fence adjacent to the Impark parking lot. Move approximately 6 private front-load bins weekly, to a location near the site specified by the Contract Administrator.**

Kennedy Street / Edmonton Street Alley from Sargent Avenue to Cumberland Avenue

Collection Day(s): Refuse: Monday and Thursday, Recycling: Monday

Collection Time: Varies

Collection Protocol: 7 Autobins will be moved to the loading zone on Kennedy Street. Remaining private front-load bins will be moved to a location near the site on a weekly basis coordinated between the Contract Administrator and the private owner.

Contractor Responsibility: Move the 7 Autobins to a location near the site specified by the Contract Administrator. Move approximately 4 private front-load bins weekly, to a location near the site specified by the Contract Administrator.

Burnell Street / Arlington Street Alley from St. Matthews Avenue to Ellice Avenue

Collection Day(s): 5

Collection Time: Varies

Collection Protocol: Homeowners on Arlington Street and Burnell Street will be instructed to place their refuse and recycling in the front street during construction. Remaining private front-load bin for business along Ellice Avenue will be moved to a location near the site on a weekly basis coordinated between the Contract Administrator and the business owner.

Contractor Responsibility: Move private front-load bin weekly, to a location near the site specified by the Contract Administrator.

Sherburn Street / Ingersoll Street Alley from Portage Avenue to St. Matthews Avenue

Collection Day(s): 5

Collection Time: Varies

Collection Protocol: Homeowners on Sherburn Street and Ingersoll Street will be instructed to place their refuse and recycling in the front street during construction.

Contractor Responsibility: No action required by the Contractor

Banning Street / Burnell Street Alley from Wellington Avenue to 190 metres North

Collection Day(s): 5

Collection Time: Varies

Collection Protocol: Homeowners on Banning Street and Burnell Street will be instructed to place their refuse and recycling in the front street during construction.

Contractor Responsibility: No action required by the Contractor

E6.3 No measurement or payment will be made for the work associated with this specification.

E7. WATER USED BY CONTRACTOR

E7.1 Further to clause 3.7 of CW 1120-R1, the Contractor shall pay for all costs associated with obtaining water in accordance with the Waterworks By-law. Sewer charges will not be assessed for water obtained from a hydrant.

E8. SURFACE RESTORATIONS

E8.1 Further to clause 3.3 of CW 1130-R1, when Total Performance is not achieved in the year the Contract is commenced, the Contractor shall temporarily repair any Work commenced and not completed to the satisfaction of the Contract Administrator. The Contractor shall maintain the temporary repairs in a safe condition as determined by the Contract Administrator until

permanent repairs are completed. The Contractor shall bear all costs associated with temporary repairs and their maintenance.

E9. RECYCLED CONCRETE BASE COURSE MATERIAL

DESCRIPTION

E9.1 General

E9.1.1 Further to CW 3110, this specification covers supply and placement of recycled concrete base course material for Full-Depth Partial Slab Patches (Class A, B, C, & D), miscellaneous concrete slabs and sidewalks.

E9.2 Definitions

E9.2.1 Deleterious material – are materials such as vegetation, organic material, wood, glass, plastic, metal, reinforcing steel, building rubble, brick, salvaged asphalt materials, clay, shale, and friable particles.

E9.3 Referenced Standard Construction Specifications

- (a) CW 3110 – Sub-Grade. Sub-Base and Base Course Construction.
- (b) CW 3230 – Full-Depth Patching of Existing Pavement Slabs and Joints.
- (c) CW 3235 – Renewal of Existing Miscellaneous Concrete Slabs.
- (d) CW 3325 – Portland Cement Concrete Sidewalk.

MATERIALS

E9.4 Recycled Concrete Base Course Material

E9.4.1 Recycled concrete base course material when used for Full-Depth Partial Slab Patches (Class A, B, C, & D), miscellaneous concrete slabs and sidewalks will be considered equal to granular or limestone base course material specified in Section 2.2 of CW 3110.

E9.4.2 Recycled concrete base course material will be approved by the Contract Administrator.

E9.4.3 Recycled concrete base course material will consist of sound durable particles produced by crushing, screening, and grading of recovered concrete materials, free from soft material that would disintegrate through decay or weathering.

E9.4.4 The recycled concrete base course material will be well graded and conform to the following grading requirements:

E9.4.5 Recycled concrete base course material when subjected to the abrasion test will have a loss of not more than 35% when tested in accordance with grading B of ASTM C131, Test for Resistance to Degradation of Small-Size Coarse Aggregate by Abrasion and Impact in the Los Angeles Machine.

E9.4.6 The amount of deleterious material will be limited to a maximum of two percent of the total dry weight.

CONSTRUCTION METHODS

- E9.5 Placement of Recycled Concrete Base Course Material
 - E9.5.1 Place and compact recycled concrete base course material as a levelling course to a maximum thickness of 50 millimetres.
 - E9.5.2 Spread materials uniformly to avoid segregation free of pockets of fine and coarse material.
 - E9.5.3 Level and compact to the finished elevation. Compact to 100% Standard Proctor Density for Full-Depth Partial Slab Patches (Class A, B, C, & D) and 90% Standard Proctor Density for miscellaneous concrete slabs and sidewalks.
 - E9.5.4 Maintain the finished material until the pavement or sidewalk is placed.

MEASUREMENT AND PAYMENT

- E9.6 Recycled Concrete Base Course Material
 - E9.6.1 The supplying, placing and compaction of recycled concrete base course material will be measured on a volume basis and paid for at the Contract Unit Price per cubic metre for the "Supplying and Placing Base Course Material" as specified in accordance with CW 3110.
 - E9.6.2 No measurement or payment will be made for material placed as a levelling course under miscellaneous concrete slabs and sidewalks where the costs are included in accordance with CW 3235 and CW 3325.
 - E9.6.3 No measurement or payment will be made for materials rejected by the Contract Administrator.

E10. 100MM CRUSHED CONCRETE SUB-BASE MATERIAL

DESCRIPTION

- E10.1 Further to CW 3110, this specification covers the supply and placement of 100mm crushed concrete sub-base material for unstable sub-grades.
- E10.2 Referenced Standard Construction Specifications
 - E10.2.1 CW 3110 – Sub-grade, Sub-base and Base Course Construction

MATERIALS

- E10.3 100mm crushed concrete sub-base material will be approved by the Contract Administrator. The 100mm crushed concrete sub-base material will conform to the following grading requirements:

- E10.3.1 Maximum size of material shall not exceed 150mm.
- E10.4 100mm crushed concrete sub-base material will be a mixture of reclaimed concrete and asphaltic concrete. The contents of the material will be limited to the following percentages based on weight.
 - (a) minimum of 85% recycled concrete
 - (b) maximum of 15% recycled asphaltic concrete

- (c) maximum of 3% clay
- (d) maximum of 1% foreign material

CONSTRUCTION METHODS

- E10.5 Place sub-base material by end dumping down the centre of the excavation. The sub-base shall be pushed forward and levelled to thickness equal to cover the entire sub-grade width, thickening the section to allow support for the hauling operations and avoid damage to the geotextile and/or geogrid. This procedure shall continue until all sub-base material has been placed down the centre of the excavation.
- E10.6 Level sub-base material utilizing a track type dozer.
- E10.7 Initial compaction of the sub-base material shall consist of two complete passes utilizing vibratory type equipment capable of setting the material. Each pass shall be over lapped by half the width of the roller. All additional compaction shall be completed utilizing static type equipment. No trucks, rubber tire loaders or graders will be allowed to travel on the sub-base material until the Contract Administrator has approved the compaction of the sub-base.
- E10.8 The final compacted thickness of the sub-base material shall be a minimum of 300 mm thickness.

MEASUREMENT AND PAYMENT

- E10.9 The supplying, placing and compaction of crushed sub-base material will be measured on a weight basis and paid for at the Contract Unit Price per tonne for the "100mm Crushed Concrete Sub-base Material". The weight to be paid for will be the total number of tonnes of 100mm crushed concrete sub-base material supplied and placed in accordance with this specification, accepted and measured by the Contract Administrator.
- E10.10 The weight to be paid for will be the total number of tonnes of 100mm crushed concrete sub-base material as measured on a certified weigh scale.
- E10.11 Only material placed within the limits of excavation will be included in the payment for 100mm crushed concrete sub-base material.
- E10.12 No measurement or payment will be made for materials rejected by the Contract Administrator.

E11. INSTALLATION OF SUBDRAINS

- E11.1 Description
 - (a) This specification shall amend CW 3120
 - (i) Replace 3.2.3 to read: Install drainage fabric in accordance with this specification and the Drawings.

E12. PLAIN CONCRETE PAVEMENT

- E12.1 General
 - E12.1.1 This specification amends CW 3310 'Portland Cement Concrete Pavement Works' to allow for the provision of plain, unreinforced concrete pavement.
 - E12.1.2 Plain, unreinforced concrete pavement exists as slender concrete driveway approach strips along alley reconstructions.
- E12.2 Definitions
 - E12.2.1 Plain Concrete Pavement – A Portland Cement Concrete pavement with no reinforcing steel in the pavement slab.

E12.3 Construction Methods

E12.3.1 Where the Drawings call for a connection from a new concrete driveway strip to a new concrete pavement, tiebars shall be placed prior to placing the concrete pavement. Placing of tiebars shall be at mid-depth and spaced as directed by the Contract Administrator.

E12.3.2 Tie Bars – As noted in CW 3310, supply and installation of tie bars, except for drilled tie bars, shall be incidental to the construction of Portland Cement Concrete pavements.

E12.4 Method of Measurement and Basis of Payment

E12.4.1 Construction of Plain Concrete Pavement will be measured by the square metre and paid for at the Contract Unit Price per square metre of Plain Concrete Pavement, which price shall be payment in full for supplying all materials and performing all operations herein described and all other items incidental to the work included in this Specification.
