The Work to be done under the Contract shall consist of exterior stone and brick masonry repairs to the building at 380 William Avenue in Winnipeg, Manitoba. Work is to include, but not be limited to, the following:

- (a) Mobilization/demobilization, permits, fees, hoardings, access, and other general conditions;
- (b) Access to all areas of all exterior building elevations for determination and quantification of repairs;
- (c) Brick and stone joint repointing;
- (d) Cornice and coping stone repairs;
- (e) Installation of vertical joint full height of building on east and west faces;
- (f) Removal and re-installation of bird netting and spikes;
- (g) Removal of existing caulking, surface preparation, and installation of new Dow 795 sealant on all main and second floor exterior windows;
- (h) Cleaning of stone cornices and coping stones using "JOS" semi-abrasive stone cleaning system;
- (i) Unit price repairs as outlined in the Specifications and on Form B (R1): Prices
