herein, for the commencement of Stage 3 - CN Track Relocation by September 15, 2011.

Refer to Section D16.6.

Revise: D21.1 to read: The Contractor shall achieve Substantial Performance by September 15, 2011.

Revise: D22.1 to read: The Contractor shall achieve Total Performance by September 30, 2011.

#### PART E - SPECIFICATIONS

Revise: E6.3.2(a) to read: The Contractor shall be responsible to develop suitable Site access in accordance

with this Section and Section E10 Encroachment on Private Property. This includes but is not limited to, temporary removal and reinstallation of chain link fencing, any landscaping and grading repairs, etc. necessary to restore any Site and construction

access areas to their pre-existing condition.

Add: E10.3 The Contractor will be permitted access by CN to the site from Nassau St. N.

(a) The Work to be done by the Contractor under this Section shall be in accordance with the Standard Construction Specification E6 Site Development and Restoration

and CN Construction and Safety Requirements.

Add: E10.4 Measurement and Payment

(a) The Access permitted by CN and associated Works will not be measured. No additional payment will be made for this item of Work.

Drain Board, Soprema sopradrain eco-vent, or equal as accepted by the Contract

Administrator. Mastic adhesive shall be as recommended by the wall drain manufacturer.
