### PART A - BID SUBMISSION

- Replace: 632-2009 Bid Submission with 632-2009 Addendum 1 Bid Submission. The following is a summary of changes incorporated in the replacement Bid Submission:
  - Form B(R1): Item A.2 (a) (1) quantity revised.
  - Form B(R1): Add Items No. A.2 (a) 2 to 3 inclusive.
  - Form B(R1): Item A.3 (a) unit revised.

### PART E - SPECIFICATIONS

Replace: E9.3 (c) and (d) to read:

- (c) Sluice Gate located on existing chamber.
  - (i) Remove the existing sluice gate, stem extensions and operator located in the existing gate chamber.
  - (ii) Costs for the removal of the sluice gate, stem extensions, operator and capping of the openings shall be included in the gate chamber construction.
- (d) Flap Gate located on existing 900mm diameter manhole.
  - (i) Remove and dispose of the existing cast iron flap gate located in the existing Lombard Avenue Manhole.
  - (ii) Install approximately 7.5 meters of 900mm diameter concrete LDS including tie-ins, bend and nipple at the new MH and Gate Chamber as shown on drawings LD-5438 and LD-5439.
  - (iii) Cost for the removal and disposal of the cast iron flap gate and section of the existing 900mm diameter LDS to allow for the tie-ins shall be included in the gate chamber construction.
  - (iv) The Contractor is advised that a video of the existing monolithic 900mm diameter LDS and cast iron flap gate to be removed can be obtained from the office of the Contract Administrator upon request.
