PART D – SUPPLEMENTAL CONDITIONS

Add: D9.5 The City shall have the right to alter the limits and/or coverages as reasonably required

from time to time during the continuance of this Contract, provided that the City shall give

the Contractor reasonable notice and shall request reasonable change.

Revise: D14.3 to read: Commencement of the Work shall be at the discretion of the Contractor provided the

commencement date will allow for the achievement of Substantial Performance in

accordance with D17.

Revise: D14.4 to read: The City intends to award this Contract by April 3, 2009.

Revise: D17.1 to read: The Contractor shall achieve Substantial Performance within eighty five (85) consecutive

Working Days of the commencement of the Work as specified in D14, or by October 30,

2009, whichever occurs first.

Revise: D19.3 to read: If the Contractor fails to achieve Total Performance in accordance with the Contract by

the day fixed herein for Total Performance, the Contractor shall pay the City one

thousand two hundred dollars (\$1200) per Working Day for each and every Working Day following the day fixed herein for Total Performance during which such failure continues.

Add: E17.3 The Contractor is advised that coordination of the installation of MH19 and MH19A may

be required with the Contractor installing the lift station. Portions of this Work in the vicinity of the lift station may be removed from this Contract and performed by the lift

station Contractor without additional compensation to the LDS Contractor.
