PART B - BIDDING PROCEDURES

B1. CONTRACT TITLE

B1.1 JOHN BLUMBERG SOCCER COMPLEX - FIELDS 9 & 10 IRRIGATION SYSTEM

B2. SUBMISSION DEADLINE

- B2.1 The Submission Deadline is 4:00 p.m. Winnipeg time, April 23, 2010.
- B2.2 Bids determined by the Manager of Materials to have been received later than the Submission Deadline will not be accepted and will be returned upon request.
- B2.3 The Contract Administrator or the Manager of Materials may extend the Submission Deadline by issuing an addendum at any time prior to the time and date specified in B2.1.

B3. SITE INVESTIGATION

B3.1 Further to C3.1, the Bidder may view the Site without making an appointment.

B4. ENQUIRIES

- B4.1 All enquiries shall be directed to the Contract Administrator identified in D3.1.
- B4.2 If the Bidder finds errors, discrepancies or omissions in the Bid Opportunity, or is unsure of the meaning or intent of any provision therein, the Bidder shall notify the Contract Administrator of the error, discrepancy or omission, or request a clarification as to the meaning or intent of the provision at least five (5) Business Days prior to the Submission Deadline.
- B4.3 Responses to enquiries which, in the sole judgment of the Contract Administrator, require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator to all Bidders by issuing an addendum.
- B4.4 Responses to enquiries which, in the sole judgment of the Contract Administrator, do not require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator only to the Bidder who made the enquiry.
- B4.5 The Bidder shall not be entitled to rely on any response or interpretation received pursuant to B4 unless that response or interpretation is provided by the Contract Administrator in writing.

B5. ADDENDA

- B5.1 The Contract Administrator may, at any time prior to the Submission Deadline, issue addenda correcting errors, discrepancies or omissions in the Bid Opportunity, or clarifying the meaning or intent of any provision therein.
- B5.2 The Contract Administrator will issue each addendum at least two (2) Business Days prior to the Submission Deadline, or provide at least two (2) Business Days by extending the Submission Deadline.
- B5.2.1 Addenda will be available on the Bid Opportunities page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt
- B5.2.2 The Bidder is responsible for ensuring that he has received all addenda and is advised to check the Materials Management Division website for addenda regularly and shortly before the Submission Deadline, as may be amended by addendum.
- B5.2.3 The Bidder shall acknowledge receipt of each addendum in Paragraph 8 of Form A: Bid. Failure to acknowledge receipt of an addendum may render a Bid non-responsive.

B6. **SUBSTITUTES**

- B6.1 The Work is based on the Plant, Materials and methods specified in the Bid Opportunity.
- Substitutions shall not be allowed unless application has been made to and prior approval has B6.2 been granted by the Contract Administrator in writing.
- B6.3 Requests for approval of a substitute will not be considered unless received in writing by the Contract Administrator at least five (5) Business Days prior to the Submission Deadline.
- The Bidder shall ensure that any and all requests for approval of a substitute: B6.4
 - (a) provide sufficient information and details to enable the Contract Administrator to determine the acceptability of the Plant, Material or method as either an approved equal or alternative;
 - (b) identify any and all changes required in the applicable Work, and all changes to any other Work, which would become necessary to accommodate the substitute:
 - (c) identify any anticipated cost or time savings that may be associated with the substitute:
 - (d) certify that, in the case of a request for approval as an approved equal, the substitute will fully perform the functions called for by the general design, be of equal or superior substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance;
 - (e) certify that, in the case of a request for approval as an approved alternative, the substitute will adequately perform the functions called for by the general design, be similar in substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance.
- B6.5 The Contract Administrator, after assessing the request for approval of a substitute, may in his sole discretion grant approval for the use of a substitute as an "approved equal" or as an "approved alternative", or may refuse to grant approval of the substitute.
- B6.6 The Contract Administrator will provide a response in writing, at least two (2) Business Days prior to the Submission Deadline, only to the Bidder who requested approval of the substitute.
- B6.6.1 The Bidder requesting and obtaining the approval of a substitute shall be entirely responsible for disseminating information regarding the approval to any person or persons he wishes to inform.
- B6.7 If the Contract Administrator approves a substitute as an "approved equal", any Bidder may use the approved equal in place of the specified item.
- B6.8 If the Contract Administrator approves a substitute as an "approved alternative", any Bidder bidding that approved alternative may base his Total Bid Price upon the specified item but may also indicate an alternative price based upon the approved alternative. Such alternatives will be evaluated in accordance with B14.
- B6.9 No later claim by the Contractor for an addition to the Total Bid Price because of any other changes in the Work necessitated by the use of an approved equal or an approved alternative will be considered.
- B6.10 Notwithstanding B6.2 to B6.9, and in accordance with B7.7, deviations inconsistent with the Bid Opportunity document shall be evaluated in accordance with B14.1(a).

B7. **BID COMPONENTS**

B7.1 The Bid shall consist of the following components:

- (a) Form A: Bid;
- (b) Form B: Prices;
- B7.2 Further to B7.1, the Bidder should include the written correspondence from the Contract Administrator approving a substitute in accordance with B6.
- B7.3 All components of the Bid shall be fully completed or provided, and submitted by the Bidder no later than the Submission Deadline, with all required entries made clearly and completely, to constitute a responsive Bid.
- B7.4 The Bid Submission may be submitted by mail, courier or personal delivery, or by facsimile transmission.
- B7.5 If the Bid Submission is submitted by mail, courier or personal delivery, it shall be enclosed and sealed in an envelope clearly marked with the Bid Opportunity number and the Bidder's name and address, and shall be submitted to:

- B7.5.1 Samples or other components of the Bid Submission which cannot reasonably be enclosed in the envelope may be packaged separately, but shall be clearly marked with the Bid Opportunity number, the Bidder's name and address, and an indication that the contents are part of the Bidder's Bid Submission.
- B7.6 Bidders are advised not to include any information/literature except as requested in accordance with B7.1.
- B7.7 Bidders are advised that inclusion of terms and conditions inconsistent with the Bid Opportunity document, including the General Conditions, will be evaluated in accordance with B14.1(a).
- B7.8 If the Bid Submission is submitted by facsimile transmission, it shall be submitted to (204) 949-1178.
- B7.8.1 The Bidder is advised that the City cannot take responsibility for the availability of the facsimile machine at any time.
- B7.8.2 Bids submitted by internet electronic mail (e-mail) will not be accepted.

B8. BID

- B8.1 The Bidder shall complete Form A: Bid, making all required entries.
- B8.2 Paragraph 2 of Form A: Bid shall be completed in accordance with the following requirements:
 - (a) if the Bidder is a sole proprietor carrying on business in his own name, his name shall be inserted:
 - (b) if the Bidder is a partnership, the full name of the partnership shall be inserted;
 - (c) if the Bidder is a corporation, the full name of the corporation shall be inserted;
 - (d) if the Bidder is carrying on business under a name other than his own, the business name and the name of every partner or corporation who is the owner of such business name shall be inserted.
- B8.2.1 If a Bid is submitted jointly by two or more persons, each and all such persons shall identify themselves in accordance with B8.2.
- B8.3 In Paragraph 3 of Form A: Bid, the Bidder shall identify a contact person who is authorized to represent the Bidder for purposes of the Bid.

- B8.4 Paragraph 10 of Form A: Bid shall be signed in accordance with the following requirements:
 - (a) if the Bidder is a sole proprietor carrying on business in his own name, it shall be signed by the Bidder:
 - (b) if the Bidder is a partnership, it shall be signed by the partner or partners who have authority to sign for the partnership;
 - (c) if the Bidder is a corporation, it shall be signed by its duly authorized officer or officers;
 - (d) if the Bidder is carrying on business under a name other than his own, it shall be signed by the registered owner of the business name, or by the registered owner's authorized officials if the owner is a partnership or a corporation.
- B8.4.1 The name and official capacity of all individuals signing Form A: Bid should be printed below such signatures.
- B8.4.2 All signatures shall be original.
- B8.5 If a Bid is submitted jointly by two or more persons, the word "Bidder" shall mean each and all such persons, and the undertakings, covenants and obligations of such joint Bidders in the Bid and the Contract, when awarded, shall be both joint and several.

B9. PRICES

- B9.1 The Bidder shall state a price in Canadian funds for each item of the Work identified on Form B: Prices.
- B9.2 The quantities listed on Form B: Prices are to be considered approximate only. The City will use said quantities for the purpose of comparing Bids.
- B9.3 The quantities for which payment will be made to the Contractor are to be determined by the Work actually performed and completed by the Contractor, to be measured as specified in the applicable Specifications.
- B9.4 Prices from Non-Resident Bidders are subject to a Non-Resident Withholding Tax pursuant to the Income Tax Act (Canada).

B10. QUALIFICATION

- B10.1 The Bidder shall:
 - (a) undertake to be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba; and
 - (b) be financially capable of carrying out the terms of the Contract; and
 - (c) have all the necessary experience, capital, organization, and equipment to perform the Work in strict accordance with the terms and provisions of the Contract.
- B10.2 The Bidder and any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
 - (a) be responsible and not be suspended, debarred or in default of any obligations to the City. A list of suspended or debarred individuals and companies is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/debar.stm
- B10.3 The Bidder and/or any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
 - (a) have successfully carried out work similar in nature, scope and value to the Work; and
 - (b) be fully capable of performing the Work required to be in strict accordance with the terms and provisions of the Contract; and

- (c) have a written workplace safety and health program if required pursuant to The Workplace Safety and Health Act (Manitoba):
- B10.4 The Bidder shall provide, on the request of the Contract Administrator, full access to any of the Bidder's equipment and facilities to confirm, to the Contract Administrator's satisfaction, that the Bidder's equipment and facilities are adequate to perform the Work.

B11. OPENING OF BIDS AND RELEASE OF INFORMATION

- B11.1 Bids will not be opened publicly.
- B11.2 Following the submission deadline, the names of the Bidders and their Total Bid Prices (unevaluated, and pending review and verification of conformance with requirements) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/bidopp.asp
- B11.3 After award of Contract, the name(s) of the successful Bidder(s) and the Contract Amount(s) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt
- B11.4 The Bidder is advised that any information contained in any Bid may be released if required by City policy or procedures, by The Freedom of Information and Protection of Privacy Act (Manitoba), by other authorities having jurisdiction, or by law.

B12. IRREVOCABLE BID

- B12.1 The Bid(s) submitted by the Bidder shall be irrevocable for the time period specified in Paragraph 9 of Form A: Bid.
- B12.2 The acceptance by the City of any Bid shall not release the Bids of the next two lowest evaluated responsive Bidders and these Bidders shall be bound by their Bids on such Work for the time period specified in Paragraph 9 of Form A: Bid.

B13. WITHDRAWAL OF BIDS

- B13.1 A Bidder may withdraw his Bid without penalty by giving written notice to the Manager of Materials at any time prior to the Submission Deadline.
- B13.1.1 Notwithstanding C23.3, the time and date of receipt of any notice withdrawing a Bid shall be the time and date of receipt as determined by the Manager of Materials.
- B13.1.2 The City will assume that any one of the contact persons named in Paragraph 3 of Form A: Bid or the Bidder's authorized representatives named in Paragraph 10 of Form A: Bid, and only such person, has authority to give notice of withdrawal.
- B13.1.3 If a Bidder gives notice of withdrawal prior to the Submission Deadline, the Manager of Materials will:
 - (a) retain the Bid until after the Submission Deadline has elapsed;
 - (b) open the Bid to identify the contact person named in Paragraph 3 of Form A: Bid and the Bidder's authorized representatives named in Paragraph 10 of Form A: Bid; and
 - (c) if the notice has been given by any one of the persons specified in B13.1.3(b), declare the Bid withdrawn.
- B13.2 A Bidder who withdraws his Bid after the Submission Deadline but before his Bid has been released or has lapsed as provided for in B12.2 shall be liable for such damages as are imposed upon the Bidder by law and subject to such sanctions as the Chief Administrative

Officer considers appropriate in the circumstances. The City, in such event, shall be entitled to all rights and remedies available to it at law.

B14. EVALUATION OF BIDS

- B14.1 Award of the Contract shall be based on the following bid evaluation criteria:
 - (a) compliance by the Bidder with the requirements of the Bid Opportunity or acceptable deviation there from (pass/fail);
 - (b) qualifications of the Bidder and the Subcontractors, if any, pursuant to B10 (pass/fail);
 - (c) Total Bid Price;
 - (d) economic analysis of any approved alternative pursuant to B6.
- B14.2 Further to B14.1(a), the Award Authority may reject a Bid as being non-responsive if the Bid is incomplete, obscure or conditional, or contains additions, deletions, alterations or other irregularities. The Award Authority may reject all or any part of any Bid, or waive technical requirements or minor informalities or irregularities, if the interests of the City so require.
- B14.3 Further to B14.1(b), the Award Authority shall reject any Bid submitted by a Bidder who does not demonstrate, in his Bid or in other information required to be submitted, that he is responsible and qualified.
- B14.4 Further to B14.1(c), the Total Bid Price shall be the sum of the quantities multiplied by the unit prices for each item shown on Form B: Prices.
- B14.4.1 If there is any discrepancy between the Total Bid Price written in figures, the Total Bid Price written in words and the sum of the quantities multiplied by the unit prices for each item, the sum of the quantities multiplied by the unit prices for each item shall take precedence.
- B14.4.2 Further to B14.1(a), in the event that a unit price is not provided on Form B: Prices, the City will determine the unit price by dividing the Amount (extended price) by the approximate quantity, for the purposes of evaluation and payment.

B15. AWARD OF CONTRACT

- B15.1 The City will give notice of the award of the Contract or will give notice that no award will be made.
- B15.2 The City will have no obligation to award a Contract to a Bidder, even though one or all of the Bidders are determined to be responsible and qualified, and the Bids are determined to be responsive.
- B15.2.1 Without limiting the generality of B15.2, the City will have no obligation to award a Contract where:
 - (a) the prices exceed the available City funds for the Work;
 - (b) the prices are materially in excess of the prices received for similar work in the past;
 - the prices are materially in excess of the City's cost to perform the Work, or a significant portion thereof, with its own forces;
 - (d) only one Bid is received; or
 - (e) in the judgment of the Award Authority, the interests of the City would best be served by not awarding a Contract.
- B15.3 Where an award of Contract is made by the City, the award shall be made to the responsible and qualified Bidder submitting the lowest evaluated responsive Bid, in accordance with B14.
- B15.3.1 Following the award of contract, a Bidder will be provided with information related to the evaluation of his Bid upon written request to the Contract Administrator.

- B15.4 Notwithstanding C4, the City will issue a Purchase Order to the successful Bidder in lieu of the execution of a Contract.
- B15.5 The Contract, as defined in C1.1, in its entirety shall be deemed to be incorporated in and to form a part of the Purchase Order notwithstanding that it is not necessarily attached to or accompany said Purchase Order.

PART C - GENERAL CONDITIONS

CO. GENERAL CONDITIONS

- C0.1 The *General Conditions for Construction* (Revision 2006 12 15) are applicable to the Work of the Contract.

- C0.2 A reference in the Bid Opportunity to a section, clause or subclause with the prefix "C" designates a section, clause or subclause in the *General Conditions for Construction*.

PART D - SUPPLEMENTAL CONDITIONS

GENERAL

D1. GENERAL CONDITIONS

D1.1 In addition to the *General Conditions for Construction*, these Supplemental Conditions are applicable to the Work of the Contract.

D2. SCOPE OF WORK

- D2.1 The Work to be done under the Contract shall consist of the supply and installation of irrigation sprinkler heads and lines at two soccer fields.
- D2.2 The major components of the Work are as follows:
 - (a) Supply and installation of valves and associated equipment
 - (b) Supply and installation of underground water lines
 - (c) Supply and installation of sprinkler heads
 - (d) Sodding repairs

D3. CONTRACT ADMINISTRATOR

D3.2 At the pre-construction meeting, Ken Rech will identify additional personnel representing the Contract Administrator and their respective roles and responsibilities for the Work.

D4. CONTRACTOR'S SUPERVISOR

D4.1 At the pre-construction meeting, the Contractor shall identify his designated supervisor and any additional personnel representing the Contractor and their respective roles and responsibilities for the Work.

D5. NOTICES

- D5.1 Except as provided for in C23.2.2, all notices, requests, nominations, proposals, consents, approvals, statements, authorizations, documents or other communications to the Contractor shall be sent to the address or facsimile number identified by the Contractor in Paragraph 2 of Form A: Bid.
- D5.2 All notices, requests, nominations, proposals, consents, approvals, statements, authorizations, documents or other communications to the City, except as expressly otherwise required in D5.3, D5.4 or elsewhere in the Contract, shall be sent to the attention of the Contract Administrator at the address or facsimile number identified in D3.1.
- D5.3 Notwithstanding C21., all notices of appeal to the Chief Administrative Officer shall be sent to the attention of the Chief Financial Officer at the following address or facsimile number:

SUBMISSIONS

D6. AUTHORITY TO CARRY ON BUSINESS

D6.1 The Contractor shall be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba, or if the Contractor does not carry on business in Manitoba, in the jurisdiction where the Contractor does carry on business, throughout the term of the Contract, and shall provide the Contract Administrator with evidence thereof upon request.

D7. SAFE WORK PLAN

- D7.1 The Contractor shall provide the Contract Administrator with a Safe Work Plan at least five (5) Business Days prior to the commencement of any Work on the Site but in no event later than the date specified in C4.1 for the return of the executed Contract.
- D7.2 The Safe Work Plan should be prepared and submitted in the format shown in the City's template which is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/Safety/default.stm

D8. INSURANCE

- D8.1 The Contractor shall provide and maintain the following insurance coverage:
 - (a) commercial general liability insurance, in the amount of at least two million dollars (\$2,000,000.00) inclusive, with The City of Winnipeg and Ken Rech Landscape Architects Inc. added as an additional insured, with a cross-liability clause, such liability policy to also contain contractual liability, unlicensed motor vehicle liability, non-owned automobile liability and products and completed operations, to remain in place at all times during the performance of the Work and throughout the warranty period;
 - (b) automobile liability insurance for owned automobiles used for or in connection with the Work in the amount of at least two million dollars (\$2,000,000.00) at all times during the performance of the Work and until the date of Total Performance;
- D8.2 Deductibles shall be borne by the Contractor.
- D8.3 The Contractor shall provide the Contract Administrator with a certificate(s) of insurance, in a form satisfactory to the City Solicitor, at least two (2) Business Days prior to the commencement of any Work but in no event later than seven (7) Calendar Days from notification of the award of Contract by Purchase Order.

D8.4 The Contractor shall not cancel, materially alter, or cause each policy to lapse without providing at least thirty (30) Calendar Days prior written notice to the Contract Administrator.

D9. PERFORMANCE SECURITY

- D9.1 If the Contract Price exceeds fifty thousand dollars (\$50,000.00), the Contractor shall provide and maintain performance security until the expiration of the warranty period in the form of:
 - (a) a performance bond of a company registered to conduct the business of a surety in Manitoba, in the form attached to these Supplemental Conditions (Form H1: Performance Bond), in the amount of fifty percent (50%) of the Contract Price; or
 - (b) an irrevocable standby letter of credit issued by a bank or other financial institution registered to conduct business in Manitoba and drawn on a branch located in Winnipeg, in the form attached to these Supplemental Conditions (Form H2: Irrevocable Standby Letter of Credit), in the amount of fifty percent (50%) of the Contract Price; or
 - (c) a certified cheque or draft payable to "The City of Winnipeg", drawn on a bank or other financial institution registered to conduct business in Manitoba, in the amount of fifty percent (50%) of the Contract Price.
- D9.1.1 Where the performance security is in the form of a certified cheque or draft, it will be deposited by the City. The City will not pay any interest on certified cheques or drafts furnished as performance security.
- D9.2 The Contractor shall provide the City Solicitor with the required performance security within seven (7) Calendar Days of notification of the award of the Contract by way of Purchase Order and prior to the commencement of any Work on the Site.

SCHEDULE OF WORK

D10. COMMENCEMENT

- D10.1 The Contractor shall not commence any Work until he is in receipt of a Purchase Order from the Award Authority authorizing the commencement of the Work.
- D10.2 The Contractor shall not commence any Work on the Site until:
 - (a) the Contract Administrator has confirmed receipt and approval of:
 - (i) evidence of authority to carry on business specified in D6;
 - (ii) evidence of the workers compensation coverage specified in C6.15;
 - (iii) the Safe Work Plan specified in D7;
 - (iv) evidence of the insurance specified in D8;
 - (v) the performance security specified in D9;
 - (b) the Contractor has attended a pre-construction meeting with the Contract Administrator, or the Contract Administrator has waived the requirement for a pre-construction meeting.
- D10.3 The Contractor shall not commence the Work on the Site before July 5, 2010.
- D10.3.1 If the actual date of award is later than the intended date, the dates specified for Substantial Performance, and Total Performance will be adjusted by the difference between the aforementioned intended and actual dates.

D11. SUBSTANTIAL PERFORMANCE

- D11.1 The Contractor shall achieve Substantial Performance within twelve (12) consecutive Working Days of the commencement of the Work as specified in D10.
- D11.2 When the Contractor considers the Work to be substantially performed, the Contractor shall arrange, attend and assist in the inspection of the Work with the Contract Administrator for

- purposes of verifying Substantial Performance. Any defects or deficiencies in the Work noted during that inspection shall be remedied by the Contractor at the earliest possible instance and the Contract Administrator notified so that the Work can be re-inspected.
- D11.3 The date on which the Work has been certified by the Contract Administrator as being substantially performed to the requirements of the Contract through the issue of a certificate of Substantial Performance is the date on which Substantial Performance has been achieved.

D12. TOTAL PERFORMANCE

- D12.1 The Contractor shall achieve Total Performance within fifteen (15) consecutive Working Days of the commencement of the Work as specified in D10.
- D12.2 When the Contractor or the Contract Administrator considers the Work to be totally performed, the Contractor shall arrange, attend and assist in the inspection of the Work with the Contract Administrator for purposes of verifying Total Performance. Any defects or deficiencies in the Work noted during that inspection shall be remedied by the Contractor at the earliest possible instance and the Contract Administrator notified so that the Work can be re-inspected.
- D12.3 The date on which the Work has been certified by the Contract Administrator as being totally performed to the requirements of the Contract through the issue of a certificate of Total Performance is the date on which Total Performance has been achieved.

D13. LIQUIDATED DAMAGES

- D13.1 If the Contractor fails to achieve Substantial Performance in accordance with the Contract by the day fixed herein for Substantial Performance, the Contractor shall pay the City five hundred dollars (\$500.00) per Calendar Day for each and every Calendar Day following the day fixed herein for Substantial Performance during which such failure continues.
- D13.2 The amount specified for liquidated damages in D13.1 is based on a genuine pre-estimate of the City's damages in the event that the Contractor does not achieve Substantial Performance by the day fixed herein for same.
- D13.3 The City may reduce any payment to the Contractor by the amount of any liquidated damages assessed.

D14. SCHEDULED MAINTENANCE

- D14.1 The Contractor shall perform the following scheduled maintenance in the manner and within the time periods required by the Specifications:
 - (a) Sodding as specified in E8.
- D14.2 Determination of Substantial Performance and Total Performance shall be exclusive of scheduled maintenance identified herein. All scheduled maintenance shall be completed prior to the expiration of the warranty period. Where the scheduled maintenance cannot be completed during the warranty period, the warranty period shall be extended for such period of time as it takes the Contractor to complete the scheduled maintenance.

CONTROL OF WORK

D15. JOB MEETINGS

D15.1 Regular weekly job meetings will be held at the Site. These meetings shall be attended by a minimum of one representative of the Contract Administrator, one representative of the City and one representative of the Contractor. Each representative shall be a responsible person capable of expressing the position of the Contract Administrator, the City and the Contractor respectively on any matter discussed at the meeting including the Work schedule and the need

- to make any revisions to the Work schedule. The progress of the Work will be reviewed at each of these meetings.
- D15.2 The Contract Administrator reserves the right to cancel any job meeting or call additional job meetings whenever he deems it necessary.

D16. PRIME CONTRACTOR – THE WORKPLACE SAFETY AND HEALTH ACT (MANITOBA)

D16.1 Further to C6.24, the Contractor shall be the Prime Contractor and shall serve as, and have the duties of the Prime Contractor in accordance with The Workplace Safety and Health Act (Manitoba).

MEASUREMENT AND PAYMENT

D17. PAYMENT

D17.1 Further to C12, the City may at its option pay the Contractor by direct deposit to the Contractor's banking institution.

GENERAL

E1. APPLICABLE SPECIFICATIONS AND DRAWINGS

- E1.1 These Specifications shall apply to the Work.
- E1.2 The City of Winnipeg Standard Construction Specifications in its entirety, whether or not specifically listed on Form B: Prices, shall apply to the Work.
- E1.2.1 The City of Winnipeg Standard Construction Specifications is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/Spec/Default.stm
- E1.2.2 The version in effect three (3) Business Days before the Submission Deadline shall apply.
- E1.2.3 Further to C2.4(d), Specifications included in the Bid Opportunity shall govern over *The City of Winnipeg Standard Construction Specifications*.
- E1.3 The following are applicable to the Work:

L-1 Fields 9 and 10 New Irrigation Plans

E2. PREVIOUS AND NEW WORK

- E2.1 In 2009 a new irrigation perimeter water supply line, river pump house and pump, and irrigation sprinkler heads were installed on fields 6 to 8. Field No: 5 had sprinkler heads installed in 2008.
- E2.2 On the west side of Field No: 9 a new 100 mm diameter water line was installed along with the decoder wires. The decoder wire was installed in Carson 910 round valve boxes at the locations where the new solenoid valves will be located. The Contractor is to use this wiring and connection point for installing the new solenoid valves, and zone water lines.
- E2.3 On the west side of Field No: 10 there is an original 75 mm diameter HDPE water line which was installed in the 1990's and has quick coupler valves along its length. There is no decoder wire along the west side of this field, however the decoder wire is located position at the extreme northwest corner of the this soccer field. The Contractor will have to install a new decoder wire along the entire west side of this field and splice this wire into the exiting decoder pump decoder wire system.
- E2.4 The work in Field No: 9 essentially consists of installing new water lines and sprinkler heads throughout the field, and the supply and installation of new water valves in prefabricated valve boxes and connecting all to the existing water service and decoder wiring.
- E2.5 The work in Field No: 10 essentially consists of installing new water lines and sprinkler heads throughout the field, the supply and installation of new water valves in prefabricated valve boxes, connecting the same to the existing water line service and the supply and installation of the new decoder wiring.
- E2.6 In addition to Fields 9 and 10, the City will be installing fully automatic sprinkler heads in the remaining Fields 2 to 4 in the future. As such the City needs to standardize the type of equipment being installed at this facility for easier of future maintenance. The City therefore will not entertain substitutions or equals for the sprinkler heads, solenoid valves and decoders. The Contractor will have to use the same type and model number of equipment installed in 2009 in Fields 6 to 8.

E3. SOCCER PLAY SEASON

E3.1 The Contractor is made aware No Work can commence on this site until July 5, 2010 due to the facility being utilized for the spring soccer season. The Contractor must commence work immediately on July 5 and expedite the work as quick as possible so the sodding restoration work can establish and allow the fields to be returned to play.

E4. LAYOUT OF WORK

- E4.1 The Contractor is responsible to set control lines and bench marks by means of stakes, buoys or marks and the Contractor shall make the completed Works conform to the lines and patterns shown on the drawings. The Contractor is responsible for protecting and replacing any stakes that have been removed as a result of construction or vandalism.
- E4.2 All layout Work shall be inspected and approved by the Contract Administrator prior to construction.
- E4.3 Before commencing Work the Contractor shall satisfy himself as to the meaning and correctness of all stakes and marks and no claims shall be entertained by the City of Winnipeg on account of any alleged inaccuracies. If any error is suspected in the plans, specifications or the directions of the Contract Administrator, Work shall be discontinued until the errors are rectified, but no claims shall be made on account of any delay occasioned thereby.
- E4.4 The Contractor shall locate all underground utilities prior to Construction and shall protect the same. Repair all damage to existing utilities as a result of the Contractor's Work at no cost to the City.

E5. SITE RESTORATION

- E5.1 Total Performance of the Work shall not be attained until the Contractor has cleaned up the Site and has removed all plant, tools, equipment, waste, debris and surplus foundation earth to the satisfaction of the Contract Administrator. Unless otherwise specified, the Contractor shall restore all areas of the Site beyond the established limit of Work, which have been disturbed by the Contractor's operations to as good as or better than the original condition to the satisfaction of the Contract Administrator. The Contractor shall pay all costs associated with this Work.
- E5.2 Excavated fill removed from the trenches and sprinkler locations may be stockpiled in the location shown on drawing detail 1-L1.

E6. SITE SAFETY

- E6.1 The Work area is a highly used Public park and athletic space and due to the inherit nature of the Site being utilized extensively by soccer players, baseball players, and recreational users, the Contractor will have to ensure all their Work and operations of equipment protects the Public and the City from harm.
- E6.2 All Work and scheduling of Work, shall be undertaken to provide the least Site disturbance or impact, and so as not to conflict with when the soccer fields and surrounding areas are being utilized.
- E6.3 When operating equipment while the public is present the Contractor must place a Safety flagman between the equipment and the public to keep the public away from the Work area.
- Any excavation pits must not be left open for any length of time while the public is on Site, or while unattended, and must be clearly marked with protective flagging or barriers. The Contract Administrator shall have the authority to shut down the Work if the Contract Administrator feels the Work areas are not properly protected, and the public may be harmed.
- E6.5 The Contractor must provide suitable traffic barriers to City of Winnipeg Standards when working on or near the vehicle roads.

Measurement and Payment

E6.6 There will be no Separate Payment for providing Safety markers and workers.

E7. PLOWING AND PROTECTION OF EXISTING FACILITES

- E7.1 This specification shall cover the plowing requirements and protection of existing underground and surface materials.
- E7.2 The Contractor shall locate and protect all underground utilities prior to commencing construction, and repair any damage to the utilities as a result of their operations to prior construction condition at no cost to the City.
- E7.3 All trenches located in grass areas shall be restored with a 100 mm depth of topsoil and seed as per CW 3520-R7. No separate payment will be made for restoring the surface grass.
- E7.4 All 50 mm diameter water lines in the play field shall be installed a minimum of 300 mm but not greater than 400 mm to the top of the pipe, below the finish grade elevation of the playfield sod. The pipe shall be installed by pulling in a full length lateral line with a vibratory plow. No mechanical joints or connections in the pipe are allowed within the play field. Connection of the new sprinkler heads is shown in drawing detail 1-L1 and further discussed in sections E9 Irrigation System.
- E7.5 New decoder wiring shall be installed a minimum of 400 mm below finish grade elevations.

Measurement and Payment

- E7.6 Supply and Installation of the lateral 50 mm dia. water lines in each play field will be paid on a per lump sum basis and is to be included in related Soccer Field Lump Sum Unit Cost Items No. 2 or 3 "Play Field 9 or 10".
- E7.7 Supply and Installation of Field No: 10 decoder wiring will be paid on a per lump sum basis and is to be included in Unit Cost Items No, 1 "Field No: 10 Decoder Wiring and Ground Bar".

E8. SODDING

- E8.1 This specification shall amend C.W. 3510-R9.
- E8.2 The Contractor is responsible to repair any damage to the existing sod, on each play field
- E8.3 Further to CW 3510-R9, Item 9.6 Watering and Rolling, the Contractor is informed they may use the irrigation system for establishing the sod; however, depending on the river water levels, the City cannot guarantee when the system will be operable. The City will not be held responsible for any equipment failures with regards to operation of the irrigation pumps and equipment. The Contractor shall co-ordinate the installation of the new irrigation system to allow it to be utilized to restore the sod and repair all seam damage.
- E8.4 The Contractor is responsible for supplying all hoses, sprinklers, and fittings necessary, to connect to the existing irrigation quick couplers, should they wish to use the quick couplers for sodding repairs.
- E8.5 The preferred method of repairing the sod by each sprinkler head is to salvaged and careful remove the existing sod with a soil plug of approx. 100 to 150 mm thickness. The soil plugs should be as large as possible with fairly vertical sides and replaced in their original orientation and position. Prior to installing the salvaged plugs install a minimum 50 mm depth of compacted topsoil under each plug over the sand backfill.
- E8.6 Should the Contractor not want to salvage the existing grass for sodding repairs by the new sprinkler locations, all areas of new sod shall have a 150 mm depth of screened topsoil installed below the sod and not 75 mm as identified in CW 3540-R4. Specified depth shall be measured after the topsoil has been rolled with a 50kg roller, minimum 900 mm wide. The sod shall be

- installed with a slight crown above finish grade to allow for settlement. See detail 2-L1 for the sprinkler backfill and restoration requirements.
- E8.7 No separate payment will made for sodding restoration. Include any costs in the related soccer field lump sum cost.

E9. IRRIGATION SYSTEM

- E9.1 This specification shall amend C.W. 3530-R3.
- E9.2 Sprinkler heads shall be Toro model D2001, 25 mm full circle c/w rubber cover and stainless steel riser (54/min)
- E9.3 Provide PVC Sch 80 nipples (length to suit) and PVC Sch 40 fittings for extensions, to obtain correct head elevation while maintaining positive swing joint drainage back to the lateral line. Wrap Teflon tape on all the PVC tapered pipe thread connections.
- E9.4 Swing joints riser assemblies shall be a Spears model # 5807-01008, 25 mm pre-fabricated (mipt x mipt), or Lasco G132-208 both 25 mm mipt inlet and outlet, 200 mm lay length. Provide positive drainage back into the HDPE lateral lines.
- E9.5 Sprinkler take off saddles shall be Clamp-It model # 422010, 50 mm x 25 mm (fpt), or 50 x 25 Cal Am, for attaching swing joints to lateral irrigation pipe.
- E9.6 The pressure regulated solenoid valves shall be a Hunter model # PGV-201-AS (set point 3.5 bars), 50mm angle style configuration. Pre install Flo-Loc model # 135-20-41FL transition fittings into the valve outlet..
- E9.7 Provide PVC Sch 80 nipples (length to suit) and PVC Sch 40 fittings for extensions, to obtain correct valve elevation, see drawing detail 3-L1. Install 50 mm BII isolation valve below the assembly
- E9.8 Solenoid valve take off saddles shall be a Clamp-It model # 444020 or 443020; respective sizes are 100 mm x 50 mm (fpt) or 75 mm x 50 mm (fpt), or Lasco equivalent, for attaching solenoid valves to mainline irrigation pipe.
- E9.9 Provided a Hunter ICD-100 single station decoder with surge suppression and ground wire at every solenoid valve. Connect wires and ground according to the manufacturer's specifications. Record all locations with decoder serial numbers and program into the system controller (provide in the new pump house).
- E9.10 Decoder wiring connections to be made with 3M DBR-6 or DBY-6 wire splice kits. All wire splices are to be made in valve boxes. Provide as-built drawing of the wire splice locations (not including solenoid valves locations).
- E9.11 Provide Carson Model # 1419-12 valve boxes with bolt down Loc-Kit to cover the solenoid valves along each play field. Centre the solenoid valve in the valve box. See drawing detail 3-L1.
- E9.12 Provide Hunter IDWIRE1 #14 gauge colour coded decoder wire. From the field junction points use a vibratory plow with a wire chute on the blade to feed the decoder wire 400mm into the ground. Leave two (2) meters of slack at all the solenoid valves.
- E9.13 Provide a 100 mm wide x 900 mm long x 1.6 mm thick Paige part # 182201 copper ground plate with three (3) meters of #10 bare copper wire at designated locations, see drawing detail 1L1. Install as per manufacture recommendations. Bury the grounding plate 600 mm deep along side of the lateral line, three (3) metres from and perpendicular to the decoder wire path. Splice the #10 bare copper wire to the decoder ground wire with a King yellow nut connector. The maximum radius of bend of the #10 ground wire is 200 mm through a 90 degree turn. Megger test and record the earth to ground resistance of each grounding circuit (include the date tested/ohms on the as-built drawing)

- E9.14 Provide PE3408 HDPE SDR17 50 mm lateral line irrigation pipe through playing fields, (see drawing1-L1 for schematic). Pull a full length lateral line with a vibratory plow (no mechanical connections in fields). Install the pipe in the playing field to a depth of minimum 300 mm, but not greater than 400 mm, to the top of the pipe. Connect to the solenoid valve using a Flo-Lock transition adapter. Seal the end of the lateral line with a butt-fusion or socket fusion cap.
- E9.15 Flush mainline irrigation pipes in sections that are isolated by butterfly valves. Start-up and test all pressurized mainlines. Protect all installed equipment by completing installation and back filling before the end of a work day.

Measurement and Payment

- E9.16 Supply and Installation of the irrigation system for each soccer field will be paid on a lump sum bases and shall include all materials and labour for the water valves, valve box and fittings, water lines, sprinkler heads, sodding repairs and all other work incidental to the installation of the irrigations system. The cost for each field shall be indicated in the appropriate Soccer Field Lump Sum Unit Cost Items No. 2 or 3 "Soccer Field 9 or 10".
- E9.17 Supply and Installation of Field No: 10 decoder wiring will be paid on a per lump sum basis and is to be included in Unit Cost Items No, 1 "Soccer Field No:10 Decoder Wiring and Ground Bar".
