

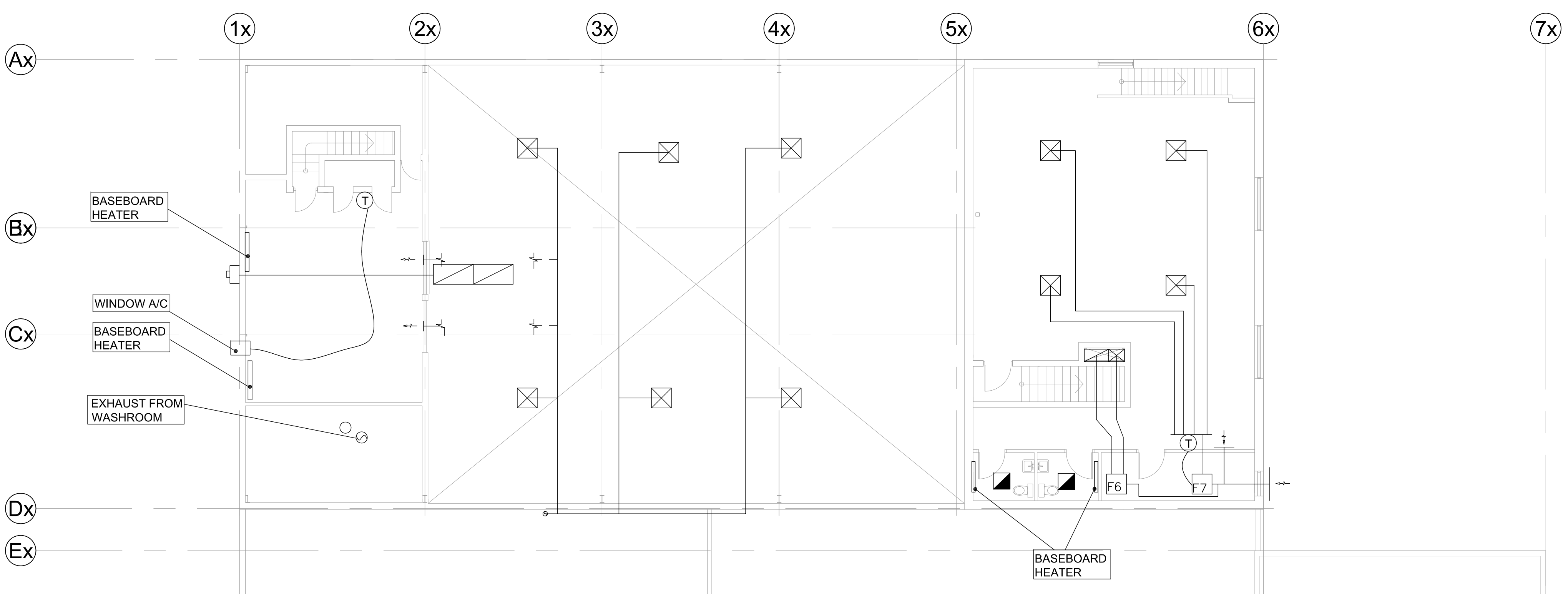
**1 EXISTING BUILDING MECHANICAL & PLUMBING DEMOLITION PLAN MAIN FLOOR**

**GENERAL NOTES:**

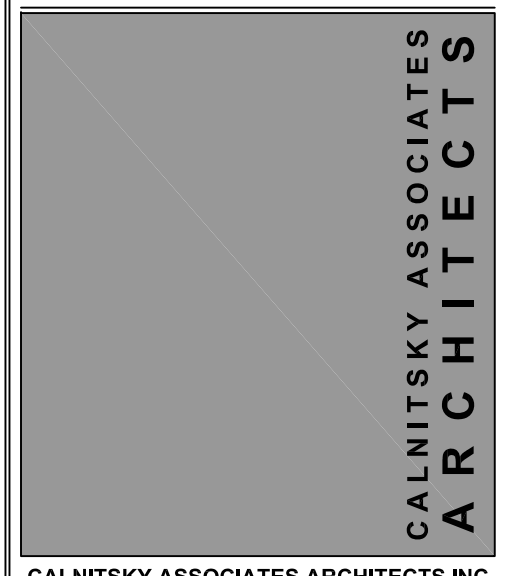
1. ADVISE GENERAL CONTRACTOR WHEN PATCHING WORK CAN BE DONE.
2. REMOVE DIFFUSERS & GRILLES PRIOR TO SPRINKLER INSTALLATION. REINSTALL DIFFUSERS & GRILLES AFTER SPRINKLER INSTALLATION. COORDINATE WITH SPRINKLER CONTRACTOR.
3. CONCEAL SPRINKLER HEADS IN ALL AREAS ,INCLUDING NEW AND EXISTING BUILDING, WITH T-BAR CEILINGS.
4. PROVIDE PROTECTION COVER FOR SPRINKLER HEADS INSIDE NEW GYM.
5. NO SPRINKLER PARTS SHALL EXTEND BEYOND UNDERSIDE OF JOISTS IN NEW GYM.
6. LOCATE SPARE PARTS CABINET FOR SPRINKLER SYSTEM IN NEW SPRINKLER ROOM.

**DRAWING NOTES:**

- ① REMOVE EXISTING FURNACE AND ITS ASSOCIATED COMPONENTS. RETURN FURNACE TO OWNER.
- ② REMOVE EXISTING EXHAUST FANS.
- ③ REMOVE EXISTING DOMESTIC WATER LINE AND CAP OFF AT BRANCH TAKE OFF. REMOVE SANITARY LINE AND CAP OFF AT BRANCH TAKE OFF. PATCH FLOORING PER THE ARCHITECTURAL FLOORING SPECIFICATIONS. RETURN WATER FOUNTAIN TO OWNER.
- ④ RELOCATE WATER LINE TO GARAGE TIGHT TO EAST WALL OF M/E ROOM 2438mm A.F.F. RELOCATE THE REST OF THE WATER COMPONENTS TIGHT TO NORTH WALL OF M/E ROOM.
- ⑤ REMOVE EXISTING HOT WATER TANK AND HOT WATER PIPING. RETURN WATER TANK TO OWNER. CAP COLD WATER SUPPLY TO HOT WATER TANK AT BRANCH TAKE-OFF.
- ⑥ REMOVE FORCED FLOW HEATERS AND RETURN TO OWNER.
- ⑦ REMOVE WINDOW A/C AND RETURN TO OWNER.
- ⑧ REMOVE EXISTING EXHAUST FAN TO BE RELOCATED.
- ⑨ REMOVE EXISTING INTAKE TO BE RELOCATED.



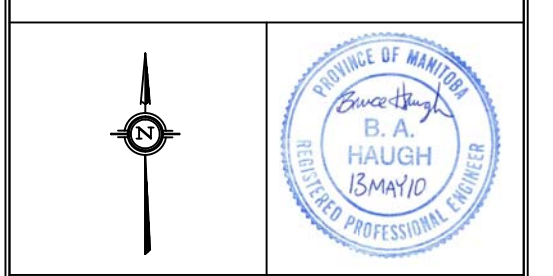
**2 EXISTING BUILDING MECHANICAL & PLUMBING DEMOLITION PLAN 2nd FLOOR**
