PART B - BIDDING PROCEDURES

B1. CONTRACT TITLE

B1.1 BCI II - ST VITAL WARD: DUCHARME PARK PLAYGROUND REDEVELOPMENT

B2. SUBMISSION DEADLINE

- B2.1 The Submission Deadline is 4:00 p.m. Winnipeg time, September 28, 2010.
- B2.2 Bids determined by the Manager of Materials to have been received later than the Submission Deadline will not be accepted and will be returned upon request.
- B2.3 The Contract Administrator or the Manager of Materials may extend the Submission Deadline by issuing an addendum at any time prior to the time and date specified in B2.1.

B3. SITE INVESTIGATION

- B3.1 Further to C3.1, the Bidder may view the Site without making an appointment.
- B3.2 The Bidder is advised that construction Site access is limited.
- B3.3 The Bidder is advised that the Salvation Army Multicultural Family Centre, located next to Ducharme Park Site, is being redeveloped including the construction of a new building, demolition of the existing building and new site development. This is scheduled for 2010-2011 at the same time as the Work at Ducharme Park.

B4. ENQUIRIES

- B4.1 All enquiries shall be directed to the Contract Administrator identified in D3.1.
- B4.2 If the Bidder finds errors, discrepancies or omissions in the Bid Opportunity, or is unsure of the meaning or intent of any provision therein, the Bidder shall notify the Contract Administrator of the error, discrepancy or omission, or request a clarification as to the meaning or intent of the provision at least five (5) Business Days prior to the Submission Deadline.
- B4.3 Responses to enquiries which, in the sole judgment of the Contract Administrator, require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator to all Bidders by issuing an addendum.
- B4.4 Responses to enquiries which, in the sole judgment of the Contract Administrator, do not require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator only to the Bidder who made the enquiry.
- B4.5 The Bidder shall not be entitled to rely on any response or interpretation received pursuant to B4 unless that response or interpretation is provided by the Contract Administrator in writing.

B5. ADDENDA

- B5.1 The Contract Administrator may, at any time prior to the Submission Deadline, issue addenda correcting errors, discrepancies or omissions in the Bid Opportunity, or clarifying the meaning or intent of any provision therein.
- B5.2 The Contract Administrator will issue each addendum at least two (2) Business Days prior to the Submission Deadline, or provide at least two (2) Business Days by extending the Submission Deadline.
- B5.2.1 Addenda will be available on the Bid Opportunities page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt

- B5.2.2 The Bidder is responsible for ensuring that he has received all addenda and is advised to check the Materials Management Division website for addenda regularly and shortly before the Submission Deadline, as may be amended by addendum.
- B5.2.3 The Bidder shall acknowledge receipt of each addendum in Paragraph 8 of Form A: Bid. Failure to acknowledge receipt of an addendum may render a Bid non-responsive.

B6. SUBSTITUTES

- B6.1 The Work is based on the Plant, Materials and methods specified in the Bid Opportunity.
- B6.2 Substitutions shall not be allowed unless application has been made to and prior approval has been granted by the Contract Administrator in writing.
- B6.3 Requests for approval of a substitute will not be considered unless received in writing by the Contract Administrator at least five (5) Business Days prior to the Submission Deadline.
- B6.4 The Bidder shall ensure that any and all requests for approval of a substitute:
 - (a) provide sufficient information and details to enable the Contract Administrator to determine the acceptability of the Plant, Material or method as either an approved equal or alternative;
 - (b) identify any and all changes required in the applicable Work, and all changes to any other Work, which would become necessary to accommodate the substitute;
 - (c) identify any anticipated cost or time savings that may be associated with the substitute;
 - (d) certify that, in the case of a request for approval as an approved equal, the substitute will fully perform the functions called for by the general design, be of equal or superior substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance;
 - (e) certify that, in the case of a request for approval as an approved alternative, the substitute will adequately perform the functions called for by the general design, be similar in substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance.
- B6.5 The Contract Administrator, after assessing the request for approval of a substitute, may in his sole discretion grant approval for the use of a substitute as an "approved equal" or as an "approved alternative", or may refuse to grant approval of the substitute.
- B6.6 The Contract Administrator will provide a response in writing, at least two (2) Business Days prior to the Submission Deadline, only to the Bidder who requested approval of the substitute.
- B6.6.1 The Bidder requesting and obtaining the approval of a substitute shall be entirely responsible for disseminating information regarding the approval to any person or persons he wishes to inform.
- B6.7 If the Contract Administrator approves a substitute as an "approved equal", any Bidder may use the approved equal in place of the specified item.
- B6.8 If the Contract Administrator approves a substitute as an "approved alternative", any Bidder bidding that approved alternative may base his Total Bid Price upon the specified item but may also indicate an alternative price based upon the approved alternative. Such alternatives will be evaluated in accordance with B14.
- B6.9 No later claim by the Contractor for an addition to the Total Bid Price because of any other changes in the Work necessitated by the use of an approved equal or an approved alternative will be considered.

B6.10 Notwithstanding B6.2 to B6.9, and in accordance with B7.7, deviations inconsistent with the Bid Opportunity document shall be evaluated in accordance with B14.1(a).

B7. BID COMPONENTS

- B7.1 The Bid shall consist of the following components:
 - (a) Form A: Bid;
 - (b) Form B: Prices;
- B7.2 Further to B7.1, the Bidder should include the written correspondence from the Contract Administrator approving a substitute in accordance with B6.
- B7.3 All components of the Bid shall be fully completed or provided, and submitted by the Bidder no later than the Submission Deadline, with all required entries made clearly and completely, to constitute a responsive Bid.
- B7.4 The Bid Submission may be submitted by mail, courier or personal delivery, or by facsimile transmission.
- B7.5 If the Bid Submission is submitted by mail, courier or personal delivery, it shall be enclosed and sealed in an envelope clearly marked with the Bid Opportunity number and the Bidder's name and address, and shall be submitted to:

- B7.5.1 Samples or other components of the Bid Submission which cannot reasonably be enclosed in the envelope may be packaged separately, but shall be clearly marked with the Bid Opportunity number, the Bidder's name and address, and an indication that the contents are part of the Bidder's Bid Submission.
- B7.6 Bidders are advised not to include any information/literature except as requested in accordance with B7.1.
- B7.7 Bidders are advised that inclusion of terms and conditions inconsistent with the Bid Opportunity document, including the General Conditions, will be evaluated in accordance with B14.1(a).
- B7.8 If the Bid Submission is submitted by facsimile transmission, it shall be submitted to (204) 949-1178.
- B7.8.1 The Bidder is advised that the City cannot take responsibility for the availability of the facsimile machine at any time.
- B7.8.2 Bids submitted by internet electronic mail (e-mail) will not be accepted.

B8. BID

- B8.1 The Bidder shall complete Form A: Bid, making all required entries.
- B8.2 Paragraph 2 of Form A: Bid shall be completed in accordance with the following requirements:
 - (a) if the Bidder is a sole proprietor carrying on business in his own name, his name shall be inserted;
 - (b) if the Bidder is a partnership, the full name of the partnership shall be inserted;
 - (c) if the Bidder is a corporation, the full name of the corporation shall be inserted;

- (d) if the Bidder is carrying on business under a name other than his own, the business name and the name of every partner or corporation who is the owner of such business name shall be inserted.
- B8.2.1 If a Bid is submitted jointly by two or more persons, each and all such persons shall identify themselves in accordance with B8.2.
- B8.3 In Paragraph 3 of Form A: Bid, the Bidder shall identify a contact person who is authorized to represent the Bidder for purposes of the Bid.
- B8.4 Paragraph 10 of Form A: Bid shall be signed in accordance with the following requirements:
 - (a) if the Bidder is a sole proprietor carrying on business in his own name, it shall be signed by the Bidder:
 - (b) if the Bidder is a partnership, it shall be signed by the partner or partners who have authority to sign for the partnership;
 - (c) if the Bidder is a corporation, it shall be signed by its duly authorized officer or officers;
 - (d) if the Bidder is carrying on business under a name other than his own, it shall be signed by the registered owner of the business name, or by the registered owner's authorized officials if the owner is a partnership or a corporation.
- B8.4.1 The name and official capacity of all individuals signing Form A: Bid should be printed below such signatures.
- B8.4.2 All signatures shall be original.
- B8.5 If a Bid is submitted jointly by two or more persons, the word "Bidder" shall mean each and all such persons, and the undertakings, covenants and obligations of such joint Bidders in the Bid and the Contract, when awarded, shall be both joint and several.

B9. **PRICES**

- B9.1 The Bidder shall state a price in Canadian funds for each item of the Work identified on Form B: Prices.
- B9.1.1 Notwithstanding C12.2.3(c), prices on Form B: Prices shall include the Manitoba Retail Sales Tax (MRST, also known as PST).
- B9.2 The quantities listed on Form B: Prices are to be considered approximate only. The City will use said quantities for the purpose of comparing Bids.
- B9.3 The quantities for which payment will be made to the Contractor are to be determined by the Work actually performed and completed by the Contractor, to be measured as specified in the applicable Specifications.
- B9.4 Payments to Non-Resident Contractors are subject to Non-Resident Withholding Tax pursuant to the Income Tax Act (Canada).

B10. **QUALIFICATION**

- The Bidder shall: B10.1
 - (a) undertake to be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba; and
 - (b) be financially capable of carrying out the terms of the Contract; and
 - (c) have all the necessary experience, capital, organization, and equipment to perform the Work in strict accordance with the terms and provisions of the Contract.

- B10.2 The Bidder and any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
 - (a) be responsible and not be suspended, debarred or in default of any obligations to the City. A list of suspended or debarred individuals and companies is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmqt/debar.stm
- B10.3 The Bidder and/or any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
 - (a) have successfully carried out work similar in nature, scope and value to the Work; and
 - (b) be fully capable of performing the Work required to be in strict accordance with the terms and provisions of the Contract; and
 - (c) have a written workplace safety and health program if required pursuant to The Workplace Safety and Health Act (Manitoba).
- B10.4 Further to B10.3(c), the Bidder shall, within five (5) Business Days of a request by the Contract Administrator, provide proof satisfactory to the Contract Administrator that the Bidder/Subcontractors has a workplace safety and health program meeting the requirements of The Workplace Safety and Health Act (Manitoba), by providing:
 - (a) a valid COR certification number under the Certificate of Recognition (COR) Program administered by the Manitoba Construction Safety Association or by the Manitoba Heavy Construction Association's Safety, Health and Environment Program; or
 - (b) a report or letter to that effect from an independent reviewer acceptable to the City. (A list of acceptable reviewers and the review template are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt)
- B10.5 The Bidder shall submit, within three (3) Business Days of a request by the Contract Administrator, proof satisfactory to the Contract Administrator of the qualifications of the Bidder and of any proposed Subcontractor.
- B10.6 The Bidder shall provide, on the request of the Contract Administrator, full access to any of the Bidder's equipment and facilities to confirm, to the Contract Administrator's satisfaction, that the Bidder's equipment and facilities are adequate to perform the Work.

B11. OPENING OF BIDS AND RELEASE OF INFORMATION

- B11.1 Bids will not be opened publicly.
- B11.2 Following the submission deadline, the names of the Bidders and their Total Bid Prices (unevaluated, and pending review and verification of conformance with requirements) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/bidopp.asp
- B11.3 After award of Contract, the name(s) of the successful Bidder(s) and the Contract Amount(s) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt
- B11.4 The Bidder is advised that any information contained in any Bid may be released if required by City policy or procedures, by The Freedom of Information and Protection of Privacy Act (Manitoba), by other authorities having jurisdiction, or by law.

B12. IRREVOCABLE BID

- B12.1 The Bid(s) submitted by the Bidder shall be irrevocable for the time period specified in Paragraph 9 of Form A: Bid.
- B12.2 The acceptance by the City of any Bid shall not release the Bids of the next two lowest evaluated responsive Bidders and these Bidders shall be bound by their Bids on such Work for the time period specified in Paragraph 9 of Form A: Bid.

B13. WITHDRAWAL OF BIDS

- B13.1 A Bidder may withdraw his Bid without penalty by giving written notice to the Manager of Materials at any time prior to the Submission Deadline.
- B13.1.1 Notwithstanding C23.3, the time and date of receipt of any notice withdrawing a Bid shall be the time and date of receipt as determined by the Manager of Materials.
- B13.1.2 The City will assume that any one of the contact persons named in Paragraph 3 of Form A: Bid or the Bidder's authorized representatives named in Paragraph 10 of Form A: Bid, and only such person, has authority to give notice of withdrawal.
- B13.1.3 If a Bidder gives notice of withdrawal prior to the Submission Deadline, the Manager of Materials will:
 - (a) retain the Bid until after the Submission Deadline has elapsed;
 - (b) open the Bid to identify the contact person named in Paragraph 3 of Form A: Bid and the Bidder's authorized representatives named in Paragraph 10 of Form A: Bid; and
 - (c) if the notice has been given by any one of the persons specified in B13.1.3(b), declare the Bid withdrawn.
- B13.2 A Bidder who withdraws his Bid after the Submission Deadline but before his Bid has been released or has lapsed as provided for in B12.2 shall be liable for such damages as are imposed upon the Bidder by law and subject to such sanctions as the Chief Administrative Officer considers appropriate in the circumstances. The City, in such event, shall be entitled to all rights and remedies available to it at law.

B14. EVALUATION OF BIDS

- B14.1 Award of the Contract shall be based on the following bid evaluation criteria:
 - (a) compliance by the Bidder with the requirements of the Bid Opportunity or acceptable deviation there from (pass/fail);
 - (b) qualifications of the Bidder and the Subcontractors, if any, pursuant to B10 (pass/fail);
 - (c) Total Bid Price:
 - (d) economic analysis of any approved alternative pursuant to B6.
- B14.2 Further to B14.1(a), the Award Authority may reject a Bid as being non-responsive if the Bid is incomplete, obscure or conditional, or contains additions, deletions, alterations or other irregularities. The Award Authority may reject all or any part of any Bid, or waive technical requirements or minor informalities or irregularities, if the interests of the City so require.
- B14.3 Further to B14.1(b), the Award Authority shall reject any Bid submitted by a Bidder who does not demonstrate, in his Bid or in other information required to be submitted, that he is responsible and qualified.
- B14.4 Further to B14.1(c), the Total Bid Price shall be the sum of the quantities multiplied by the unit prices for each item shown on Form B: Prices.
- B14.4.1 If there is any discrepancy between the Total Bid Price written in figures, the Total Bid Price written in words and the sum of the quantities multiplied by the unit prices for each

item, the sum of the quantities multiplied by the unit prices for each item shall take precedence.

B14.4.2 Further to B14.1(a), in the event that a unit price is not provided on Form B: Prices, the City will determine the unit price by dividing the Amount (extended price) by the approximate quantity, for the purposes of evaluation and payment.

B15. AWARD OF CONTRACT

- B15.1 The City will give notice of the award of the Contract or will give notice that no award will be made.
- B15.2 The City will have no obligation to award a Contract to a Bidder, even though one or all of the Bidders are determined to be responsible and qualified, and the Bids are determined to be responsive.
- B15.2.1 Without limiting the generality of B15.2, the City will have no obligation to award a Contract where:
 - (a) the prices exceed the available City funds for the Work;
 - (b) the prices are materially in excess of the prices received for similar work in the past;
 - (c) the prices are materially in excess of the City's cost to perform the Work, or a significant portion thereof, with its own forces;
 - (d) only one Bid is received; or
 - (e) in the judgment of the Award Authority, the interests of the City would best be served by not awarding a Contract.
- B15.3 Where an award of Contract is made by the City, the award shall be made to the responsible and qualified Bidder submitting the lowest evaluated responsive Bid, in accordance with B14.
- B15.3.1 Following the award of contract, a Bidder will be provided with information related to the evaluation of his Bid upon written request to the Contract Administrator.
- B15.4 Notwithstanding C4, the City will issue a Purchase Order to the successful Bidder in lieu of the execution of a Contract.
- B15.5 The Contract, as defined in C1.1, in its entirety shall be deemed to be incorporated in and to form a part of the Purchase Order notwithstanding that it is not necessarily attached to or accompany said Purchase Order.

PART C - GENERAL CONDITIONS

C0. GENERAL CONDITIONS

- C0.1 The *General Conditions for Construction* (Revision 2006 12 15) are applicable to the Work of the Contract.
- C0.1.1 The General Conditions for Construction are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmqt/gen_cond.stm
- C0.2 A reference in the Bid Opportunity to a section, clause or subclause with the prefix "C" designates a section, clause or subclause in the *General Conditions for Construction*.

PART D - SUPPLEMENTAL CONDITIONS

GENERAL

D1. GENERAL CONDITIONS

D1.1 In addition to the *General Conditions for Construction*, these Supplemental Conditions are applicable to the Work of the Contract.

D2. SCOPE OF WORK

- D2.1 The Work to be done under the Contract shall consist of the redevelopment of the playground at Ducharme Park, located on Morrow Avenue, Winnipeg.
- D2.2 The major components of the Work are as follows:
 - (a) Removal of existing play equipment, timber edging, protective surfacing, picnic shelter, site furniture, bollards, fencing, and asphalt and concrete paths;
 - (b) Site grading and the supply and installation of subsurface drainage systems;
 - (c) Supply and installation of timber edging;
 - (d) Supply and installation of wood fibre protective surfacing system;
 - (e) Supply and installation of sand play area.
 - (f) Supply and installation of asphalt paving/paths;
 - (g) Supply and installation of fencing;
 - (h) Supply and installation of site furniture;
 - (i) Supply and installation of new swings and other play equipment;
 - (j) Supply and installation of topsoil and sod.

D3.2 At the pre-construction meeting, Laurie Lamb Wagner will identify additional personnel representing the Contract Administrator and their respective roles and responsibilities for the Work.

D4. CONTRACTOR'S SUPERVISOR

D4.1 At the pre-construction meeting, the Contractor shall identify his designated supervisor and any additional personnel representing the Contractor and their respective roles and responsibilities for the Work.

D5. NOTICES

D5.1 Except as provided for in C23.2.2, all notices, requests, nominations, proposals, consents, approvals, statements, authorizations, documents or other communications to the Contractor

- shall be sent to the address or facsimile number identified by the Contractor in Paragraph 2 of Form A: Bid.
- D5.2 All notices, requests, nominations, proposals, consents, approvals, statements, authorizations, documents or other communications to the City, except as expressly otherwise required in D5.3, D5.4 or elsewhere in the Contract, shall be sent to the attention of the Contract Administrator at the address or e-mail address identified in D3.1.
- D5.3 Notwithstanding C21., all notices of appeal to the Chief Administrative Officer shall be sent to the attention of the Chief Financial Officer at the following facsimile number:

SUBMISSIONS

D6. AUTHORITY TO CARRY ON BUSINESS

D6.1 The Contractor shall be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba, or if the Contractor does not carry on business in Manitoba, in the jurisdiction where the Contractor does carry on business, throughout the term of the Contract, and shall provide the Contract Administrator with evidence thereof upon request.

D7. SAFE WORK PLAN

- D7.1 The Contractor shall provide the Contract Administrator with a Safe Work Plan at least five (5) Business Days prior to the commencement of any Work on the Site but in no event later than the date specified in C4.1 for the return of the executed Contract.
- D7.2 The Safe Work Plan should be prepared and submitted in the format shown in the City's template which is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/Safety/default.stm

D8. INSURANCE

- D8.1 The Contractor shall provide and maintain the following insurance coverage:
 - (a) commercial general liability insurance, in the amount of at least two million dollars (\$2,000,000.00) inclusive, with The City of Winnipeg and David Wagner Associates Inc. added as an additional insured, with a cross-liability clause, such liability policy to also contain contractual liability, unlicensed motor vehicle liability, non-owned automobile liability and products and completed operations, to remain in place at all times during the performance of the Work and throughout the warranty period;

- (b) automobile liability insurance for owned automobiles used for or in connection with the Work in the amount of at least two million dollars (\$2,000,000.00) at all times during the performance of the Work and until the date of Total Performance:
- D8.2 Deductibles shall be borne by the Contractor.
- D8.3 The Contractor shall provide the Contract Administrator with a certificate(s) of insurance, in a form satisfactory to the City Solicitor, at least two (2) Business Days prior to the commencement of any Work but in no event later than seven (7) Calendar Days from notification of the award of Contract by Purchase Order.
- D8.4 The Contractor shall not cancel, materially alter, or cause each policy to lapse without providing at least thirty (30) Calendar Days prior written notice to the Contract Administrator.

D9. PERFORMANCE SECURITY

- D9.1 If the Contract Price exceeds one hundred thousand dollars (\$100,000.00), the Contractor shall provide and maintain performance security until the expiration of the warranty period in the form of:
 - (a) a performance bond of a company registered to conduct the business of a surety in Manitoba, in the form attached to these Supplemental Conditions (Form H1: Performance Bond), in the amount of fifty percent (50%) of the Contract Price; or
 - (b) an irrevocable standby letter of credit issued by a bank or other financial institution registered to conduct business in Manitoba and drawn on a branch located in Winnipeg, in the form attached to these Supplemental Conditions (Form H2: Irrevocable Standby Letter of Credit), in the amount of fifty percent (50%) of the Contract Price; or
 - (c) a certified cheque or draft payable to "The City of Winnipeg", drawn on a bank or other financial institution registered to conduct business in Manitoba, in the amount of fifty percent (50%) of the Contract Price.
- D9.1.1 Where the performance security is in the form of a certified cheque or draft, it will be deposited by the City. The City will not pay any interest on certified cheques or drafts furnished as performance security.
- D9.2 The Contractor shall provide the City Solicitor with the required performance security within seven (7) Calendar Days of notification of the award of the Contract by way of Purchase Order and prior to the commencement of any Work on the Site.

D10. SUBCONTRACTOR LIST

- D10.1 The Contractor shall provide the Contract Administrator with a complete list of the Subcontractors whom the Contractor proposes to engage (Form J: Subcontractor List) at least two (2) Business Days prior to the commencement of any Work on the Site but in no event later than seven (7) Calendar Days from notification of the award of Contract.
- D10.2 The Bidder shall list the play equipment installer even if the Bidder intends to perform the Work with his own crew.

D11. DETAILED WORK SCHEDULE

- D11.1 The Bidder shall provide a detailed work schedule (Form L: Detailed Work Schedule).
- D11.2 The detailed work schedule shall adhere to the requirements set out in the Critical Stages, D13.
- D11.3 The detailed work schedule shall consist of the following:
 - (a) Ordering of play equipment;
 - (b) Delivery of play equipment;

- (c) Start of Work on Site;
- (d) Removals, excavation and site preparation;
- (e) Installation of play equipment and site furnishings including the excavation of holes and concrete pouring for posts;
- (f) Site development and site restoration;
- (g) Completion.

SCHEDULE OF WORK

D12. COMMENCEMENT

- D12.1 The Contractor shall not commence any Work until he is in receipt of a Purchase Order from the Award Authority authorizing the commencement of the Work.
- D12.2 The Contractor shall not commence any Work on the Site until:
 - (a) the Contract Administrator has confirmed receipt and approval of:
 - (i) evidence of authority to carry on business specified in D6;
 - (ii) evidence of the workers compensation coverage specified in C6.15;
 - (iii) the Safe Work Plan specified inD7;
 - (iv) evidence of the insurance specified in D8;
 - (v) the performance security specified in D9;
 - (vi) the Subcontractor list specified in D10; and
 - (vii) the detailed Work schedule specified in D11.
 - (b) the Contractor has attended a pre-construction meeting with the Contract Administrator, or the Contract Administrator has waived the requirement for a pre-construction meeting.
- D12.3 The Contractor shall commence the Work on the Site within seven (7) Working Days of receipt of the Purchase Order.
- D12.4 The City intends to award this Contract within four (4) weeks after Submission Deadline.
- D12.4.1 If the actual date of award is later than the intended date, the dates specified for Critical Stages, Substantial Performance, and Total Performance will be adjusted by the difference between the aforementioned intended and actual dates.

D13. CRITICAL STAGES

- D13.1 The Contractor shall achieve critical stages of the Work in accordance with the following requirements:
 - (a) Phase I A minimum of Items 23, 24, 25, 26, 27, 28, 31, and 32 on Form B: Prices must be supplied and delivered to a City of Winnipeg storage facility by December 15, 2010.

D14. SUBSTANTIAL PERFORMANCE

- D14.1 The Contractor shall achieve Substantial Performance by June 15, 2011.
- D14.2 When the Contractor considers the Work to be substantially performed, the Contractor shall arrange, attend and assist in the inspection of the Work with the Contract Administrator for purposes of verifying Substantial Performance. Any defects or deficiencies in the Work noted during that inspection shall be remedied by the Contractor at the earliest possible instance and the Contract Administrator notified so that the Work can be reinspected.
- D14.3 The date on which the Work has been certified by the Contract Administrator as being substantially performed to the requirements of the Contract through the issue of a certificate of Substantial Performance is the date on which Substantial Performance has been achieved.

D15. TOTAL PERFORMANCE

- D15.1 The Contractor shall achieve Total Performance by July 15, 2011.
- D15.2 When the Contractor or the Contract Administrator considers the Work to be totally performed, the Contractor shall arrange, attend and assist in the inspection of the Work with the Contract Administrator for purposes of verifying Total Performance. Any defects or deficiencies in the Work noted during that inspection shall be remedied by the Contractor at the earliest possible instance and the Contract Administrator notified so that the Work can be reinspected.
- D15.3 The date on which the Work has been certified by the Contract Administrator as being totally performed to the requirements of the Contract through the issue of a certificate of Total Performance is the date on which Total Performance has been achieved.

D16. LIQUIDATED DAMAGES

- D16.1 If the Contractor fails to achieve Critical Stages, Substantial Performance or Total Performance in accordance with the Contract by the days fixed herein for same, the Contractor shall pay the City the following amounts per Calendar Day for each and every Calendar Day following the days fixed herein for same during which such failure continues:
 - (a) Critical Stages five hundred dollars (\$500);
 - (b) Substantial Performance five hundred dollars (\$500);
 - (c) Total Performance five hundred dollars (\$500).
- D16.2 The amounts specified for liquidated damages in D16.1 are based on a genuine pre-estimate of the City's losses in the event that the Contractor does not achieve critical stages, Substantial Performance or Total Performance by the days fixed herein for same.
- D16.3 The City may reduce any payment to the Contractor by the amount of any liquidated damages assessed.

D17. SCHEDULED MAINTENANCE

- D17.1 The Contractor shall perform the following scheduled maintenance in the manner and within the time periods required by the Specifications:

- D17.2 Determination of Substantial Performance and Total Performance shall be exclusive of scheduled maintenance identified herein. Where the scheduled maintenance cannot be completed during the warranty period, the warranty period shall be extended for such period of time as it takes the Contractor to complete the scheduled maintenance.

CONTROL OF WORK

D18. JOB MEETINGS

- D18.1 Regular job meetings will be held at the Site as determined at the pre-construction meeting. These meetings shall be attended by a minimum of one representative of the Contract Administrator, one representative of the City and one representative of the Contractor. Each representative shall be a responsible person capable of expressing the position of the Contract Administrator, the City and the Contractor respectively on any matter discussed at the meeting including the Work schedule and the need to make any revisions to the Work schedule. The progress of the Work will be reviewed at each of these meetings.
- D18.2 The Contract Administrator reserves the right to cancel any job meeting or call additional job meetings whenever he deems it necessary.

D19. PRIME CONTRACTOR – THE WORKPLACE SAFETY AND HEALTH ACT (MANITOBA)

D19.1 Further to C6.24, the Contractor shall be the Prime Contractor and shall serve as, and have the duties of the Prime Contractor in accordance with The Workplace Safety and Health Act (Manitoba).

D20. PAYMENT

D20.1 Further to C12, the City may at its option pay the Contractor by direct deposit to the Contractor's banking institution.

E2. SITE ACCESS

- E2.1 Access to the Site will be determined at the pre-construction meeting. The access areas shall be maintained and restored by the Contractor at his own expense and approved by the Contract Administrator.
- E2.2 The Contractor's operations shall be limited to the Site access location and the minimum area necessary for undertaking the Work. The Contractor shall be responsible for all damage resulting from his Work on private or public property.

E3. PERMITS, NOTICES, LICENSES, CERTIFICATES, LAWS AND RULES

- E3.1 Further to C: 6.12, the Contractor shall give all necessary notices, obtain all necessary permits and pay all fees in order that the Work may be carried out. The Contractor shall submit all plans required by any inspection authority and obtain approval of same before proceeding with the Work, and pay any cost attached to the inspection of such plans.
- E3.2 The Contractor shall comply with all laws, ordinances, rules and regulations that would relate to the Work.
- E3.3 All notices, consents, approvals, statements, authorizations, documents or other communications to the City shall be submitted to the Contract Administrator.
- E3.4 All Work shall be performed in compliance with Manitoba Workplace Safety and Health.
- E3.5 All Work shall be performed in compliance with Manitoba Workplace Safety and Health Fall Protection guidelines.

E3.6 The Contractor and Sub-contractors must be fully aware of all Work involving hazardous materials. All Work must be performed in compliance with the Manitoba Department of Labour Workplace Safety and Health Guidelines and all other applicable codes. The Contractor is responsible for the immediate notification to the Contract Administrator of his/her encountering of suspected hazardous material during their course of Work.

E4. DAMAGE TO EXISTING STRUCTURES AND PROPERTY

Further to C: 17, all necessary precautions shall be exercised by the Contractor so as not to remove, disturb, or damage any existing trees, shrubs, sod, pavements, streets, roads, boulevards, poles, hydrants, water pipes, gas pipes, electrical wires, cables, conduits, sewers or other existing facilities and equipment at the Sites of the Work. For all damage incurred thereto in the performance of the Work, the Contractor shall upon instructions from and to the satisfaction of the Contract Administrator and the owners thereof, either replace and repair such damage, whichever may be deemed necessary in the opinion of, and acceptable to, the Contract Administrator and the owners thereof. The cost of which shall be borne entirely by the Contractor. The Contractor shall also indemnify and save harmless the City and David Wagner Associates Inc. from all claims made directly or indirectly against it in respect to any such damage.

E5. EXISTING SERVICES AND UTILITIES

E5.1 No responsibility will be assumed by the Owner for correctness or completeness of the Drawings, when provided, with respect to the existing utilities, pipes or other objects either underground or on the surface; the Owner shall not be liable for the incorrectness and inadequacy thereof. It shall be the responsibility of the Contractor to determine the location of all such utilities, pipes and other objects and to make good any damage done to them.

E6. PROTECTION OF EXISTING TREES

- E6.1 The Contractor shall take the following precautionary steps to prevent damage from construction activities to existing trees within the limits of the construction area:
 - (a) The Contractor shall not stockpile materials and soil or park vehicles and equipment within 2 metres of trees.
 - (b) Trees identified to be at risk by the Contract Administrator are to be strapped with 25x100x2440 mm wood planks, or other suitable protection as approved by the Contract Administrator. Do not use nails or other fasteners that penetrate the tree trunk. The width and length of strapping may be reduced to suit the tree being protected as approved by the Contract Administrator.
 - (c) Excavation shall be performed in a manner that minimizes damage to the existing root systems. Where possible, excavation shall be carried out such that the edge of the excavation shall be a minimum of 1.5 times the diameter (measured in inches) where 1 inch diameter equals 1 foot measured from the closest edge of the trunk of the tree at 6 inches above grade. Where roots must be cut to facilitate excavation, they shall be pruned neatly at the face of excavation.
 - (d) Operation of equipment within the drip line of the trees shall be kept to a minimum required to perform the Work required. Equipment shall not be parked, repaired, refuelled; construction materials shall not be stored, and earth materials shall not be stockpiled within the drip lines of trees. The drip line of a tree shall be considered to be the entire ground surface located directly beneath the tree and radiating out to the tips of its outermost branches. The Contractor shall ensure that the operations do not cause flooding or sediment deposition on areas where trees are located.
 - (e) Repair, replace and maintain tree protection materials during construction until the Project completion.
 - (f) Carefully remove safety fencing and strapping material without harming the trees as soon as the construction and restoration Work is complete.

- E6.2 Obtain approval from the Contract Administrator to excavate within 2.0 M of a tree.
- E6.3 Take precautions to ensure tree limbs overhanging the Work area are not damaged by construction equipment. Contact the Forestry Branch for consultation or pruning of overhanging or damaged limbs and branches and other unanticipated problems with trees during the construction of the Works.
- E6.4 All damage or pruning required to existing trees caused by the Contractor's activities shall be repaired to the requirements and satisfaction of the Contract Administrator and the Forestry Branch. Damages must be repaired by an Individual with a Manitoba Arborist Licence or by the Forestry Branch.
- E6.5 Protection of existing trees, repair of trees and pruning of damaged limbs will not be measured for payment and is to be included with the Underground or Surface Works. Removal and replacement of existing trees by the Forestry Branch deemed to have died or that are dying due to damage from carelessness during construction, will be at the Contractor's cost. The Contractor will be invoiced for the cost, or have the cost deducted from any payments owing.

E7. PROTECTION OF SURVEY INFRASTRUCTURE

E7.1 The project has been cleared for survey monuments. The Geomatics Cleared Job Number is 11378.

E8. TEMPORARY UTILITIES

- E8.1 Further to C: 6.12, the Contractor shall make his own arrangements in connection with the temporary use of lighting, power, gas, sewer, water or other utilities, and pay all costs in connection therewith.
- E8.2 All necessary permits, fees and other like expenses as well as the cost of temporary connections to existing facilities shall be arranged and paid for by the Contractor.

E9. RELATED WORKS BY OTHERS

- E9.1 The Salvation Army Multicultural Family Centre, located next to Ducharme Park Site, is being redeveloped including the construction of a new building, demolition of the existing building and new site development. This is scheduled for 2010-2011 at the same time as the Work at Ducharme Park.
- E9.2 The Contractor shall complete the Work along the west property line to meet the site development adjoining it by the other project.

E10. SITE ENCLOSURES

- E10.1 Temporary Site enclosures, if determined necessary at the pre-construction meeting, shall be erected and maintained as required for the duration of the construction period.
- E10.2 Site enclosures shall be considered incidental to the Contract Work.

E11. LAYOUT

- E11.1 The Contractor is responsible for the layout of all Work. The Contractor is to coordinate the layout of all play spaces with the play equipment suppliers to ensure that CSA requirements are met.
- E11.2 The Contract Administrator shall be advised of the staking of the layout at least twenty-four (24) hours in advance in order that the layout may be inspected and adjusted as required prior to construction.

E12. SITE RESTORATION

E12.1 Total Performance of the Work shall not be attained until the Contractor has cleaned up the Site and has removed all tools, equipment, waste, debris and surplus foundation earth to the satisfaction of the Contract Administrator. Unless otherwise specified, the Contractor shall restore all areas of the Site beyond the established limit of Work, which have been disturbed by the Contractor's operations to as good as or better than the original condition to the satisfaction of the Contract Administrator. The Contractor shall pay all costs associated with this Work.

E13. CANADIAN STANDARDS ASSOCIATION

E13.1 All playground equipment supplied and the method of installation shall be in accordance with the latest edition of the "National Standard of Canada. CAN/CSA-Z614-07".

E14. MAINTENANCE KITS

E14.1 All play equipment shall include, at no extra cost, the supply of maintenance kits. Maintenance kits shall include maintenance manuals, complete manufacturer's parts lists, touch-up paint, PVC repair paint, 10% extra of each bolt, washer and any other hardware utilized on the play equipment, and all special tools necessary for assembly and maintenance.

WORKS

E15. DEMOLITION AND REMOVALS

E15.1 General Description

(a) This specification shall cover the removal of the existing play equipment, picnic shelter, site furniture, bollards, fencing, timber edging, pea stone and sand protective surfacing, concrete paving and asphalt paving, as scheduled for removal and shown on the Drawings. It shall also cover any demolition and removal necessary to construct the project, which may be considered incidental to other items of Work.

E15.2 Removals

- (a) All materials, to be demolished and removed, are to be removed from the Site and disposed of in a safe and legal manner.
- (b) Play equipment is to be removed including any bases or foundations in their entirety. Removals are to be scheduled such that no partial or unsafe structures are left unsecured.
- (c) The picnic shelter and site furniture, including benches, waste receptacles, and bike racks, are to be removed including any bases, foundations and concrete pads in their entirety.
- (d) Existing bollards and fences are to be removed, including any foundations in their entirety.
- (e) Existing timber edging, sand and pea stone protective surfacing shall be removed from the Site.
 - (i) Areas that are to receive Turf Renovation are to be prepared to the depth required for topsoil and sod as specified in E21.
- (f) Asphalt and concrete paving shall be removed from the Site. Base material shall be excavated and removed to the required depth to enable the new Work proposed for those areas.

E15.3 Site Restoration

- (a) Any holes left by the removal of posts or foundations shall be filled with compacted clean clay fill to meet the adjacent grades and be restored to match surrounding conditions to the satisfaction of the Contract Administrator.
- (b) Any site restoration required due to removals, and not shown on the Drawings as areas for new development, shall be considered incidental to the removal Work.

E15.4 Basis of Payment

- (a) Removal of existing asphalt and concrete paving, including their base materials, shall be considered incidental to the Work that generates the material to be removed, including Site Preparation and Asphalt Paving on Form B: Pricing. There will be no separate measurement or payment for this portion of the Work.
- (b) Removal of existing sand and pea stone protective surfacing shall be considered incidental to the Work specified under Site Preparation on Form B: Pricing. There will be no separate measurement or payment for this portion of the Work.
- (c) Payment for Work specified under this section shall be for the removal of play equipment, picnic shelter, site furniture, bollards, fencing, and timber edging. It shall be paid for at the Lump Sum Price, which price shall include all costs of removal and proper disposal, and any associated Site restoration.
- (d) Items of Work:
 - (i) Demolition and Removals

E16. SITE PREPARATION

E16.1 General Description

- (a) This specification shall cover the preparation of the play areas to receive new timber edging, sub-surface drainage systems and wood fibre or sand protective surfacing.
- (b) This specification shall cover the removal of the berm and grading of the area to form a level playing field.

E16.2 Play Area Site Preparation

- (a) Further to E15, new play areas are to be excavated to the depth required for the installation of timber edging, sub-surface drainage systems and the correct depth of protective surfacing as shown on the Drawings and as required in E13. All extraneous materials are to be removed from the Site and disposed of in a safe and legal manner.
- (b) Play areas are to be graded as shown on the Drawings and to achieve proposed drainage patterns.
- (c) Subgrade shall be completed and subject to inspection by the Contract Administrator prior to the installation of other Works.

E16.3 Removal Of Berm

- (a) The berm shall be removed and the area graded as shown on the Drawings.
- (b) All extraneous materials are to be removed from the Site and disposed of in a safe and legal manner.
- (c) The rough grade is to be at the correct level to receive topsoil and sod as per E21.

E16.4 Basis of Payment

- (a) Payment for Work specified under this section shall be paid for at the Unit Price, measured on a square metre basis, which price shall include all costs of excavation and proper disposal, and any associated Site restoration.
- (b) Items of Work:
 - (i) Play Area Site Preparation
 - (ii) Berm Removal and Grading

E17. SUB-SURFACE DRAINAGE

E17.1 General Description

(a) This Work shall consist of providing and placing geocomposite prefabricated drainage systems as shown on the Drawings. The drainage systems shall be in accordance with

these Specifications and in reasonably close conformity with the locations and dimensions as shown on the plans or as specified by the Contract Administrator. The quantities of drainage system materials as shown may be increased or decreased at the discretion of the Contract Administrator based on actual Site conditions that occur during construction. Such variations in quantity will not be considered as alterations in the details of construction or a change in the character of the Work. This drainage system is in addition to any sub-surface drainage called for by the manufacturer of the play safety surfacing.

E17.2 Materials

- (a) Multi-Flow Drain System
 - (i) Drainage pipe shall be Multi-Flow or approved substitute in accordance with B6. Size shall be 150mm as shown on Drawings. All fittings shall be sized to fit and approved for use with Multi-Flow or approved substitute by the manufacturer.
 - (ii) The drain conduit shall be of flexible, prefabricated, rounded rectangular shaped, composite product. The drain conduit shall be wrapped with a non-woven geotextile and shall be a non-woven needle-punched construction and consist of long-chain polymeric fibres composed of polypropylene, polyethylene or polyamide. The fibres shall be oriented into a multi-directional stable network whereby they retain their positions relative with each other and allow the passage of water as specified. The fabric shall be free of any chemical treatment or coating, which reduces permeability and shall be inert to chemicals commonly found in soil. The geotextile shall conform to the following minimum average roll values:

(iii) The drainage core shall be made of a high-density polyethylene. The core shall be constructed using interconnected corrugated pipes that define and provide the flow channels and structural integrity of the system. The geotextile shall function only as a filter. The core of the conduit shall conform to the following physical property requirements:

(i) The fittings used with the drainage system shall be of a snap together design. In no case shall any product be joined without the use of the manufacturer's connector designed specifically for the purpose.

(c) Pipe

- (i) Pipe for drain outlet shall be either PVC pipe meeting the requirements of ASTM D-2729 or ASTM F-949, or high density polyethylene pipe meeting the requirements of AASHTO M252.2.4. A rodent screen made of 7.6 mm by 7.6 mm square opening size, 1.6 mm gauge, stainless steel or galvanized welded mesh shall be installed in each outlet line. When using galvanized welded wire mesh, the rodent screen shall be galvanized after it has been formed to the shape and dimensions required.
- (ii) Drain pipe for connection to catch basins shall be 100mm.

(d) Backfill for Trenches

(i) Backfill shall be coarse sand whose particle size is defined as less then 5% retained on a #10 screen, and less than 5% passing through a #30 screen. (US Std Sieve) In no case shall more than 1% pass a #60 screen.

E17.3 Methods

- (a) The layout of the sub-drain is to be marked on Site and approved by the Contract Administrator.
- (b) Sub-drain is to be installed vertically in trenches in locations as shown on the Drawings.
- (c) Trenches are to be excavated with a trenching machine or by hand. Locations, where the trench crosses existing utilities, irrigation pipes and all other sub-surface pipes or fixtures, are to be excavated by hand. The amount of trench excavated at any time shall not exceed the amount of drain that can be set and backfilled completely prior to the end of that Working Day. Trench width shall be as specified on the Drawings.
- (d) The bottom surface of the trench is to be free of looses particles and is to have the slope shown on the Drawings. Over excavation in the bottom of the trench shall be backfilled to the proper grade with the excavated material or sand prior to the placement of the drain. Where sand or excavated material is used to fill the trench to the proper elevation that material shall be compacted to 95% of standard proctor density using appropriate means. Where the trench is to pass through an area of existing turf, the excavated material is not to remain on the grassed surface for a period of longer than 24 hours. All excavated material shall be removed from the Site daily and disposed of legally.
- (e) Multi-Flow drain pipe is to be placed in the trench using a Multi-Flow centering device. Trench is to be backfilled with coarse sand to the surface. Backfill shall be placed in maximum of 45 cm loose lifts. Backfill is to be lightly tamped into place and watered.
- (f) Fittings for the drain shall be installed in accordance with manufacturer's recommendations.
- (g) Any damaged drain system shall be replaced or repaired by splicing in an undamaged section of like material at the Contractor's expense.
- (h) Connections to existing catch basins shall be below the ground surface and grouted into place as per CW 2130-R11 and SD-025. Prior to completion of the project the Contractor shall clean out the catch basin of all debris.
- (i) Sub-surface drainage required as part of the safety surfacing installation shall be considered incidental to the safety surfacing Work.
- The Contractor shall be responsible for restoration of any surfaces damaged during the Work under this section.

E17.4 Basis of Payment

(a) Payment for Work specified under this section shall be paid for at the Unit Price, measured on a lineal metre or per unit basis, for the Items of Work listed below, which price shall include all costs of material supply, piping, fittings, trenching, proper material installation, backfill, Site restoration and all other items incidental to the Work.

- (i) Multi-Flow Drain 150 mm
- (ii) LDS Pipe to CB 100 mm
- (iii) Connection to Existing Catch Basin

E18. TIMBER EDGING

E18.1 General Description

(a) This specification shall cover the supply and installation of timber edging to contain the protective surfacing for the play areas and the sand play area.

E18.2 Materials

- (a) Timber Edging and Sand Play Edging shall be subject to inspection and approval by the Contract Administrator.
- (b) Timber Edging and Sand Play Edging shall be as shown Drawings.
- (c) All wood for the bottom row(s) shall be spruce, pine or fir, No. 2 or better, no wane, bark, checking or splitting permitted. Wood shall be smooth (not rough sawn) and free of rough areas. All timbers to be 150 x 150mm with a minimum length of 1200mm.
- (d) Timbers shall be ACQ pressure treated (P.T.). All ends and cuts shall be treated with preservative before being secured.
- (e) All fasteners used with the ACQ products shall be stainless steel or ceramic coated fasteners.
- (f) For the cap on Timber Edging, the wood shall be untreated 32 x 150 Pedra, minimum length 1200mm.
- (g) For the cap on Sand Play Edging, the board shall be 50x250mm untreated cedar or treated spruce. Top edges of all exposed wood shall have a 8mm (45°) chamfer. The cap boards shall be sanded smooth. The wood, if spruce, shall be treated with Bio-Wash Ltd., Mill Glaze Away and Natural Deck Oil as per manufacturer's specifications.
- (h) Geotextile fabric shall be in accordance with CW 3130 and installed between the crushed granular base and the protective surfacing.
- (i) Granular base shall conform to CW 3110 and CW 3130.

E18.3 Methods

- (a) Layout of edging shall be as shown on the Drawings, or as approved, to adequately provide protective surfacing area around play equipment, based on the most recent CSA safety zone requirements.
- (b) Grades for the installation of timber edging shall be as shown on Drawings and as determined on Site in consultation with the Contract Administrator.
- (c) Timber Edging and Sand Play Edging shall be installed as per Drawings.
 - (i) A compacted granular base course shall be installed to a minimum 75mm depth and as required to set the timbers at the correct grade. It is to be compacted to a minimum of 95 percent Proctor Density.
 - (ii) Base course timbers shall be pinned with a minimum of two (2) 19mm diameter by 500mm rebar at maximum 1200mm O.C.
 - (iii) For two and three tier edging, the upper timbers shall be securely spiked with a minimum of two (2) 12mm diameter by 250mm spikes predrilled at maximum 1200mm O.C.
 - (iv) The cap boards shall be predrilled and screwed with two screws at each end of the timber and at alternating sides at 600mm O.C. Screws shall be treated for ACQ use and sized to suit.
- (d) All timbers shall be cut neatly for a proper fit with no spaces or gaps between. All cuts, except in the untreated cap boards, shall be treated before being secured. Finished elevations shall ensure that all timbers are smooth, level, set plumb and spaced uniformly.

- (e) All corners and joints shall be lap joints where one layer overlaps the join of the other.
- (f) Topsoil shall be used to bury the outer edge of treated timbers. Turf shall be repaired as required around edging in accordance with City of Winnipeg Standard Specifications for Topsoil and Sodding. Unless noted on the Drawings as areas for Turf Renovation, this shall be considered incidental to the timber edging Work.

E18.4 Basis of Payment

- (a) Payment for Work specified under this section shall be paid for at the Unit Price, measured on a linear metre basis for the Items of Work listed below, which price shall include all costs of material supply, excavation, sub-grade preparation, proper material installation and any associated Site restoration.
- (b) Items of Work
 - (i) Timber Edging One Tier
 - (ii) Timber Edging Two Tier
 - (iii) Timber Edging Three Tier
 - (iv) Sand Play Edging

E19. WOOD FIBRE PROTECTIVE SURFACING

E19.1 Description

(a) This specification shall cover the supply and installation of engineered wood fibre protective surfacing within the play area.

E19.2 Materials

- (a) Wood Fibre product shall be either Zeager Woodcarpet or Fibar FibarSystem 300 products or approved substitute in accordance with B6.

(b) Wood Fibre surfacing shall include wood fibre, filter cloth, subsurface drainage system and mats for bottom of slides and under swings.

E19.3 Methods

(a) Sub grade preparation shall be inspected by the Contract Administrator prior to installation of safety surfacing.

- (b) Sub-surface drainage Work specified in E17 shall be coordinated with the safety surfacing drainage system to create a total working system.
- (c) Wood Fibre shall be installed within the play area to adequately provide the correct depth based on the most recent CSA safety requirements.
- (d) The installation of the Wood Fibre shall be done immediately after the play equipment has been installed.
- (e) Installation of entire system, including fibre, filter cloth, subsurface drainage and mats shall be done according manufacturer's instructions. Adequate drainage within play equipment area must be ensured as per same.
- (f) Installation shall be done by equipment sized to suit the Work being done and the Wood Fibre shall be spread by hand as necessary in the immediate vicinity of the play equipment so as not to damage same. The play equipment shall be swept clean to the satisfaction of the Contract Administrator after installation of the Wood Fibre.
- (g) The same product shall be installed as a wood chip mulch in the boxed in area around the trees to the depth shown on the Drawings. This mulch shall not require a subsurface drainage system.
 - (i) This installation has been included in the quantity for the Wood Fibre Protective Surfacing System and a separate price shall not be provided.

E19.4 Basis of Payment

- (a) Payment for Work specified under this section shall be paid for at the Unit Price, measured on a square metre basis, for the Items of Work listed below, which price shall include all costs of material supplied for the wood fibre system, sub-grade preparation, drainage sump pit and proper material installation.
- (b) Items of Work:
 - (i) Wood Fibre Protective Surfacing System

E20. SAND

E20.1 General Description

(a) This specification shall cover the supply and installation of sand for the sand play area.

E20.2 Materials and Methods

- (a) Sand: natural washed sand of rounded particles, free of fines, clay, silt stones or other debris and shall meet the following criteria:
 - (i) 100% passing 6.7 mm sieve;
 - (ii) 99.5% passing 4.75 mm sieve;
 - (iii) 97-100% passing 2.36 mm sieve;
 - (iv) 70-90% passing 1.18 mm sieve;
 - (v) 25-60% passing 600 um sieve;
 - (vi) 5-25% passing 300 um sieve;
 - (vii) 0-3% passing 150 um sieve;
 - (viii) 0-1% passing 75 um sieve.
- (b) Samples of the specified sand shall be submitted for approval to the Contract Administrator at least seven (7) Calendar Days prior to installation.
- (c) Sand shall be installed and spread to the depths shown on the Drawings.
- (d) Installation shall be done by equipment sized to suit the Work being done and the sand shall be spread by hand as necessary in the immediate vicinity of the play equipment so as not to damage same. The play equipment shall be swept clean to the satisfaction of the Contract Administrator after installation of the sand.

E20.3 Basis of Payment

- (a) Payment for Work specified under this section shall be paid for at the Unit Price, measured on a cubic metre basis, for the Items of Work listed below, which price shall include all costs of material supply and proper material installation.
- (b) Items of Work
 - (i) Sand

E21. TURF RENOVATION

E21.1 General Description

- (a) This specification shall cover the supply and installation of topsoil and sod for the renovation of turf.
- (b) Areas of the park that require turf renovation are shown on the Drawings.

E21.2 Materials and Methods

- (a) Topsoil: As per CW 3540-R5.
- (b) Sodding
 - (i) As per CW 3510-R9.
 - (ii) Sod shall be mineral base.
- (c) Areas to be sodded shall be excavated and/or filled with clean fill to meet the grades required for the installation of topsoil and sod. Surplus materials shall be removed off-site in a legal manner.
- (d) No area for Turf Renovation shall be less than the width of a full piece of sod.
- (e) Where Turf Renovation meets existing turf, the edges are to be cut neatly in straight lines and new sod is to be installed to match the existing grades of the surrounding turf. Positive drainage away from play areas is to be maintained.
- (f) Seams between new and old turf are to be topdressed, seeded and rolled.
- (g) Only those areas shown on the Drawings as Turf Renovation shall be paid for under this section. All other Site restoration shall be considered incidental to other Works.

E21.3 Maintenance Period

(a) The Contractor shall maintain the sod for 30 Calendar Days after the completion of the installation or until such a time as the turf is established in accordance with CW 3510-R9.

E21.4 Basis of Payment

- (a) Payment for Work specified under this section shall be paid for at the Unit Price, measured on a square metre basis, for the Items of Work listed below, which price shall include all costs of material supply, sub-grade preparation, proper material installation, maintenance and all other items incidental to the Work.
- (b) Items of Work
 - (i) Turf Renovation

E22. ASPHALT PAVING

E22.1 General Description

(a) Further to CW 3110-R12 and CW3410-R8, this specification shall cover the supply and installation of the asphalt path including excavation, sub-base and base construction, and asphaltic paving.

E22.2 Materials and method

(a) Materials and installation as per CW 3110-R12 and CW3410-R8.

- (b) Further to E15, existing asphalt and concrete paving shall be removed from those areas shown on the Drawings. Existing asphalt, that is to remain, shall be saw cut to create a clean edge to join the new asphalt.
- (c) Sub-base and base materials and depths are as specified on the Drawings.
- (d) Asphaltic paving depth as specified on the Drawings.
- (e) Path widths and paved areas are indicated on the Drawings.
- (f) The paths and paved areas must be constructed to the grades shown on the Drawings. This Work shall be coordinated with the construction of the timber edging.
- (g) The Contract Administrator shall inspect the sub-base prior to the installation of asphalt.
- (h) The Contractor is to ensure that the timber edging and other adjacent materials and surfaces remain clean and free of asphalt. Over pour of asphalt and excess granular base shall be removed prior to acceptance of the asphalt paving.

E22.3 Basis of Payment

- (a) Payment for Work, specified under this section shall be paid for at the Unit Price, measured the square meter, for the Items of Work listed below. The price for Asphaltic Paving shall include all costs of excavation, material supply and proper material installation for sub-grade, sub-base and base preparation, and asphaltic paving. Removal and disposal of existing pathways, rough and final grading and Site restoration work shall be considered incidental to the Work.
- (b) Items of Work:
 - (i) Asphalt Paving

E23. FENCES

E23.1 General Description

(a) This specification shall cover the supply and installation of fencing as shown on the Drawings.

E23.2 Materials and Methods

- (a) Repair of Existing Fences
 - (i) The two most easterly sections of the existing wood fence along the rear property line are to be replaced.
 - (ii) Any portions of those two sections of the wood fence, that are remaining on Site, are to be removed and disposed of off Site in a safe and legal manner.
 - (iii) The Work is to be done as shown on the Drawings and to match the existing wood fence in materials and methods.
 - (iv) The chain link fence along the east property line, where it meets the rear wood fence, is to be repaired as required. Replacement materials and methods shall be to the original design and to CW 3550-R2.

(b) New Fences

- (i) The wood for the post and rails shall be tight knot cedar and sized as shown on the Drawings. Wood shall be smooth (not rough sawn), free of rough areas, no wane, bark, checking or splitting permitted.
- (ii) Further to CW 3550-R2, the chain link fabric shall be 9 gauge galvanized steel mesh. The fabric shall be stretched taut and stapled in place to the satisfaction of the Contract Administrator.
- (iii) Fasteners shall be galvanized and sized to suit the application, keeping in mind that these fences will be climbed by children.
- (iv) Granular for post holes: 38mm Ø crushed limestone with 16mm down crushed limestone for the top 25mm.

- (v) Fence layout shall be as shown on Drawings and adjusted as required to accommodate existing trees. Fence post layout shall be of equal spacing at approximately 2.4M O.C. Fence layout shall be inspected by the Contract Administrator prior to installation.
- (vi) Fences are to be constructed as shown on the detail Drawings. Tops of fences are to be set level across the length of the fence. If grade changes along the length of the fence require the fence to step down, the change is to be as directed by the Contract Administrator prior to installation.

E23.3 Basis of Payment

- (a) Payment for Work specified under this section shall be paid for at the Unit Price, measured on a lump sum or lineal meter basis, for the Items of Work listed below, which price shall include all costs of material supply, and proper material installation. Site restoration shall be considered incidental to the Work.
- (b) Items of Work:
 - (i) Repair of Existing Fences
 - (ii) Post and Rail Fence
 - (iii) Post, Rail and Chain Link Fence

E24. FOUNDATIONS

- E24.1 All playground equipment posts, bases and anchors are to be set in concrete footings or piles to ensure stability and prevent frost heaving. The current Standard Construction Specifications of the City of Winnipeg, CW 2160 Concrete Underground Structures and Works, is to be utilized in the installation of the concrete works for all below ground components.
- E24.2 The specific concrete requirements shall be;
 - (a) Sulfate resistant, Type 50 Cement;
 - (b) 28 day compressive strength of 30 Mpa;
 - (c) maximum aggregate size of 20 mm, nominal;
 - (d) slump 80 ±20 mm;
 - (e) maximum water/cement ratio 0.49.

E24.3 Installation

- (a) Contractor shall notify the Contract Administrator at least 48 hours prior to installation of concrete, so that footings may be inspected in advance of concrete being poured.
- (b) Playstructure posts shall have a minimum 300mm (12") diameter concrete footing and shall be centred in the concrete footing to provide a minimum 50mm (2") band of concrete on all sides.
- (c) All concrete footings for play equipment shall be a minimum of 900mm depth or in accordance with manufacturer's specifications, whichever is greater.
- (d) Work under this section is considered incidental to the installation of play equipment and site furniture.

E25. SITE FURNITURE

E25.1 General Description

(a) This specification shall cover the supply and installation of site furniture as shown on the Drawings.

E25.2 Materials

(a) Benches

E26. PLAYSTRUCTURE

E26.1 This specification shall cover the supply and installation of the accessible Tree House playstructure, including the independent play panels, as shown on the Drawings.

E26.2 Products

- (a) Landscape Structures Inc custom Tree House Playbooster, product # 23945199-1-4-2 and as depicted on the attached Drawings, or approved substitute in accordance with B6.
 - The structure shall have components made to look like real trees, stumps and animals.
 - (ii) The structure shall have a roof and panels made to look like it is a children's tree house.
 - (iii) The structure shall be accessible via a transfer module.

E26.3 Shop Drawings

- (a) Further to CW 1110, shop drawings shall be submitted to the Contract Administrator for all the play equipment specified in this Section, within seven (7) Calendar Days of receipt of a Purchase Order.
- (b) Shop Drawings shall include, but not be limited to:
 - (i) Layout and configuration of equipment including required safety zones
 - (ii) Colours
 - (iii) Custom graphics or products

E26.4 Materials

- (a) Posts / Caps
 - (i) All posts shall be a minimum of 127 mm (5") O.D. round tubing. All posts shall be fabricated from aluminum (0.125" min. wall thickness) tubing with a baked-on TGIC polyester powder coating. The powder coating finish shall meet or exceed ASTM standards for hardness, adhesion, impact and salt spray resistance. All fabrication cuts, drill holes and weld joints shall be sprayed with a corrosion resistant coating prior to powder coating. The bottom end of the posts is to be sealed with a moisture barrier.
 - (ii) Top caps for posts shall be aluminum die cast and powder coated the same as the post colour. All caps shall be factory installed and secured in place with tamper proof, self-sealing rivets.

(b) Decks

- (i) All decks shall be manufactured from vinyl-coated, perforated steel.
- (ii) Increments between deck heights shall be 200 mm (8") unless connected by a climbing component.

(c) Clamping System

- (i) All deck, rail and play component clamping systems shall be fabricated from zinc plated, and galvanized steel, stainless steel or aluminum, and baked-on polyester powdercoated to match post colour unless noted otherwise. Tamper proof, corrosion resistant fasteners shall be used to retain clamping systems.
- (d) Handrails, Safety Rails and Handloops
 - (i) All handrails and safety rails shall be fabricated using a minimum of 1 1/8" O.D. with a 120" wall thickness steel tubing. After all fabrication activities have occurred including end cuts, drill holes, bends and weld joints, all components shall be hot dipped galvanized and baked-on polyester powdercoated.

 - (ii) The roof and planks for the tree house shall be manufactured from 100% post consumer recycled planks and made to look like wood planks.

 - (vii) one (1) Cliff Climber, inclined plank with chain to 48" deck;
 - (viii) one (1) Pilot Panel, permalene panel with graphics c/w two (2) Steering Wheels;
 - (ix) one (1) Slant Entrance Panel, below deck;
 - (x) one (1) Vertical Ascent, climbing wall to 64" deck;
 - (xi) one (1) Orbitor Spinner;

- (b) The playstructure shall be installed by factory certified installers only and to manufacturer's specifications.
- (c) Installation of the playstructure shall be coordinated with associated Site development Work. The playstructures shall be secured and rendered unusable until protective surfacing is in place.

E26.8 Basis of Payment

- (a) Payment for Work specified under this section shall be paid for at the unit price for the "Items of Work" listed below, which price shall include all costs of supply and installation. The independent play panels shall be included with the price of the playstructure.

E27.4 Materials

- (a) All materials shall be structurally sound and suitable for safe play. Durability shall be ensured on all parts and materials.
- (b) Cable Net Components
 - (i) Space Cable nets shall be fully assembled and made of six-stranded and tempered Corocord-rope (galvanized steel cable). The galvanized steel wire cores of the six strands are to be heated and covered with UV-stable polyamide nylon.
 - (ii) Chains shall be steel 3/16" straight link chain, 800 lb. working load limit.
- (c) Rocks
 - (i) The rock climber shall be manufactured from Glass Fibre Reinforced Concrete (GFRC) and made to look and feel like a real rock.
- (d) Spring toys and see saws shall be as follows:
 - (i) The body, if poly, shall be fabricated from compressed or rotationally moulded, highdensity polyethylene with U.V. stabilizers and all edges chamfered. Colours and graphics are to be moulded-in.

E28.1 General Description

(a) This specification shall cover the supply and installation of two complete swing sets as specified herein.

E28.2 Product

- (a) Senior Swings: Landscape Structures Inc. 5000 Series, or approved substitute in accordance with B6.
 - (i) Tri-pod Leg, Two Bay, Heavy Duty Swing Frame, 2.4 m (8') high, complete with four (4) slash-proof rubber belt seats, heavy duty chain, anti-wrap swing hangers.
- (b) Toddler Swings: Landscape Structures Inc. Toddler Swing product # 117962, or approved substitute in accordance with B6.
 - (i) Single Leg, two (2) full bucket seats, heavy duty chains angled to prevent side-sway.

E28.3 Materials -Swing Frame

- (a) Topbeam Senior Swings
 - (i) All topbeams shall be fabricated from min. 90mm (3 1/2") O.D. 7 gauge, RS40 galvanized steel pipe or 60mm (2 3/8") 5 gauge, RS40 galvanized steel pipe with anti-wrap swings. All fabrication cuts, drill holes and weld joints shall be sprayed with a corrosion resistant coating.
- (b) Topbeam Toddler Swings
 - (i) Topbeam shall be fabricated from min. 90 mm (3 ½") O.D. 7 gauge, RS40 galvanized steel pipe. All fabrication cuts, drill holes and weld joints shall be sprayed with a corrosion resistant coating.
- (c) Legs Senior Swings
 - (i) All legs shall be fabricated from min. 60 mm (2 3/8") O.D. 10 gauge, RS40 galvanized steel pipe. All fabrication cuts, drill holes and weld joints shall be sprayed with a corrosion resistant coating and the bottom end of the posts shall be sealed with a moisture barrier.
- (d) Leg Toddler Swings
 - (i) Leg shall be fabricated from min. 127 mm (5") O.D. galvanized steel pipe. All fabrication cuts, drill holes and weld joints shall be sprayed with a corrosion resistant coating and the bottom end of the posts shall be sealed with a moisture barrier.
- (e) Yoke Clamps
 - (i) All yoke clamps shall be either one piece construction and fabricated from 8 gauge, RS40 galvanized steel or two piece, compression clamping cast aluminum or galvanized metal with baked on polyester powdercoating. They shall be complete with tamper-proof hardware.
- (f) Swing Hangers
 - All swing hangers shall be fabricated from galvanized malleable iron and have oil impregnated bearings pressed in.

 - Any coloured portion of the swing frames shall be Pine Green or as directed by the Contract Administrator.

 - (i) All swing chain shall be 4/0 straight link, galvanized steel.

(i) All enclosed infant seats shall be moulded of U.V. stabilized, high quality, rubber with a tempered stainless steel reinforcement plate insert moulded inside, rendering the seats slash proof. Infant seats shall be fully enclosed to prevent slipping out and provide extra lower back support.

(c) Belt Seats

(i) All belt seats shall be moulded of U.V. stabilized, high quality, rubber with a tempered stainless steel reinforcement plate insert moulded inside, rendering the seats slash proof. The perimeter shall be moulded to form a blunt, impact absorbing edge.

(d) Hardware

(i) All fasteners shall be socketed and tamperproof in design, and either carbon steel plated with zinc/nickel and iridescent chromate finish or stainless steel. Bolt links and "S" hooks shall be drop forged carbon steel, heat treated and hot dipped galvanized.

- (b) Installation of swings shall be coordinated with associated Site development Work. Swings shall be secured and rendered unusable until protective surfacing is in place.
