PART B - BIDDING PROCEDURES

B1. CONTRACT TITLE

B1.1 ST. VITAL PARK ATHLETIC FIELD DEVELOPMENT

B2. SUBMISSION DEADLINE

- B2.1 The Submission Deadline is 4:00 p.m. Winnipeg time, June 24, 2011.
- B2.2 Bids determined by the Manager of Materials to have been received later than the Submission Deadline will not be accepted and will be returned upon request.
- B2.3 The Contract Administrator or the Manager of Materials may extend the Submission Deadline by issuing an addendum at any time prior to the time and date specified in B2.1.

B3. SITE INVESTIGATION

B3.1 Further to C3.1, the Bidder may view the Site without making an appointment.

B4. ENQUIRIES

- B4.1 All enquiries shall be directed to the Contract Administrator identified in D3.1.
- B4.2 If the Bidder finds errors, discrepancies or omissions in the Bid Opportunity, or is unsure of the meaning or intent of any provision therein, the Bidder shall notify the Contract Administrator of the error, discrepancy or omission, or request a clarification as to the meaning or intent of the provision at least five (5) Business Days prior to the Submission Deadline.
- B4.3 Responses to enquiries which, in the sole judgment of the Contract Administrator, require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator to all Bidders by issuing an addendum.
- B4.4 Responses to enquiries which, in the sole judgment of the Contract Administrator, do not require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator only to the Bidder who made the enquiry.
- B4.5 The Bidder shall not be entitled to rely on any response or interpretation received pursuant to B4 unless that response or interpretation is provided by the Contract Administrator in writing.

B5. ADDENDA

- B5.1 The Contract Administrator may, at any time prior to the Submission Deadline, issue addenda correcting errors, discrepancies or omissions in the Bid Opportunity, or clarifying the meaning or intent of any provision therein.
- B5.2 The Contract Administrator will issue each addendum at least two (2) Business Days prior to the Submission Deadline, or provide at least two (2) Business Days by extending the Submission Deadline.
- B5.2.1 Addenda will be available on the Bid Opportunities page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt
- B5.2.2 The Bidder is responsible for ensuring that he has received all addenda and is advised to check the Materials Management Division website for addenda regularly and shortly before the Submission Deadline, as may be amended by addendum.

B5.2.3 The Bidder shall acknowledge receipt of each addendum in Paragraph 8 of Form A: Bid. Failure to acknowledge receipt of an addendum may render a Bid non-responsive.

B6. SUBSTITUTES

- B6.1 The Work is based on the Plant, Materials and methods specified in the Bid Opportunity.
- B6.2 Substitutions shall not be allowed unless application has been made to and prior approval has been granted by the Contract Administrator in writing.
- B6.3 Requests for approval of a substitute will not be considered unless received in writing by the Contract Administrator at least five (5) Business Days prior to the Submission Deadline.
- B6.4 The Bidder shall ensure that any and all requests for approval of a substitute:
 - (a) provide sufficient information and details to enable the Contract Administrator to determine the acceptability of the Plant, Material or method as either an approved equal or alternative;
 - (b) identify any and all changes required in the applicable Work, and all changes to any other Work, which would become necessary to accommodate the substitute;
 - (c) identify any anticipated cost or time savings that may be associated with the substitute;
 - (d) certify that, in the case of a request for approval as an approved equal, the substitute will fully perform the functions called for by the general design, be of equal or superior substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance;
 - (e) certify that, in the case of a request for approval as an approved alternative, the substitute will adequately perform the functions called for by the general design, be similar in substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance.
- B6.5 The Contract Administrator, after assessing the request for approval of a substitute, may in his sole discretion grant approval for the use of a substitute as an "approved equal" or as an "approved alternative", or may refuse to grant approval of the substitute.
- B6.6 The Contract Administrator will provide a response in writing, at least two (2) Business Days prior to the Submission Deadline, only to the Bidder who requested approval of the substitute.
- B6.6.1 The Bidder requesting and obtaining the approval of a substitute shall be entirely responsible for disseminating information regarding the approval to any person or persons he wishes to inform.
- B6.7 If the Contract Administrator approves a substitute as an "approved equal", any Bidder may use the approved equal in place of the specified item.
- B6.8 If the Contract Administrator approves a substitute as an "approved alternative", any Bidder bidding that approved alternative may base his Total Bid Price upon the specified item but may also indicate an alternative price based upon the approved alternative. Such alternatives will be evaluated in accordance with B14.
- B6.9 No later claim by the Contractor for an addition to the Total Bid Price because of any other changes in the Work necessitated by the use of an approved equal or an approved alternative will be considered.

B6.10 Notwithstanding B6.2 to B6.9, and in accordance with B7.7, deviations inconsistent with the Bid Opportunity document shall be evaluated in accordance with B14.1(a).

B7. BID COMPONENTS

- B7.1 The Bid shall consist of the following components:
 - (a) Form A: Bid;
 - (b) Form B: Prices;
- B7.2 Further to B7.1, the Bidder should include the written correspondence from the Contract Administrator approving a substitute in accordance with B6.
- B7.3 All components of the Bid shall be fully completed or provided, and submitted by the Bidder no later than the Submission Deadline, with all required entries made clearly and completely, to constitute a responsive Bid.
- B7.4 The Bid Submission may be submitted by mail, courier or personal delivery, or by facsimile transmission.
- B7.5 If the Bid Submission is submitted by mail, courier or personal delivery, it shall be enclosed and sealed in an envelope clearly marked with the Bid Opportunity number and the Bidder's name and address, and shall be submitted to:

- B7.5.1 Samples or other components of the Bid Submission which cannot reasonably be enclosed in the envelope may be packaged separately, but shall be clearly marked with the Bid Opportunity number, the Bidder's name and address, and an indication that the contents are part of the Bidder's Bid Submission.
- B7.6 Bidders are advised not to include any information/literature except as requested in accordance with B7.1.
- B7.7 Bidders are advised that inclusion of terms and conditions inconsistent with the Bid Opportunity document, including the General Conditions, will be evaluated in accordance with B14.1(a).
- B7.8 If the Bid Submission is submitted by facsimile transmission, it shall be submitted to (204) 949-1178.
- B7.8.1 The Bidder is advised that the City cannot take responsibility for the availability of the facsimile machine at any time.
- B7.8.2 Bids submitted by internet electronic mail (e-mail) will not be accepted.

B8. BID

- B8.1 The Bidder shall complete Form A: Bid, making all required entries.
- B8.2 Paragraph 2 of Form A: Bid shall be completed in accordance with the following requirements:
 - (a) if the Bidder is a sole proprietor carrying on business in his own name, his name shall be inserted;
 - (b) if the Bidder is a partnership, the full name of the partnership shall be inserted;
 - (c) if the Bidder is a corporation, the full name of the corporation shall be inserted;

(d) if the Bidder is carrying on business under a name other than his own, the business name and the name of every partner or corporation who is the owner of such business name shall be inserted.

- B8.2.1 If a Bid is submitted jointly by two or more persons, each and all such persons shall identify themselves in accordance with B8.2.
- B8.3 In Paragraph 3 of Form A: Bid, the Bidder shall identify a contact person who is authorized to represent the Bidder for purposes of the Bid.
- B8.4 Paragraph 10 of Form A: Bid shall be signed in accordance with the following requirements:
 - (a) if the Bidder is a sole proprietor carrying on business in his own name, it shall be signed by the Bidder;
 - (b) if the Bidder is a partnership, it shall be signed by the partner or partners who have authority to sign for the partnership;
 - (c) if the Bidder is a corporation, it shall be signed by its duly authorized officer or officers;
 - (d) if the Bidder is carrying on business under a name other than his own, it shall be signed by the registered owner of the business name or by the registered owner's authorized officials if the owner is a partnership or a corporation.
- B8.4.1 The name and official capacity of all individuals signing Form A: Bid should be printed below such signatures.
- B8.4.2 All signatures shall be original.
- B8.5 If a Bid is submitted jointly by two or more persons, the word "Bidder" shall mean each and all such persons, and the undertakings, covenants and obligations of such joint Bidders in the Bid and the Contract, when awarded, shall be both joint and several.

B9. PRICES

- B9.1 The Bidder shall state a price in Canadian funds for each item of the Work identified on Form B: Prices.
- B9.2 The quantities listed on Form B: Prices are to be considered approximate only. The City will use said quantities for the purpose of comparing Bids.
- B9.3 The quantities for which payment will be made to the Contractor are to be determined by the Work actually performed and completed by the Contractor, to be measured as specified in the applicable Specifications.
- B9.4 Payments to Non-Resident Contractors are subject to Non-Resident Withholding Tax pursuant to the Income Tax Act (Canada).

B10. QUALIFICATION

- B10.1 The Bidder shall:
 - (a) undertake to be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba; and
 - (b) be financially capable of carrying out the terms of the Contract; and
 - (c) have all the necessary experience, capital, organization, and equipment to perform the Work in strict accordance with the terms and provisions of the Contract.
- B10.2 The Bidder and any proposed Subcontractor (for the portion of the Work proposed to be

subcontracted to them) shall:

- (a) be responsible and not be suspended, debarred or in default of any obligations to the City. A list of suspended or debarred individuals and companies is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <u>http://www.winnipeg.ca/matmgt/debar.stm</u>
- B10.3 The Bidder and/or any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
 - (a) have successfully carried out work similar in nature, scope and value to the Work; and
 - (b) be fully capable of performing the Work required to be in strict accordance with the terms and provisions of the Contract; and
 - (c) have a written workplace safety and health program if required pursuant to The Workplace Safety and Health Act (Manitoba);
- B10.4 Further to B10.3(c), the Bidder shall, within five (5) Business Days of a request by the Contract Administrator, provide proof satisfactory to the Contract Administrator that the Bidder/Subcontractors has a workplace safety and health program meeting the requirements of The Workplace Safety and Health Act (Manitoba), by providing:
 - (a) a valid COR certification number under the Certificate of Recognition (COR) Program administered by the Manitoba Construction Safety Association or by the Manitoba Heavy Construction Association's Safety, Health and Environment Program; or
 - (b) a report or letter to that effect from an independent reviewer acceptable to the City. (A list of acceptable reviewers and the review template are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt).
- B10.5 The Bidder shall submit, within three (3) Business Days of a request by the Contract Administrator, proof satisfactory to the Contract Administrator of the qualifications of the Bidder and of any proposed Subcontractor.
- B10.6 The Bidder shall provide, on the request of the Contract Administrator, full access to any of the Bidder's equipment and facilities to confirm, to the Contract Administrator's satisfaction, that the Bidder's equipment and facilities are adequate to perform the Work.

B11. OPENING OF BIDS AND RELEASE OF INFORMATION

- B11.1 Bids will not be opened publicly.
- B11.2 Following the submission deadline, the names of the Bidders and their Total Bid Prices (unevaluated, and pending review and verification of conformance with requirements) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/bidopp.asp
- B11.3 After award of Contract, the name(s) of the successful Bidder(s) and the Contract amount(s) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt
- B11.4 The Bidder is advised that any information contained in any Bid may be released if required by City policy or procedures, by The Freedom of Information and Protection of Privacy Act (Manitoba), by other authorities having jurisdiction, or by law.

B12. IRREVOCABLE BID

- B12.1 The Bid(s) submitted by the Bidder shall be irrevocable for the time period specified in Paragraph 9 of Form A: Bid.
- B12.2 The acceptance by the City of any Bid shall not release the Bids of the next two lowest evaluated responsive Bidders and these Bidders shall be bound by their Bids on such Work for the time period specified in Paragraph 9 of Form A: Bid.

B13. WITHDRAWAL OF BIDS

- B13.1 A Bidder may withdraw his Bid without penalty by giving written notice to the Manager of Materials at any time prior to the Submission Deadline.
- B13.1.1 Notwithstanding C23.3, the time and date of receipt of any notice withdrawing a Bid shall be the time and date of receipt as determined by the Manager of Materials.
- B13.1.2 The City will assume that any one of the contact persons named in Paragraph 3 of Form A: Bid or the Bidder's authorized representatives named in Paragraph 10 of Form A: Bid, and only such person, has authority to give notice of withdrawal.
- B13.1.3 If a Bidder gives notice of withdrawal prior to the Submission Deadline, the Manager of Materials will:
 - (a) retain the Bid until after the Submission Deadline has elapsed;
 - (b) open the Bid to identify the contact person named in Paragraph 3 of Form A: Bid and the Bidder's authorized representatives named in Paragraph 10 of Form A: Bid; and
 - (c) if the notice has been given by any one of the persons specified in B13.1.3(b), declare the Bid withdrawn.
- B13.2 A Bidder who withdraws his Bid after the Submission Deadline but before his Bid has been released or has lapsed as provided for in B12.2 shall be liable for such damages as are imposed upon the Bidder by law and subject to such sanctions as the Chief Administrative Officer considers appropriate in the circumstances. The City, in such event, shall be entitled to all rights and remedies available to it at law.

B14. EVALUATION OF BIDS

- B14.1 Award of the Contract shall be based on the following bid evaluation criteria:
 - (a) compliance by the Bidder with the requirements of the Bid Opportunity or acceptable deviation there from (pass/fail);
 - (b) qualifications of the Bidder and the Subcontractors, if any, pursuant to B10 (pass/fail);
 - (c) Total Bid Price;
 - (d) economic analysis of any approved alternative pursuant to B6.
- B14.2 Further to B14.1(a), the Award Authority may reject a Bid as being non-responsive if the Bid is incomplete, obscure or conditional, or contains additions, deletions, alterations or other irregularities. The Award Authority may reject all or any part of any Bid, or waive technical requirements or minor informalities or irregularities, if the interests of the City so require.
- B14.3 Further to B14.1(b), the Award Authority shall reject any Bid submitted by a Bidder who does not demonstrate, in his Bid or in other information required to be submitted, that he is responsible and qualified.
- B14.4 Further to B14.1(c), the Total Bid Price shall be the sum of the quantities multiplied by the unit prices for each item shown on Form B: Prices adjusted, if necessary, as follows:

 (a) if the lowest evaluated responsive Bid submitted by a responsible and qualified Bidder is within the budgetary provision for the Work, no adjustment will be made to the Total Bid Price; or

- (b) if the lowest evaluated responsive Bid submitted by a responsible and qualified Bidder exceeds the budgetary provision for the Work, the Total Bid Prices of all responsive Bids submitted by responsible and qualified Bidders will be adjusted by progressively deducting item 9, until a Total Bid Price within the budgetary provision is achieved.
- B14.4.1 If there is any discrepancy between the Total Bid Price written in figures, the Total Bid Price written in words and the sum of the quantities multiplied by the unit prices for each item, the sum of the quantities multiplied by the unit prices for each item shall take precedence.
- B14.4.2 Further to B14.1(a), in the event that a unit price is not provided on Form B: Prices, the City will determine the unit price by dividing the Amount (extended price) by the approximate quantity, for the purposes of evaluation and payment.

B15. AWARD OF CONTRACT

- B15.1 The City will give notice of the award of the Contract or will give notice that no award will be made.
- B15.2 The City will have no obligation to award a Contract to a Bidder, even though one or all of the Bidders are determined to be responsible and qualified, and the Bids are determined to be responsive.
- B15.2.1 Without limiting the generality of B15.2, the City will have no obligation to award a Contract where:
 - (a) the prices exceed the available City funds for the Work;
 - (b) the prices are materially in excess of the prices received for similar work in the past;
 - (c) the prices are materially in excess of the City's cost to perform the Work, or a significant portion thereof, with its own forces;
 - (d) only one Bid is received; or
 - (e) in the judgment of the Award Authority, the interests of the City would best be served by not awarding a Contract.
- B15.3 Where an award of Contract is made by the City, the award shall be made to the responsible and qualified Bidder submitting the lowest evaluated responsive Bid, in accordance with B14.
- B15.3.1 Following the award of contract, a Bidder will be provided with information related to the evaluation of his Bid upon written request to the Contract Administrator.
- B15.4 Notwithstanding C4, the City will issue a Purchase Order to the successful Bidder in lieu of the execution of a Contract.
- B15.5 The Contract, as defined in C1.1, in its entirety shall be deemed to be incorporated in and to form a part of the Purchase Order notwithstanding that it is not necessarily attached to or accompany said Purchase Order.

PART C - GENERAL CONDITIONS

C0. GENERAL CONDITIONS

- C0.1 The *General Conditions for Construction* (Revision 2006 12 15) are applicable to the Work of the Contract.
- C0.1.1 The *General Conditions for Construction* are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <u>http://www.winnipeg.ca/matmgt/gen_cond.stm</u>
- C0.2 A reference in the Bid Opportunity to a section, clause or sub-clause with the prefix "**C**" designates a section, clause or sub-clause in the *General Conditions for Construction*.

PART D - SUPPLEMENTAL CONDITIONS

GENERAL

D1. GENERAL CONDITIONS

D1.1 In addition to the *General Conditions for Construction*, these Supplemental Conditions are applicable to the Work of the Contract.

D2. SCOPE OF WORK

- D2.1 The Work to be done under the Contract shall consist of the Development of St. Vital Park Athletic Field.
- D2.2 The major components of the Work are as follows: the rotovation of all existing surfaces within the Limit of Work; All earthworks and grading of the sub-grade to elevations which are 150 mm. below the finished elevations shown on the Grading and Drainage Plan (L3), including the scarifying of the sub-grade to a depth of 150 mm.; the supply and installation of
 - (a) The rotovation of all surfaces within the Limit of Work;
 - (b) All earthworks and grading of the sub-grade to elevations which are150 mm. below the finished elevations shown on the Grading and Drainage Plan (L3), including the scarifying of the completed sub-grade to a depth of 150 mm.;
 - (c) The supply and installation of two (2) 600mm. diameter "Nyloplast" Catch Pits and nine(9) "Nyloplast" Catch Pits, and all smooth-walled interior HDPE sub-surface drainage pipe;
 - (d) The supply and installation of a fully automatic sports field irrigation system, including the electrical connection to the power source at the existing playground washroom and the water connection to the existing 50 mm. diameter water line.
 - (e) The finished grading of all compacted topsoil surfaces to the elevations shown on the Grading and Drainage Plan (L3);
 - (f) The supply and installation of all sod;
 - (g) The maintenance of all sod within the Limit of Work until a dense uniform of turfgrass has been established; and
 - (h) The installation of a Turf Stone Service Road as per the Grading and Drainage Plan (L3).

D3. DEFINITIONS

- D3.1 When used in this Bid Opportunity:
 - (a) "Nyloplast" Catch Pit means an HDPE Catch Pit

SUBMISSIONS

D6. AUTHORITY TO CARRY ON BUSINESS

D6.1 The Contractor shall be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba, or if the Contractor does not carry on business in Manitoba, in the jurisdiction where the Contractor does carry on business, throughout the term of the Contract, and shall provide the Contract Administrator with evidence thereof upon request.

D7. SAFE WORK PLAN

E2. SITE ACCESS AND STAGING

- E2.1 Access to the site will be from principal park road via the existing wood chip path to the Summer Shelter building.
- E2.2 A staging area within the adjacent parking lot to the south will be provided to the Contractor for staging of the project construction. This area will be marked out by the Contractor and approved by the Contract Administrator before work proceeds on the project.
- E2.3 The Contractor will be restricted to the site access location and the staging area, so that there is

a minimum of disturbance to the existing ground and all adjacent property. Damage to those areas beyond the marked routes and staging areas shall be repaired by, and at the expense of the Contractor.

E3. PERMITS, NOTICES, LICENSES, LAWS AND RULES

- E3.1 The Contractor shall give all necessary notices, obtain all permits and pay all fees in order that the Work may be carried out. The Contractor shall submit all plans required by the inspection authority and obtain approval of same before proceeding with the Work, and pay any cost attached to the inspection of such plans.
- E3.2 The Contractor shall comply with all the laws, ordinances, rules and regulations that would relate to the Work.
- E3.3 All notices, consents, approvals, statements, authorizations, documents, or other communications to the City shall be submitted to the Contract Administrator.
- E3.4 All Work shall be shall be performed in compliance with the Manitoba Workplace Health and Safety Act.

E4. DAMAGE TO EXISTING STRUCTURES, PROPERTY, SERVICES AND UTILITIES

- E4.1 Further to C17, all necessary precautions shall be exercised by the Contractor so as not to remove, disturb, or damage existing trees, shrubs, sod, pavements, streets, roads, boulevards, poles, hydrants, water pipes, gas pipes, electrical wires, cables, conduits, sewers or other existing facilities, and equipment at the Sites of the Work. For all damage incurred thereto in the performance of the Work, the Contractor shall upon instructions from the Contract Administrator and the City thereof, either replace and repair such damage, whichever may be deemed necessary in the opinion of, and acceptable to, the Contract Administrator and the City thereof. The cost shall be borne entirely by the Contractor. E6. PROTECTION OF EXISTING TREES

- E6.1 The Contractor shall take the following precautionary steps to prevent damage to existing trees within the limits of the construction areas:
 - (a) The Contractor shall not stockpile materials and soil, or park vehicles and equipment within two (2) meters of trees.
 - (b) Trees identified to be at risk by the Contract Administrator are to be strapped with 25 mm.x.100 mm. x 2440 mm. wooden planks or other suitable protection as approved by the Contract Administrator. Do not use nails or other fasteners which may penetrate the tree trunk. The width and length of the strapping may be reduced to suit the tree being protected; as approved by the Contract Administrator.
 - (c) Excavation shall be performed in a manner which minimizes damage to root systems of all trees within the construction areas. Where possible, excavation shall be carried out such that the edge of the excavation of the shall be a minimum of 1.5 times the diameter of the tree trunk Measured in inches where one (1) inch diameter equals one (1) foot measured from the closest edge of the tree trunk at six (6) inches above grade. Where roots must be cut to facilitate construction, they must be neatly pruned by a licensed arborist using sharp pruning tools at the face of the excavation.
 - (d) Operation of equipment within the drip line of trees shall be kept to a minimum required to perform the required work. Positive surface drainage shall be provided on all areas by creating grades of not less than 1.5%, unless shown differently on the drawing(s). The finished sub-grade shall be 150 mm. below the final grade, to permit the installation of topsoil and sod to meet the final grades shown on the drawings and in these specifications.
 - (b) Once the sub-grade has been established, and its elevations and slopes approved by the Contract Administrator, the sub-grade shall be scarified to a depth of 150 mm.
 - (c) Wherever proposed grades meet existing grades at the Limit of Work, the grades shall match and positive surface drainage shall be maintained or created.
 - (d) All surplus materials shall be disposed of as per CW 3170 R-3.
 - (e) Upon completion of rough grading, the Work specified under this section shall be reviewed by the Contract Administrator prior to commencement of other Works.
- E11.5 Basis of Payment
 - (a) Payment for Work under this section shall be for Site Grading. It shall be paid for at the Unit Price measured on a square meter basis. The price shall include excavation, cut and fill, all rough grading, and any associated Site restoration.

E12. SUB-SURFACE DRAINAGE WORKS

- E12.1 General Description
 - (a) Further to CW 2030-R7 and CW 2130-R12, this specification shall include the installation of a sub-surface drainage system including:
 - (i) The supply and installation of Hancor Sure-Lok ST 06110020IBEA HDPE sub-surface drainage pipe including all connections.
 - (ii) The supply and installation of Nyloplast Catch Pits including all connections to subsurface drainage pipes.
 - (iii) The connection of the sub-surface drainage pipe to the existing concrete catch basin located west of the Park Road.
- E12.2 Materials
 - (a) Nine (9) 381 mm. diameter Nyloplast Catch Pits inclusive of all required fittings specified by the manufacturer; as shown on the Drawings.
 - (b) Two (2) 600 mm. diameter Nyloplast Catch Pits inclusive of all required fittings specified by the manufacturer; as shown on the Drawings.
 - (c) 150 mm. diameter and 250 mm. diameter smooth–walled interior solid Hancor Sure-Lok ST 06110020IBEA HDPE sub-surface drainage pipe inclusive of all fittings specified by the manufacturer; according to the lengths and diameters shown on the Drawings.

E12.3 Methods

- (a) The catch pits are to be installed as shown on the Drawings.
- (b) The layout of the sub-surface drainage system is to be marked out on Site and reviewed by the Contract Administrator.
- (c) The trenches are to be excavated with a small backhoe or excavator or by hand as shown on the Drawings. Locations where the trench crosses existing utilities, irrigation pipes and all other sub-surface pipes or fixtures are to be excavated by hand. The amount of trench excavated at any time shall not exceed the amount of drainage pipe that can be installed and backfilled prior to the end of each Working Day. Trench width and depth are specified on the Drawings.
- (d) The bottoms of trenches are to be free of loose materials and shall have a constant minimum slope of 0.5% as shown on the Drawings. Over excavation of the trench shall be backfilled to the correct grade with excavated material prior to placement of the subsurface drainage pipe. Where material is used as fill in a trench, it shall be compacted to 95% standard proctor density.
- (e) The grades of the bottom of the trench are to be reviewed by the Contract Administrator prior to the installation of sub-surface drainage pipe.
- (f) Sub-surface drainage pipe shall be installed as shown on the Drawings.
- (g) Trenches shall be backfilled with excavated material in 150 mm. lifts compacted to 95% standard proctor density.
- (h) Fittings for the sub-surface drainage system shall be in accordance with the manufacturer's specifications.
- (i) Any damaged portion of the drainage system shall be replaced or repaired by splicing in an undamaged section of like material at the Contractor's expense.
- (j) The sub-surface drainage system shall be connected to the existing concrete catch basin as per CW 2130-R7.
- (k) The Contractor shall be responsible for the restoration of any damages caused during the Work under this section.

E12.4 Basis of Payment

- (a) Payment for Work specified under this section shall be paid for at the Unit Price, measured on a lineal meter or per unit basis, for the Items of Work listed below, which price shall include the costs of excavation and trenching, material supply, proper installation of all materials, backfill, Site restoration, and all other items incidental to the Work.
- (b) Items of Work
 - (i) Catch Pits
- (ii) Connections of the Sub-surface Drainage System to the Concrete Catch Basin
- (iii) HDPE Sub-surface Drainage System

E13. AUTOMATIC IRRIGATION SYSTEM

E13.1 General Description

- (a) This specification shall cover the supply and installation of a fully automatic sports field irrigation system including:
 - (i) HDPE pipe and all associated fittings
 - (ii) LDPE pipe and all associated fittings
- (iii) Gear Driven Rotary Pop-Up Sprinklers
- (iv) Swing Joints

- (v) Sleeves composed of PVC pipe (160 PSI rated)
- (vi) Manual Isolation Valves
- (vii) Automatic Zone Control Valves
- (viii) Valve Boxes
- (ix) Automatic Controllers
- (x) Quick Coupling Valves
- (xi) Quick Coupling Keys
- (xii) Swivel Ells
- (xiii) Controller Case
- (xiv) Rain Sensor
- E13.2 Protection
 - (a) Prevent damage to fencing, tree, landscaping, natural features, benchmarks, existing building, pavements, surfaces or underground utility lines which are to remain. Make good any damage.
- E13.3 Existing buried utilities and structures:
 - (a) Size depth and location of existing utilities and structures as indicated are for guidance only.
 - (b) Prior to commencing any excavation work, notify Contract Administrator and utility company, establish location and state use of buried locations to prevent disturbance during the work.
 - (c) Confirm locations of buried utilities by careful test excavations.
 - (d) Maintain and protect from damage, water, sewer, gas, electric, telephone and other utilities and structures as indicated on plans. Obtain direction from Contract Administrator before moving or otherwise disturbing utilities or structures.
 - (e) Advise Contract Administrator and utility company prior to excavation work and coordinate with other Contractors who may be working concurrently on site.
 - (f) Promptly remove surplus material and debris from excavations and dispose of in a legal manner.
- E13.4 Maintenance Data & Demonstration Procedures
 - (a) Provide maintenance data for operation and maintenance of irrigation system and equipment to Owner. The maintenance manual shall include all original manufacturers' warranty certificates, controller operation and programming instructions, servicing and replacement procedures for all sprinklers and valves, and procedures for blowing out the system in the fall and charging the system in the spring. Demonstrate procedures for Owners as directed by the Contract Administrator.
- E13.5 As-Built Drawings
 - (a) Upon completion of the work, submit an as-built plan showing the exact location of all components of the system. Provide a control schedule which balances system hydraulics and watering requirements.
- E13.6 Layout Work & Inspection
 - (a) All work shall be laid out by the Contractor in conformance to the layout shown on Irrigation Drawing L 4. The Contractor shall be fully responsible for the accuracy thereof. Stake the locations of head and valves and receive approval from the Contract Administrator prior to excavation and installation. Install mainlines and laterals and receive approval from Consultant prior to backfilling. Upon completion of irrigation, the entire system shall be tested and balanced. The Contractor shall notify the Contract

Template Version: C320110520 - C LR Administrator for a final test to allow the Contract Administrator to observe and approve. All components shall be checked for proper; and the system shall not be accepted by the Consultant until all portions are operating as intended and until all deficiencies have been rectified. The Contractor shall provide all pumps, gauges and fittings as required for testing. The Contractor shall notify the Contract Administrator with a minimum of 24 hours prior to inspection. Do not proceed to subsequent work without approval of the Contract Administrator.

E13.7 Warranty

(a) All irrigation system equipment and installation shall be guaranteed for twelve (12) months following the date of Total Performance. The Contractor shall provide manufacturers' warranty certificates for all products. End of warranty inspection will be conducted by the Contractor.

E13.8 System requirements

- (a) Performance criteria: Design system to provide 25 mm. of actual precipitation per week within a five (5) hour day watering window. Apply all of weekly water requirements to each zone on the same day. Provide head to head coverage to all areas. Limit over spray on hard surfaces, fences and buildings.
- (b) Distribution: Use HDPE pipe for all mains and laterals, 50 mm. and larger. Use LDPE pipe for all smaller laterals. Provide sleeves under all roadways, driveways and walkways as required.
- (c) Loose equipment: Provide three (3) quick coupling keys with swivel ells as loose equipment.

E13.9 Materials

- (a) HDPE pipe: Type 3, Series 100 or better, high density polyethylene to CGSB 41, Gp-25M. Join by thermal butt fusion in strict accordance with manufacturer's written instructions.
- (b) Fittings for HDPE Pipe: Approved saddle fittings at head connections Lasco 50 mm. IPS x 38 mm. Acme outlet – Part No.364-251. Fittings to be approved by pipe manufacturer for fusion with pipe.
- (c) LDPE Pipe: 75 PSI low density polyethylene to CSA B137.0 and B137.1
- (d) Fittings for LDPE Pipe: PVC insert fittings with double stainless steel clamp at pipe connection.
- (e) Swing Joints: Lasco prefab 38 mm. Acme x 25 mm. MPT x 300mm. Part No. GIP2-212
- (f) Sleeves: Series 160 PVC pipe or sufficient diameter to allow clear passage of irrigation pipe and control wires.
- (g) Manual Isolation Valves: Min. 200 PSI rated, WOG, lever type gate valves of approved manufacturer's quality. Sizes as indicated or as required to suit application.
- (h) Automatic Zone Control Valves: 200 PSI (1100 KPa) rated normally closed, 24 VAC electric solenoid valve (P220-26-08) with manual operation capability and flow control adjustment. Glass reinforced nylon body and bonnet or other approved durable material. Valve shall be serviceable from top without removing it from the line. Match valves to selected controller and to zone flow requirements. Maximum pressure loss of 4 PSI design flow.
- (i) Valve Boxes: high density polyurethane or fibreglass reinforced prefabricated plastic boxes complete with locking cover and stainless steel bolt. Size to suit valve clusters as indicated.
- (j) Automatic Controllers: Wall mounted solid state I.C. Controller with fully independently programmable stations and total manual override. Single switch control to reduce or expand watering schedules from 0 200%.Controller size to suit number of zones Toro

TMC 212 non-volatile fail safe programming or approved equal.

- (k) Quick Coupling Valves (QCV101): 25 mm. one piece brass valves of approved manufacturer's quality.
- (I) Quick Coupling Keys (QC101): To match valve.
- (m) Swivel Ells: To match key and with 25 mm. diameter male hose thread.
- (n) Controller Case: Submit shop drawings for final approval of Controller case.
- (o) C.M.P. Enclosure: Construct enclosure for system connection to existing 50 mm. water line as per City of Winnipeg SD-241A. Enclosure to include manual isolation valve, dual check backflow preventer, and a quick coupler valve for system blowout.

E13.10 Sprinklers

- (a) Gear Driven Rotary Pop-up Sprinklers: Toro 2001 stainless steel part circle or full circle sprinklers or approved equal. Nozzles sizes to suit. Submit flow calculation sand nozzle sizes with Shop Drawings for approval by Contract Administrator. Contractor to provide valves to risers of all sprinklers not equipped with internal check valve.
- E13.11 Installation of Pipes
 - (a) Install pipes and fittings in accordance with manufacturers' instructions, from point of connection of supply. Stake out and obtain approval from Contract Administrator prior to installing pipes. Polyethylene pipe shall be installed by "pulling in" pipe. With the pull-in method, the pipe "plow" shall be a vibratory type. The "Mole" or "Bullet" which precedes the pipe is used to form the opening of the pipe, shall be no less 25 mm. larger in diameter than the outside diameter of the pipe. Make connections of the pipe for sprinkler with approved fittings. Install sleeves where pipe will run under walks, walls, driveways and other hard surfaces. Coordinate with other Contractors.
- E13.12 Valves
 - (a) Install valves according to manufacturer's instructions, in valve box set plumb and flush with the finished grade. Provide 150 mm. depth of pea gravel below the valve. Each valve box is to contain its own manual isolation gate valve. All 50 mm. HDPE lateral lines shall be connected to the Toro P220 Electric "zone" valves or approved equal using Leemco RF-11MA 50 mm. IPS GSK X MIPT restrained bell adaptor.
- E13.13 Sprinklers and Quick Coupler Valves
 - (a) Install all sprinklers and Quick Coupler (Q.C.) valves on swing joints. Install HDPE sleeves around Q.C. valve as indicated.
- E13.14 Installation
 - (a) Install all lines in a neat and orderly fashion. Bundle wires together and tape every two (2) meters. Minimize splicing. Make splices where required in valve boxes. Make waterproof with use of approved waterproof kits. Install all wiring in accordance with existing codes. Control lines within building to be run in EMT conduit.
- E13.15 Electrical
 - (a) 110V power for controller will be supplied by others. The irrigation Sub-contractor is responsible for supplying and mounting a 508 mm. x 508 mm. x 300 mm. lockable metal case, weather proof cabinet to cover supplied exterior 110V electrical outlet. The case shall be mounted on the inside of the washroom building adjacent to the power source. Irrigation Sub-contractor shall check with Contract Administrator for approved location and placement of the case.

- (a) Mount controller inside lockable metal case. All wiring shall be done in a neat workman like manner and in compliance with local codes. Run 24 volt control lines to the outside in electrical conduit and seal to prevent leakage. Coordinate work with other Contractors to ensure proper sequence of installation.
- E13.17 Rain Sensor
 - (a) Toro TWRS wireless rain sensor or approved equivalent to be mounted onto gutter of Summer Shelter using quick-clip gutter bracket. Exact location of rain sensor to be verified on site by the Contractor and Contract Administrator. Rain Sensor supply and installation includes Receiver.
- E13.18 Testing
 - (a) Upon completion of system installation, test irrigation system for proper operation. Leave all joints and fittings exposed and pressure test in presence of the Contract Administrator. Provide all pumps and gauges as required for testing as instructed by Contract Administrator.
- E13.19 Balance and Adjustments
 - (a) Balance and adjust the various components of the sprinkler system so the overall system operation is most efficient, and coverage is uniform to the satisfaction of the Contract Administrator.
- E13.20 Maintenance
 - (a) Blow-out all irrigation water lines prior to freeze-up and reconnect the irrigation system in the spring of the following year. Emergency repairs may be required to protect property or permit operation of the work. The Contract Administrator shall notify the Contractor immediately, who shall make all necessary repairs. The cost of such emergency repairs shall be paid by the Contractor. Maintenance not of an emergency nature shall be brought to the attention of the Contractor in writing, and he shall take the necessary action to correct the faulty work. The Contractor shall provide on site orientation as directed by the Contract Administrator to familiarize the Owner/maintenance personnel with the proper operation of the irrigation system and locations of control equipment.
- E13.21 Cleanup
 - (a) Promptly remove surplus material and debris from excavations and dispose of in locations and manner designated by the Contract Administrator.
- E13.22 Basis of Payment
 - (a) Payment for Work specified under this section shall be paid for at the Lump Sum, which price shall include the costs of excavation and trenching, material supply, proper installation of all materials, backfill, Site restoration, and all other items incidental to the Work.

E14. TOPSOIL AND FINISH GRADING

- E14.1 General Description
 - (a) Further to CW 3540-R4, this specification shall cover the supply and installation of topsoil for the establishment of turfgrass within the Limit of Work.
- E14.2 Materials and Methods
 - (a) Topsoil shall be installed and compacted to a depth of 150 mm. as per CW 3540-R5, or as directed by the Contract Administrator.
 - (b) Following compaction and inspection of the rough grading, the entire Work area shall be

scarified to a depth of 150 mm. prior to installation of the topsoil. The finished surface shall be "floated" to a smooth compacted surface with a maximum deviation from designed grade of 25 mm. in 10 meters. Water holding pockets shall not be accepted. No particles greater than 25 mm. in diameter shall be accepted.

E14.3 Basis of Payment

(a) Payment for Work specified under this section shall not be measured separately, but shall be included in the price for Topsoil and Sodding.

E15. SODDING

- E15.1 General Description
 - (a) This specification shall cover the supply and installation of dwarf bluegrass sod to the Limits of Work as shown on the Drawings and as per CW 3540-R5 and CW 3510-R9.
- E15.2 Materials and Methods:
 - (a) Sod
 - (i) As per CW 3510-R9.
 - (ii) Further to CW 3510-R9, the sod type shall consist of the following blend of dwarf bluegrass varieties which are suitable for athletic fields:
 20% Bedazzled, 20% Blackberry, 20% Bordeaux, 20% Midnight, and 20% Nu Destiny.
 - (iii) All sod shall be big roll; grown on a mineral base.
 - (b) Edges are to be cut neatly in straight lines and new sod is to be installed to match the existing grades of the surrounding turf at the Limit of Work. All knives and tools, and sod cutters used for the installation of sod shall be maintained with a sharp cutting edge.
 - (c) Seams between new sod and old turf are to be top dressed and seeded with the blend of dwarf bluegrass varieties mentioned in E15.2 (a) (ii). Areas to be sodded are shown on the drawings. Site restoration outside of those areas remains the responsibility of the Contractor.
- E15.3 Maintenance Period:
 - (a) The Contractor shall maintain the sod for thirty (30) Calendar Days after the completion of the installation or until such a time as the turf is established in accordance with CW 3510-R9.
- E15.4 Basis of Payment:
 - (a) Payment for Work specified under this section shall be paid for at the Unit Price, measured on a square meter basis, for the Items of Work listed below, which price shall include all costs of material supply for sod, sub-grade preparation, proper material installation, maintenance and all other items incidental to the Work.
 - (b) Items of Work
 - (i) Topsoil and Sodding

E16. ASPHALT INSTALLATION

- E16.1 General Description
 - (a) Further to CW 3110-R14 and CW 3410-R8, this specification covers the installation of asphalt and repairs to the existing asphalt Park Road required after installation of, and connection of the sub-surface drainage system to, the existing concrete catch basin as

shown on the Drawings.

E16.2 Materials

- (a) As specified in CW 3110-R14 and CW 3410-R8 and shown on the Drawings.
- (b) Further to CW 3110-R14 and CW 3410-R8. the asphalt road shall consist of :
 - (i) 75 mm. of asphalt laid in two equal lifts, over
 - (ii) 150 mm. of 19 mm. down granular base course, over
- (iii) 300 mm. of 50 mm. down granular sub-base course, over
- (iv) compacted sub-grade

E16.3 Methods

- (a) Install as per CW 3110-R14 and CW 3410-R8 and as shown on the Drawings.
- E16.4 Basis of Payment
 - (a) Payment for work specified under this section shall be paid for at the Unit Price, measured on a square meter basis; which price shall include all cost of material supply including asphalt, base and sub-base materials, proper material installation, and all other items incidental to the work.

E17. SERVICE ROAD - TURF STONE PAVING STONES

- E17.1 General Description
 - (a) Further to CW 3110-R14 and CW 3330-R5, this specification covers the supply and installation of a Service Road from the Park Road to the Summer Shelter as shown on the Drawings.
- E17.2 Materials
 - (a) As specified in CW 3110-R14 and CW 3330-R5, and as shown on the Drawings.
- E17.3 Methods
 - (a) Install as per CW 3110-R14 and CW 3330-R5, and as shown on the Drawings.
 - (b) Once the concrete turf stone paving stones have been installed, all voids and grid spaces shall be filled with topsoil and seeded with dwarf bluegrass varieties specified in E15.2 (a) (ii).
- E17.4 Basis of Payment
 - (a) Payment for work specified under this section shall be paid for at the Unit Price, measured on a square meter basis; which price shall include all cost of material supply including Turf Stone Concrete Paving Stones, base and sub-base materials, non-woven geotextile fabric, proper material installation, and all other items incidental to the work.
