### 2.8 VIBRATION ISOLATION

- .1 Flexible connections at inlet and outlet of fan: to Section 23 33 00 Air Duct Accessories.
- .2 Vibration isolators on fan section: rubber in shear.

# 2.9 FILTER BOX

- .1 Material to match casing. For flat type filter arrangement: as indicated.
  - .1 Provide access to filter through hinged door with suitable hardware.
- .2 Provide blank-off plates and gaskets to prevent air bypass.
- .3 Filters: in accordance with Section 23 41 00 Particulate Air Filtration.
  - .1 Minimum Efficiency Reporting Value (MERV) value 8 filtration media to ASHRAE 52.2.

## 2.10 MIXING BOX

- .1 Material to match casing and produce uniformly mixed air temperature within plus or minus 5 degrees C of design across face of outlet.
- .2 Dampers:
  - .1 Dampers for mixing boxes: in accordance with Section 23 33 15 Dampers Operating.

### 2.11 CHIMNEYS AND BREECHING

- .1 In accordance with Section 23 51 00 Breeching, Chimneys and Stacks.
- .2 Installation and venting provisions: in accordance with CAN/CSA Standard B149.1, and local authorities having jurisdiction.

### 2.12 CONDENSATE DRAIN

- .1 Provide PVC condensate drain trap.
- .2 Condensate filter/neutralizer kit.

### 2.13 ELECTRICAL

.1 Internal wiring: EMT and liquid tight flex conduit.

## 2.14 CONTROLS

- .1 General: conform to CSA C22.2 No.24.
- .2 Gas firing:
  - .1 Operating controls:
    - .1 Proportional and integral control with discharge air sensor to maintain set point temperature and provide rapid response to incremental changes in discharge air temperature.

- .2 Combustion air motor speed varies proportionally in response to the modulation of gas flow to provide optimum fuel/air mixture and efficiency at all conditions.
- .3 Prove combustion blower RPM using a hall effect speed sensor.
- .4 Combustion efficiency of high efficiency heat exchangers to increase by up to 1-3% from high fire to low fire while turning down on units incorporating 15:1 turndown (HT Burner).
- .5 Manual main shut-off valve, automatic safety pilot, automatic electric valve and gas pressure regulator.
- .6 Controller features:
  - .1 Service analyzer with diagnostic lights for ease of set-up and service.
  - .2 Linear gas and combustion air flow obtained via a built in solidstate linear algorithm.
  - .3 -40°F(-40°C) minimum operating ambient temperature.
  - .4 Maintained purge to decrease temperature cycles.
  - .5 Post purge.
  - .6 Interrupted pilot.
  - .7 Self check on start-up to make sure air proving and discharge air sensors are operating within design tolerances.
  - .8 Low fire start.
  - .9 Controlled burner start-up and shut down.
  - .10 Blower contactor that starts fan after burner prepurge.
  - .11 Economizer enable control.
  - .12 Damper contact that allows fan to start after damper opens, damper to close after fan stops, and damper to close on flame failure.
  - .13 Non-recycling auto by-pass low limit with alarm contacts and built-in sensor checking.
  - .14 Built-in alternate blower and damper functions and set back temperatures for unoccupied mode operation using a single room thermostat.
  - .15 Separate gas and air actuators independently controlled to give the correct air to fuel ratio though out the entire firing range.
- .7 Modulate heating control function discharge air with 0-10VDC, BMS reset. Minimum discharge air set point is 50°F (10°C) if BMS control signal fails.
- .8 Unit mounted discharge air sensor.
- .2 Safety controls:
  - .1 Electronic combustion control relay with flame rectification sensor to detect and supervise flame by shutting off fuel upon flame failure or safety interlock signal within seconds, in sequence prepurge-pilot ignition, supervision-main valve opening-pilot cut-off-burner operation and roll out switch.
  - .2 Low limit feature.
  - .3 Blocked vent shut-off switch or control system.

- .4 Limit control to shut down furnace if heat exchanger temperature exceeds limit setting. Combination fan and limit control to be spiral wound.
- .5 Electronic board built-in diagnostics.
- .3 Alarms: normally closed (contact to open on alarm).
- .4 PLC Interface:
  - .1 PLC Outputs to Air Handler Inputs:
    - .1 General Requirements
      - .1 Provide 24 VDC coils.
      - .2 Provide two terminals per signal.
    - .2 Signals
      - .1 Air Handler Run Command (Fan)
      - .2 Burner Enable
  - .2 Air Handler Outputs to PLC Inputs:
    - .1 General Requirements
      - .1 Dry contacts
      - .2 Provide two terminals per signal.
    - .2 Signals
      - .1 Fan Running Status (via CT) N.O.
      - .2 Temp. Low Limit Alarm N.C.
      - .3 Burner Failure N.C.
      - .4 Summer Filter Plugged N.C.
      - .5 Winter Filter Plugged N.C.

## 2.15 ACCEPTABLE MATERIAL

.1 Engineered Air or approved equal in accordance with B6.

## Part 3 Execution

## 3.1 APPLICATION

.1 Manufacturer's Instructions: comply with manufacturer's written recommendations, including product technical bulletins, handling, storage and installation instructions, and datasheets.

## 3.2 INSTALLATION

- .1 Provide appropriate protection apparatus.
- .2 Install units in accordance with manufacturer's instructions and as indicated.
- .3 Ensure adequate clearance for servicing and maintenance.

## 3.3 FANS

- .1 Install fan sheaves required for final air balance.
- .2 Install flexible connections at fan inlet and fan outlets.

.3 Install vibration isolators.

### 3.4 DRIP PANS

- .1 Install deep seal P-traps on drip lines.
  - .1 Depth of water seal to be 1.5 times static pressure at this point.

### 3.5 CLEANING

- .1 Proceed in accordance with Section 01 74 11 Cleaning.
- .2 Upon completion and verification of performance of installation, remove surplus materials, excess materials, rubbish, tools and equipment.
