responsive.

PART D - SUPPLEMENTAL CONDITIONS

Add: D3.4(c) The City has retained Stantec Consulting Ltd. to:

(i) complete an environmental screening under the Canadian Environmental Assessment Act (CEAA);

(ii) complete a pre-construction survey of the Waverley West Arterial Roads Project (WWARP) footprint to facilitate the identification of any Species at Risk (vegetative or wildlife);

(iii) develop an Environmental Protection Plan (EPP). All construction contracts issued under WWARP must include and implement the EPP;

(iv) conduct environmental site inspections of the Waverley West Arterial Roads Project, submitting Monitoring Plan reports to Transport Canada.

Add: D3.7 The Water and Waste Department will be coordinating the installation of a 750mm

Feedermain along the east right-of-way of Kenaston Bv from Waverley St through to the

existing Feedermain at Bison Dr.

Add: D4.2(a)(i) The Water and Waste Department for the Feedermain installation along Kenaston Bv from

Waverley St to Bison Dr.

Add: D4.2(i) The City's environmental consultant for WWARP – Stantec Consulting Ltd. – as described in

Add: D5.3(d)(i) Incorporate the EPP developed by the City's environmental consultant (D3.4(c)(iii)).

Add:	D5.3(g)(ii)	The City will provide any available geotechnical reports conducted within the Project limits.
Add:	D5.3(g)(iii)	The Consultant will be expected to provide the results of their sub-surface explorations and analyses to the Water and Waste Department for their use in the Feedermain installation (D3.7).
Revis	e: D5.3(i)(i) to read	Determining by means of traffic operational studies and analyses, appropriate geometric requirements for all intersections – including any auxiliary lane requirements – and median openings. Analysis is to be conducted using Synchro and Simtraffic and the resulting files are to be provided to the City for review.

		(ii) The City will provide the Consultant with any available background traffic studies.
