- Add: E22.3.6(a)(iv) Contractor to place dowels in tree vault as shown on the drawings.
- Add: E36 PROTECTION OF HIRSCH/HENDRY SCULPTURE
  - E36.1 The Contractor shall take care and implement precautionary measures to avoid damage to the existing Hirsh/Hendry Statue located at the south east corner of the intersection of Market Avenue and Lily Street.
  - E36.2 The Hirsh/Hendry Statue shall remain in place throughout the entirety of the project.
  - E36.3 If the Hirsh/Hendry Statue must be temporarily moved to complete installation of the Work, the Contractor shall be responsible for any removal, protective measures, damage, transportation, temporary storage and placement of the statue back to its original location in its original condition.
  - E36.4 The Hirsh/Hendry Statue shall not be moved or altered in any way without prior approval from the Contract Administrator.
  - E36.5 Protection of the Hirsch/Hendry Statue shall be considered incidental to the Contract Work, and no separate measurement or payment shall be made.
