#### PART B - BIDDING PROCEDURES

Revise: B9.1 to read:

The Proponent shall complete Form B: Fees, making all required entries and summarizing all Fees for the Scope of Services

- (a) Include a Fixed Fee for all phases of the work listed in D5 except for Resident Services;
- (b) Include a Time Based Fee for Resident Services
  - The proposal shall include a Time Based Fee schedule calculated on a time basis for Resident Services.
  - (ii) Time Based fees shall be based on one Inspector providing inspection services as described in D10.1.
- (iii) For proposal purposes these fees should be based on 400 hours of inspection.
- (iv) The number of hours listed in B9.1(b)(iii) is to be considered approximate only. The City will use this number for the purpose of comparing bids.
- (v) The number of hours for which payment will be made to the Consultant for Resident Services is to be determined by the amount of hours actually worked by the Consultant.

#### PART D - SUPPLEMENTAL CONDITIONS

Revise: D7.4 to read:

Review the results of the hydraulic study presented in the 2007 report "Preliminary Design Report for the GWWD Railway Bridge Replacement at Mile 77.6 and Bridge Rehabilitation at Miles 22.15 and 41.3" and:

- (a) Advise if any supplemental work is required for the Proponent's selected design approach;
- (b) The Department has approximately 10 years of Boggy River water level data taken at the Mile 77.6 Bridge. This data will be supplied to the successful proponent on request.
