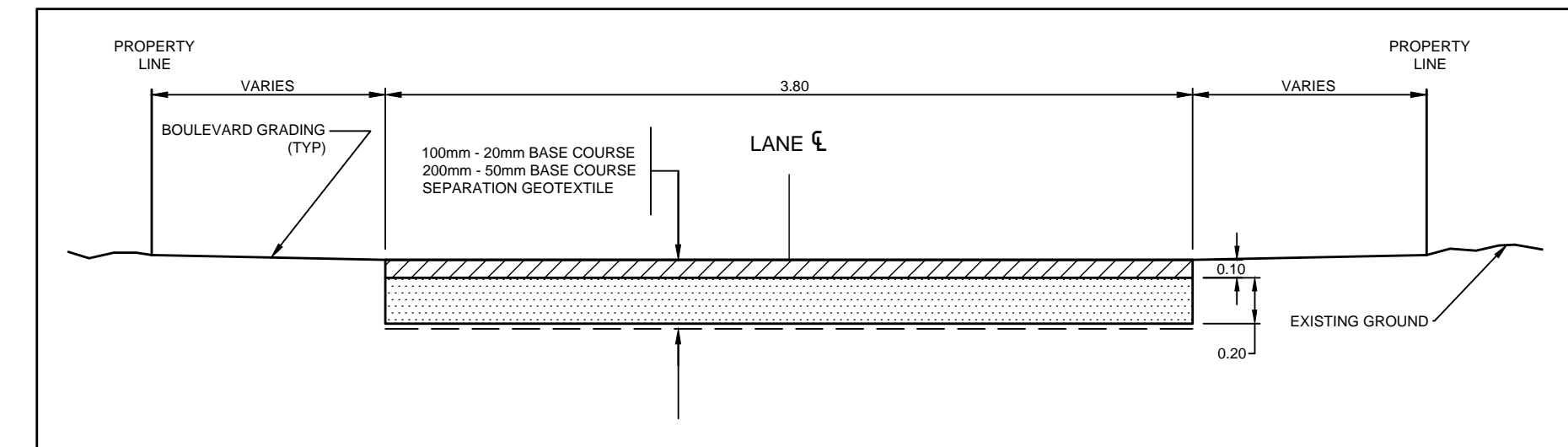


TYPICAL 3.80m LANE CROSS SECTION W / ENVIROGRID
