

NOTES:

- 1. DISCONNECT AND REMOVE THE EXISTING NON-ADDRESSABLE ALARM SYSTEM. EXISTING NON-ADDRESSABLE PULL STATIONS AND FIRE DETECTORS TO REMAIN.
- 2. EXISTING NETWORK RACK TO BE DISCONNECTED, REMOVED AND HANDED OVER TO THE CITY OF WINNIPEG.
- 3. DISCONNECT AND REMOVE ALL EXISTING ELECTRICAL EQUIPMENT IN THIS AREA. THIS IS INCLUSIVE, BUT IS NOT LIMITED TO RECEPTACLES, DATA OUTLETS IN THE INDICATED AREA EXCEPT AS OTHERWISE NOTED. EXISTING ELECTRICAL EQUIPMENT TO BE TURNED OVER TO THE CITY OF WINNIPEG OR AS DIRECTED BY THE CONTRACT ADMINISTRATOR.
- 4. EXISTING 1' x 4' T8 FLUORESCENT FIXTURES TO BE SALVAGED AND RE-USED IN THE NEW CONSTRUCTION (15 FRAMED-IN AND 32 LAY-IN T8 FIXTURES).
- 5. FORCE FLOW HEATER TO REMAIN.
- 6. DISCONNECT AND REMOVE THE EXISTING FEEDER.
- 7. HAND DRYERS TO BE DISCONNECTED AND REUSED.
- 8. MOTION DETECTORS TO BE DISCONNECTED AND REUSED.
- 9. EXISTING ELECTRICAL PANELS TO REMAIN. ANY REMAINING CIRCUITS IN PANEL 'A' TO BE RELOCATED INTO PANEL 'B' OR 'D'.
- 10. SECURITY CAMERA TO BE DISCONNECTED AND RE-USED.
- 11. DISCONNECT AND REMOVE FIRE ALARM BELLS AROUND THE POOL DECK AND INSIDE THE BOILER ROOM.
- 12. PA SPEAKER TO BE DISCONNECTED AND REUSED.


