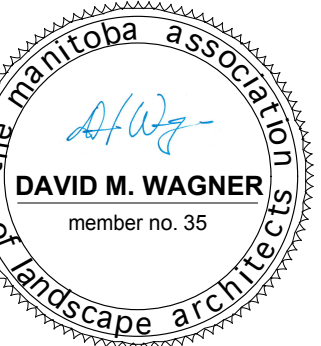
The contractor shall check all dimensions and other data on site and report any discrepancies to the Landscape Architect.
