## **PART B - BIDDING PROCEDURES**

## **B1.** CONTRACT TITLE

B1.1 FLOOD DAMAGE REPAIRS AT VARIOUS SITES

#### **B2. SUBMISSION DEADLINE**

- B2.1 The Submission Deadline is 4:00 PM on September 19, 2013.
- B2.2 Bids determined by the Manager of Materials to have been received later than the Submission Deadline will not be accepted and will be returned upon request.
- B2.3 The Contract Administrator or the Manager of Materials may extend the Submission Deadline by issuing an addendum at any time prior to the time and date specified in B2.1.

#### **B3.** SITE INVESTIGATION

- B3.1 Further to C3.1, the Bidder may view the Site without making an appointment.
- B3.2 The Bidder is advised that he/she is responsible for making any inquiries or arrangements necessary to become fully informed as to the nature of the work and existing site conditions prior to submitting his or her bid. By the submission of the Bid the Bidder acknowledges that it has investigated and satisfied itself as to the nature and scope of the works as well as any other site conditions, laws or restrictions and any other items necessary to undertake and perform the Work.

## **B4.** ENQUIRIES

- B4.1 All enquiries shall be directed to the Contract Administrator identified in D3.1.
- B4.2 If the Bidder finds errors, discrepancies or omissions in the Bid Opportunity, or is unsure of the meaning or intent of any provision therein, the Bidder shall notify the Contract Administrator of the error, discrepancy or omission, or request a clarification as to the meaning or intent of the provision at least five (5) Business Days prior to the Submission Deadline.
- B4.3 Responses to enquiries which, in the sole judgment of the Contract Administrator, require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator to all Bidders by issuing an addendum.
- B4.4 Responses to enquiries which, in the sole judgment of the Contract Administrator, do not require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator only to the Bidder who made the enquiry.
- B4.5 The Bidder shall not be entitled to rely on any response or interpretation received pursuant to B4 unless that response or interpretation is provided by the Contract Administrator in writing.

## **B5.** CONFIDENTIALITY

- B5.1 Information provided to a Bidder by the City or acquired by a Bidder by way of further enquiries or through investigation is confidential. Such information shall not be used or disclosed in any way without the prior written authorization of the Contract Administrator. The use and disclosure of the confidential information shall not apply to information which:
  - (a) was known to the Bidder before receipt hereof; or
  - (b) becomes publicly known other than through the Bidder; or
  - (c) is disclosed pursuant to the requirements of a governmental authority or judicial order.

B5.2 The Bidder shall not make any statement of fact or opinion regarding any aspect of the Bid Opportunity to the media or any member of the public without the prior written authorization of the Contract Administrator.

#### B6. ADDENDA

- B6.1 The Contract Administrator may, at any time prior to the Submission Deadline, issue addenda correcting errors, discrepancies or omissions in the Bid Opportunity, or clarifying the meaning or intent of any provision therein.
- B6.2 The Contract Administrator will issue each addendum at least two (2) Business Days prior to the Submission Deadline, or provide at least two (2) Business Days by extending the Submission Deadline.
- B6.2.1 Addenda will be available on the Bid Opportunities page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <a href="http://www.winnipeg.ca/matmgt/">http://www.winnipeg.ca/matmgt/</a>
- B6.2.2 The Bidder is responsible for ensuring that he/she has received all addenda and is advised to check the Materials Management Division website for addenda regularly and shortly before the Submission Deadline, as may be amended by addendum.
- B6.2.3 The Bidder shall acknowledge receipt of each addendum in Paragraph 8 of Form A: Bid. Failure to acknowledge receipt of an addendum may render a Bid non-responsive.

### **B7.** SUBSTITUTES

- B7.1 The Work is based on the Plant, Materials and methods specified in the Bid Opportunity.
- B7.2 Substitutions shall not be allowed unless application has been made to and prior approval has been granted by the Contract Administrator in writing.
- B7.3 Requests for approval of a substitute will not be considered unless received in writing by the Contract Administrator at least five (5) Business Days prior to the Submission Deadline.
- B7.4 The Bidder shall ensure that any and all requests for approval of a substitute:
  - (a) provide sufficient information and details to enable the Contract Administrator to determine the acceptability of the Plant, Material or method as either an approved equal or alternative:
  - (b) identify any and all changes required in the applicable Work, and all changes to any other Work, which would become necessary to accommodate the substitute;
  - (c) identify any anticipated cost or time savings that may be associated with the substitute;
  - (d) certify that, in the case of a request for approval as an approved equal, the substitute will fully perform the functions called for by the general design, be of equal or superior substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance;
  - (e) certify that, in the case of a request for approval as an approved alternative, the substitute will adequately perform the functions called for by the general design, be similar in substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance.
- B7.5 The Contract Administrator, after assessing the request for approval of a substitute, may in his/her sole discretion grant approval for the use of a substitute as an "approved equal" or as an "approved alternative", or may refuse to grant approval of the substitute.

- B7.6 The Contract Administrator will provide a response in writing, at least two (2) Business Days prior to the Submission Deadline, only to the Bidder who requested approval of the substitute.
- B7.6.1 The Bidder requesting and obtaining the approval of a substitute shall be entirely responsible for disseminating information regarding the approval to any person or persons he/she wishes to inform.
- B7.7 If the Contract Administrator approves a substitute as an "approved equal", any Bidder may use the approved equal in place of the specified item.
- B7.8 If the Contract Administrator approves a substitute as an "approved alternative", any Bidder bidding that approved alternative may base his/her Total Bid Price upon the specified item but may also indicate an alternative price based upon the approved alternative. Such alternatives will be evaluated in accordance with B15.
- B7.9 No later claim by the Contractor for an addition to the Total Bid Price because of any other changes in the Work necessitated by the use of an approved equal or an approved alternative will be considered.
- B7.10 Notwithstanding B7.2 to B7.9, and in accordance with B8.7, deviations inconsistent with the Bid Opportunity document shall be evaluated in accordance with B15.1(a).

## **B8.** BID COMPONENTS

- B8.1 The Bid shall consist of the following components:
  - (a) Form A: Bid;
  - (b) Form B: Prices;
- B8.2 Further to B8.1, the Bidder should include the written correspondence from the Contract Administrator approving a substitute in accordance with B7.
- B8.3 All components of the Bid shall be fully completed or provided, and submitted by the Bidder no later than the Submission Deadline, with all required entries made clearly and completely, to constitute a responsive Bid.
- B8.4 The Bid Submission may be submitted by mail, courier or personal delivery, or by facsimile transmission.
- B8.5 If the Bid Submission is submitted by mail, courier or personal delivery, it shall be enclosed and sealed in an envelope clearly marked with the Bid Opportunity number and the Bidder's name and address, and shall be submitted to:

- B8.5.1 Samples or other components of the Bid Submission which cannot reasonably be enclosed in the envelope may be packaged separately, but shall be clearly marked with the Bid Opportunity number, the Bidder's name and address, and an indication that the contents are part of the Bidder's Bid Submission.
- B8.6 Bidders are advised not to include any information/literature except as requested in accordance with B8.1.
- B8.7 Bidders are advised that inclusion of terms and conditions inconsistent with the Bid Opportunity document, including the General Conditions, will be evaluated in accordance with B15.1(a).
- B8.8 If the Bid Submission is submitted by facsimile transmission, it shall be submitted to 204 949-1178.

- B8.8.1 The Bidder is advised that the City cannot take responsibility for the availability of the facsimile machine at any time.
- B8.8.2 Bids submitted by internet electronic mail (e-mail) will not be accepted.

## B9. BID

- B9.1 The Bidder shall complete Form A: Bid, making all required entries.
- B9.2 Paragraph 2 of Form A: Bid shall be completed in accordance with the following requirements:
  - (a) if the Bidder is a sole proprietor carrying on business in his/her own name, his/her name shall be inserted:
  - (b) if the Bidder is a partnership, the full name of the partnership shall be inserted;
  - (c) if the Bidder is a corporation, the full name of the corporation shall be inserted;
  - (d) if the Bidder is carrying on business under a name other than his/her own, the business name and the name of every partner or corporation who is the owner of such business name shall be inserted.
- B9.2.1 If a Bid is submitted jointly by two or more persons, each and all such persons shall identify themselves in accordance with B9.2.
- B9.3 In Paragraph 3 of Form A: Bid, the Bidder shall identify a contact person who is authorized to represent the Bidder for purposes of the Bid.
- B9.4 Paragraph 10 of Form A: Bid shall be signed in accordance with the following requirements:
  - (a) if the Bidder is a sole proprietor carrying on business in his/her own name, it shall be signed by the Bidder;
  - (b) if the Bidder is a partnership, it shall be signed by the partner or partners who have authority to sign for the partnership;
  - (c) if the Bidder is a corporation, it shall be signed by its duly authorized officer or officers;
  - (d) if the Bidder is carrying on business under a name other than his/her own, it shall be signed by the registered owner of the business name, or by the registered owner's authorized officials if the owner is a partnership or a corporation.
- B9.4.1 The name and official capacity of all individuals signing Form A: Bid should be printed below such signatures.
- B9.4.2 All signatures shall be original.
- B9.5 If a Bid is submitted jointly by two or more persons, the word "Bidder" shall mean each and all such persons, and the undertakings, covenants and obligations of such joint Bidders in the Bid and the Contract, when awarded, shall be both joint and several.

## B10. PRICES

- B10.1 The Bidder shall state a price in Canadian funds for each item of the Work identified on Form B: Prices.
- B10.2 The quantities listed on Form B: Prices are to be considered approximate only. The City will use said quantities for the purpose of comparing Bids.
- B10.3 The quantities for which payment will be made to the Contractor are to be determined by the Work actually performed and completed by the Contractor, to be measured as specified in the applicable Specifications.
- B10.4 Payments to Non-Resident Contractors are subject to Non-Resident Withholding Tax pursuant to the Income Tax Act (Canada).

## **B11. QUALIFICATION**

## B11.1 The Bidder shall:

- (a) undertake to be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba; and
- (b) be financially capable of carrying out the terms of the Contract; and
- (c) have all the necessary experience, capital, organization, and equipment to perform the Work in strict accordance with the terms and provisions of the Contract.
- B11.2 The Bidder and any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
  - (a) be responsible and not be suspended, debarred or in default of any obligations to the City. A list of suspended or debarred individuals and companies is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <a href="http://www.winnipeg.ca/matmgt/debar.stm">http://www.winnipeg.ca/matmgt/debar.stm</a>
- B11.3 The Bidder and/or any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
  - (a) have successfully carried out work similar in nature, scope and value to the Work; and
  - (b) be fully capable of performing the Work required to be in strict accordance with the terms and provisions of the Contract; and
  - (c) have a written workplace safety and health program if required pursuant to The Workplace Safety and Health Act (Manitoba);
- B11.4 Further to B11.3(c), the Bidder shall, within five (5) Business Days of a request by the Contract Administrator, provide proof satisfactory to the Contract Administrator that the Bidder/Subcontractors has a workplace safety and health program meeting the requirements of The Workplace Safety and Health Act (Manitoba), by providing:
  - (a) a valid COR certification number under the Certificate of Recognition (COR) Program administered by the Construction Safety Association of Manitoba or by the Manitoba Heavy Construction Association's WORKSAFELY™ COR™ Program; or
  - (b) a report or letter to that effect from an independent reviewer acceptable to the City. (A list of acceptable reviewers and the review template are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <a href="http://www.winnipeg.ca/matmgt/">http://www.winnipeg.ca/matmgt/</a>.
- B11.5 The Bidder shall submit, within three (3) Business Days of a request by the Contract Administrator, proof satisfactory to the Contract Administrator of the qualifications of the Bidder and of any proposed Subcontractor.
- B11.6 The Bidder shall provide, on the request of the Contract Administrator, full access to any of the Bidder's equipment and facilities to confirm, to the Contract Administrator's satisfaction, that the Bidder's equipment and facilities are adequate to perform the Work.

## B12. OPENING OF BIDS AND RELEASE OF INFORMATION

- B12.1 Bids will not be opened publicly.
- B12.2 Following the submission deadline, the names of the Bidders and their Total Bid Prices (unevaluated, and pending review and verification of conformance with requirements) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <a href="http://www.winnipeg.ca/matmgt/bidopp.asp">http://www.winnipeg.ca/matmgt/bidopp.asp</a>

- B12.3 After award of Contract, the name(s) of the successful Bidder(s) and the Contract amount(s) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <a href="http://www.winnipeg.ca/matmgt/">http://www.winnipeg.ca/matmgt/</a>
- B12.4 The Bidder is advised that any information contained in any Bid may be released if required by City policy or procedures, by The Freedom of Information and Protection of Privacy Act (Manitoba), by other authorities having jurisdiction, or by law.

#### **B13.** IRREVOCABLE BID

- B13.1 The Bid(s) submitted by the Bidder shall be irrevocable for the time period specified in Paragraph 9 of Form A: Bid.
- B13.2 The acceptance by the City of any Bid shall not release the Bids of the next two lowest evaluated responsive Bidders and these Bidders shall be bound by their Bids on such Work for the time period specified in Paragraph 9 of Form A: Bid.

#### **B14. WITHDRAWAL OF BIDS**

- B14.1 A Bidder may withdraw his/her Bid without penalty by giving written notice to the Manager of Materials at any time prior to the Submission Deadline.
- B14.1.1 Notwithstanding C23.3, the time and date of receipt of any notice withdrawing a Bid shall be the time and date of receipt as determined by the Manager of Materials.
- B14.1.2 The City will assume that any one of the contact persons named in Paragraph 3 of Form A: Bid or the Bidder's authorized representatives named in Paragraph 10 of Form A: Bid, and only such person, has authority to give notice of withdrawal.
- B14.1.3 If a Bidder gives notice of withdrawal prior to the Submission Deadline, the Manager of Materials will:
  - (a) retain the Bid until after the Submission Deadline has elapsed;
  - (b) open the Bid to identify the contact person named in Paragraph 3 of Form A: Bid and the Bidder's authorized representatives named in Paragraph 10 of Form A: Bid; and
  - (c) if the notice has been given by any one of the persons specified in B14.1.3(b), declare the Bid withdrawn.
- B14.2 A Bidder who withdraws his/her Bid after the Submission Deadline but before his/her Bid has been released or has lapsed as provided for in B13.2 shall be liable for such damages as are imposed upon the Bidder by law and subject to such sanctions as the Chief Administrative Officer considers appropriate in the circumstances. The City, in such event, shall be entitled to all rights and remedies available to it at law.

## **B15. EVALUATION OF BIDS**

- B15.1 Award of the Contract shall be based on the following bid evaluation criteria:
  - (a) compliance by the Bidder with the requirements of the Bid Opportunity or acceptable deviation there from (pass/fail);
  - (b) qualifications of the Bidder and the Subcontractors, if any, pursuant to B11 (pass/fail);
  - (c) Total Bid Price;
  - (d) economic analysis of any approved alternative pursuant to B7.
- B15.2 Further to B15.1(a), the Award Authority may reject a Bid as being non-responsive if the Bid is incomplete, obscure or conditional, or contains additions, deletions, alterations or other irregularities. The Award Authority may reject all or any part of any Bid, or waive technical requirements or minor informalities or irregularities, if the interests of the City so require.

- B15.3 Further to B15.1(b), the Award Authority shall reject any Bid submitted by a Bidder who does not demonstrate, in his/her Bid or in other information required to be submitted, that he/she is responsible and qualified.
- B15.4 Further to B15.1(c), the Total Bid Price shall be the sum of the quantities multiplied by the unit prices for each item shown on Form B: Prices adjusted, if necessary, as follows:
  - (a) if the lowest evaluated responsive Bid submitted by a responsible and qualified Bidder is within the budgetary provision for the Work, no adjustment will be made to the Total Bid Price; or
  - (b) if the lowest evaluated responsive Bid submitted by a responsible and qualified Bidder exceeds the budgetary provision for the Work, the Total Bid Prices of all responsive Bids submitted by responsible and qualified Bidders will be adjusted by progressively deducting item(s) 25, 26, 27,11, and 9 in the order listed, until a Total Bid Price within the budgetary provision is achieved.
- B15.4.1 If there is any discrepancy between the Total Bid Price written in figures, the Total Bid Price written in words and the sum of the quantities multiplied by the unit prices for each item, the sum of the quantities multiplied by the unit prices for each item shall take precedence.
- B15.4.2 Further to B15.1(a), in the event that a unit price is not provided on Form B: Prices, the City will determine the unit price by dividing the Amount (extended price) by the approximate quantity, for the purposes of evaluation and payment.

#### B16. AWARD OF CONTRACT

- B16.1 The City will give notice of the award of the Contract or will give notice that no award will be made.
- B16.2 The City will have no obligation to award a Contract to a Bidder, even though one or all of the Bidders are determined to be responsible and qualified, and the Bids are determined to be responsive.
- B16.2.1 Without limiting the generality of B16.2, the City will have no obligation to award a Contract where:
  - (a) the prices exceed the available City funds for the Work;
  - (b) the prices are materially in excess of the prices received for similar work in the past;
  - (c) the prices are materially in excess of the City's cost to perform the Work, or a significant portion thereof, with its own forces;
  - (d) only one Bid is received; or
  - (e) in the judgment of the Award Authority, the interests of the City would best be served by not awarding a Contract.
- B16.3 Where an award of Contract is made by the City, the award shall be made to the responsible and qualified Bidder submitting the lowest evaluated responsive Bid, in accordance with B15.
- B16.3.1 Following the award of contract, a Bidder will be provided with information related to the evaluation of his/her Bid upon written request to the Contract Administrator.
- B16.4 Notwithstanding C4, the City will issue a Purchase Order to the successful Bidder in lieu of the execution of a Contract.
- B16.5 The Contract, as defined in C1.1, in its entirety shall be deemed to be incorporated in and to form a part of the Purchase Order notwithstanding that it is not necessarily attached to or accompany said Purchase Order.

## **PART C - GENERAL CONDITIONS**

## C0. GENERAL CONDITIONS

- C0.1 The *General Conditions for Construction* (Revision 2006 12 15) are applicable to the Work of the Contract.
- C0.1.1 The General Conditions for Construction are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <a href="http://www.winnipeg.ca/matmgt/gen\_cond.stm">http://www.winnipeg.ca/matmgt/gen\_cond.stm</a>
- C0.2 A reference in the Bid Opportunity to a section, clause or subclause with the prefix "C" designates a section, clause or subclause in the *General Conditions for Construction*.

## **PART D - SUPPLEMENTAL CONDITIONS**

## **GENERAL**

#### D1. GENERAL CONDITIONS

D1.1 In addition to the *General Conditions for Construction*, these Supplemental Conditions are applicable to the Work of the Contract.

#### D2. SCOPE OF WORK

- D2.1 The Work to be done under the Contract shall consist of repair of flood damages incurred in the 2011 flood at various sites.
- D2.2 The major components of the Work are as follows:
  - (a) Removal of materials deposited during the flood.
  - (b) Repair of damages to a boat launch facility.
  - (c) Repair of damages to the Tache boat dock including paving, rip rap and concrete grade beams.
  - (d) Repair of railings damaged during the flood.
  - (e) Repair/replacement of park lights damaged during the flood.
  - (f) Supply and installation of Topsoil and Sod and other surface restoration items.
  - (g) Supply and install of erosion control materials.

## D3. CONTRACT ADMINISTRATOR

- D3.2 At the pre-construction meeting, Dean Spearman will identify additional personnel representing the Contract Administrator and their respective roles and responsibilities for the Work.
- D3.3 Bids Submissions must be submitted to the address in B8.5.

## D4. CONTRACTOR'S SUPERVISOR

D4.1 At the pre-construction meeting, the Contractor shall identify his/her designated supervisor and any additional personnel representing the Contractor and their respective roles and responsibilities for the Work.

## D5. OWNERSHIP OF INFORMATION, CONFIDENTIALITY AND NON DISCLOSURE

- D5.1 The Contract, all deliverables produced or developed, and information provided to or acquired by the Contractor are the property of the City and shall not be appropriated for the Contractors own use, or for the use of any third party.
- D5.2 The Contractor shall not make any public announcements or press releases regarding the Contract, without the prior written authorization of the Contract Administrator.
- D5.3 The following shall be confidential and shall not be disclosed by the Contractor to the media or any member of the public without the prior written authorization of the Contract Administrator;

- (a) information provided to the Contractor by the City or acquired by the Contractor during the course of the Work;
- (b) the Contract, all deliverables produced or developed; and
- (c) any statement of fact or opinion regarding any aspect of the Contract.
- D5.4 A Contractor who violates any provision of D5 may be determined to be in breach of Contract.

#### D6. NOTICES

- D6.1 Except as provided for in C23.2.2, all notices, requests, nominations, proposals, consents, approvals, statements, authorizations, documents or other communications to the Contractor shall be sent to the address or facsimile number identified by the Contractor in Paragraph 2 of Form A: Bid.
- D6.2 All notices, requests, nominations, proposals, consents, approvals, statements, authorizations, documents or other communications to the City, except as expressly otherwise required in D6.3, D6.4 or elsewhere in the Contract, shall be sent to the attention of the Contract Administrator at the facsimile number identified in D3.1.

#### **SUBMISSIONS**

## D7. AUTHORITY TO CARRY ON BUSINESS

D7.1 The Contractor shall be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba, or if the Contractor does not carry on business in Manitoba, in the jurisdiction where the Contractor does carry on business, throughout the term of the Contract, and shall provide the Contract Administrator with evidence thereof upon request.

## D8. SAFE WORK PLAN

- D8.1 The Contractor shall provide the Contract Administrator with a Safe Work Plan at least five (5) Business Days prior to the commencement of any Work on the Site but in no event later than the date specified in C4.1 for the return of the executed Contract.
- D8.2 The Safe Work Plan should be prepared and submitted in the format shown in the City's template which is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <a href="http://www.winnipeg.ca/matmgt/Safety/default.stm">http://www.winnipeg.ca/matmgt/Safety/default.stm</a>

## D9. INSURANCE

- D9.1 The Contractor shall provide and maintain the following insurance coverage:
  - (a) commercial general liability insurance, in the amount of at least two million dollars (\$2,000,000.00) inclusive, with The City of Winnipeg and Dean Spearman Landscape Architect added as an additional insured, with a cross-liability clause, such liability policy to also contain contractual liability, unlicensed motor vehicle liability, non-owned automobile liability and products and completed operations, to remain in place at all times during the performance of the Work and throughout the warranty period;
  - (b) if applicable, Automobile Liability Insurance covering all motor vehicles, owned and operated and used or to be used by the Contractor directly or indirectly in the performance of the Work. The Limit of Liability shall not be less than \$2,000,000 inclusive for loss or damage including personal injuries and death resulting from any one accident or occurrence;
  - (c) all risks installation floater, carrying adequate limits to cover all machinery, equipment, supplies and/or materials intended to enter into and form part of any installation.
- D9.2 Deductibles shall be borne by the Contractor.
- D9.3 The Contractor shall provide the Contract Administrator with a certificate(s) of insurance, in a form satisfactory to the City Solicitor, at least two (2) Business Days prior to the commencement of any Work but in no event later than seven (7) Calendar Days from notification of the award of Contract by Purchase Order.
- D9.4 The Contractor shall not cancel, materially alter, or cause each policy to lapse without providing at least thirty (30) Calendar Days prior written notice to the Contract Administrator.

## D10. PERFORMANCE SECURITY

- D10.1 If the Contract Price exceeds twenty-five thousand dollars (\$25,000.00), the Contractor shall provide and maintain performance security until the expiration of the warranty period in the form of:
  - (a) a performance bond of a company registered to conduct the business of a surety in Manitoba, in the form attached to these Supplemental Conditions (Form H1: Performance Bond), in the amount of fifty percent (50%) of the Contract Price; or
  - (b) an irrevocable standby letter of credit issued by a bank or other financial institution registered to conduct business in Manitoba and drawn on a branch located in Winnipeg, in the form attached to these Supplemental Conditions (Form H2: Irrevocable Standby Letter of Credit), in the amount of fifty percent (50%) of the Contract Price; or

- D10.1.1 Where the performance security is in the form of a certified cheque or draft, it will be deposited by the City. The City will not pay any interest on certified cheques or drafts furnished as performance security.
- D10.2 The Contractor shall provide the City Solicitor with the required performance security within seven (7) Calendar Days of notification of the award of the Contract by way of Purchase Order and prior to the commencement of any Work on the Site.

## D11. SUBCONTRACTOR LIST

D11.1 The Contractor shall provide the Contract Administrator with a complete list of the Subcontractors whom the Contractor proposes to engage (Form J: Subcontractor List) at least two (2) Business Days prior to the commencement of any Work on the Site but in no event later than seven (7) Calendar Days from notification of the award of Contract.

## D12. DETAILED WORK SCHEDULE

- D12.1 The Contractor shall provide the Contract Administrator with a detailed work schedule at least two (2) Business Days prior to the commencement of any Work on the Site but in no event later than the date specified in C4.1 for the return of the executed Contract.
- D12.2 The detailed work schedule shall consist of the following dates:

- (b) Contractor to review schedule with Contract Administrator and indicate changes to the schedule including changes to activity durations, start and finish dates.
- (c) Contractor to document changes to schedule complete with explanations and or reasons for changes.
- (d) Contractor to indicate corrective actions they will take to bring the project back on schedule should the project schedule indicate a change in finish date or critical path items.

- D13.3 Plan drawings submitted shall include the following:

  - (b) Scale, north point
  - (c) Date, address, name, professional seal and signature of the design engineer or architect.
- D13.4 Detailed plans. All detailed plans shall be drawn to a suitable scale and include the following information:

- (a) Complete construction details, including dimensions, elevations and appropriate crosssections.
- D13.5 The Contractor shall provide at minimum the following Shop Drawings:
  - (a) Electrical work at Mostyn Place Park.
  - (b) Schematic Drawing of each site indicating the contractors intended access routes and staging areas.
- D13.6 The Contractor shall maintain, during the course of construction, a complete set of Drawings including the original Bid Opportunity Drawings, any Drawings released by addenda or change order, and the Contractors Shop Drawings.
  - (a) These drawings shall have any deviations between the actual built Work and the Drawings noted on them in red as well as the reason for the deviation.
  - (b) These drawings shall be made available to the Contract Administrator for review upon request during the Construction phase of the project.
  - (c) These drawings shall be provided to the Contract Administrator at the date of Substantial Performance.
- D13.7 There shall be no separate measurement or payment for Shop Drawings or Record Drawings.

## D14. COMMENCEMENT

- D14.1 The Contractor shall not commence any Work until he/she is in receipt of a Purchase Order from the Award Authority authorizing the commencement of the Work.
- D14.2 The Contractor shall not commence any Work on the Site until:

- D14.3 The Contractor shall commence the Work on the Site within seven (7) Working Days of receipt of the Purchase Order.

## D15. SUBSTANTIAL PERFORMANCE

- D15.1 The Contractor shall achieve Substantial Performance within Twenty Five (25) consecutive Working Days of the commencement of the Work as specified in D14.
- D15.2 When the Contractor considers the Work to be substantially performed, the Contractor shall arrange, attend and assist in the inspection of the Work with the Contract Administrator for purposes of verifying Substantial Performance. Any defects or deficiencies in the Work noted during that inspection shall be remedied by the Contractor at the earliest possible instance and the Contract Administrator notified so that the Work can be reinspected.

D15.3 The date on which the Work has been certified by the Contract Administrator as being substantially performed to the requirements of the Contract through the issue of a certificate of Substantial Performance is the date on which Substantial Performance has been achieved.

#### D16. TOTAL PERFORMANCE

- D16.1 The Contractor shall achieve Total Performance within Thirty (30) consecutive Working Days of the commencement of the Work as specified in D14.
- D16.2 When the Contractor or the Contract Administrator considers the Work to be totally performed, the Contractor shall arrange, attend and assist in the inspection of the Work with the Contract Administrator for purposes of verifying Total Performance. Any defects or deficiencies in the Work noted during that inspection shall be remedied by the Contractor at the earliest possible instance and the Contract Administrator notified so that the Work can be reinspected.
- D16.3 The date on which the Work has been certified by the Contract Administrator as being totally performed to the requirements of the Contract through the issue of a certificate of Total Performance is the date on which Total Performance has been achieved.

#### D17. LIQUIDATED DAMAGES

- D17.1 If the Contractor fails to achieve Substantial Performance or Total Performance in accordance with the Contract by the days fixed herein for same, the Contractor shall pay the City the following amounts per Working Day for each and every Working Day following the days fixed herein for same during which such failure continues:
  - (a) Substantial Performance Five Hundred dollars (\$500.00);
  - (b) Total Performance Five Hundred dollars (\$500.00).
- D17.2 The amounts specified for liquidated damages in D17.1 are based on a genuine pre-estimate of the City's losses in the event that the Contractor does not achieve Substantial Performance or Total Performance by the days fixed herein for same.
- D17.3 The City may reduce any payment to the Contractor by the amount of any liquidated damages assessed.

## D18. SCHEDULED MAINTENANCE

- D18.1 The Contractor shall perform the following scheduled maintenance in the manner and within the time periods required by the Specifications:
  - (a) Maintenance of sod and seed as specified in E16;
  - (b) Maintenance of Erosion Control Blanket as specified in E18.
- D18.2 Determination of Substantial Performance and Total Performance shall be exclusive of scheduled maintenance identified herein. All scheduled maintenance shall be completed prior to the expiration of the warranty period. ## E2. HAZARDOUS MATERIALS

E2.1 If asbestos or other hazardous materials are encountered during the Work of the Contract, the Contractor shall stop all work and notify the Contract Administrator immediately. Removal of hazardous materials shall be dealt with by the City and the Contractor shall await further instruction by the Contract Administrator.

## E3. EXISTING SERVICES AND UTILITIES

## E4. ACCESS TO SITE

- E4.1 Access to the Site as required by the Contractor shall be provided and maintained by the Contractor at his own expense and approved by the Contract Administrator.
- E4.2 The Contractor's operations shall be limited to the minimum area necessary for undertaking the Work and he shall be responsible for all damage resulting from his Work on private or public property.

## E5. PERMITS, NOTICES, LICENCES, CERTIFICATES, LAWS AND RULES

- E5.1 Further to C6.12, the Contractor shall give all necessary notices, obtain all necessary permits and pay all fees in order that the Work may be carried out. All Work must be performed in compliance with the Manitoba Department of Labour Workplace Health and Safety Guidelines and all other applicable codes. The Contractor is responsible for the immediate notification to the Contract Administrator of his/her encountering of suspected hazardous material during their course of Work.

## E6. DAMAGE TO EXISTING STRUCTURES, TREES AND PROPERTY

All necessary precautions shall be exercised by the Contractor so as not to remove, disturb, or damage any existing trees, shrubs, sod, pavements, streets, roads, boulevards, poles, hydrants, water pipes, gas pipes, electrical wires, cables, conduits, sewers or other existing facilities and equipment at the Site of the Work. For all damage incurred in the performance of the Work (either directly or indirectly), the Contractor shall either replace and repair such damage, whichever may be deemed necessary in the opinion of, and acceptable to the Contract Administrator, and the cost of which shall be borne entirely by the Contractor. The Contractor shall also indemnify and save harmless the City and the Contract Administrator from all claims made directly or indirectly against it in respect to any such damage.

## E7. PEDESTRIAN SAFETY AND TRAFFIC MANAGMENT

- E7.1 Further to CW 1130-R1, the Contractor shall take such measures as are necessary to ensure safe and convenient pedestrian ingress and egress is maintained to private properties while he is Working near them. Any damage caused by the negligence of the Contractor or his SubContractors to the adjacent Works or properties, shall be promptly repaired by him/her at his own expense, to the satisfaction of the Contract Administrator.
- E7.2 Ambulance/ Emergency vehicle access must be maintained at all times.

#### E8. PROTECTION OF THE SURVEY INFRASTRUCTURE

- E8.1 Nonwithstanding CW 1130 3.14 'Protection of Survey Infrastructure' of the Standard Construction Specifications, current legislation, The Surveys Act, places the onus on those undertaking construction to protect the Survey Infrastructure from damage as a result of their activity.
- E8.2 Further to C:6.26(g), at least 72 hours prior to the commencement of the On-Site Work the Contractor shall contact the City of Winnipeg, Geomatics Services Branch at 918-1360 (8:00 a.m. to 4:00 pm Monday to Friday excluding holidays) to obtain clearance. Geomatics Services will locate and mark all known outline survey monuments and geodetic control monuments and confirm the physical condition of those monuments upon completion of construction, at no cost to the Contractor.

- E8.3 Where a survey post, bar, or control monument lies in the line of proposed Work and must be disturbed, the Contractor shall provide the Contract Administrator with 48 hours notice to permit referencing for future replacement, at no cost to the Contractor. Failure to provide the specified notice shall result in the Contractor paying for all costs associated with replacing or relocating the disturbed outline survey monuments and geodetic control monuments.
- E8.4 Outline survey monuments and geodetic control monuments at or adjacent to the Site, not in line of the proposed construction that are damaged or disturbed by the Contractor shall be replaced or relocated by the City or its agent and all associated costs shall be paid for by the Contractor. An approximate estimate of the costs involved to restore a legal survey monument is \$1000 per bar and \$3000 per control monument. Contractors must ensure SubContractors are aware of this clearance procedure and the potential restoration costs.
- E8.5 Where possible, amounts owed to the City in accordance with the above will be deducted from any payments to be made by the City to the Contractor.

#### E9. WORK ADJACENT TO WATERWAYS

- E9.1 The Contractor is to note that much of the work pertaining to this contractor will take place adjacent to rivers.
- E9.2 The Contractor shall take into account all City, Provincial, and Federal bylaws, regulations, and guidelines and adopt all appropriate best practices necessary to protect the rivers, minimize erosion and control sediment deposition throughout all stages of work on this project. The Contractor shall be solely responsible for compliance with said bylaws, regulations and guidelines.
- E9.3 For each item of work the Contractor shall erect and maintain a suitable silt fence to prevent material and contaminants from entering the rivers. The cost of this shall be incidental to the Excavation or Excavation and Removals items on Form B:Prices.
- E9.4 The Contractor shall accelerate any work adjacent to the rivers to ensure that the work is completed in the fall of 2013 during the river draw down period and prior to any spring flooding.
- E9.5 In addition to the above the Contractor is directed to the City of Winnipeg's "Best Management Practices Handbook for Activities In and Around the City's Waterways and Watercourses" as a guide to the City's requirements. This guide is available at <a href="http://winnipeg.ca/ppd/riverbank/BMPHandbook.pdf">http://winnipeg.ca/ppd/riverbank/BMPHandbook.pdf</a>

## E10. SITE ENCLOSURES

- E10.1 Temporary Site enclosures, as determined necessary at the pre-construction meeting or as shown on the Drawings, shall be erected and maintained as required for the duration of the construction period.
- E10.2 Site enclosures shall, at a minimum, consist of sectional, 1.8 m ht, non-climbable metal fencing.
- E10.3 Site enclosure shall be sufficient to isolate and secure the jobsite from the adjacent area.
- E10.4 Site enclosures shall be considered incidental to the Contract Work and will not be separately measured or paid for.

## E11. ACCESS ROUTES AND STOCKPILE LOCATIONS

- E11.1 The Contractor shall provide a schematic drawing for each site identifying access routes and stock pile locations within 5 days of award of Contract.
- E11.2 This drawing shall be subject to review and approval of Contract Administrator prior to construction work starting on each site.

E11.3 Stockpile locations must take into account river bank conditions in the area and be consistent with any requirements placed under the Waterways Permit.

## SITE WORK

#### E12. TREE PROTECTION

- E12.1 The Contractor shall take the following precautionary steps to prevent damage from construction activities to existing park trees within the limits of the construction area.
- E12.2 The Contractor shall not stockpile materials and soil or park vehicles and equipment within 2 metres of trees.
- E12.3 Trees identified to be at risk by the Contract Administrator are to be strapped with 25x100x2400 wood planks, or suitable protection as approved by the Contract Administrator.
- Excavation shall be performed in a manner that minimizes damage to the existing root systems. Where possible, excavation shall be carried out such that the edge of the excavation shall be a minimum of 1.5 times the diameter (measured in inches), with the outcome read in feet, from the closest edge of the trunk. Where roots must be cut to facilitate excavation, they shall be pruned neatly at the face of excavation. This shall not apply to recently deposited fill which may specifically be noted for removal on the drawings.
- E12.5 Operation of equipment within the drip line of the trees shall be kept to a minimum required to perform the Work required. Equipment shall not be parked, repaired, refuelled; construction materials shall not be stored, and earth materials shall not be stockpiled within the drip lines of trees. The drip line of a tree shall be considered to be the ground surface directly beneath the tips of its outermost branches. The Contractor shall ensure that the operations do not cause flooding or sediment deposition on areas where trees are located.
- E12.6 Where tree protection fencing is called for the Contractor shall install orange safety fencing with a minimum height of 1.2m using t-rail metal stakes at a maximum spacing of 2 m o.c.. Safety fencing shall be securely fastened to the trail stake.
- E12.7 Contractor shall maintain tree protection fence until such time as construction is sufficiently well progressed as to ensure that vehicular traffic and movement of heavy materials is no longer necessary to complete the remaining works.
- E12.8 All damage to existing trees caused by the Contractor's activities shall be repaired to the requirements and satisfaction of the Contract Administrator and the City Forester or his/her designate.
- E12.9 Tree protection shall be considered incidental to the work and will not be measured or paid for separately.

#### E13. EXCAVATION AND REMOVALS

- E13.1 This section shall cover the removal of existing site features where scheduled for removal, any other demolition and removal necessary to construct the project which may be considered incidental to other items of Work.
- E13.2 To the extent and limits shown on the Drawings, where the existing surfacing is to be removed, it is to be removed in its entirety.
- E13.3 Where removal of excess materials is called for the excess materials shall be removed from the site immediately upon excavation and not stockpiles on site. Excess materials shall be disposed of in a legal manner.
- E13.4 Removal of items designated for removal on the drawings shall be included and paid for under the items that replace them and be considered incidental to that work.

## E14. EXCAVATION, EARTHWORK AND GRADING

## Description

- E14.1 This specification shall cover all clearing and grubbing, excavation, stockpiling of topsoil, removal or supply and placement of materials necessary to achieve the grades and drainage patterns documented in the Drawings at the sub grade (mud grade) level.
- E14.2 This specification is supplemental to CW 3010, CW 3110 and CW 3170. Materials and installation are to conform to these standard Specifications.
  - Construction Methods
- E14.3 Prior to beginning work the Contractor shall establish limits of grading and stake finish grades in a manner consistent with the drawings. Contractor shall not proceed until Contract Administrator has reviewed the grades and the limits for conformance with the design intent and authorized the Contractor to proceed. This contractor shall remain responsible for attaining the design grades irrespective of the Contract Administrators review.
- E14.4 Clearing and grubbing operations are to be completed to the satisfaction of the Contract Administrator prior to the beginning of Earthwork and Grading.
- E14.5 Contractor shall limit grading operations to the area shown on the drawing with the exception of local grading and or excavation which may be necessary to install other works.
- E14.6 Grading operations are to be conducted to ensure adequate subcut to install surface materials and structures as detailed on the drawings while still ensuring positive drainage of the finished project.
- E14.7 Subgrade shall be completed and accepted by the Contract Administrator prior to the installation of other works.
  - Method of Measurement and Basis of Payment
- E14.8 There will be no separate measurement or payment for stockpiling of topsoil, clearing and grubbing operations.
- E14.9 There shall be no separate measurement of payment for excavation and the supply or removal of fill material required for installation of sod, site furniture, asphalt or concrete work or skate features to the elevations indicated as it shall be considered incidental to the supply and installation of those items.
- E14.10 Excavation of surplus fill material to achieve grades and cross sections shown on the drawings shall be measured and paid for under items on Form B:Prices.

## E15. TOPSOIL, SEED AND SODDING

**General Description** 

E15.1 This specification covers the removal of existing grass, topsoil or sand, levelling or excavating the area designated to receive sod, supply and installation of topsoil and sod, the topdressing and seeding of seam, edges and areas of Site restoration.

Materials and Methods

- E15.2 Topsoil is to be supplied and installed as per CW 3540.
- E15.3 Sod is to be supplied and installed as per CW 3510.
- E15.4 Seeding is to be supplied and installed as per CW 3520.

- Areas to be Sodded and/or Seeded are to be laid out on Site and approved by Contract Administrator before commencing Work. Work outside the limits approved by the Contract Administrator will not be measured and will not be paid for under this section but considered incidental to the Work. Such incidental items that will not be measured include but are not limited to topsoil and sod or seed used for incidental Site
- E15.6 Topsoil, Sod or Seed as part of incidental restoration shall conform to the same Specifications.
- E15.7 Where edges of excavation abut existing turf those edges are to be cut with a sod cutter prior to excavation.
- E15.8 Except where otherwise specified on the drawings the compacted depth of topsoil shall be minimum 10 cm.
- E15.9 Topsoil depth where stated on the drawings shall be deemed to refer to compacted depth.

**Payment** 

- E15.10 Payment will be at the contract unit Price on Form B:Prices. Price shall be payment in full for supplying materials and for performing all operations listed below:
  - (a) Supply and installation of topsoil.
  - (b) Supply and placement of sod and'or seed.
  - (c) maintenance of sod and/or seed.

## E16. LANDSCAPE MAINTENANCE

- E16.1 This section shall cover the maintenance for all sod and shrub beds installed during the course of this Contract.
- E16.2 Sod Maintenance shall be as per CW 3510.
- E16.3 Active maintenance is to include;
  - (a) Watering
  - (b) Weeding control
  - (c) Pest and Disease control
  - (d) Pruning
  - (e) Tree Support and tie maintenance and adjustment
  - (f) Winter protection
- E16.4 Water shall be applied as required to maintain optimum conditions. During dry weather the Contractor should expect to water on a weekly basis. Contractor is to avoid over watering by reducing the frequency during wet weather.
- E16.5 Contractor shall maintain planting beds in a weed free condition throughout the maintenance period. Weed should be removed frequently and not left to establish for a period greater than 10 days.
- E16.6 Contractor is to control pests and diseases as required. Contractor shall inform the Contract Administrator prior to applying pesticides and use only those pesticides of low mammalian toxicity. Persons applying pesticides shall have a valid pesticide applicators license and strictly follow manufacturers instructions regarding the application of the chemicals and the safety precautions required to apply them.
- Pruning shall be done by persons with a valid Manitoba Tree Pruners license. Pruning shall be as necessary to remove dead or damaged limbs as well as maintain species typical form and healthy growth. Pruning shall also be done to ensure clearances to all pathways and other facilities as well as maintain safe viewed into the facility. Pruning shall be done in accordance

with industry accepted methods to standard good practice. In the event of a disagreement the opinion of the Contract Administrator as to what constituted standard good practice shall be considered final.

- E16.8 At the end of each growing season Contractor is to ensure that tree is properly fitted with rodent protection as per the planting detail.
- E16.9 Maintenance operation are to be diarised. Each diary entry is to contain the following:
  - (a) Maintenance Site Forman
  - (b) Date
  - (c) Weather conditions
  - (d) Actions performed
- E16.10 Maintenance of the sodded areas shall be deemed a part of Topsoil, Sod and Shrub Bed preparation and paid for as per CW 3510.
- E16.11 Pruning shall be considered incidental to the work and paid for under the items of work that necessitate the pruning.

## E17. CRUSHER FINES PAVING

**General Description** 

E17.1 This specification covers the supply and installation of granular paving including all excavation, compaction, geotextile, sub-base and base construction as well as gravel surfacing, and repair of existing sod to ensure a smooth transition to the paving. Other items necessary to complete this portion of the Work and not noted elsewhere are considered incidental to this Work.

Materials and Methods

- E17.2 This specification is supplemental to CW 3110, CW 3130 and CW 3170. Materials and installation are to conform to these standard Specifications.
- E17.3 Sub-base, base materials and depths are as noted on drawing.
- E17.4 Excavation is to be reviewed by Contract Administrator prior to the installation of fabric or subbase.
- E17.5 Sub-base is to be installed and compacted.
- E17.6 Where the granular paving is to pass through an existing grassed surface the Contractor is to cut the sod using a sod cutter at the edges of the new patio prior to excavation.
- E17.7 Except as specifically noted on the drawing areas of granular paving are to be constructed so as to function with existing drainage patterns and are to have a minimum cross slope of 1% and a maximum cross slope of 3%.
- E17.8 Granular paving is to meet existing landscaping, concrete paving and roads in a neat and precise manner.

Measurement and Payment

- E17.9 Payment will be at the contract lump sum price for 'Crusher Fines Path' on Form B: Prices.
- E17.10 Where restoration of sod is required and is outside of an area specified for new sod, this shall be considered incidental to the crusher fines or red shale paving and will not be measured or otherwise paid for.
- E17.11 Price shall be payment in full for supplying materials and for performing all operations listed below:

- (a) Excavate in-situ material to accommodate the pavement structure including base and subbase.
- (b) Supply and installation of Geotextile.
- (c) Supply and placement of Crushed limestone base course.
- (d) Supply and placement of Crushed surfacing.
- (e) Compaction

## E18. EROSION CONTROL BLANKET

### **General Description**

- E18.1 This Specification shall cover supply and installation of erosion control blankets over disturbed areas where called for on the drawings.
  - (a) The Work to be done under this Specification shall include the furnishing of all overhead, superintendence, labour, materials, equipment, tools, supplies and any other items necessary for or incidental to the supply and installation of erosion control blankets.

#### Materials

- E18.2 Erosion control blanket (ECB) shall be machine produced 100% coconut fibres matrix with a functional longevity of 12 to 36 months.
- E18.3 The blanket shall be of consistent thickness with the coconut fibres evenly distributed over the entire area at a minimum of 0.27 of coconut fibre/sm.
- E18.4 Biodegradable reinforcement netting on both sides manufactured from heavy weight cotton of jute fibre thread )1.47 kg/100m of thread). The mesh dimension shall be a 16 x 16 mm sewn together on 38 mm centres.
- E18.5 Approved products are:
  - (a) Erosion Control Blanket C32BD;
  - (b) North American Green C125BN.
- E18.6 The Contractor shall submit all manufacturers' product specifications and recommended installation methods for the proposed erosion control blankets a minimum two weeks before proposed installation date.

## Construction Methods

- E18.7 The Contractor shall install according to the manufacturer's recommended procedure.
- E18.8 Roll blanket out in direction of water flow.
- E18.9 Securely fasten blanket against soil surface with a staggered staple pattern as per the manufacturer's recommendation and as accepted by the Contract Administrator. Rate is to be no less than two staples per square metre.
- E18.10 Overlap between rows of blanket is to be not less than150 mm with staggered joints. Secure overlaps with a double row of staples not less than 10 cm apart.
- E18.11 Up flow edge of ECB is to be lapped above down flow edge.
- E18.12 Install a double row of stables staggered at 10 cm apart and 10 cm on centre over the blanketed area at 10 m intervals.
- E18.13 The upstream edge of the blanket shall be secured in a 15 cm deep by 15 cm wide trench and anchored with staples at a maximum of 30 cm spacing. The trench shall be backfilled with compacted clay.

#### Maintenance

- E18.14 The areas covered with ECB shall be regularly inspected for blanket separation or breakage until the end of the warranty period. At a minimum the ECB shall be inspected after every severe rainfall, storms or flooding.
- E18.15 Any damaged or poorly performing areas as a result of storm/flood damage shall be replaced or repaired immediately. If rill or gully erosion is present this shall be repaired by manual methods.
  - Measurement and Payment
- E18.16 Erosion Control blanket and related Work shall be measured on an area basis and paid for at the Contract Unit Price for "Erosion Control Blanket" on Form B:Prices.
- E18.17 The Contractor shall be compensated for replacing ECB damaged during a flood or storm event provided that the Contract Administrator has reviewed the damage and approved the replacement prior to the repair taking place.
  - (a) There shall be no measurement or payment for ECB replacement if the damage during storms or flooding are the result of conditions within the control of the Contractor such as faulty materials or installation methods.

#### E19. BOAT RAMP

**General Description** 

E19.1 This Specification shall cover supply and installation of materials and Works necessary to reconstruct the boat ramp

Materials

- E19.2 Reinforced Concrete Precast boat ramp pads are to be Barkman 3.66x0.425x0.15 m precast pads bolted and cabled in accordance with manufacturers recommendation or equal approved in accordance with B7.
- E19.3 Rebar is to be 15 m epoxy coated.
- E19.4 Limestone is to be as specified on the drawing.
- E19.5 Boulders are to be rounded granite boulders in the sizes specified on the drawing.
- E19.6 Woven Geotextile in accordance with CW 3130

Installation

- E19.7 Contractor to install all necessary temporary erosion control measures.
- E19.8 Prepare subgrade, remove any remaining debris.
- E19.9 Install geotextile and limestone. Compact to 95% proctor density
- E19.10 Install boat ramp pads, lower curb, rebar and boulders in accordance with manufacturers specification and drawings.

Measurement and Payment

E19.11 Boat ramp pads shall be measured per each. Said payment shall include all items necessary and incidental to the supply and installation or the pads, including subgrade preparation, geotextile, limestone, precast pads, connecting bolts and cable.

- E19.12 Boat ramp curb, pins and anchoring boulders shall be lump sum and include all items necessary and incidental to the supply and installation of the curb, including subgrade preparation, geotextile, limestone, precast pads, and rebar.
- E19.13 Payment shall be as per the respective items on Form B:Prices.

#### E20. SITE LIGHTING

E20.1 This section shall cover the supply and installation replacement site lighting including concrete bases, light poles, fixtures and bulbs as well as connection to the existing electrical services.

Materials

- Fixture foundation to be minimum 400 ø x 1.8m poured in place concrete pile with anchoring bolts to match light pole, conduit for electrical (poured into pile) with exit min 610 mm below top, 25 mm chamfer at top, reinforced with min four 15 m rebar (vertical) connected to 10 m hoops 30 cm oc..
- E20.3 Fixture and standard to match existing Martec fixtures.

Installation

- E20.4 Contractor to supply shop drawings showing fixtures, base cw. Reinforcing, and electrical. Shop drawings shall be stamped by professional engineer registered to work in the Province of Manitoba.
- E20.5 Contractor shall obtain the requisite electrical permit.
- E20.6 Contractor shall locate existing lines, other underground services, and existing bases.
- E20.7 Contractor shall confirm light locations and base heights with Contract Administrator.
- E20.8 Contractor shall drill piles, install reinforcing, conduit and anchor bolts and pour bases.
- E20.9 Contractor shall install poles fixtures and connect to existing electrical.

Measurement and payment

- E20.10 Measurement shall be for each new fixture and be deemed to include all items necessary and incidental to the supply and installation of working lights such as permit, underground utility location, removals, new base, new fixture and standard and bulbs.
- E20.11 Payment shall be as per item 'Replace Light Standards' on Form B:Prices.

## E21. RAILING

E21.1 This section shall cover the supply and installation replacement metal railing at the Mostyn Park site.

Materials

E21.2 Metal railing supplied shall match the existing railing both in material, anchoring method and finish.

Installation

- E21.3 Contractor shall confirm on site with Contract Administrator the extent of railing to be replaced.
- E21.4 Contractor shall measure and prefabricate replacement railing sections.

- E21.5 Existing railing to be cut at the joint and new railing welded to the existing railing. Bases of the new railing to be bolted to the existing concrete base.
- E21.6 Where only a new intermediate rail is required Contractor is to make a clean cut of the existing railing and weld in place new rail.
  - Measurement and Payment
- E21.7 Replacement railing and replacement railing parts shall be lump sum.
- E21.8 Payment shall be as per item 16 on Form B:Prices.

## **E22.** CONCRETE GRADE BEAM

E22.1 This section shall cover the supply and installation of the replacement concrete grade beam at the Tache boat dock.

Materials

- E22.2 Concrete, formwork, and testing shall be as per CW 2160
- E22.3 Reinforcing shall be as specified on the Drawings.

Installation

- E22.4 Contractor shall secure worksite
- E22.5 Contractor shall confirm extent of removal with Contract Administrator on site, saw cut and remove existing concrete grade beam scheduled for removal.
- E22.6 Contractor shall excavate to the required depths, supply and install void form, reinforcing, and formwork as required.
- E22.7 Contractor shall arrange inspection by Contract Administrator prior to ordering concrete and pouring.
- E22.8 Following approval of the formwork and reinforcing Contractor shall pour concrete and arrange for testing as per CW 2160.
- E22.9 Contractor shall allow concrete to set, shall strip and shall strip and remove formwork and, when the concrete has cured, backfill.
- E22.10 Measurement and payment
- E22.11 Concrete Grade Beam shall be measured by length of new grade beam installed. Said measure shall be deemed to include new grade beam, reinforcing, formwork, and any other items necessary and incidental to installing the grade beam.
- E22.12 Payment shall be as per item 6 on Form B:Prices.

## **E23. SITE RESTORATION**

E23.1 Total Performance of the Work shall not be attained until the Contractor has cleaned up the Site and has removed all tools, equipment, waste, debris and surplus foundation earth to the satisfaction of the Contract Administrator. Unless otherwise specified, and as a condition of Total Performance the Contractor shall restore all areas of the Site beyond the established limit of Work, which have been disturbed by the Contractor's operations to as good as or better than the original condition to the satisfaction of the Contract Administrator. The Contractor shall pay all costs associated with this Work.
