PART A – BID SUBMISSION

Replace: 733-2014 Bid Submission with 733-2014 Addendum 1 - Bid Submission. The following is a summary of changes incorporated in the replacement Bid Submission:

Form B (R1): PRICES Items 1 revised quantity to 6200.

Page numbering on some forms may be changed as a result.

PART B – BIDDING PROCEDURES

Revise: B2.1 to read: **The Submission Deadline is 4:00 p.m. Winnipeg time. February 27, 2015.**

PART D – SUPPLEMENTAL CONDITIONS

Add: D2.2.1 In accordance with D2.2(a); an existing contractor has the first right of refusal on all Tree Wood Waste Material coming into The BRRMF. During the initial grind of existing Tree Wood Waste Material the existing contractor will be on site to mark the logs that meet their specifications. These marked logs must be set aside in a pile for the existing contractor to pick up after grinding has been completed. This will be the only time the contractor will sort through the existing pile for the specified logs. Future work won't require the Contractor to set aside specified logs. As the material is dropped off the existing contractor will sort through and have their specified logs clearly marked and set aside in a location identified by the Contract Administrator before the required grinding.

Add: D28. **PERFORMANCE SECURITY**

D28.1 The Contractor shall provide and maintain performance security until the expiration of the warranty period in the form of:

(a) a performance bond of a company registered to conduct the business of a surety in Manitoba, in the form attached to these Supplemental Conditions (Form Hs1: Performance Bond), in the amount of fifty percent (10%) of the Contract Price; or

(b) an irrevocable standby letter of credit issued by a bank or other financial institution registered to conduct business in Manitoba and drawn on a branch located in Winnipeg, in the form attached to these Supplemental Conditions (Form H2: Irrevocable Standby Letter of Credit), in the amount of fifty percent (10%) of the Contract Price; or

(c) a certified cheque or draft payable to "The City of Winnipeg", drawn on a bank or other financial institution registered to conduct business in Manitoba, in the amount of fifty percent (10%) of the Contract Price.

- D28.1.1 Where the performance security is in the form of a certified cheque or draft, it will be deposited by the City. The City will not pay any interest on certified cheques or drafts furnished as performance security.
- D28.2 The Contractor shall provide the City Solicitor with the required performance security within seven (7) Calendar Days of notification of the award of the Contract and prior to the commencement of any Work on the Site.

Revise: D15.1(a)(i) to read: Thumb attachment or equivalent in accordance with B7.

Revise: D15.1(b)(i) to read: Minimum 4 yard bucket or equivalent in accordance with B7.

Revise: D15.1(c)(i) to read: Can either be a horizontal grinder or tub grinder.

- Add: E10. **COMPLETION OF WORK**
- E10.1 Work of the existing Tree Wood Waste Stock pile material as noted in Item 1 of Form B: Prices will need to be completed before April 15, 2015.
- Add: E11. **STATIONING OF EQUIPMENT**
- E11.1 Equipment utilized for this Contract will be allowed to remain onsite at the Wood Processing area as shown on drawing 1-04008-D0003-001. The City is not responsible for any damages or theft of the equipment that may occur when stationed at The BRRMF.
