PART A – BID SUBMISSION

Replace: 242-2015 Bid_Submission with 242-2015 Addendum_2_Bid_Submission. The following is a summary of changes incorporated in the replacement Bid Submission:

Form B(R1): Add Item No. 13, REMOVE AND DISPOSE OF IRRIGATION PIPING

PART D – SUPPLEMENTAL CONDITIONS

Revise: D2.2(d) to read: Restore all areas damaged during construction, including curbing, sidewalk, and grassed areas. No extra will be allowed for restoration Work.

Delete: D2.2(d)(i)

Add: D2.2(e) Create Construction Access Path following Specification E6, and protect all trees adjacent to the Work Area. The City will mark the boundaries of the Work Area, where construction fencing shall be installed.

Add: D2.2(f) Contractor shall arrange and pay for all necessary permits and inspections, and obtain all necessary approvals of the Authority Having Jurisdiction.

PART E – SPECIFICATIONS

Add: E5.4(a) Contractor shall be permitted to stockpile materials at the southwest side of the Work Area.

Revise: E5.6 to read: Golf Course parking lot shall not be used by the Contractor for personal parking or any construction-related purpose.

Revise: E5.7 to read: Contractor must provide washroom facilities for their workers. Contractor may not use the washroom facilities in the Clubhouse. Contractor's washroom facilities to be located on the south side of the Work Area.

Add: E5.8 Contractor to provide own generator for any required power. Generator to be located on the southwest side of the Work Area, to be least disruptive to golfers on the 18th green.

- Revise: E6.1 to read: Construction deliveries shall use the designated Construction Access Path only. No deliveries or access of any kind will be permitted at the North (parking lot) side of the Site.
- Add: E6.3(c) The City will spray-paint lines to indicate Work Area extents, where Contractor shall install boundary fencing.
- Delete: E6.4(a)(ii)
- Delete: E6.4(b)
- Revise: E6.4(c) to read: Contractor shall lay 5/8" plywood over the entire Construction Access Path.
- Revise: E7.3 to read: Contractor shall be responsible for obtaining permit(s) to block a lane on Main Street for deliveries. No construction deliveries will be allowed after 3:00 pm daily.
- Revise: E7.5 to read: Contractor shall ensure that Work Area is secured at the end of each day.
- Revise: E7.6 to read: Only the following vehicles/equipment will be allowed on the Construction Access Path:
- Delete: E7.6(a)
- Revise: E7.6(b) to read: Bobcat or Skid Steer with tracks
- Delete: E7.6(c)

Add: **E22 REMOVE AND DISPOSE OF IRRIGATION PIPING**

E22.1	<u>Description</u>
E22.1.1	Work shall include the removal and disposal of underground irrigation piping, including capping the piping.
E22.1.2	Confirm extent of removal with Contract Administrator.
E22.1.3	In removal areas where new construction work is not specified elsewhere in the drawings and specifications, Contractor shall remediate the area with topsoil and sod.
E22.1.4	Specification E21.1.5 will apply to this section.
E22.2	<u>Method of Measurement and Basis of Payment</u>
E22.2.1	Removal and Disposal of Irrigation Piping will be measured on a linear metre basis and shall be included in Item 13 Remove and Dispose of Irrigation Piping in Form B(R1): Prices.
E22.2.2	Removal and Disposal of Irrigation Piping will be paid for at the Contract Unit Price for Item 13 Remove and Dispose of Irrigation Piping in Form B(R1): Prices.
