For systems where the part of cylinder and / or piping is not exposed for visible inspection, a written record shall be kept of the quantity of hydraulic fluid added to the system and emptied from leakage collection containers and pans. The written record shall be kept in the machine room. When the quantity of hydraulic fluid loss cannot be accounted for, the test specified in 8.11.3.2.1 and 8.11.3.2.2 shall be made - 8.6.5.7 B44 07. [REDACTED].

Repair the hoistway access key switch at top floor. [REDACTED]
