PART A – BID SUBMISSION

Replace: 598-2016 Bid Submission with 598-2016 Addendum 1 - Bid Submission. The following is a summary of changes incorporated in the replacement Bid Submission:

- Form B(R1): Delete Items No. A.10 and A.11
- Form B(R1) Update approx. quantity of A.2, A.4.i and A.7.
- Form B(R1): Update Item No. B.1 description to "Tennis Posts and Nets."

Page numbering on some forms may be changed as a result.

PART E – SPECIFICATIONS

- Revise: E9.1 (b) to read: If tree branches require further pruning outside of the clearing limits, as determined by the Contract Administrator, the work shall be undertaken by a licensed arborist.
- Revise: E9.2 (b) to read: No separate measurement or payment will be made for the pruning of trees and shall be deemed incidental to Clearing & Grubbing.
- Delete: E14
- Revise: E21.3 (b) to read: Woodchip Mulch to be carefully spread to a consistent depth of 150 mm minimum over the entire area.
- Replace: E23 to read:
 - E23. TENNIS POSTS & NETS
 - E23.1 DESCRIPTION
 - E23.2 This Specification shall cover the supply and installation of Tennis Posts and Nets designated for installation by the Contract Administrator. The Work to be done by the Contractor shall include the furnishing of all superintendence, overhead, labour, materials, equipment, tools, supplies and all other things necessary for and incidental to the satisfactory performance and completion of all Work as shown on the Drawings and as hereinafter specified.

E23.3 MATERIALS

- (a) Tennis Posts as manufactured by Douglas Tennis Systems, or approved equal. Post model: Premier SQ. #63053, 75mm square, 11 gauge steel, Plated steel gears, green colour. Supply and install four (4) tennis posts. The posts will require cutting and welding to a new steel surface mount base plate.
- (b) Aerosol spray paint matching color of posts.
- (c) Tennis Net as manufactured by Douglas Tennis Systems, or approved equal. Net to be #30030 model TN-30DM. Supply and install two (2) nets. Nets may require modification by the manufacturer or Contractor to fit custom spacing between posts.
- (d) Steel Base Plates to be custom manufactured. All metal to be primed and painted to match tennis posts.

E23.4 CONSTRUCTION METHODS

E23.4.1 Removal of existing tennis nets

- (a) Before commencement of any work, the Contractor shall consult with the Contract Administrator as to which tennis nets shall be removed.

E23.4.2 Installation of new tennis nets

- (a) Contractor to cut existing tennis posts to 25mm above finished asphalt grade
- (b) Custom fabricate a new 25mm thick steel base plate with a centre hole opening of 95mm and place over existing tennis posts. Base plate to be primed and painted on all surfaces not being welded prior to installation. Level plate using silicone sealant. Weld new steel base plate continuously to the top edge of the existing post. Grind welds smooth.
- (c) Cut new tennis posts so that top of new post will be 1070 mm above the top of the asphalt paving. Remove paint where welds will be installed. Weld new post to base plate.
- (d) Weld 4-6mm steel braces to the base of the post and the steel base plate. All welds to be continuous and ground smooth. Finish all metal with one coat of primer and two coats of paint to match the manufacturer's tennis posts.
- (e) Install tennis nets upon completion of project

E23.5 MEASUREMENT AND PAYMENT

E23.5.1 Tennis Posts and Nets

- (a) Tennis posts, metal base plates, fabrication and painting shall be paid on a unit basis and paid for at the Contract Unit Price for "Tennis Posts and Nets." The item to be paid for will be the total number of completed installations. Each installation shall include fabrication, cutting, paint, metal base plates, two (2) posts, one (1) net satisfactorily installed in accordance with this Specification, accepted and measured by the Contract Administrator.

E23.5.2 No separate measurement or payment shall be made for the removal and disposal of any waste material from the fabrication and customization process.
