

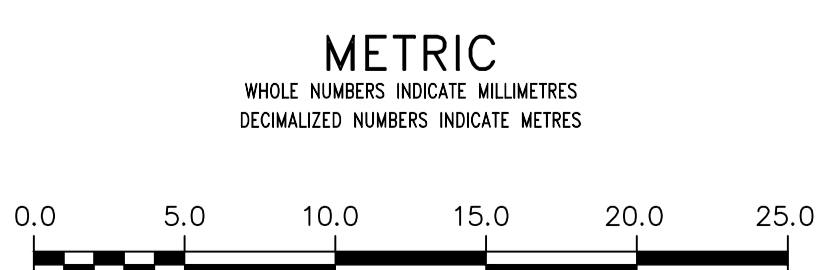
CONSTRUCTION NOTES:
