Good day John. The City of Winnipeg Solid Waste Services Division (SWSD) would be happy to receive the clean fill material from the Parker Stormwater Retention Basin (SRB) at the Brady Facility. As you have stated in your email, the excavation contractor for the SRB project will need to supply their own equipment to move/shape the material dumped at the Brady Facility. Given that this is the case, the rate at which the material comes in will be governed by the contractor's commitment to ensuring sufficient equipment is available on site at Brady to manage whatever the material flow might be. The SWSD will designate an area at Brady for the stockpiling of the clean fill material. The designated area will be adjacent to a haul road at the facility and will be prepared (levelled and topsoil stripped) by the SWSD. All other aspects associated with the movement of this material into the Brady Facility will be the responsibility of the excavation contractor. Assuming that the material meets the CCME Canadian Environmental Quality Guidelines for Industrial sites there will be no tipping fee applied.

All: Further to Tony's email from March 2017 I would like to get confirmation from the City of Winnipeg Solid Waste Division and Brady Landfill about how much clean fill material from the Parker Stormwater Retention Basin (SRB) it will accept on a daily basis. We will be posting the Bid Opp for this project in July and need to know this information before then. I have been told that the excavation contractor for the SRB project will need to supply their own equipment to move/shape material dumped at the Brady landfill. It is not certain that this clean material will even go to the Brady landfill as the winning bidder may make a deal with other landowner(s) in town or nearby. However, as the Brady landfill is a logical City site that often takes clean fill it would be better to have more accurate information about this one option to provide bidders.

Raymond,

Further to our conversation yesterday regarding clean fill acceptance at the Brady Landfill, see email thread below and attached email with soil sample results that were reviewed previously by the City.

Can you confirm that the Brady Landfill will be accepting clean fill at no charge (no tipping fee)? And please confirm how much clean fill will typically be accepted daily on days that the landfill is accepting clean soils? The Parker SRB project that will be starting up this fall 2017 will have approximately 300,000 cubic metres of soil to be removed from site and moved somewhere. I would expect a significant number of hauling trucks moving soil every working day during the project.
