Revise : D2.1 to read: The Work to be done under the Contract shall consist of upgrades to the existing building safeguards and the construction of a new Data Centre inside the building located at 700 Assiniboine Park Drive. Please be advised that the building will be partially occupied and will remain in operation 24 hours/day, 7 days per week. The Contractor shall take precautions to protect all equipment inside each room during construction to ensure it remains in operation. If an equipment shutdown is required the Contractor shall submit a request in writing to shut down the equipment at least 3 days in advance of the shut down to the Contract Administrator. The Contractor may use room 109 for their site office and may use washroom facilities on the South end of the main floor.
