E38. CSP DITCH OUTLET BAR SCREEN

E38.1 Description

(a) This specification clarifies CW 2130 "Gravity Sewers" for installation of all CSP outlet bar screens.

E38.2 Construction Methods

(a) The Contractor shall refer to the Construction Drawings – Typical Drainage Details drawing for information regarding the supply and installation of the typical ditch outlet.

E38.3 Material

E38.3.1 General

- (a) All materials supplied under this Specification shall be of a type approved by the Contract Administrator and shall be subject to inspection and testing by the Contract Administrator.
- (b) The CSP outlet bar screen shall use a 15mm diameter bar and the assembly shall be galvanized after fabrication.
- (c) All nuts and bolts in the CSP outlet assembly shall be stainless steel.

E38.4 Measurement and Payment

E38.4.1 Supply and Install of CSP Ditch Outlet Bar Screen

(a) Supply and Installation of the CSP ditch outlet bar screen will not be measured and payment shall be considered incidental to B.30 Sewer Service.
