

CONSTRUCTION NOTES:

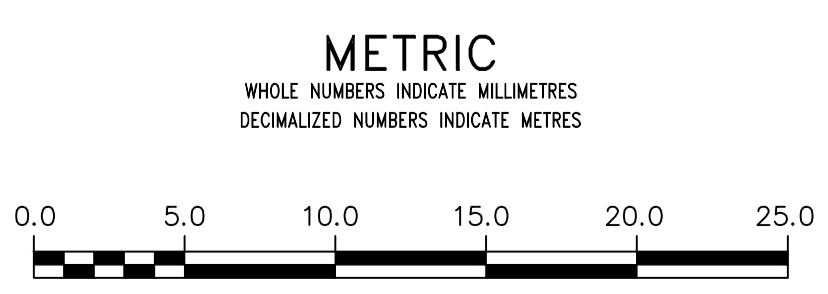
1. REMOVE AND DISPOSE OF CONSTRUCTION MATERIALS FROM SITE DAILY.
