PART D – SUPPLEMENTAL CONDITIONS

- Add: D4.3 The Water & Waste Department has purchased materials and will undertake works to have a temporary bypass pipe installed on the bridge sidewalk in order to bypass the failing section of pipe. This bypass will be put into service should a pipe failure occur. It is assumed that this bypass pipe can be used throughout the force main rehabilitation or repair works construction period and will be removed following completion of the works by City of Winnipeg staff. Attached drawing number 1-0117L-M0001-001 titled "2018 Bypass Pumping Assembly" shows pertinent information about the bypass pipe and configuration. Pumping for the bypass pipe is from the existing pumps at the Baltimore pump station.

- Add: D4.4 No infrastructure in the Baltimore pump station is to be upgraded or replaced as part of this project. All existing relevant pump station information will be transmitted to the Consultant upon award. Solutions must be designed such that the existing pump station performance is not negatively impacted.

- Add: D5.2 An excerpt from the specifications of the original force main installation contract is attached in Appendix B however, no shop drawings are available to confirm if what was specified was actually installed.

- Add: D6.4.4 The Consultant shall meet with the Project Manager during the preparation of the Concept Evaluation Workshop materials no later than two (2) weeks before the Workshop to review draft materials.

- Add: D6.4.5 The Workshop will be held in Training Room A/B/C at 1155/1199 Pacific Ave. Approximately 15 City of Winnipeg staff will be participating in the Workshop. The room has a 60 person capacity and tables and chairs can be moved around into any configuration. There is an overhead projector available however the Consultant should request a time to test out any audio visual presentation materials in the training room prior to the Workshop.
