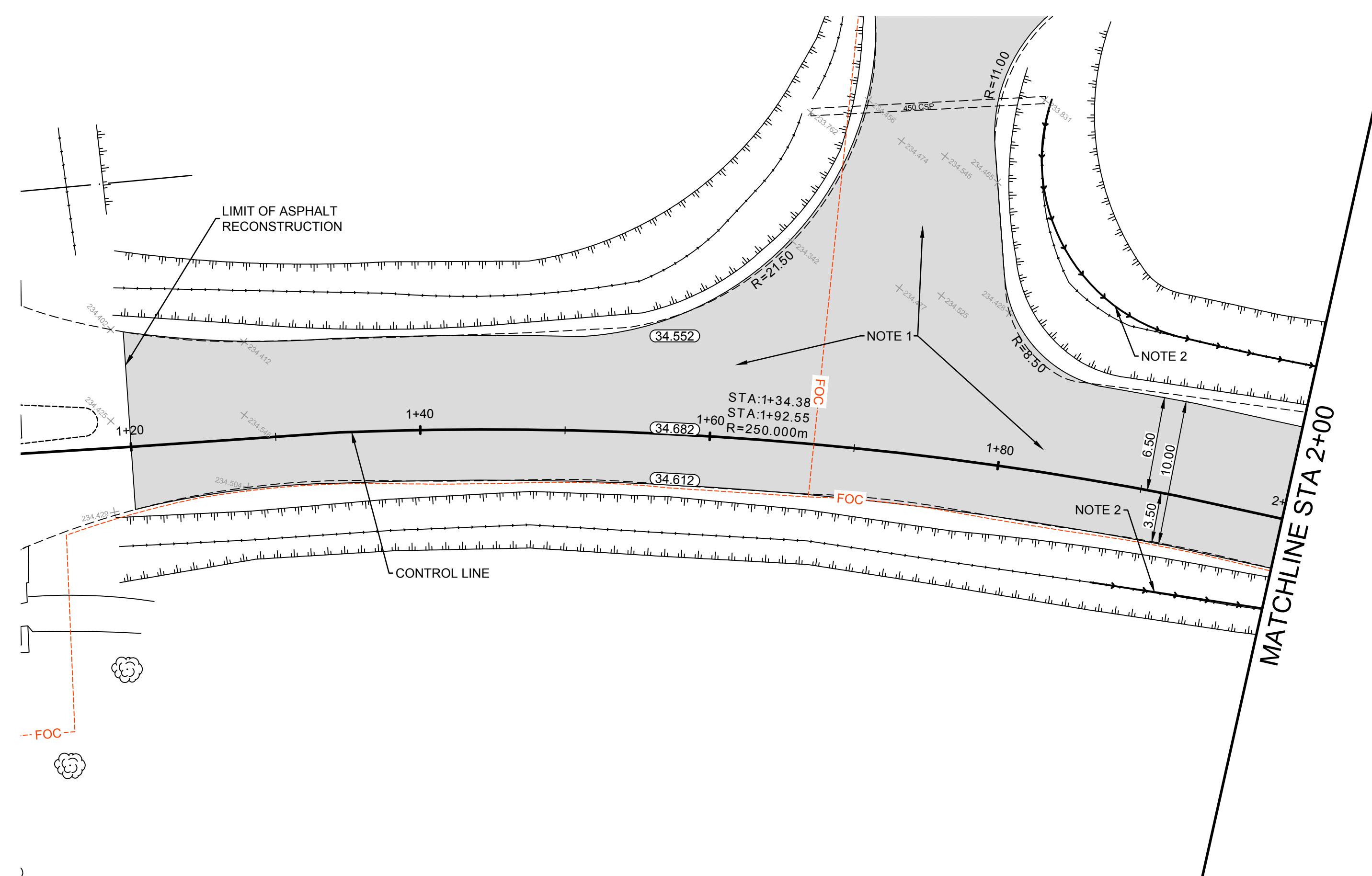
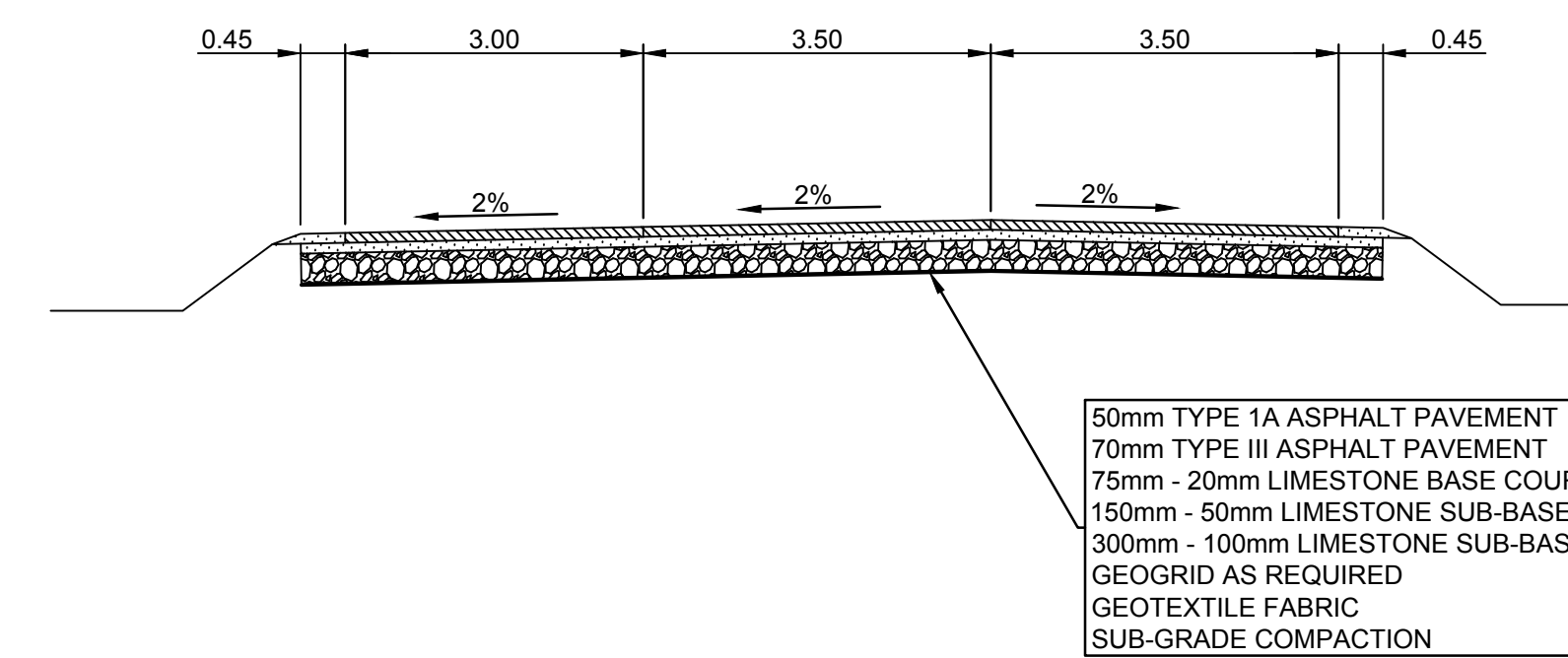


ASSINIBOINE PARK DRIVE
