The Limit of Liability shall not be less than \$2,000,000 inclusive for loss or damage including personal injuries and death resulting from any one accident or occurrence;
- Revise: D9.1(c) to read: All risks course of construction insurance in the amount of one hundred percent (100%) of the cost of the boiler work, including testing and commissioning, written in the name of the Contractor and The City of Winnipeg, to remain in place at all times during the performance of the Work and until the date of Total Performance;

PART E – SPECIFICATIONS

Revise: Section 01 11 00 clause 1.3.4 to read:

.4 Apply architectural coating as specified in section 09 96 53 at concrete wall repairs and as detailed on 5/S2.

Add: Section 01 11 00 clause 1.3.4:

.7 Treat cracks and apply new traffic topping system on ramp 2 as specified in section 07 10 70.

.8 Perform concrete repairs to the exposed cast-in-place concrete stub walls adjacent to the Smith Street sidewalk (along gridline 1) as detailed in the project drawings (Section 8/S2).
